## **Depend less on CIP, reduce tax concessions – IMF**

Sandals Grande Antigua Resort and Spa was the venue Thursday for a special Business Breakfast Forum hosted by the Antigua and Barbuda Chamber of Commerce and Industry.

The half-day event was in collaboration with the International Monetary Fund (IMF), whose Mission Chief for Antigua and Barbuda, Leo Bonato, was the feature speaker.

#### The Living Word

Water into Hope

Read: John 4:4–14

Let anyone who is thirsty come to me and drink. John 7:37

Tom and Mark's ministry refreshes lives. This is clear in the video they share of a group of fully clad children laughing and dancing in the refreshing water of an open shower—their first ever. The men work with indigenous churches to install water filtration systems on wells in Haiti, easing and lengthening lives as diseases connected to contaminated water are prevented. Access to clean, fresh water gives the people hope for their future.

Jesus referred to "living water" in John 4 to capture a similar idea of a continual source of refreshment. Tired and thirsty, Jesus had asked a Samaritan woman for a drink (vv. 4–8). This request led to a conversation in which Jesus offered the woman "living water" (vv. 9–15)—water that would become a source of life and hope within them, like "a spring of water welling up to eternal life" (v. 14).

We discover what this living water is later in John, when Jesus said, "Let anyone who is thirsty come to me and drink," declaring that whoever believed in Him would have "rivers of living water [flowing] from within them." John explains, "By this he meant the Spirit" (7:37–39).

Through the Spirit, believers are united to Christ and have access to the boundless power, hope, and joy found in God. Like living water, the Spirit lives inside believers, refreshing and renewing us.

How has Jesus satisfied your thirst through His Spirit? How will you share what Jesus has done for you?

Dear God, thank You for leaving us Your Spirit. Work in us so that our lives point others to You.

Two men convicted for illegal firearms

Two men - Alvin Spencer, 29 and Jason McLeod, 25 both of Swetes were convicted and sentenced to Her Majesty's Prison on charges of possession of firearm and ammunition in All Saints Magistrate's Court on Thursday.

Spencer pleaded guilty to possession of one .25 pistol and six matching rounds of ammunition and was convicted and sentenced to one year for possession of firearm and three months for possession of ammunition.

Meanwhile, co-accused Jason McLeod pleaded guilty to possession of one .38 revolver and five matching rounds of ammunition and was convicted and sentenced to one year for possession of firearm and three months for possession of ammunition.

Both sentences are to run concurrently.

Both men were among five people jointly charged

by police, after they were found in possession of the illegal weapons during a search of their home in Swetes on Tuesday 4th February.

The complaints against the other accused were withdrawn before the Court. Magistrate Ngaio Emanuel-Edwards presided over the matter.

Meanwhile, the case against the Jamaican man suspected of being a drug mule will continue at the

All Saints Magistrate's court, currently holding session at the new Transport Board Building at Herbert's.

Perspective on the Trends of Antigua and Barbuda's Economic Performance in Relation to Regional and Global Economies.'

"We expect growth to slow down somewhat in the next few years, but we also think that there are some risks – some upside, some downside," he stated. "If the growth in advanced economies that we expect does not materialize, growth in Antigua is going to be smaller."

Noting that "there is a cost to having government," Bonato said economies of scale tended to be achievable in bigger countries, "But if you are in an archipelago like St. Vincent and the Grenadines and you have to provide services to all these small communities in the islands, that's very expensive."

Despite these unavoidable downsides, Bonato said resignation or surrender to such circumstances was not an option.

"It's precisely because you are so vulnerable that you have to be prepared. One of the problems is high debt [while] revenues have declined."

He noted that these factors were mentioned in the recent budget address by Prime Minister and Minister for Finance Gaston Browne.

Bonato observed that there is a lot of reliance on Citizen

Cc: Sir Robin Yearwood- Minister of Public Utilities, Civil Aviation, Transportation and Energy by Investment Programs, which have allowed many countries to do good things with the extra revenues derived. "But by definition, you cannot use those revenues to finance you current spending, which has to be financed by predictable revenues."

He said CIP funds could be used to finance things "that you would be able to do without in situations of difficulty ... for example, certain investment projects, doing climate resilience, these sorts of things I think the funds are good to be used for, but not to finance the current activities of the government."

Bonato said the public coffers of Antigua and Barbuda had to bear a multiplicity of what he termed "spending pressures", mainly because of the large numbers of people employed in the public sector and the corresponding wage bill.

"Public employment in Antigua is very high compared with the rest of the region.

"In terms of individual wages and salaries, I don't think they are very high," he said, "but employment has grown a lot and so that is a problem."

He added that the cash flow problems that government experiences "are clearly a sign of the weakness of the fiscal situation".

He said that was all the more reason why prudent fiscal policies – such as debt to GDP ratios – were essen-



tial for not just Antigua and Barbuda, but the entire currency union.

Bonato said Antigua needed to make choices that would help spur economic growth and thereby lower its debt to GDP ratio, and that would require certain corrections. He referred to delays in making payments (for goods and services) that have affected the economy.

He illustrated it this way: "If I don't receive my payments on time, the options I have are either I go to the bank for a loan, or I delay my payments to someone else. So it's like a disease that transmits quickly through the rest of the economy."

Prime Minister Browne has repeatedly stated that tax revenues have not reflected the high levels of economic growth and expansion that Antigua and Barbuda has experienced in the last five years. According to Bonato, "In general we have a lot of concessions. Antigua is one of the countries that give the most concessions and that undermine the tax base.

"Once concessions become so pervasive without any clear rules as to the basis on which they are given, then it creates uncertainty."

### High power delegation attends meetings

A high-powered delegation is representing Antigua and Barbuda at two important sub-regional meetings taking place in St Kitts-Nevis today.

The delegation is headed by Prime Minister Gaston Browne and it includes Opposition Leader, Jamal Pringle, the Financial Secretary Whitfield Harris, OECS Commissioner, Colin Murdoch, the head of the Information Technology Unit, Luzmore Edwards and CIP agent, Vanetta Rodgers. The meetings are 95th Meeting of the Monetary Council of the Eastern Caribbean Currency Union the OECS Monetary Council and an emergency meeting of the OECS Authority, its 68th such gathering.

A series of meetings preceded the two that are taking place today. These include the growth forum, which traditionally precedes the Monetary Council and focuses on critical issues facing the economies of the region

including payment system transformation, digital economy transformation and the leveraging of renewable energy.

The Authority's meeting takes place after the Monetary Council.

It will look at the finances of the Commission, the budget of the Eastern Caribbean Supreme Court, issues related to ECCAA, the OECS Embassy in Brussels and issues related to the coordination of OECS and CARICOM systems to prevent overlap, duplication and conflict.

Prime Minister Browne is the current chairman of the OECS Authority.

Other matters on the agenda include a report on the banking sector up to the end of 2019 as well as an examination of the Medical Cannabis Evolution: Challenges in banking a budding industry in the ECCU.

## **Debt reduction an excellent** use of CIP funds, says IMF

Antigua and Barbuda and other OECS countries that run Citizenship by Investment or CIP programs would do well to heed advice that the revenues derived should be employed to pay down their debts.

That advice had been given several years ago by the Eastern Caribbean Central Bank (ECCB), and the International Monetary Fund (IMF) now says it is certainly a very good choice for utilization, though not the only one, depending on the particular circumstance.

His presentation was titled 'The IMF's Perspective on the Trends of Antigua and Barbuda's Economic Performance in Relation to Regional and Global Economies."

The Washington DC-based multi- ment needs, which must be looked at to see the value of these projects compared with the value of getting into a safer financial position.

> There is a lot of merit in reducing your debt and increasing your savings in all these countries," he stated.

> But while lauding the recommendation as good advice, Bonato said other important things such as climate resilience were also worthy of consideration for funding with CIP revenues.

The government is putting aside funds to construct a building in Barbuda that will be termed the Office of the Ministry of Barbuda Affairs.

The Cabinet said it is determined that it needs a new building that will bring all the services that it offers to the island under one roof.

Government spokesman Lionel Max Hurst said the new building, resilient and hurricane-proof, will be large enough to accommodate all Central Government operations on Barbuda, and will serve to consolidate and to strengthen the Central Government's presence on the sister-isle.

"Policemen, firemen, teachers, nurses, doctors, orderlies, petty officers, government pensioners, Social Security recipients, APUA Electricity Water and Telephones personnel are paid directly from Antigua-not through the Barbuda Council," Hurst explained.

He stated that the object is for the

Central Government to have a sustaining presence in Barbuda and to ensure that recipients of government payouts are not left behind. The new Minister of Barbuda Affairs will be visiting Barbuda shortly.

There has been a longstanding dispute between the Barbuda Council and the central government over the use of publicly owned building on the island with the council refusing to allow officials from central government access to these facilities.

#### **Park Invite** novation Greene:

The newly established Science and Innovation Park located in the former US Naval Facility at Burma is now available for use not only by nationals or Antigua and Barbuda, but to anyone living in the Caribbean region who wishes to use its services.

The invitation to the Caribbean region was issued Thursday by Foreign Affairs and Trade Minister, E.P Chet Greene, during an address at the opening of a regional workshop for active measurers, and poli-European Union/CARIFO-RUM Standby Facility for Capacity Building at the Rex Halcyon Cove hotel.

Greene said that as small developing states, there is a need for the region to become more economically resilient noting that the regional integration framework provides an opportunity to achieve this.

However, he is of the view that as a region, the Caribbean must engage in pro-

cies to expand and grow its economies.

According to the trade minister the Government of Antigua and Barbuda has embarked on a strategy to support existing SMEs and encourage the development of new entrepreneurs through greater infusion of innovation and information technology within the business structure.

"I call on stakeholders and especially our young people to take advantage of the newly created Science and Innovation Park. We need more people to use the park. It will cost you nothing," he urged.

Noting Antigua and Barbuda's primary role in the regional integration movement, Greene has extended an invitation for people from across the Caribbean to make use of the park as well. "While the park is domiciled here, it was never the intention for it to be a coal construct. It was designed and created for regional use," the minister explained.

The minister drew attention to the data which suggests that the Caribbean as a region is lagging behind other areas in innovation. He recommended Antigua and Barbuda as a willing partner for any Caribbean national or company that wishes to make use of the park's services.

The Science and Innovation Park is a joint project of the government and the United Nations Office for Special Projects (UNOPS). It was founded on the premise that it will provide an environment 'incubation' for start-up businesses to grow and develop before launching out to the wider community.

He suggested that other projects could be weighed to determine if their economic growth and development value or potential did not render them fit for higher or more immediate prioritization.

He said whether or not Antigua and Barbuda had followed the advice of using CIP revenues to reduce its debt to GDP ratio from more than 100 percent to less than 70 percent in five years was easy to verify, while noting that once revenues become available it is very easy for them to be spent if governments allow themselves to become fiscally sidetracked upon coming into possession of such additional resources.

### Hypocrisy unmasked at the OAS

If candidates were to get a prize for making the best case for why they are best suited to be Secretary-General of the OAS, María Fernanda Espinosa would have easily walked away with it when the three contenders for the post appeared before the Permanent Council of the Organization on February 12.

Showing all the competence, knowledge and experience that come from holding high ministerial offices and the Presidency of the UN General Assembly, Ms. Espinosa handled, with remarkable grace and aptitude, difficult interrogations from the representatives of the U.S. and governments supporting the re-election of the incumbent, Luis Almagro.

The objective of the interrogations from this group of countries, which included Bolivia, Brazil and Colombia, was to try to paint Ms. Espinosa as an ideologue who would act against decisions and declarations of the OAS, engineered by a majority of 18 delegations, against the Maduro and Ortega governments of Venezuela and Nicaragua and the Presidency of Evo Morales of Bolivia which was ended by a coup d'état, however else it is portrayed.

This group of governments strongly support Mr. Almagro because, in the abuse of his office, he has been their most enthusiastic standard bearer against the Maduro and Ortega governments.

So preoccupied is this group of governments with trying to ensure that Mr. Almagro remains in position, that they have, so far, refused to recognize that Ms. Espinosa is not an ideologue and is, in fact, a realist; a pragmatic leader who fully understands that the success of any organisation depends on its capacity to build consensus among all its stakeholders. Incidentally, the regime in Bolivia is still to hold credible elections to legitimize the government it seized.

Only the deaf, or those who deliberately blocked their ears, would not have heard her say with passion and commitment that she will "strengthen human rights bodies" and "promote an initiative for the universalization of inter-American human rights instruments". If they were listening, they would also have heard her say that, as Secretary-General, she would be more "Secretary" than "General" (a failing of Mr. Almagro's), and that she would carry out the mandate and instructions given to her by Ministers.

And, it would only be the malicious who would deliberately misrepresent Ms. Espinosa's undertakings. Yet, the Brazilian Ambassador, in a later public session treating with the candidate for the post of Assistant Secretary General, and with Ms. Espinosa unable to respond, completely misrepresented her remarks, saying that she had stated she would not be guided by decisions of Ministers and the Permanent Council of the OAS. It took, another woman, Lou-Ann Gilchrist, the Ambassador of St. Vincent and the Grenadines, with great diplomatic restraint, to point out the Brazilian Ambassador's misrepresentation.

If, those who are so desperate to retain Mr. Almagro as their attack dog, would acknowledge that it is that posture that has led to the polarisation and ineffectiveness of the OAS, they might see in Ms. Espinosa an experienced and capable diplomat who, as she herself has publicly declared, "will not promote personal ideologies or the interest of any group". It is precisely because Mr. Almagro has been so ready to be partisan that the OAS is now a fractured and weak organisation, recognised not for its achievements but for its contentious di-



visions.

It was accepted by most delegates at the February 12 presentations that Mr. Almagro was the worst performer. He should have been the best. The debate was taking place on his ground - inside the headquarters of the OAS - and on his agenda, the role of the Secretary-General which post he has held for nearly 5 years. Yet, he was clearly not in control of his brief; he answered questions badly; and in some cases, did not know answers that should have come to him easily. Perhaps, this is because he has been a one-item Secretary-General, focussed on events in Venezuela to the near exclusion of everything else.

No one could have derived any pleasure from Mr. Almagro's poor performance. As I have written repeatedly, he is a very bright and able man. Somehow, he has lost his way, and was hoisted by his own petard. Not least, because he could not give to questioners a valid reason for seeking re-election when, in his first campaign to be elected and for most of his term, he had categorically stated that he would not run again.

The other contender for the OAS stewardship is Hugo de Zela of Peru. On the general view, he achieved second place, after Ms. Espinosa, in the effectiveness of his presentation and the content of the answers he gave to questions. His Achilles heel is his central and pivotal role in the creation and operation of the Lima Group, a gathering of a few countries dedicated to regime change in Ven-

#### ezuela.

Mr. de Zela's smooth veneer was dented by the Ambassador of Grenada, Yolande Smith, who inquired how he planned to build consensus in the OAS when he was the planter of the seeds of division by creating the Lima Group (not an official or recognised group of the Organisation) that ignored the official regional groups and operated in an exclusive process.

The OAS is at the crossroads. It can continue the business of the last five years, in which case countries will withdraw and the Organization will become an unrepresentative body with no hemispheric legitimacy, or it can choose sound management, transparency and greater effectiveness through the inclusion of all in genuine dialogue that takes account of every view. The latter would not be seeking a lowest common denominator consensus; it would be based on guidance by established rules, principles and international law.

Of the candidates who spoke on February 12, María Fernanda Espinosa offered the best course for every member state to achieve the latter objective – and that was the general belief.

## Community making strides to boost Services Sector

In recognition of the key role that the Services Sector plays in the Caribbean Community (CARICOM), the Community is taking steps to boost its performance in a more structured and harmonised approach.

At a Special Meeting of the Council for Trade and Economic Development (COTED) on Services held 31 January 2020, in Georgetown, Guyana, Ministers examined the Draft Regional Strategic Plan and an Implementation Plan for Services across the Region.

The developments come against the background of the important role that the Services Sector plays in the economic and social growth of the Community. At a minimum, the Sector accounts for 50 per cent of all regional economies, and is flagged as the economic area on which the Community can rely to develop and deliver on the objectives of the Article 6 of the Revised Treaty of Chaguaramas. Among the provisions of that Article are improved standards of living and work, full employment of labour and other factors of production. accelerated. coordinated and sustained economic development, and more efficient operation of common services and activities for the benefit of the people of the Community.

Barbados Prime Minister, the Hon. Mia Mottley currently Chairs the Caribbean Community (CARICOM)

Barbados does not have the capacity, given its population, to go it alone to achieve economic development, and thus should be more welcoming of its regional neighbours, said Prime Minister Mia Mottley, as Parliament moved to tweak the law governing the entry of skilled CARICOM nationals. Introducing the CAR-ICOM Freedom of Movement of Persons Amendment Bill to the House of Assembly this evening, she declared: "Barbados has a trade surplus with one region in the world, and that is the Organisation of Eastern Caribbean States, as well as with Guyana.

"So when xenophobic statements come, we forget to recognise our economic stability is linked to our neighbours, and Trinidad is where the second or third largest source of investment into Barbados comes from.

"And when we add that one in every five visitors to Barbados comes from the CARICOM region, we begin to understand why the political party I lead has a constitutional objective to pursue regional integration.

"We cannot survive only on the 280,000 people who live here, because we do not have enough economic activity on our own."

## **Puerto Rico Online Scam Targeted** More Than \$4M Amid Crisis

SAN JUAN, Puerto Rico (AP) — An online scam that targeted Puerto Rican agencies attempted to steal more than \$4 million, police said Thursday, deepening concerns about the management of local government finances during an economic crisis.

Authorities have frozen at least \$2.9 million, said an official who was not authorised to comment on the case and requested anonymity.

The government has not said how much money was seized by the hacker.

The scam began when someone hacked into the computer of a finance worker at the island's Employee Retirement System in December, said José Ayala, director of the fraud unit within the bank robbery division.

The hacker then posed as the female employee and sent emails to various government agencies alleging a change in bank accounts,

he told The Associated while the island's Tourism Press. Company sent \$1.5 million

Two agencies fell victim to the scam in recent months: Puerto Rico's Industrial Development Company sent \$63,000 in December and more than \$2.6 million in January, while the island's Tourism Company sent \$1.5 million in January to fraudulent accounts on the US mainland, he said.

Puerto Rico government officials realised what had happened when the finance worker at the Employee Retirement System called the agencies and said she had not received any payments and officials responded they had already sent them.

## **CARPHA Now Testing for Novel Coronavirus**



Caribbean Public The Health Agency (CARPHA) now has the ability to do testing for the Novel Coronavirus, which the World Health Organisation has named Covid-19. The CARPHA Laboratory is accredited to internationally recognised standards and provides testing services for national laboratories, not for individuals. It takes between 24 and 48 hours from the time CAR-PHA receives a sample to get the results, which are shared

electronically with Member States.CARICOM's Communications Officer, Jascene Dunkley-Malcolm recently spoke with Executive Director of CARPHA, Dr. Joy St. John, who gave an update about the work CARPHA has been doing in relation to the disease.

In the interview Dr. St. John explained what the virus was, how it can be transmitted and debunked a number of myths that have been circulating. She also gave some useful tips that can help to prevent the spread of the virus in the event of an outbreak, but hastened to point out that there were no reported cases in the CARICOM Region and that the current risk of an outbreak was low.

The virus was first reported from Wuhan, China, on 31 December 2019. Coronaviruses (CoV) are a large family of viruses that cause illness ranging from the common cold to more severe diseases such as Middle East Respiratory Syndrome (MERS-CoV) and Severe Acute Respiratory Syndrome (SARS-CoV). A novel coronavirus (nCoV) is a new strain that has not been previously identified in humans.

On Thursday, 30 January, the WHO declared the outbreak a global health emergency, or a public health emergencies of international concern (PHEIC).

He has already spent more than \$300m in his bid to win the White House.

Mr Bloomberg, a former Republican, is one of eight remaining contenders vying to become the Democratic presidential candidate who will challenge President Donald Trump in November's election.

Sabrina Singh, Mr Bloomberg's national spokeswoman, said: "Mike Bloomberg 2020 has teamed up with social creators to collaborate with the campaign, including the meme world.

"While a meme strategy may be new to presidential politics, we're betting it will be an effective component to reach people where they are and compete with President Trump's powerful digital operation."

## **US-Taliban talks: Pompeo hails 'pretty important breakthrough'**

US Secretary of State Mike Pompeo says there has been a "pretty important breakthrough" in peace talks with the Taliban in recent days.

Defence Secretary Mark Esper earlier said they had "negotiated a proposal" for a week-long reduction in violence.

The two sides have long been engaged in negotiations aimed at ending the 18-year war in Afghanistan.

But they have been fraught with challenges. President Donald Trump declared the talks "dead" in September.

On Thursday, Mr Pompeo said the US president had given the go-ahead for further talks. He hailed recent progress, but said the negotiations were complicated and that a peace deal had not yet been reached.

"We hope we can get to the place where we can get a significant reduction in violence, not only on a piece of paper," he said. "If we can get there and we can hold that posture for a while, we may well be able to begin the serious discussion which is all the Afghans sitting at a table finding a true reconciliation."

His comments came af-

ter Mr Esper told reporters about the proposal for a "seven-day reduction in violence". "We've said all along that the best, if not only, solution in Afghanistan is a political agreement. Progress has been made on this front and we'll have more to report on that soon," he said. "It will be a continual evaluative process as we go forward - if we go forward."

Details about when the partial truce was set to begin were not immediately clear, but a Taliban official told AFP news agency that the group would begin a "reduction of violence" on Friday.

Mr Trump has made withdrawing US troops from Afghanistan a key foreign policy aim. Some 13,000 US troops remain in Afghanistan after the US intervention to oust the Taliban in 2001.

## **Eight Republicans join Democrats to pass** Senate measure to limit President Trump's war powers against Iran

WASHINGTON - Eight Senate Republicans broke with President Donald Trump on Thursday - joining all the chamber's Democrats to support legislation that would restrict the president's ability to wage war with Iran.

The 55-45 vote marked a rare bipartisan effort to curb Trump's powers and lawmakers' underscored concerns that U.S. tensions with Iran could escalate into a full-fledged war.

Democrats said Congress had to act to rein in an unpredictable president, arguing Trump brought the United States to the brink of war with Iran when he green-lighted a deadly strike targeting Tehran's powerful military most

leader, Gen. Qasem Soleimani.

"I fear that the president's erratic decision-making, his lack of strategy, his inability to control his im-

pulses may bumble us into a war ... even if he doesn't intend it," Senate Minority Leader Charles Schumer, D-N.Y., said during Thursday's debate.

Schumer said Thursday's vote was "a clear shot across the bow" to Trump that Congress will not support another "endless war" in the Middle East.

### U.K. Treasury chief Sajid Javid quits as PM Boris Johnson shakes up Cabinet

LONDON -- British Prime Minister Boris Johnson tightened his grip on the government Thursday with a Cabinet shake-up that triggered the unexpected resignation of his Treasury chief, the second-most powerful figure in the administration.

Sajid Javid's resignation was the most dramatic moment i n a shuffle that saw Johnson fire a handful of Cabinet members he viewed as under-performing or untrustworthy, and promote loyal lawmakers to senior jobs.

Javid smiled as he entered the prime minister's 10 Downing St. office on Thursday morning to meet Johnson along with other ministers who were being promoted or kept in place. But a spokesman confirmed soon after that Javid had quit.

Speaking later, Javid said Johnson had asked him to fire all his aides and replace them with staff approved by the prime minister's office.

"I don't believe any self-respecting minister would accept such conditions," Javid said.

"I felt that I was left with no option other than to resign."

Johnson quickly replaced him with Rishi Sunak, who had previously been a dep-

uty to Javid at the Treasury and is widely regarded as a dependable loyalist to the prime minister.

Johnson's office confirmed it was creating a new team of advisers covering both the prime minister's office and the Treasury.

Javid's resignation followed reports he had clashed with Johnson's powerful adviser, Dominic Cummings, a self-styled political disruptor who is mistrusted by many lawmakers and officials.

"Dominic Cummings has clearly won the battle to take absolute control of the Treasury and install his stooge," said John McDonnell, finance spokesman for the opposition Labour Party.

Javid, who became Chancellor of the Exchequer when Johnson succeeded Theresa May as prime minister in July, had been due to deliver his first budget in less than a month -- a crucial staging post for the government in the wake of the country's departure from the European Union last month.

The prime minister's office could not confirm Thursday whether the budget would take place as scheduled on March 11.

In the wake of Brexit, Johnson has vowed to take a more interventionist economic approach than some of his Conservative predecessors in order t o boost poorer regions outside the economic hub of London and southeast England. That involves ambitious infrastructure plans, including a 100 billion-pound (\$130 billion) high-speed railway connecting London to central and northern England.

Paul Dales, chief U.K. economist at Capital Economics, said Javid, a fiscal conservative, had appeared reluctant to increase public borrowing to fund higher spending.

He said Javid's departure should "allow the government to push through even bigger increases in public investment and perhaps resuscitate tax cuts that previously looked dead in the water."

That appeared to be the main sentiment in financial markets, as traders calculated that the higher spending would inevitably lead to the Bank of England having to raise interest rates more quickly than anticipated. The pound got a boost, trading 0.8% higher at \$1.3058.

The resignation was a curve ball in a Cabinet shake-up that comes in the wake of the Conservatives' big election win in December. That victory allowed Johnson to take Britain out of the EU last month, delivering on his key election promise.

## Alleged bookie Sanjeev Chawla extradited from United Kingdom



Alleged bookie Sanjeev Chawla at Patiala House Court

Sanjeev Chawla, an alleged bookie, was extradited from the UK on Thursday. He is one of the primary accused in the 2000 match-fixing scandal that involved former South African captain Hansie Cronje.

Chawla's extradition was sought by the Delhi police, who had filed a chargesheet in 2013, naming him along with five others including the late Cronje, for conspiracy to cheat, a criminal offence under Section 420 of the Indian Penal Code.

In a media release issued on Thursday, Dr G. Ram Gopal Naik, Deputy Commissioner of Police (Crime Branch), said Chawla will be in the police "remand/custody" for 12 days. Based on the progress of the investigations, the cops could ask for a further remand, but following that Chawla would be shifted to the Tihar Jail before the judicial proceedings begin.

Apart from Chawla and Cronje, the other accused were: Rajesh Kalra, Krishan Kumar, Sunil Dara - all three based in India - and Manmohan Khattar, who is believed to be living overseas. In the chargesheet, the Delhi police said Chawla and the other five accused were charged with IPC 420 (cheating) and 120B (criminal conspiracy). The chargesheet cited 65 witnesses and ran over 2500 pages, but the operative portion was only 80 pages.

The Delhi police had sought Chawla's extradition because of his alleged involvement in the match-fixing controversy which eventually implicated Cronje, who confessed during the King Commission inquiry to accepting money from bookies to fix matches during South Africa's ODI series in India in 2000.

Chawla's extradition was approved by the UK Home Secretary Sajid Javid in February last year under the India-UK Extradition Treaty 1992. On June 14, 2016, Chawla was arrested in the UK after the Indian government sought his extradition in February that year but was let out on bail. In January 2019, the Westminster Magistrates' Court, which had blocked the extradition in 2017 on human interest grounds, eventually asked Javid's office to take the final decision.
