

The Living Word

Water into Hope

Read: John 4:4-14

Let anyone who is thirsty come to me and drink. John 7:37

Tom and Mark's ministry refreshes lives. This is clear in the video they share of a group of fully clad children laughing and dancing in the refreshing water of an open shower—their first ever. The mer work with indigenous churches to install water filtration systems or wells in Haiti, easing and lengthening lives as diseases connected to contaminated water are prevented. Access to clean, fresh water gives the people hope for their future.

Jesus referred to "living water" in John 4 to capture a similar idea of a continual source of refreshment. Tired and thirsty, Jesus had asked a Samaritan woman for a drink (vv. 4–8). This request led to a conversation in which Jesus offered the woman "living water" (vv 9–15)—water that would become a source of life and hope within them, like "a spring of water welling up to eternal life" (v. 14).

We discover what this living water is later in John, when Jesus said, "Let anyone who is thirsty come to me and drink," declaring that whoever believed in Him would have "rivers of living water [flowing] from within them." John explains, "By this he meant the Spirit" (7:37–39).

Through the Spirit, believers are united to Christ and have access to the boundless power, hope, and joy found in God. Like living water, the Spirit lives inside believers, refreshing and renewing us.

How has Jesus satisfied your thirst through His Spirit? How will you share what Jesus has done for you?

Dear God, thank You for leaving us Your Spirit. Work in us so that our lives point others to You.

'Burga' gets multiple life sentences

Calvin 'Burga' James will Lawrence James. likely die in prison after he was given two life sentences plus 30 years in the High Court yesterday.

The sentences will run concurrently, meaning they will run at the same time.

In February, James, in the early stages of his trial pleaded guilty to two counts of murder for the death of his niece. Tahisha Thomas and his nephew's girlfriend, Sanchezca Charles.

Facing charges for five offences, he also pleaded guilty to shooting with intent to murder his nephew

During the sentencing hearing yesterday noon, Justice Ian Morley described the convicted man as "permanently dangerous".

Burga shot his niece, his nephew and his nephew's girlfriend in Donovans, when he entered the home they were occupying in October, 2018. One woman died at the crime scene and the other succumbed at hospital.

James was asking for his sister and when he was told she wasn't there, he opened

fire on those that were present, before fleeing in a stolen vehicle.

At the time of the shooting, the suspect was on bail, on charges of attempted murder.

In 2015, Calvin James was charged with three counts of attempted murder.

He had attacked his sister, tazing her with a stun gun and beating her with a piece of wood. In the same 2015 incident, he inflicted several chops on his niece with a cutlass.

He escaped before the police arrived, but was later traced to an abandoned house in Hatton.

In their attempts to apprehend him, Calvin James fired a flare gun at the law enforcement officers. He was subsequently arrested and charged.

While he was remanded to prison by the Magistrates' Court, a High Court judge later granted him bail. It is during that period of his freedom the 2018 incident occurred.

Police subsequently issued a wanted bulletin for Calvin James after he went on the run. He was captured on January 13th, 2019.

During the sentencing, Justice Morley ordered the gun used to kill the two women be destroyed and the land said to have been at the centre of the feud to be vested to his sister.

The purpose of the Black History Month project was to commemorate Antiguan women who have made an outstanding contribution and highlight their achievements.

During the month of February, the stories of the inspirational women were shared with the public through radio and television.

Country prepares for the inevitable

"The entry of Covid-19, now," the epicurean cus-Coronavirus to our shores is inevitable. No need to panic, or become hysterical. We have established the protocols and infrastructure to contain its spread among the domestic population. In the meantime, kindly take the necessary precaution to protect yourselves from the Coronavirus. Blessings."

These were the words of Prime Minister Gaston Browne on his social media platforms earlier this month. With the reality of COVID-19 hitting our shores now settling in, the country has moved in full preparation mode.

Last evening, hundreds of shoppers flooded supermarkets across Antigua, purchasing loose and bulk items in preparation for a possible social distancing advisory. One shopper commented, "the reality is when this virus becomes a real thing in the country, I and my family will not be going anywhere-especially a supermarket. So, I am doing my bunkering shopping

Items such as Lysol, hand sanitizers and Clorox wipes are now scarce commodities on the island.

tomer said.

With the increased traffic, supermarkets have also employed sanitization measures in their businesses. Portable handwashing areas and self-use hand sanitizer desks can be seen on entry to Epicurean- one of the largest supermarkets on the island.

While citizens continue to prepare for self-quarantine, the COVID-19 task force continues to amplify their awareness and education campaign.

Over 3,000 awareness posters are being plastered across the island. Schools, clinics, government offices, and businesses are being provided with copies of illustrated COVID-19 educational reproductions. COVID-19 themed Town hall meetings and staff meetings are also taking place across the island with the anticipation of a major public consultation in short order.

The Ministry of Health, Wellness, and the Environment have also advised that the isolation and quarantine units at the Margetson Ward are nearing completion; and, preparations are at an advanced stage to have testing for the COVID-19 virus being done locally with the assistance of the Pan American Health Organization (PAHO). This would allow for the swift diagnosis of potential cases.

According to the ministry's press statement, "the health ministry also advises that PAHO will be on the island on March 16th, 2020. The team of technicians is expected to conduct meetings, site visits, training and simulation exercises."

This was highlighted on the same day it was announced that there are 2 suspected cases of COVID-19 in Antigua that is being investigated on Thursday. The health ministry advised that "once the reports of the testing results are available, this information will be shared with the public."

Up to press time, no confirmation of the test results was revealed.

Thursday's announcement by Princess Cruises that it will halt all further cruises for two months, has sent shock waves through the local cruise sector.

Director of the Caribbean Cruise Association and President of the Antigua and Barbuda Cruise Association, Nathan Dundas, said he fears the announcement will lead other cruise lines to adopt similar measures.

Reports out of the United States said Princess Cruises will halt global operations of its 18 cruise ships for two months, after two of its ships carried passengers who were diagnosed with the coronavirus.

The move came after another cruise ship operator,

Viking, announced it would also suspend all ocean and river cruises until May 1. Viking has 16 ocean-going ships and more than 70 vessels overall.

According to Dundas there are between 30 and 50 additional calls booked for Antigua until the end of the season with one more month to go. "I am very concerned that we are not likely to get that number of calls if the trend of cancellations continues," he observed.

al Port Holdings Limited, Donnas Regis, said the fact that the cancellations are coming at the back end of the cruise season, is perhaps the one of the positive out this situation.

She noted that Princess Cruises only had two remaining calls for the season thus the impact would be less than had the announcement take effect a month or two earlier.

She said its too early to tell the overall impact as there's every likelihood that other vessels may fill the breach. She added that the company is working closely with the ministries of health and tourism to coordinate its action plan.

> "Our season runs for six months, so each call is important as taxi men have to earn enough to take them through the lean months. Its going to be a hard couple of months for my members," Burnett noted.

Government preparing for COVID-19

There is a firm commitment on the part of the Antiguan and Barbudan government that it will spend as much as it takes on preparing the country to withstand the effects of COVID-19.

Health Minister, Molwyn Joseph commented this week it is no longer a case of if, but rather when the virus is detected in the country. Speaking to reporters during yesterday's post-cabinet press briefing, Information Minister, Melford Nicholas said while US \$ 2 million were set aside in the initial phase to commence preparations, it will not be viewed a budget, since more resources will have to be acquired. Rather he described it as "a project".

"It is often puerile to actually say we are starting with a budget," he declared, adding this is a situation where government does not intend to "count the pennies."

Using the isolation and quarantine facilities at the old Holberton Hospital and frontline staff as examples, Nicholas said if renovation totals in the millions of dollars, the funds will be sourced.

The information minister indicated government's response to the virus is inevitable and ports of entry, improved in-

frastructure and procurement of supplies are among its priorities. Cabinet notes of 11th March outlined that; "Cabinet expressed its satisfaction that the response of the administration has been strictly in line with the guidelines issued by the WHO and the Pan American Health Organization (PAHO)."

Government is working assiduously to complete preparation for quarantine units at Margetson's Ward at the old Holberton Hospital building. Financial measures necessary to ride-out the Coronavirus

Regardless of the number of Coronavirus cases (COVID-19) that occur in the Caribbean, the economies of each of them, particularly those dependent on tourism, will suffer in the immediate to medium term.

Fear, and travel restrictions on persons living in countries with COVID-19, have already disrupted the global economy and supply chains for goods and services.

Indeed, every country in the world will be adversely affected economically even if any of them avoid a major public health emergency.

The International Monetary Fund (IMF) has already made an early forecast that its predicted 3.3% growth in 2020 will not occur. Optimistically, the Fund now expects growth below 2.9%.

Growth rates in the tourism-reliant countries have already declined. Many hotels have experienced cancellations over the immediate period and well into the next winter season. Of the world's top twenty-five tourism dependent countries, nine are in the Caribbean.

In order of highest dependence, they are: British Virgin Islands, Aruba, The Bahamas, St Lucia, Belize, Barbados, Antigua and Barbuda, Dominica and Jamaica.


With a reduction in the numbers of hotel guests and patrons of restaurants as well as the number of persons renting vehicles, earnings in the sector have dropped; jobs are being lost; and government revenues are declining.

The situation is worse for those Caribbean countries that also rely on cruise-ships as part of the overall contribution of tourism to the economy. The latest authoritative figures rank those countries in order of dependence as: St. Kitts and Nevis at 5.9% of Gross Domestic Product (GDP); Antigua and Barbuda, 4.1%; Belize, 4.0%, St. Lucia, 3.9%; Bahamas 3.0%; Dominica, 3.0%; Grenada, 2.8%; and Barbados, 1.5%.

The U.S. State Department has been discouraging Cruise ship travel, warning U.S. citizens, particularly travellers with underlying health conditions, "not to travel by cruise ship". The U.S. Centers for Disease Control and Prevention has issued guidance, cautioning travellers of "increased risk of infection of COVID-19 in a cruise ship environment."

Fear of being quarantined on a cruise ship anywhere in the world has frightened potential passengers. Cruises to the Caribbean have been badly affected. Stock values in Carnival Corp. is down 52.7% year-to-date; Royal Caribbean is down 61.3%, and Norwegian has fallen 65%.

Obviously, all the commercial businesses in the tourism sector in Caribbean countries will also face a reduction in their profits. If the fear over COVID-19 persists and the quest for a vaccine is protracted, these businesses could fall into financial loss. In those circumstances, even more work-



ers will be laid-off and their restricted spending will impact other sectors from which they buy goods and services.

Governments will be particularly hard-pressed because they will be deprived of revenues at a time when they are required to spend more money, much of it in foreign exchange, in their attempts to militate against COVID-19 which, despite best efforts, will enter their countries and could spread into community clusters as it has done elsewhere in the world.

Small Caribbean states do not have the considerable resources or economic and fiscal tools of rich North American and European countries that can be deployed by Treasury Departments and Central Banks. But, there are still come options available provided all sections of the society assume the mantle that "everyone is in this together".

Measures to stop the incubation and spread of the virus, including good hygiene, meticulous handwashing, self-isolation, cancellation of events that attract large crowds – all of these are necessary. But steps will also have to be taken to help both persons who become unemployed and those self-employed persons who get ill with COVID-19 and are forced not to work for a minimum of 14 days.

The banking sector could be enormously helpful in efforts to keep the economy buoyant by implementing several actions. Among them: renegotiate payment terms for house mortgages and other property, particularly vehicles, for persons who are either temporarily laid-off or self-employed persons who cannot earn because of illness; bank fees and charges, which are higher in the Caribbean than in many other parts of the world could be reduced significantly; and interest rates on loans could also be decreased while COVID-19 affects economies.

Certainly, government debt to domestic banks should be renegotiated and the banks should agree to extend the repayment periods and reduce the interest rates while governments are compelled to increase spending to deal with the public health emergency that all Caribbean countries now face.

If, heaven forbid, Banks are unwilling to adopt such measures, which, ultimately, will be to their benefit by ensuring that loans don't sour, and customers can continue to buy their services, then governments might have to resort to legislation to urge them in a sensible direction.

Trade Unions and other bargaining agents could also play an important part in the current crisis by putting into abeyance all demands for increased wages and payment of arrears. Making such de-

mands, at a time when both governments and the private sector face reduced income, would destabilize already unstable economies.

Governments might also have to consider placing a moratorium on repayment of foreign debts. The repayment of such debt requires foreign exchange, whose earning will be reduced by the decline in tourism. Further, existing foreign exchange reserves will dwindle as those reserves are used to continue to import goods and services for the society, including new spending on equipment and medicines to fight the coronavirus.

reasonable international bank or foreign lending agency, including Export-Import banks of individual nations, could demand to be paid debts in full at a time of impossibility, when there is every possibility of debts being discharged in the future.

The spread of COVID-19 in North America and Europe, and the economic effect on the Caribbean region, once again demonstrates the region's vulnerability to external circumstances.

The need for a stronger, more resilient, more integrated region - at all levels including fiscal policies and financial strategies - is emphasised by the vulnerability that COVID-19 has underscored, even though the virus itself hardly hit Caribbean shores.

Antigua and Barbuda Bar Association Press Release on Respect for Rule of Law

The Antigua and Barbuda Bar Council expresses its unwavering support for the Rule of Law, the Separation of Powers and for the independence and integrity of our judiciary.

In an interview broadcast on PointFM radio station on or about7 March, 2020 (and subsequently reported on by various media outlets), the Honourable Prime Minister Gaston Brown attributed certain actions to a judge of the High Court of Justice and further commented critically on those alleged actions in relation to a court case involving the Government and HMB Holdings Ltd.

There is nothing improper about anyone expressing concern with a particular judicial decision or characterizing a decision as "flawed". However in doing so it is important, particularly for members of the Executive and senior government officials, to demonstrate respect for the Rule of Law and Separation of Powers which form the foundation of our democratic society.

It is the considered view of the Bar Council that some of the Honourable Prime Minister's words during the above-referenced interview raised real concerns with respect to the Rule of Law and the doctrine of Separation of Powers. Additionally, the information conveyed in that interview



did not accurately represent the actions of the judge who was the apparent subject of the Prime Minister's criticisms.

In the interview it was stated that a judge "is about to or has made a garnishee order" on NAMCO. In fact, the Bar Council has confirmed that, while there was an application for garnishment brought before a Judge, that application was not fully heard and the Judge has to date made no final decision in respect of such application. It is therefore not accurate to suggest the judge had made a garnishee order at all.

In any event, an application for garnishment is a well-established process by which judgements of the Courts may be enforced. The rules and procedures pertaining to such applications are long-standing and provide considerable pro-

tections for both parties to such proceedings.

The Bar Council considers the use of the words "perverted" and "nonsense" as inappropriate to describe a judge's actions. Further and of even greater concern was the Honourable Prime Minister's statement in response to a purported request from the judge to give an undertaking not to sell shares or assets of NAM-CO.

The Prime Minister said, "I sent back a message to tell him [the Judge] that I am not giving him any such undertaking so if he want put me in jail he can put me in jail."

The Bar Council considers these words to be indicative of a disregard for the Court's authority. Such words suggest to the public that it is acceptable to be confrontational with the Court and that it is accept-

able to defy an order of a judge (or in this case what appears to have been an anticipated order). The idea that any member of the Executive would embrace or encourage defiance of any actual or anticipated judicial pronouncement is abhorrent to the doctrine of Separation of Powers.

Further there is nothing unusual or improper about a judge enquiring of a party (or of one party enquiring of another at a hearing) whether an undertaking may be offered as an interim resolution pending hearing of certain matters. Such undertakings are generally volountary and cannot properly be characterized as a perverted decision of the court.

Moreover, there is a system of appeal in place which offers recourse to any person who disagrees with a judgment. It is perfectly acceptable to express an intention to appeal a decision with which one disagrees. In fact the Honourable Prime Minister also indicated such an intention. However to suggest that the head of the Executive branch of government might deliberately disobey a court order undermines public confidence in the Rule of Law.

The Bar Council is encouraged by the fact that the Honourable Prime Minister did acknowledge in his in-

We also call on all members of the Executive and the Legislature to demonstrate at all times unreserved respect for the judiciary and to ensure that all comments in respect of judges and court decisions are expressed in terms which recognize the important role of the judiciary in our democracy and

Antigua and Barbuda helps draft pro-women resolution

Antigua and Barbuda participated in the drafting of the Resolution now up for discussion at the Organisation of American States on "Women's Representation and Participation in the OAS".

The country's permanent representative to the OAS, Sir Ron Sanders said the country was pleased to have been a part of this important exercise.

However, he said while Antigua and Barbuda was proud to be among the sponsors of the Resolution, it still felt that it could have gone further.

"Mr. Chairman, were it left to the delegation of Antigua and Barbuda alone, the Resolution before us would have been very different, and it would have been named differently.

"It would have been entitled, "The failures of the OAS to ensure representation and participation of Women", Sir Ron explained.

Additionally, he added, it would have listed the several resolutions adopted by General Assemblies of the OAS mandating the Secretariat to remedy the many deficiencies in this Organization that have prevented women to be treated as equals.

As an example,he said previously, in June 2004, by Resolution AG/RES. 1977 (XXXIV-O/04), APPOINT-MENT OF WOMEN TO SENIOR MANAGEMENT POSITIONS AT THE OAS, the General Assembly had urged the Secretary General to, among other things, achieve by 2005 the goal of having women occupy 50 percent of posts at each grade level within the OAS organs, agencies, and entities, particularly at the P-5 grade level and above, in order to achieve gender balance at all levels in the OAS.

Sadly, according to Sir Ron, neither this nor the other four

goals have been achieved.

Despite all these resolutions, spanning a period of 21 years, the Organization has still not fulfilled these mandates and it is felt that this Permanent Council is still repeating the same urgings made by General Assemblies as far back as 1999.

"There is clearly something very wrong, and it is up to member states to right that wrong. Women's rights are human rights; they are political rights; and they are civil rights. We cannot, with any credibility, argue for respect for human, political and civil rights, without demonstrating, within our own organization, our high regard for the rights of our women," Sir Ron declared.

TRAVEL RESTRICTIONS TO THE DESTINATION STEPPED-UP FROM 14 TO 21 DAYS.

EOC TO MEET THURSDAY AND MPS TO BE INFORMED

The travel restrictions which were issued by the Government of Sint Maarten have now been increased from 14 to 21-days, Prime Minister Silveria Jacobs disclosed on Wednesday.

The Emergency Operations Center (EOC) will be meeting on Thursday and a meeting will be held with Members of Parliament (MPs) to provide them with an update on national preparations for COVID-19.

Jacobs said the World Health Organization (WHO) on Wednesday declared that the coronavirus COVID-19 is now an international pandemic. Such a declaration calls on all countries to speed up their response and containment measures and to be prepared to take any additional measures that are required to protect public health. The Government continues to work closely with the Government of French Saint-Martin and Kingdom counterparts in order to prepare and plan to mitigate the spread. Prime Minister Jacobs added that the business community as well as Government will have to look at ways of allowing workers to work remotely from home, especially for persons who have traveled to COVID-19 hotspots including those who are not mentioned in the country's travel restriction lists. Persons should self- isolate for 14-days at home; contact their family physician (GP) and provide a list of their flu-like symptoms to their GP if they develop any. The family physician will determine if the Collective Prevention Services (CPS) should be contacted. For more information you can call the 914-hot line during business hours.

Children with flu-like symptoms should remain home; self-isolation is the best way to contain communicable diseases. Special attention should be paid to senior citizens, especially those with pre-existing health (respiratory) conditions. Passengers and airline crew who have been in China (People's Republic), Hong Kong (SAR China), Iran, Italy, Japan, Korea (Rep.), Macao (SAR China) or Singapore in the past 21 days, are not allowed to transit or enter Sint Maarten.

This does not apply to nationals of the Kingdom of the Netherlands (being from Aruba, Bonaire, Curacao, Netherlands, St. Eustatius, Saba and Sint Maarten); and this does not apply to residents of Sint Maarten.



All passengers must fill in the embarkation card in order to know where the passengers are coming from before the aircraft/ship arrives in Sint Maarten.

There are zero cases of suspected or confirmed COVID-19 on Dutch Sint Maarten at this time. Our screening processes at our ports of entry have been stepped up in cooperation with the airlines who are also following their own screening protocols based on World Health Organization (WHO) recommendations. There is no reason to panic; stay calm and take preventative hygiene mea-

sures at home, on the job, in school that have been promoted by the Ministry of Public Health for the past several weeks via the Government's Department of Communication. Persons should refrain from hugging and touching each other when visiting family or friends. We have to get back to the 'No touch rule' in order to protect ourselves at this point in time with the global COVID-19 outbreak.

The Government continues to work diligently to increase capacity within the public health sector, but this will take some time.

Lockdown – PM Holness says Jamaican schools will be closed for 14 days



Jamaica Prime Minister Andrew Holness closes all Jamaican Schools from today.

Prime Minister Andrew Holness has announced that Jamaicans schools will be closed for a period of 14 days in light of the coronavirus outbreak.

This was disclosed at a press conference at the Office of the Prime Minister on Thursday afternoon.

Holness said that as of March 13 schools across the island will be closed for 14 days with a plan to review that decision after 10 days.

He said the period will give time to parents to prepare for having their children at home, as well as give educational institutions an opportunity to make preparation for students to continue learning at home.

The Prime Minister also disclosed that the Heart Trust/NTA will be closed during the 14-day period. Teachers' colleges and community colleges, as well as early childhood institutions, will be closed.

Universities are not included in the 14-day lock-down. However, Holness said that the government is encouraging the tertiary institutions to offer online classes.

St. Maarten: Carnival Postponed!



The Government of St. Maarten has decided to postpone Carnival 2020 in response to the rapid spreading of the COVID-19 Pandemic.

The foundation was informed of this in a meeting called by Government on Thursday, March 12 and agrees that public safety comes first. The SCDF

will issue a series of notices to the public and all Carnival stakeholders in the coming days. Please monitor the media for updates.

Early Grade teachers in the OECS producing their own

culturally relevant books to teach reading!



The OECS/USAID ELP will run through to September 2020 continuing to develop and implement impactful initiatives that advance early grade reading throughout the OECS.

The USAID/OECS Early Learners Programme (ELP) has facilitated the training of primary school teachers in Bloom Software to enable the creation of customized content for their classrooms.

One of the challenges in the OECS is a lack of culturally relevant books for students and the Bloom software makes it easy to create simple relatable books. The software is so user-friendly that primary school students are also being encouraged to create their own books to engender more reading throughout the OECS.

Thus far a total of approximately 130 teachers have been trained across the OECS, with training still ongoing in Saint Lucia. These learning sessions are enabling teachers to create books with content that would facilitate learning in a more culturally relevant way. Teachers know their students and curriculum, and therefore have the opportunity to create tailor-made books that can

address specific topics and meet the needs of their students. Teachers with basic computer skills who participated in the sessions felt well equipped and confident to go back to the schools and teach the students how to create and publish their own books. The creation of books by students facilitates and enhances reading and writing skills. Further, when the students create content that they are interested in, they are keen to read and share their publications. This fuels creativity, critical thinking and stimulates interest in reading and writing.

Dominica held one of the most recent Bloom Software training sessions with 48 primary school teachers. According to the facilitator and ELP Coordinator Carine Burnette, "The programme is quite important as it gives teachers or anyone who wants to write, the opportunity to generate and express ideas. The software further enables the teachers to publish their books for utilization within the classroom setting. The teachers had the opportunity to create content that was relevant to the students in their classrooms and the specific lessons that they are working on to make the subject more interesting and relevant. Language, characters and activities within the books can be specifically related to the Caribbean lifestyle which enhances the reading and learning process. The teachers were very enthusiastic about going back to the classroom to use the software and share it with their students."

Police probe live radio threat on Wickham's life



Renowned Caribbean Pollster and Talkshow host Peter Wickham

A threat on the life of pollster and talkshow host Peter Wickham, made Tuesday on live national radio, is now the subject of a police investigation.

The ongoing political tensions in Guyana appeared to boil over on Voice of Barbados radio while Wickham was presenting the Down to Brass Tacks callin programme, apparently drawing the ire of a caller

about his comments on the post-election impasse.

The caller said: "I warned you before sir to stay out of the affairs of my country and you still meddle into it."

Wickham asked: "You are Guyanese?"

The caller did not reply but said: "Now I know that you are travelling soon from now, make your peace with the Lord before your leave." The call ended.

Wickham, a Director of the Caribbean Development Research Services, which conducts public opinion polling across the Caribbean had expressed concern about the process in Guyana. A week after the March 2 regional and general elections, the winner is yet to be declared after the electoral commission released unverified results from the populous Region Four, prompting the Opposition People's Progressive Party/Civic to file an injunction asking the court to bar the declaration of a winner while the court reviews the case.

Wickham suggested that the data published so far favours the Opposition PPP/ Civic and the party was likely to be declared the winner.

Today, Chief Justice Roxane George-Wiltshire ordered the Guyana Elections Commission to restart or continue the verification of the results for Region Four by 11 a.m. on Thursday.

Wickham, who described the call as a threat, con-

firmed this evening he had lodged a report with the police and that an investigation had begun.

On his Facebook page, he also invited anyone with information about the caller to provide any information they could.

Wickham also made it clear that he would not be intimidated.

A defiant Wickham said: "I should also add that I remain committed to my work in the region and promise to continue offering professional opinions whenever the opportunity arises (as long as I am in this business).

"I do appreciate that my comments will often delight and sometimes offend, but such is life!"

Anger, confusion in Europe as Trump issues coronavirus travel ban

Travel to the US from most of Europe will be suspended for 30 days beginning on Friday, President Donald Trump announced, citing a need to combat the spread of the coronavirus.

Trump's move on Wednesday came amid rising global panic after the World Health Organization (WHO) warned that the spread and severity of the illness, now considered a pandemic, was due to "alarming" levels of inaction. The ban applies to the 26-country Schengen Area. Among the countries excluded from the ban as they are not in that zone are infection-hit countries such as the United Kingdom, Ireland, Romania, Bulgaria, Croatia and Cyprus. "The restriction applies to foreign nationals who have been in the Schengen Area, 26 countries in Europe with open borders agreements, in the last 14 days," a White House statement said. "Those who are exempt from these restrictions, such as American citizens, will be directed to a limited number of airports where screening can take place.

"There is extensive travel back and forth between Europe that heightens the risk here in the United States."

The response to Trump's move in Europe ranged from anger to confusion. "The European Union disapproves of the fact that the US decision to improve a travel ban was taken unilaterally and without consultation," Ursula von der Leyen and Charles Michel, the respective presidents of the European Commission and European Council, said in a joint statement. "The European Union is taking strong action to limit the spread of the virus.

"The coronavirus is a global crisis, not limited to any continent and it requires cooperation rather than unilateral action."

Trump said on Thursday that he did not notify EU leaders because "it takes time" and he had to move quickly. He added that he excluded the United Kingdom because the country was doing a good job at controlling the spread of the coroanvirus. Many had concerns over the economic impact of travel bans. The news hit financial markets hard, with stocks diving and oil slumping, as investors were disappointed by the lack of broad measures to offset a likely fall in consumption.

British finance minister Rishi Sunak played down the prospect of the UK imposing similar travel restrictions, but acknowledged the US decision could have a knock-on effect on the British economy.

He told BBC Radio 4's Today programme: "With regard to flight bans, we are always guided by the science as we make our decisions here, and the advice we are getting is that there isn't the evidence that interventions like closing borders or travel bans are going to have a material effect on the spread of the infection."

Meanwhile, many observers said the ban lacked clarity and could be interpreted as a political move.

"Non-Schengen and UK excepted: this is not about containment, this is about sending a political message. In a time where the EU is challenged to its core, the US is closing its borders and turning its back on allies," tweeted Benjamin Haddad, director of the Future Europe Initiative at Atlantic Council.

Al Jazeera's Laurence Lee, reporting from London, said: "The EU is absolutely furious about this, bewildered, and trying to work out what the ramifications are. They weren't consulted apparently before Trump said this

in the middle of the night, European

"They are trying to understand what it means. There are enormous concerns about trade between the EU and US.

"Trump seems to be making a cynical but political point out of this, by blaming Europe but not the UK. But it is a problem for the UK too, because European travellers who want to go to the US will think maybe I should stop off in London and travel from there."

If that happened, Lee said, it would be extra strain on Britain's National Health Service.

Trump said it was possible that he could extend or shorten the Europe travel ban depending how the situation plays out.

There have been more than 126.000 cases of the virus worldwide since its outbreak late last year in China, and over 68,000 people have recovered.

China is the epicentre of the crisis, with most infections and deaths, followed by Italy, Iran and South Korea.

Coronavirus: US is failing on testing, says Fauci

The testing system for coronavirus in the US is currently failing, a top health official has admitted.

"The system is not really geared to what we need right now... let's admit it," said Dr Anthony Fauci from the National Institute of Allergy and Infectious Diseases.

Authorities in the US have come under fire for carrying out far fewer tests than many other affected countries.

There are currently more than 1,300 confirmed cases of the virus in the US.

President Donald Trump says the US has "a tremendous testing set up where people coming in have to be tested". However, he has not given further details, and there has not been routine testing for the virus in the US.

How many tests are being done in the US?

In an interview with CNN on Thursday, Vice-President Mike Pence could not confirm how many Americans had been tested for the virus, saying he "would leave that to the experts".

According to the Centers for Disease Control and Prevention (CDC), a total of at least 11,079 specimens have been tested since January. However, the number of people tested is likely to be lower, as patients typically provide at least two specimens for testing.

Furthermore, government



officials say they do not know the number of people being tested, because some tests are being conducted by private hospitals and laboratories that have not been reporting in to the CDC.

The Atlantic, which is running a project to track the number of tests being conducted, estimates about 8,000 people have been tested. Meanwhile, lawmakers who went to a briefing with health officials told Politico that fewer than 10,000 Americans had been tested.

By contrast, South Korea has tested more than 210,000 people and is testing nearly 20,000 people every day, while in the UK, more than 29,700 people have been tested, and more than 1,000 tests are being carried out per day.

In neighbouring Canada, there are currently about 100 confirmed cases. About half

of those are in Ontario, which has tested about 4,185 samples.

Dr Fauci acknowledged to a congressional hearing that the US faced particular difficulties with testing.

"The idea of anybody getting it [testing] easily, the way people in other countries are doing it, we're not set up for that. I think it should be, but we're not."

Why has testing in the US been slow?

It could be down to a combination of factors.

The US declined to use a test approved by the World Health Organization in January - instead, the CDC developed its own coronavirus test. However, there were manufacturing defects with the initial CDC tests which meant many of the results were inconclusive.

Lawmakers who attended

Thursday's health briefing said that there were also problems with the supply chain for testing kits, with stocks of cotton swabs and gloves running low.

And earlier this week, the director of the CDC told a congressional hearing: "There's not enough equipment, there's not enough people, there's not enough internal capacity."

"The truth is... we've underinvested in the public health labs."

What's the reaction been?

On Wednesday, President Donald Trump announced sweeping travel restrictions on 26 European countries - but was criticised by Democratic leaders Nancy Pelosi and Chuck Schumer for not addressing the lack of sufficient coronavirus testing kits.

Republican lawmakers have also expressed frustration, with one senator, James Lankford saying: "We've got a long way to go to be able to get rapid, efficient testing."

Mr Lankford added that it was "not accurate" when President Trump said everyone in the US who wanted to get tested could get one.

Meanwhile, Senator Mitt Romney said it was "very frustrating" that the testing had been slow.

"You can't get wipes for your countertop. You can't get alcohol... and it's very difficult to get tests."

Sophie Trudeau, wife of Canadian Prime Minister, tests positive for coronavirus

Prime Minister Justin Trudeau's wife, Sophie Grégoire Trudeau, has been placed in isolation after testing positive for coronavirus.

She is feeling well and has mild symptoms, and will remain in isolation for 14 days, according to a statement from the Prime Minister's office.

He is not being tested at this time.

Health officials will reach out to those who've been in contact with her as necessary, the office said.

"The Prime Minister is in good health with no symptoms. As a precautionary measure and following the advice of doctors, he will be in isolation for a planned period of 14 days," the office said in a statement.

"Also on the advice of doctors, he will not be tested at this stage since he has no symptoms.

"For the same reason,

Judge orders Chelsea Manning to be released

A federal judge ordered Thursday that former Army analyst Chelsea Manning immediately be released from the Virginia jail where she's been held in contempt for almost a year.

Manning, 32, was taken to a hospital Wednesday after she attempted suicide, her legal team said. She had been sched-

uled for a hearing Friday in Alexandria, Virginia, where she has been held since May after she refused to answer questions from a grand jury looking into the release of documents to WikiLeaks.

But U.S. District Judge Anthony Trenga said Thursday that the grand jury had completed its business and found that Manning's "appearance before the Grand Jury is no longer needed." He ordered the Justice Department to release her immediately but ordered her to pay the \$256,000 in fines that had accrued as she fought the order to testify.

Manning was convicted at a court-martial of espionage and other charges in 2013 for leaking secret military files to WikiLeaks. She has refused to answer further questions about WikiLeaks, arguing that she already did so during her trial seven years ago.

She was ordered jailed in May 2019

after refusing to appear before the grand jury, even with a grant of immunity. She was told then that she would be jailed and fined each day until she agreed to appear or until the grand jury went out of existence. (Federal grand juries typically serve limited terms.)

Manning was sentenced to 35 years in prison, but she was released in 2017 after President Barack Obama commuted her sentence. Manning said she refused to testify before the grand jury because "I don't believe in the grand jury process." "I don't believe in the secrecy of this," she said outside the courthouse before she was jailed.

Her lawyers asked that the fine be set aside, but the judge denied the request Thursday, declaring that it had been "necessary to the coercive purpose" of the civil contempt order that put her in jail in the first place.
