## Definitive steps to regain Category 1 status

The member countries of the OECS union, which also comprise the Eastern Caribbean Civil Aviation Authority (ECCAA), are making steady progress in their attempts to regain Category 1 status for the authority.

ECCAA was demoted to Category 2 status earlier this year.

Since then, the governments of the sub-region have quickened their pace to ensure the reinstatement of their former status.

OECS heads met virtually on Monday to address the ECCAA issue and two other items which formed the agenda.

A source close to the meeting said

one of the outstanding matters that led to the loss of Category 1 status was the failure of the governments to harmonise specific pieces of legislation governing the authority.

According to the source, the EC-CAA legislation has been drafted and circulated to all member states. The legislation will now likely be debated and adopted by parliaments in the sub-region.

The legislation gives more autonomy to the ECCAA board and reduces the influence of ministers of aviation in the affairs of the authority.

It was one of the sticking points that led the United States of America's

Federal Aviation Authority (FAA) and the United Nations' International Civil Aviation Organization (ICAO) to relegate the ECCAA to Category 2.

Antigua and Barbuda has already approved the legislation.

Meanwhile, the recruitment of a new Director General for ECCAA DG has commenced with advertisements being circulated.

Current head, Donald McPhail, leaves the post sometime in September.

Antigua and Barbuda's Prime Minister, Gaston Browne, is leading the OECS heads of government's attempts to regain Category 1 status.

## Police carry out search of St John's businesses


Officers from at least two national security agencies have conducted a search of three businesses in St. John's operated by a popular Chinese-Antiguan businessman.

Reports are that around 8:00am on Tuesday morning, armed policemen served search warrants on the premises of Oriental Choice Supermarket on the All Saints Road, its affiliate supermarket. Pick 'N' Save located east of the School for the Blind and Bar Stox. a drink depot located on Long Street.

The teams conducting the search included officers from the Organisation of National Drug Control Policy (ONDCP) and Police K-9 Unit.

The officers thoroughly searched each of the three premises and took away several boxes containing items which have since been entered into evidence. The items seized included several boxes of cash.


A rifle was also said to be among the evidence seized by law enforcement.



The proprietor of the businesses, along with two of his family members, were reportedly taken into custody and all are being questioned by the police.

Meanwhile, although no arrests have yet been made in the shooting homicide of former Customs Officer, Nigel Christian, Police spokesman, Inspector Frankie Thomas, has said that the raid on Tuesday on the three businesses have unearthed 'useful leads' in the case.

Thomas confirmed that a number of persons of interest have been ques-



tioned by the police concerning 'several threads of investigations' into Christain's murder.

While Thomas acknowledged that these leads may not all form part of the investigation into Christian's death, he continued 'that is the direction that the evidence is leading'.

Thomas revealed that an autopsy has been conducted on Christian's body and the police are now awaiting the results.

Christian was allegedly kidnapped from his home at McKinnon's at approximately 5:30pm on July 10. Several hours later his bullet ridden body was discovered along a roadside near New Winthorpes.

His death sent shockwaves throughout the country prompting calls for external assistance to solve the brutally executed homicide.

## ERC plans major Investment forum targeting locals

Arrangements are being made to host an investment forum specifically targeting Antigua and Barbuda nationals as part of the post-COVID-19 recovery plan.

The symposium is one of the suggestions coming from the Economic Recovery Committee (ERC) appointed by the Cabinet and is designed to bring together a cross section of interests who will formulate a plan for the way forward following global pandemic.

Informed sources say while the ERC's final report is not yet complete, one area where there is already broad agreement is hosting the forum which will attract participation by nationals in order to

A special committee, headed by Investment Commissioner, Ambassador Daven Joseph, has been appointed to coordinate and promote the event.

"Our aim is to encourage local business people to invest in a number of potentially high return projects; projects that can see return on capital in a significant manner," Ambassador Joseph told PointeXpress newspaper.

The committee has identified the Willoughby Bay area, which is located between St. Philip's and Bethesda, for a major development in which local entrepreneurs will take center stage.

"We are hoping to develop over three thousand acres in the area. The development includes a hotel, a marina, high and middle income homes, agro-business, including a farmers' market and a manufacturing zone to facilitate local manufacturing for local consumption and for export,"


he detailed.

Joseph explained that the focus on agro-processing is designed to reduce the losses suffered by the farming community when they harvest their produce. It will also serve as value added to local produce for both the local and export markets.

"The time has come for more development opportunities to include local capital. The opportunities for investment include real estate, hospitality, manufacturing and other services and agriculture. We have the full spectrum of investment opportunities to attract local investment capital," he remarked.

The Investment Commissioner said the plans being finalised by his committee, under the aegis of the ERC, will develop the economy of Antigua and Barbuda in a sustained manner primarily using local investors and foreign capital through joint venture arrangements.

The forum will take place later this month.

# Magistrate court system gets UK assistance

Antigua and Barbuda, along with five other countries in the Eastern Caribbean, will share in a \$200,000 donation which will be used to improve the operations of magistrates' courts in the jurisdiction.

The contribution from the United Kingdom's Caribbean Security and Stability Fund (CSSF), will aid in facilitating remote operations of magistrates' courts during the COVID-19 pandemic.

A release from the British High Commission in St. John's noted that the COVID-19 pandemic has forced jurisdictions to implement stringent social distancing rules to lessen the risk of transmitting the virus.

These measures have resulted in the suspension of physical court activity.

US/UK Criminal Justice Adviser to Barbados and the Eastern Caribbean, Sirah Abraham, said a functioning criminal justice system is essential to delivering law and order and reducing the risk of social unrest.

As a consequence, she approached the UK's Conflict, Stability and Security Fund (CSSF) for assistance to support remote working in regional Magistrates Courts.

The funds have been used to purchase equipment including laptops, printers, scanners, mobile phones and Zoom subscriptions.

The equipment and use of technology will allow the courts to make a smooth transition to the digital delivery of some essential services and limit substantial disruption to the criminal justice process.

Resident British Commissioner to Antigua and Barbuda, Lindsy



Thompson, handed over this equipment to Chief Magistrate Joanne Walsh on Monday.

The Chief Justice of the Eastern Caribbean Supreme Court (ECSC), Dame Janice Pereira, had already urged courts to use remote hearings to facilitate the continuation of proceedings and prepared guidance on how these matters were to be conducted in a Practice Direction issued in relation to COVID-19 emergency measures.

The jurisdictions to benefit from the funding are Antigua and Barbuda, Dominica, Grenada, St. Lucia, St. Kitts and Nevis and St. Vincent and the Grenadines.

Abraham explained the importance of ensuring a responsive and adaptable criminal justice system during the pandemic.

"This support will reduce the risk of spreading the virus, prevent courts from being shut down as a result of spread and limit any delays in the criminal justice process by ensuring that these essential services are still provided to the public."

Dame Janice expressed her gratitude for the funding and the continued support of the Criminal Justice Reform Project.

"I thank you so much for your continued assistance in coming to our aid and more particularly, in these times when we must retool to ensure that the justice system continues to deliver justice fairly and effectively, even if the physical doors and spaces are closed," said Chief Justice Pereira

# Training for school vendors

Preparations for the reopening of schools across Antigua and Barbuda extend beyond the classroom as plans for vendors intending to conduct business in, or near schools, are being considered.

The Central Board of Health (CBH) has announced that it will conduct a series of food safety workshops for persons who vend in the vicinity of schools or in their cafeterias.

Registration for the workshops is now taking place at the CBH head-quarters located in the newly refurbished former Ministry of Education building on Upper Church Street.


Senior Public Health Supervisor, Julienne Mannix, has said vendors will not be allowed to ply their trade in or near schools unless they complete the department's training programme.


Mannix said fifty persons are expected to attend each of the workshops which take place from August 17-20 at the Multipurpose Cultural Centre.

"All school vendors must be retrained and approved by CBH before returning to vend at their respective schools," Mannix stated.

She said food safety training for other persons working in the food industry will run concurrently in the afternoon.

Since the easing of restrictions and resumption of business in the country, CBH has conducted health and safety compliance inspections across the hotel, hospitality and beauty sectors.

# No new COVID-19 cases in over a week

As the country seeks to return to some level of normalcy having reopened its borders and tourism sector, and with schools soon to follow suit, the Ministry of Health is reporting that there are no new cases of COVID-19.

On Tuesday, the health ministry reported that as of Monday 10th August 2020 at 6 pm, the Mount St. John's Medical Center had revealed no new laboratory confirmed COVID-19 cases in Antigua and Barbuda.

According to ministry officials, there have been no new confirmed cases since August 3rd, 2020, bringing it to just over a week since the last report of non-imported or local transmission of the virus.

The Ministry of Health explained, "Subsequent to the publication of the dashboard on Monday 10th August 2020 with the cut off time of 6 pm, fifty-one samples were processed at the Mount St. John's Medical Center's (MSJMC) Laboratory. All fifty-one samples tested yielded negative results."

The total number of COVID-19 cases that the island has reported since the first case was confirmed remains at 92. Of the ninety-two (92) confirmed cases, seventy-six (76) have


recovered. There have been three COVID- 19 related deaths.

The nation's COVID-19 dashboard also revealed that there are thirteen (13) active cases while the results

of twenty-two (22) samples are pending.

The twenty-two pending samples, according to the Ministry of Health, were sent to the Caribbean Public Health Agency (CARPHA) on Monday, August 10th.

Currently, there are seventeen persons (17) in government quarantine while six hundred and twelve (612) persons remain in self-quarantine.

The governments of the OECS and Barbados are moving to standardise entry into their jurisdictions in efforts to limit the domestic spread of the coronavirus.

A meeting of health technicians from the OECS and Barbados is taking place today where a proposal from the Germany based company, Ecolog, will be discussed.

#### MULTI-LEVEL REGIONAL PARTNERSHIP IN A MULTI-HAZARD ENVIRONMENT

Moreover, the management of multi-hazards is further challenged by the necessary adherence to COVID-19 health protocols, in order to maintain the region's effective minimisation of the spread of this disease. Against this backdrop, a fundamental area of strategic partnership between CARILEC and CARPHA is the updating of current protocols for the CARILEC Disaster Assistance Programme (CDAP) deployment crews, in order to ensure full compliance with approved COVID-19 health practices.



## So You Have To Sever An Employee...

The Labour Code of Antigua & Barbuda, together with Collective Bargaining Agreements (CBA) where they exist, seek to protect and preserve employment. In the absence of a CBA, employers must have a written severance policy in place. A written policy will ensure that employees know what to expect to receive if they are severed, and can ensure consistent treatment across similar categories of employees. A well-established severance policy can also reduce the instances of employee litigation for unfair labour practice.

Why are you considering severance? Employers should not consider severance in instances where they have not considered other cost-saving initiatives. In situations where business is bad but is expected to rebound, employers should consider laying off employees first. Severance is a permanent action and employers should reserve it for genuine cases of redundancy. Genuine cases include a reduction of the number of employees due to permanent loss of business, machinery or computers replacing workers, or in instances where due to ill health or incapacity an employee can no longer perform their duties. Employers should act prudently to ensure their actions do not constitute unfair dismissal, in accordance with Division C part 5 of the Labour Code. Part 4 of Division C of the Code outlines the computation of severance pay but collective agreements and recent rulings of



the Industrial Court provide even more generous severance provisions. C41 of the Labour Code computes severance payment as one day per month served for employees.

Most employers are not overstaffed, and have the requisite staff complement for their size of operations. They will have difficulty continuing normal operations with a reduced staff complement, and need to consider the immediate impact on cash flow of a severance payout, particularly a sizeable one. A severance package is due and payable on the date of termination. Particularly in this period of economic downturn, an employer may not be able to pay the severance in full at this time. C 42 (2) of the Labour Code directs that the employer is liable to pay interest at the rate of ten percent per annum on the unpaid balance. In these instances, the employer should communicate this inability to pay to the affected employee, and negotiate a mutually agreeable payment schedule. An employee may not be opposed to continuing to receive a salary monthly while they seek new employment.

Some general reminders when one is involved in a severance process are: Employers must be fair, empathetic and diligent when processing severances.

Employers must ensure that they pay over to the exiting employee in a timely manner, all outstanding emoluments, some of which for example commissions, bonuses and incentives become due and payable after the employee would have left.

Employers must wind up all employee benefits such as pension and thrift funds speedily to ensure the employees receive the proceeds in a timely manner.

Depending on company policy, employee tenure and other factors, employers may consider continuing select employee benefits for instance employee discounts, to severed employees.

Employers should offer a business reference where appropriate without the employees having to ask. Employers should assist the exiting employee, where ap-

propriate and when requested, to manage or reschedule their debt, as companies normally must settle outstanding employee debt to lenders from their final pay packages.

Employers should facilitate where appropriate, informal gatherings where employees can appreciate and bid farewell to their exiting colleagues.

In summary, after the employer determines that severance is necessary, they should execute the steps legally required with empathy and care. They must then take steps to mitigate against the fallout from the severance on the engagement and productivity of remaining employees. Employers must communicate clearly with the remaining employees the reason the severance action was necessary, to provide a measure of reassurance.

## Why We Can't Wait: Danny Glover's Statement in Support of HR-40

The public lynching of George Floyd pierced deep into the "souls of Black folks" compelling a thorough-going examination of the flawed foundation, values, systems and symbols of white supremacy and structural/institutional racism in these United States.


A massive Black Lives multiracial. Matter-led, cross-generational movement has erupted in cities large and small and surprisingly in rural towns and villages where few if any Black people reside. According to a recent article in the New York Times, we are witnessing the unfolding of the largest social movement in the history of the country; a movement which marks an inflection point, where there is not only a demand for fundamental restructuring of policing and the criminal justice system, but a reckoning with an original sin that gave birth to a racialized capitalist political-economy in this nation.

Speaking at a Congressional Black Caucus Press Conference on July 10th of this year, Congresswoman Sheila Jackson Lee said: "systemic racism has been a cancer on the skin and the fabric of this nation that has not been remedied. It has only deepened. Reparations are the answer to the original sin." Encouraged by the mass movement in the

streets, Congresswoman Lee has adopted Dr. Martin Luther King's "Why We Can't Wait" as the call to action as she prepares to push for passage of HR-40 in the House of Representatives.

An American history of progressive African American life sacrifices and transformative struggles for consistent democracy, justice, and material well-being has brought the nation to this moment of reckoning and great promise. When the walls of segregation remained firmly intact throughout the South and de facto segregation was the order of the day in the north, Dr. Martin Luther King, Jr, ever the optimist was convinced that the "Negro Revolution" would succeed. "Why We Can't Wait" was a declaration of his determination to intensify the movement to finally ensure "liberty and justice for all" in this nation.

The Civil Rights Act of 1964 and Voter Rights Act of 1965 marked major successes of the "Negro Revolution" along the path towards a more perfect union. By 1967 Dr. King was openly expressing his opposition to the Viet Nam War, calling for a "revolution of values" and fundamental structural/institutional change in America. He proclaimed: "True Compassion is more than flinging a coin to a beggar; it comes to see that an

edifice which produces beggars needs restructuring."

Despite the "strides toward freedom" of the "Negro Revolution" and the era of 'Black Power," the COVID-19 Pandemic and the epidemic of police violence and murders of Black people has revealed anew in stunning detail the raw racial and socio-economic disparities that still afflict people of African descent in this country.

Reparations for the enslavement of African Americans and racially exclusionary policies after generations of heroic, multigenerational struggle, dating from the 1863 Emancipation Proclamation, has now gained remarkable momentum. The concept of HR-40 the Congressional Bill first introduced in 1989 by the late Congressman John Conyers, Jr. to study the institution of slavery and assess restitution has taken on new life.

Under the leadership of the National African American Reparations Commission (NAARC) a Working Group which includes the National Coalition for Reparations for Blacks in America (N'COBRA) and the Movement for Black Lives (M4BL) collaborated with Congressman Conyers's staff to reformulate HR-40 from a "study" bill to a

"remedy" bill. The revised HR-40 is entitled: "Commission to Study and Develop Reparation Proposals for African-Americans Act."

Congresswoman Sheila Jackson Lee has become the Lead Sponsor of HR-40. Under her leadership and the advocacy of the N'COBRA Legislative Committee along with the American Civil Liberties Union (ACLU), Human Rights Watch (HRW) and the Center for American Progress (CAP) HR-40 has amassed more Co-Sponsors than ever before. Nancy Pelosi, Speaker of the House and the Democratic Leadership fully support the bill and Senator Corey Booker has introduced a Senate version, S.1083 which enjoys the open support of Senate Minority Leader Chuck Schumer.

her in declaring that we cannot wait in pursuing HR-40 as the harbinger of a new future for people of African descent and the marginalized and oppressed in this nation and the world. Please join with me in expressing your support and petitioning your Congressional Representatives to support passage of HR-40. ## Trinbagonians give Prime Minister Rowley another term

Prime Minister Dr Keith Rowley led his People National Movement (PNM) to victory in Trinidad and Tobago's general elections on Monday.

Preliminary results show the PNM won with a reduced majority, capturing 22 seats, down from the 23 they got in the last elections in 2015. The victorious candidates include first-timer Brian Manning, son of the late former Prime Minister Mr Patrick Manning.

The main opposition United National Congress (UNC) of Opposition Leader Ms Kamla Persad-Bissessar captured the Moruga/Tableland seat from the PNM to increase its tally to 19.

Nineteen political parties and four independent candidates contested Monday's poll.

In his victory speech on Monday night, Prime Minister Rowley signalled that the upcoming term will be a period of transition for

him and the party, as this may be his last elections. "This is my period to ensure that the young people I have been mentoring that they move into greater responsibility during that period. So Trinidad and Tobago this is a period of transition but I will not shirk my responsibility to the people of Trinidad and Tobago who have elected me for this five year period," Prime Minister Rowley said.

In the meantime the UNC Lead-

er has requested a recount of the marginal seats, and said her party will not concede until then.

"We fought a good fight. However, tonight I am not giving a concessionary speech. I am not conceding. Our candidates in several marginals are filing for recounts and only then we can concede. Go brave, we fought a good fight and we will continue to go and fight," Ms Persad-Bissessar told party supporters Monday night.

## Barbados: Drug trafficker claims drug deal was to save his children



Harbone Mackinon Griffith claims he was forced to join an enterprise to import 525.36 pounds of marijuana into Barbados because the lives of his two daughters were being threatened.

"I would like to apologise to the court for my misbehavoiur in society. My two little girls' lives were being threatened through an incident me and a guy had years ago. So, he decided to hit back at me by getting back at my two little children so I could do a deed for him. "I made various complaints to the police and nothing came out of it. He even had people running about behind my children, spying bout and sending pictures of my children telling me he know where to get them, he know where them is. So I did it out of trying to protect my children. "I begging for the court's leniency in this matter," Griffith, 49, of Checker Hall, St Lucy said as he addressed the No. 2 Supreme Court judge, Justice Randall Worrell this morning via Zoom.

Griffith had previously pleaded guilty to importation, trafficking and possession of 238.3 kilogrammes or 525.36 pounds of cannabis. He will return before Justice Worrell on August 13. The time he has spent on remand will be submitted by prison officials before he is sentenced.

Mitigating on Griffith's behalf

attorney-at-law Angela Mitchell-Gittens urged the court to be as lenient as possible while Crown Counsel Oliver Thomas submitted that a starting sentence of seven years would be an appropriate punishment under the circumstances. Both submitted that the most aggravating feature of the case was the quantity of drugs involved. They also agreed that there was "no great level" of sophistication. However Thomas said Griffith "played a substantial and important role" in the enterprise.

He told the court that Coast Guard officials were conducting surveillance about ten nautical miles off Batt's Rock, St Michael on August 30, 2018 when they received information and began heading in the direction of Heron Bay, St James. On the way they spotted a white vessel off Holetown registration number J6-1464 bearing the name Power Struggle. Three men were spotted on board the boat, which began making evasive manoeuvres on seeing the Coast Guard vessel. The boat was intercepted about 15 nautical miles off Heron Bay with three people on board including Griffith.

The bags containing the cannabis along with the detainees were taken to the Coast Guard base and subsequently to the Oistins Police Station.



## LIAT's SVG workers yet to secure appointment with Gonsalves



The trade union representing LIAT workers in St. Vincent and the Grenadines say they are still awaiting an appointment with former chair of the bankrupt airline's former shareholder government, Prime Minister of SVG, Ralph Gonsalves.

In a press statement on Tuesday, Jeremiah Howard, president of the LIAT Workers Union, said that the airline's SVG staff learnt by social media two months ago that LIAT (1974) Ltd, was going into liquidation.

Howard said that in a June 8 letter to Gonsalves, the SVG workers requested a meeting to

discuss the matter.

"... and, to date, nine weeks have passed and we have still not received an appointment," Howard said.

"The anxiety and frustration that is being experienced by the staff losing their jobs, through no fault of their own, is now exasperated by the poor communication with management and the failure to secure a meeting with the Prime Minister to resolve the matter of the outstanding salaries, severance pay and other benefits," Howard said.

He continued:

"We fully understand the

complex nature of this situation, the legal ramifications and the current crises engendered by COVID-19, have resulted in an unprecedented economic fall-out. However, our patience and understanding for the past nine weeks, is waning thin.

"The Prime Ministers of Barbados, Grenada and Antigua and Barbuda have met with the LIAT staff of their respective countries regarding the same issues.

"This crisis is not just about our fiduciary interest but speaks to a moral obligation to show care and compassion to us as staff members of LIAT and by extension citizens of St. Vincent and the Grenadines, in this unprecedented time. We should be valued like the other shareholders' citizens."

Howard said that six active-duty staff have not received a salary since April.

"Their commitment and dedication despite the handling of this situation is exemplary. This arrangement is, however, under review and simply cannot continue given the lack of reciprocal care and concern for our staff members," the press statement said.

### German police seize 1.5 tons of cocaine hidden in Guyana rice

Authorities in the German port city of Hamburg have found over €300 million worth of cocaine in a cargo ship container from Guyana containing rice.

According to Deutsche Welle, Hamburg authorities discovered 15 tons of cocaine in a freight container, one of the largest quantities ever seized in the northern German port city, a spokesperson for the Customs Investigations Office said yesterday. Rice from this country has been used on several occasions to conceal cocaine. Some rice exporters from this country have previously been implicated in such shipments. The massive haul, which has an estimated street value of around €300 million (US\$353 million), was hidden between sacks of rice in the container which came from Guyana, local newspaper Hamburger Abendblatt said.

"The 1.5 tons of cocaine seized may be a highly pure drug, which would be tripled in price for street sales," the Hamburger Abendblatt quoted an official as saying.

The container had arrived in Hamburg's port at the end of June on the 300-meter-long container ship, "CMA CGM Jean Gabriel." The container was to be loaded

onto a feeder ship together with 11 other transport containers and then ultimately carry the cargo to Poland. As a result, the container was temporarily stored at the Hamburg terminal. Investigators at the Joint Customs and Police Investigation Group (JIT) had reportedly received a tip-off about drug smuggling, Deutsche Welle said.

The container in question was then taken to the city's Waltershof customs office and examined in a testing facility. Officers found 47 large packages hidden between the rice sacks and within those packages, a total of 1,277 small parcels with cocaine, the report said.

The parcels all had various symbols on them, including a cat's face, the Gallic rooster, and the Ampelmännchen (red and green traffic light symbols shown on pedestrian signals in Germany). Several hundred of the packages were marked with the same logo.

Authorities presumed the cocaine was to be distributed from Poland to bulk buyers all over Europe who would then sell the drugs to street dealers. A variety of commodities from this country have been used to conceal cocaine including timber and pepper sauce.

### Bahamas PM enters voluntary quarantine after COVID-19 exposure

Prime Minister Dr Hubert Minnis and Deputy Prime Minister K Peter Turnquest have entered voluntary self-quarantine after their offices were exposed to COVID-19.

In a statement, the Cabinet Office said it has not been confirmed whether the pair were directly exposed.

The statement announced that the Cecil Wallace-Whitefield Centre, which houses the Office of the Prime Minister, the Ministry of Finance and their agencies, has been closed for cleaning and sanitization following exposure to the virus.

"The Ministry of Health's Surveillance Unit has initiated contact tracing to determine the

level of exposure to employees and visitors to the Cecil Wallace-Whitfield Centre," the statement read.

"At this point there has been no confirmation that the Prime Minister or the Deputy Prime Minister have been exposed.

"Out of an abundance of caution, the Prime Minister and the Deputy Prime Minister will voluntarily enter into self-quarantine until further instructions from the Ministry of Health."

It added: "Other employees of the Cecil Wallace-Whitfield Centre are encouraged to self-quarantine until further instructions are issued by the Ministry of Health."

## Joe Biden picks Sen. Kamala Harris to be his vice presidential running mate, making her the first Black woman on a major ticket

Former Vice President Joe Biden has chosen Sen. Kamala Harris of California to join him on the Democratic ticket, fulfilling his pledge to select a female running mate and making Harris the first Black woman ever to appear on a major party ticket. His campaign announced the pick Tuesday afternoon through its website.

Biden's selection of Harris, 55, lends racial diversity, gender parity and generational breadth to his campaign. It also represents a strategic decision by the 77-year-old former vice president to keep his ticket firmly within the more moderate wing of the Democratic Party. "Back when Kamala was Attorney General, she worked closely with Beau," tweeted Biden, referring to his late son, Beau Biden. "I watched as they took on the big banks, lifted up working people, and protected women and kids from abuse. I was proud then, and I'm proud now to have her as my partner in this campaign."

The selection came despite a monthslong pressure campaign from leftist factions that wanted Biden to pick a progressive star such as Sen. Elizabeth Warren of Massachusetts, and in the final few weeks of the search, concerted lobbying by prominent Democrats on behalf of Rep. Karen Bass of California and former Obama National Security Advisor Susan Rice.

Harris said in her own tweet shortly after Biden's decision, "Joe Biden can unify the American people because he's spent his life fighting for us. And as president, he'll build an America that lives up to our ideals. I'm honored to join him as our party's nominee for Vice President, and do what it takes to make him our Commander-in-Chief."

Former President Barack Obama complimented his vice president's choice. "Joe Biden nailed this decision," Obama said in a statement. "By choosing Senator Kamala Harris as America's next vice president, he's underscored his own judgment and character. Reality shows us that these attributes are not optional in a president. They're requirements of the job. And now Joe has an ideal partner to help him tackle the very real challenges America faces right now and in the years ahead."

Following the announcement, Rice complimented Harris in a statement, calling her "a tenacious and trailblazing leader who will make a great partner on the campaign trail." Bass did the same, saying in a tweet that Harris' "tenacious pursuit of justice and relentless advocacy for the people is what is needed right now."

Harris has a uniquely American biography: Her mother was a widely respected breast cancer researcher who immigrated to the United States from India in the 1960s. Her father, Donald Harris, is an eminent economist who spent much of his career at Stanford

University. Also an immigrant, Harris moved to the United States from Jamaica around the time his future wife came from India. A first-term senator who served as California's attorney general from 2010-16, Harris has drawn on her personal and professional experience to emerge as a leader in the Senate on racial justice issues.

"We've all watched her hold the Trump administration accountable for its corruption, stand up to a Justice Department that's run amok, and be a powerful voice against their extreme nominations," said Biden in his announcement Tuesday, touting her experience in the Senate.

"She's been a leader on criminal justice and marriage equality. And she has focused like a laser on the racial disparities as a result of the coronavirus," Biden said.

### **Belarus opposition leader flees** the country

The main opposition candidate in Sunday's disputed presidential election in Belarus has left the country after security forces mounted a sweeping crackdown on protests over the result.

Svetlana Tikhanovskaya, who stood in for her husband as an opposition candidate after he was jailed in the run-up to the vote, was forced out of the country and is now in neighboring Lithuania with her children, her campaign said Tuesday.

Tikhanovskaya fled after publicly rejecting preliminary election results that handed the longtime Belarusian President Alexander Lukashenko a landslide victory. But many details around her departure are still unclear.

Protests erupted after official exit polls were released late Sunday, granting a sixth term to Lukashenko, who has ruled Belarus for 26 years and earned the nickname "Europe's last dictator." Thousands were arrested and the demonstrations resumed on Monday night.

Tikhanovskaya's campaign and independent observers say the vote was marred with widespread ballot stuffing and falsifications. The independent monitoring group "Honest people" said that according to its data, she had won in at least 80 polling stations across Belarus.

On Monday, Tikhanovskaya "left to an unknown location" after filing a complaint with Belarus' central elections committee demanding a recount of the votes. After spending several hours at the committee alone,

she came out and told her lawyer that "she made up her mind" and left the building, according to her campaign. The campaign could not reach her for several hours before she got in touch to confirm she was safe. Lithuania's foreign affairs minister announced early on Tuesday that Tikhanovskaya was in the country.

Tikhanovskaya defended her flight from Belarus in a video posted on the YouTube channel of her husband, Sergey Tikhanovskiy, a popular blogger and former candidate who has been jailed since May.

"I thought this campaign strengthened my spirit and gave me so much energy that I could bear it all. But I guess I'm still just that weak woman I was in the beginning," a visibly distressed Tikhanovskaya said in the clip.

"I made a very hard decision, I've made this decision on my own ... and I know that many people will understand me, many will judge me and many will hate me but god forbid you will ever have to face the choice that I had to face."

A few hours later, a pro-government channel on the messaging app Telegram shared a video of Tikhanovskaya quietly reading from a piece of paper and calling on Belarusians to cease protests. In the video, she insisted that "the nation has made its choice" — a complete reversal from her claim that the election was rigged.

It was unclear where and when the second video had been recorded, but it spurred intense

speculation on social media about possible threats that could have been levied against the candidate, forcing her out of the country.

The candidate's representative Olga Kovalkova told Belarusian outlet TUT.BY on Tuesday that Tikhanovskaya "had no choice," and said that part of Tikhanovskaya's team was still being "held hostage."

Her campaign told CNN on Sunday that nine people associated with the campaign had been arrested. Tikhanovskaya's husband has been in a detention center since May and the family sent their children abroad before the election following threats they would be placed in an orphanage.

"Svetlana had no choice, the Belarusian authorities took her out of the country," Kovalkova told TUT.BY. "It is important that she is free and alive. Svetlana's departure made the release of [campaign manager] Maria Moroz, who was a hostage in this situation, possible and they left together."

The nine campaigners were arrested for various reasons, including allegedly preparing unauthorized demonstrations, according to police. The Belarusian authorities did not officially acknowledge that Moroz has been released.

### Scientists uneasy as Russia approves 1st coronavirus vaccine

Russia on Tuesday became the first country to approve a coronavirus vaccine, a move that was met with international skepticism and unease because the shots have only been studied in dozens of people. President Vladimir Putin announced the Health Ministry's approval and said one of his two adult daughters already was inoculated. He said the vaccine underwent the necessary tests and was shown to provide lasting immunity to the coronavirus, although Russian authorities have offered no proof to back up claims of safety or effectiveness. "I know it has proven efficient and forms a stable immunity," Putin said. "We must be grateful to those who made that first step very important for our country and the entire world." However, scientists in Russia and other countries sounded an alarm, saying that rushing to offer the vaccine before final-stage testing could backfire. What's called a Phase 3 trial which involves tens of thousands of people and can take months is the only way to prove if an experimental vaccine is safe and really works.

By comparison, vaccines entering final-stage testing in the U.S. require studies of 30,000 people each. Two vaccine candidates already have begun those huge studies, with three more set to get underway by fall. "Fast-tracked approval will not make Russia the leader in the race, it will just expose consumers of the vaccine to unnecessary danger," said Russia's Association of Clinical Trials Organizations, in urging government officials to postpone approving the vaccine without completed advanced trials.

While Russian officials have said large-scale production of the vaccine wasn't scheduled until September, Deputy Prime Minister Tatyana Golikova said vaccination of doctors could start as early as this month. Officials say they will be closely monitored after the injections. Mass vaccination may begin as early as October "We expect tens of thousands of volunteers to be vaccinated within the next months," Kirill Dmitriev, chief executive of the Russian Direct Investment Fund that bankrolled the vaccine, told reporters. The vaccine developed by the Gamaleya Institute in Moscow with assistance from Russia's Defense Ministry uses a different virus – the common cold-causing adenovirus - that's been modified to carry genes for the "spike" protein that coats the coronavirus, as a way to prime the body to recognize if a real COVID-19 infection comes along. That's a similar technology as vaccines being developed by China's CanSino Biologics and Britain's Oxford University and AstraZeneca — but unlike those companies, Russian scientists haven't published any scientific information about how the vaccine has performed in animal tests or in early-stage human studies. Dmitriev said even as Russian doctors and teachers start getting vaccinated, advanced trials are set to start Wednesday that will involve "several thousand people" and span several countries, including the United Arab Emirates, Saudi Arabia, the Philippines and possibly Brazil.

The Associated Press couldn't find documentation in the Russian



Health Ministry's records indicating that permission to start the advanced trials was granted. The ministry has not responded to a request for comment. Putin said one of his daughters has received two doses, and had minor side effects such as slight fever, and is now "feeling well and has a high number of antibodies." It wasn't clear if she was one of the study volunteers. The Health Ministry said in a statement Tuesday that the vaccine is expected to provide immunity from the coronavirus for up to two years, citing its experience with vaccines made with similar technology.

However, scientists around the world have been cautioning that even if vaccine candidates are proven to work, it will take even more time to tell how long the protection will last.

"The collateral damage from release of any vaccine that was less than safe and effective would exacerbate our current problems insurmountably," Imperial College London immunology professor Danny Altmann said in a statement Tuesday. The World Health Orga-

nization has urged that all vaccine candidates go through full stages of testing before being rolled out, and said Tuesday it is in touch with the Russian scientists and "looks forward to reviewing" Russia's study data. Experts have warned that vaccines that are not properly tested can cause harm in many ways — from harming health to creating a false sense of security or undermining trust in vaccinations.

Becoming the first country in the world to approve a vaccine was a matter of national prestige for the Kremlin as it tries to assert the image of Russia as a global power. Putin repeatedly praised Russia's effective response to the outbreak in televised addresses to the nation, while some of Moscow's top officials - including the country's prime minister and Putin's own spokesperson - became infected. And the U.S., Britain and Canada last month accused Russia of using hackers to steal vaccine research from Western labs. Russia has denied involvement. Russia has so far registered 897,599 coronavirus cases, including 15,131 deaths.

## China increases military drills as tensions with US heat up

China is stepping up military drills around East Asia as a war of words with the United States heats up over Washington's military activities and the visit of a US cabinet secretary to Taiwan.

One Chinese think tank even says the People's Liberation Army (PLA) may consider livefire exercises near the US island of Guam. Beijing has stepped up the pace of its war games in recent weeks, after the US sent two aircraft carrier strike groups on rare dual-carrier exercises in the South China Sea twice in the month of July. But the visit of US Health and Human Services Secretary Alex Azar to the self-governed island of Taiwan this week has added fuel to the smoldering tensions. Azar is the highest-ranking US official to visit the island - which Beijing regards as Chinese territory - in decades. Azar's presence in Taipei is "a serious breach" of US commitments on Taiwan, Chinese Foreign Ministry spokesperson Zhao Lijian said Monday afternoon.

"We urge the US side to abide by the one-China principle and the provisions of three China-U.S. joint communiques, stop official interactions and contact of all kinds as well as the upgrading of substantive relations with the island, and handle Taiwan-related issues in a prudent and proper manner, so as not to seriously damage China-US cooperation in major areas as well as peace and stability across the Taiwan Strait," Zhao said, according to the state-run Xinhua news agency. On Monday morning,

China sent fighter jets across the median line in the Taiwan Strait, which Taiwan said its warplanes warned off. The Chinese jets were also tracked by Taiwan's land-based anti-aircraft missiles, Taiwan's Defense Ministry said.

Though still in international airspace, the Taiwan Strait median line has been an informal but largely respected dividing line for Beijing and Taipei. According to Taiwanese and US government reports, Beijing's warplanes have only crossed it intentionally three times since 1999 — once in March 2019, in February of this year, and again on Monday.

A story from state-supported Global Times, appearing on the official English language website of the PLA, showed Beijing's displeasure with Washington over Azar's visit to Taiwan.

"The PLA operation is considered a strong response to the US move, which broke a diplomatic bottom line of China-US relations," the story said.

It goes on to say if Washington doesn't back down, more moves by the PLA may be necessary.

"If the US goes further, the PLA could take more countermeasures, including live-fire missile drills east of Taiwan island and near Guam," the story says, citing Xu Guangyu, a senior adviser to the China Arms Control and Disarmament Association.

Maj. Randy Ready, spokesman for the US Indo-Pacific Command in Hawaii, said the US military "won't speculate on hypothetical exercises that may or may not take place in the future."



The mention of possible exercises off Guam, home to the important US military installations of Andersen Air Force Base and Naval Station Guam, comes after a busy few weeks for the PLA.

"Ground and naval forces of the Chinese People's Liberation Army (PLA) have been on concentrated schedules in amphibious landing and maritime exercises in the past weeks and will continue to do so in the weeks to come," a Global Times report said.

Recent drills include a mock beach assault in Hainan province on the South China Sea; a sea-crossing and landing with amphibious assault vehicles in Guangdong province; sea-crossing assault drills in Fujian province; and flights of missile-armed bombers and fighters over the South China Sea.

The PLA has live-fire exercises planned for this week and next, according to another Global Times report.

Those drills will be off Zhoushan, an island on China's east coast south of Shanghai.

"The PLA drills come amid the increasingly frequent provocative military activities made by the US near the island of Taiwan and in waters in the South China Sea," the Global Times report says.


In a Xinhua interview, Chinese Foreign Minister Wang Yi last week accused Washington of sending 2,000 military flights over the South China Sea in the first half of this year. That would be a rate of almost 11 a day.

Ready, the Indo-Pacific command spokesman, would not confirm Wang's assertion on the number of US flights.

## Sarwan heads home

Former West Indies batsman, Ramnaresh Sarwan, will not serve as an assistant coach for the Jamaica Tallawahs in this year's edition of the Caribbean Premier League (CPL) after being given leave to return home.

The entirety of this season's tournament will take place on the island of Trinidad and Tobago as organisers have decided to operate with an abundance of caution as a result of the COVID-19 pandemic.

The six CPL franchises and match officials reported to the twin island republic a week ago where they have been quarantined at the Hilton Hotel in St. Ann's.

The tournament will get under way on August 18.

Tallawahs CEO, Jeff Miller, confirmed that Sarwan, who was appointed to the post two years ago, was not present.

"Mr Sarwan requested leave for personal reasons and that was granted," Miller said in an interview with the Trinidad and Tobago Newsday.

"It's a big loss. Sars (Sarwan) brings a lot to the game; his knowledge, his experience and the way he has dealt with the players over the years, so it is a great loss," he added.

Sarwan will be replaced by former West Indies spinner, Ryan Austin.

In April, Sarwan was in the news after a public spat with former teammate and then Tallawahs batsman, Chris Gayle. In a Youtube rant, Gayle

blamed Sarwan after he was released by the team.

Sarwan denied Gayle's accusations.

### British player complained about 'lightheadedness' during match

Johanna Konta has said she felt "lightheaded" after suffering from heart palpitations during her straight-set defeat at the Lexington Open.

Konta, seeded third on her WTA Tour return, was beaten 6-4 6-4 by world number 48 Marie Bouzkova in Kentucky.

The Briton needed medical attention early on but, after consultation with a doctor, was able to return to court.

Konta said, "My heart rate shoots up for no reason and I wasn't gassing in any way in my lungs."

She continued: "It actually goes up and stays there so it makes me a bit lightheaded. I just needed to see the doctor and the physio.

"It was very high when they came out. I was having all the checks. I am as fit as a fiddle, but it can happen. It took a while to settle down but then it did and I was able to concentrate on the tennis."

Konta had also lost to the

Czech Republic's Bouzkova in Mexico in March in her final match before the tour was suspended because of the coronavirus pandemic.

After play was delayed by four hours because of a rain storm, and after surviving a break-point scare in the opening game of the match which was played in extreme humidity, Konta appeared to be struggling with the conditions.

She has suffered similar issues in the past, notably at the 2016 US Open and at the Fed Cup last year where she recovered to win both matches.

"We don't know why it happens. It's been under stressful situations, in no-stress situations. We just don't know. It's been sporadic," Konta said.

"It's not ideal. I am going to have another ECG and see what protocols we can take. It's probably not going to happen again for another year or something. I'm not too worried, no."

### Focusing on youth development

National Women's Football Coach, Lisa Cole, says she is focusing on youth development with the aim of creating pathways to university for local players and producing a competitive Women's national team to compete in the 2022 FIFA World Cup qualifiers.

Cole, speaking to PointeXpress, said she was contacted a few years ago by Antigua Barbuda Football Association (ABFA) Vice President, Gwen Salmon, about the women's coaching vacancy in Antigua and Barbuda. She said she immediately accepted the challenge of helping to improve the sport on the island.

Cole, who has vast experience coaching on the college circuit in the United States and professionally, said when she arrived on island all she was looking for is bodies to participate in women's football, however, with the introduction of the 2019/20 Female Senior Football League at the ABFA technical center she has seen the emergence of young talent. According to Cole, the future of the national team

is bright.

"I was lucky to travel with the Under-17 and Under-20 national teams not long after taking up the position as Head Coach and was able to make an early assessment of what was needed moving forward," she noted.

Cole, who has worked with the Papua New Guinea Women's National Under-20 team, says emphasis needs to be directed to the primary and secondary schools programme in order to enhance the development of female football on the island.

"We have to find a way to energize

young ladies between the ages of 9 to 12 to get involved in the sport and develop their motor skills and appetite for the game at an early age," Cole explained.

"Our aim is to start our development process early by preparing our girls at 13 years old for Under-15, at 16 for under-17 and at 17 for under-20 moving forward, Cole stated.

The national coach, who has worked professionally with the Boston Breakers, Houston Dash and Washington Spirit, says the immediate goal for the female national programme is to be competitive and more organized in 2022.

"We have to start competing with countries like Trinidad and Tobago, Jamaica and Haiti by closing the gap," she said.

The national team has been transitioning slowly from its older athletes to the younger players presently in the

Cole has coached at University of Mississippi, UConn, University of Rhode Island, and Florida State.
