#### **HUMAN RIGHTS AND WHAT IT MEANS** FOR ANTIGUA AND BARBUDA PT. 2

Also, we have witnessed reoccurring issues regarding the prison and the conditions in which prisoners must subject themselves to undesirable situations whether in physical form, i.e. the inhumane facilities or intangible form, i.e. procedures all within, ironically, the justice system. Here, the prohibition against inhumane and degrading treatment takes into account the duration of the treatment, its physical and mental effects. along with the sex, age, and state of the person's health arising from the detention conditions.

Inhumane and degrading treatment need not be deliberate, it could stem from omissions, however, we must remember that human rights prevent us from stripping away the sinews of one's existence as a human being even though convicted by a court. This issue is controversial and requires widespread dialogue and the development of a consensus across society on how we should treat even those who are punished for breaching law and order.

Another controversial issue is the treatment of LGBTQ+ persons in society and the discrimination they face day in and day out. Although there have been significant strides reaardina the respect aiven



that respect given is void of accepting one's identity, which leads to tacit or indirect discrimination. Relevant here is the prohibition of discrimination and the protection of the individual and their right to express themselves and their identity as a human being, inclusive of their gender and sexual orientation. Many LGBTQ+ persons also face inhumane and degrading treatment, i.e. acts, policies, and institutional mechanisms which make one feel less than human often inflicting actual mental and physical harm.

Also, persons face the erosion of their right to private life, resulting in fear, harassment, and attacks on their physical and mental integrity, intellectual freedom, and honour and reputation. As a people, however, we must gitimate role and business of the state or any group to regulate what happens in someone's intimate life, for what purpose and to what end.

Lastly, there are discussions currently centred around the protection of the environment and the need to balance economic development. This is an issue faced by all countries, developed and developing, however, in the context of human rights, the rights which are fundamental to one's dignity, identity, diversity, and sustainability should not be compromised in negotiations.

Also, in relation to the pandemic and with vaccinations on the horizon, human rights can ensure that no person is barred from inoculations on the grounds of race, sex, gender, creed, or nationality since the pandemic affects us all equally.

Given these issues, particular nuances frame the way persons in our society view human rights. Generally, there is a lack of understanding and appreciation for the substance and benefits of human rights. Coupled with this reality, there is no prioritising per se of human rights within every-day life in professional, business, and social spheres. Moreover, given that the constitution provides and guarantees human rights while many human rights issues go unaddressed, law enforcement institutions and stakeholders of the rule of law must ask themselves whether they are doing enough to bringing about the universality and indivisibility of human rights for persons in Antigua and Barbuda.

One final point is the role and influence of church in society the and other civil society groups. Many of the biblical teachings and institutional doctrines of the church are more or less incompatible with human rights and significantly influenced how their members view the LGBTQ+ community, the equal and equitable treatment women, freedom of expression, freedom of association et al.

Although historians proved that throughout the ages the bible has been edited to reflect prevailing norms at each junction, there comes a day of reckoning when churches and other religious groups in society should give up promoting dogmatic teachings and doctrinal attempts to erode the aims, objectives, and benefits of human rights. This objective, however, requires an honest dialogue and an appreciation for a plurality of views and interpretations to co-exist peacefully for the greater good.

We all must play an in-

strumental part in planting human rights at the centre of our lives and livelihood and more so at the core of our socio-economic development as a people. It must start with the media's role in facilitating discussions on human rights issues through radio and television shows, publications, documentaries, and use of digital and social media platforms.

Also, advocates on social and other issues need to get more involved in actually assisting those who they advocate for rather than facilitating endless and meaningless talk-shops. By this, advocates need to engage more directly with policymakers; conduct substantial research and transform those findings into actionable and practical initiatives; and regularly interact with those whose rights are affected while providing more assistance where necessary.

There must also be legal reform to eliminate antiquated norms and principles that are incompatible with a modern and progressive society.

The time has come for us to embrace the full gamut of human rights and place it at the heart of our development as a people. Although human rights are guaranteed in law, the reality is that in fact, human rights are not effectively enjoyed by all across all spheres of life and society. Positive action is required to prevent their erosion and further enhance the quality of the rights enjoyed. Hence, particularly for Antigua and Barbuda, recognising, guaranteeing, protecting human rights means realigning our values, our perception, and even our identity as a people if we truly want to become a modern, forward-thinking, and developed society.

# Six inmates at HMP complete computer asses

Six inmates at Her Majesty's Prison (HMP) have successfully completed a three month introduction to computer training programme.

Prison Superintendent, Col. Eugene Phillip, said the graduation was held at HMP this week at the course's close.

The training was facilitated by Abraham of Computer Reset.

The inmates graduated with an average of 89 percent.

Col. Phillip revealed that this is the second group of inmates to graduate from the programme.

"The programme is designed to equip inmates with skills that will make their transition to society much easier when they complete their time at the penal institution," he remarked.

He also bemoaned the high rate of recidivism among inmates at the prison.

"There is one inmates who we released just last week. That was the 34th time that he has been released from the institution. I want to help these guys be better able to function on the outside. Many lack basic reading and writing skills and that account for their continued involvement in criminal behavior," he observed.

In the new year, an intermediary class will be added to the introductory computer programme now being offered. The superintendent also revealed that a current inmate will assist in teaching reading and arithmetics to his fellow inmates.

Col. Phillip added that in 2021 there are plans to partner with people who can facilitate training for the inmates in plumbing and electrical as part of the prison's expanding education programme.

#### Government to begin charging quarantine stays

Changes are coming to the way the government operates its quarantine centres.

In the past, people required to quarantine in government centres were provided with three meals per day at the expense of the government. This arrangement is coming to an end.

Government spokesman, Melford Nicholas, said the government will soon charge persons required to stay at these facilities \$100.00 per day. This comes on the heels announcement the that the Halcyon Hotel, which has served as the government's auarantine centre for the past three months, will begin renovations shortly and must be vacated.

The government has since decided that it will use the Jolly Beach Hotel, which is closed, as its new quarantine facility.

As part of the new policy changes, Nicholas said greater emphasis will be placed on having people quarantine in government operated facilities instead of at their homes.

"You would notice from the dashboard that we now have more people auarantining at home rather than at a government facility. This changed from what it was in the beginning when there [were] more people in the centre and not at home. When we announced the regime in the first instances we stated that we wanted people to pay \$100 to pay for their meals. There was a push-back to that so the government relented. Providing free meals has cost the government over two million dollars and we cannot carry the cost any longer," he declared.

This new policy largely affect nationals returning from abroad who must stay in the quarantine facility as the government moves to strengthen the management of this process.

As part of the auarantine process, individuals will also be required to wear a bracelet that will monitor their movements to ensure compliance.

The bracelets are proarammed to sound an alarm at the Command Center whenever a person wearing the device breaches defined perime-

According to the Cabinet, as the number of people arriving in the country increases, so will the need for people to be quarantined. This in turn will result in the need for improved ways of ensuring compliance with the terms of a 14 day auarantine.

"The object is to prevent the spread of the coronavirus within the communities principally where family members of the visitors reside. The largest threat of contagion faced by the nation has come from returning nationals who disobey quarantine conditions and who then minale with friends and family members before the 14 day quarantine period has ended," Minister Nicholas stated.

# Closed companies owe **Social Security millions**

Concrete evidence of the significant negative impact of the COVID-19 pandemic on Antigua and Barbuda's economy has been revealed in new data from the Social Security Board (SSB).

On Wednesday, Director of the SSB David Matthias and Deputy Director Geoffrey Joseph addressed Cabinet on the compliance of firms that are required to pay contributions deducted from the wages and salaries of the nation's workforce.

"The Cabinet learned that 926 companies have closed their operations since the onset of COVID-19. 426 of these companies are still owing the SSB deductions totaling \$9,000,000.00 approximately," the Cabinet Notes disclosed.

Matthias said there are over 4,300 companies operating in the country. About half of those businesses are operated by self-employed people.

"We need more self-employed persons to come and register their businesses but we are aware that during the current pandemic this may be difficult," he stated.

Matthias said the high rate of business closures can only be reversed by increased economic activity in an improving economv.

While there have been closures, the SSB director noted that many new businesses that have opened during the pandemic.

"There is still hope!" he declared.

Meanwhile, the Cabinet Notes revealed that the Barbuda Council owes the SSB \$21,000,000 for deductions made from wages and salaries but which

have not been paid over. Matthias said he spoke with the parliamentary representative for Barbuda, Trevor Walker, on Thursday in which he indicated a need for the talks on the matter.

According to Matthias, outstanding amount dates back more than thirtv vears.

The SSB director further announced that a compliance team will be dispatched to Barbuda to encourage contractors working on the housing programme there to register with the scheme.

The Cabinet Notes also provided clarity regarding the government's standing with SSB.

"The Government of Antigua and Barbuda has been paying its required contribution in full has provided additional amounts to meet the shortfall in revenue caused by the layoffs in the private sector."

In order to ensure greater compliance with payment requirements, ten graphic zones have been created to which an equal number of Compliance Officers have been assigned.

"Construction workers, fisher-folk and some farmers, the self-employed, tend to pay nothing into the SSB. Upon reaching old age, many discover that they cannot pursue their accustomed livelihoods and are plunged into poverty. Their current contributions to SSB are therefore an investment which will bear fruit in their declining years. The SSB plans a series of radio and television series to inform and to nudge these self-employed workers to make regular contributions," the Cabinet Notes said.

#### December 28 declared a public holiday

Antiguans and Barbudans are in for a lona break next weekend as Christmas holidays approach.

The Cabinet decided on Wednesday that it will ask the Governor General to declare Monday 28th December a public holiday. This is because December 26, Boxing Day, will fall on a Saturday this year.

Cabinet's request has effectively extended the holiday weekend from Christmas day, which falls on a Friday this year, to Monday, December 28.

Cabinet spokesman, Melford Nicholas clarified that the law only addresses what happens when Boxing Day falls on Sunday but is silent regarding what happens when it falls on Saturday.

Under those circumstances, the Cabinet took the decision that it would ask the GG to issue a proclamation declaring December 28 a public hol-

Nicholas also addressed the close of business activities on Christmas Eve.

"The Cabinet reiterated its policy, embedded in law, to bring an end to all commercial activity on Christmas Eve at 8:00 pm. Only essential services may continue past that hour. Gasoline stations and pharmacies are the essential services that may go beyond 8:00 pm," he explained.

Churches are allowed to continue their worship services past midnight on Christmas Eve and Old Year's night but must end in time to allow worshipers to return home by 1:00 am.

"Private parties are limited to ten persons only and are to end before 1:00 am on Old Year's night/New Year's Day. Beaches are open on the holidays for limited hours from 5:00 am to 1:00 pm on the three holidays that are on the calendar, to wit: Christmas Day, Boxing Day, and New Year's Day. Some consideration is being given to expanding the hours to maybe 3:00 pm," he stated.



# PM to help resolve port impasse

Prime Minister Gaston Browne will use his office to help bring resolution to the current impasse between Antiqua Port Authority's (APA) management and its employees over bonus payments for 2020.

PM Browne has invited the APA's management team representatives of the Antigua and Barbuda Workers Union (ABWU) to a meeting on Monday to discuss a resolution.

Both sides are at loggerheads over the payment of 2021 bo-port as it has handled nuses which is part of the collective bargaining agreement. There is mutual agreement between the two that the bonus should be paid based on productivity.

Port manager, Darwin Telemaque, told **PointeXpress** that based on the sharp decline in APA earnings this year, the decision to forego paying bonuses is in order. He revealed that the COVID-19 pandemic has caused a 30 to 40 percent reduction in the operation of the

less tonnage. He also disclosed that the port saw a reduction in activities in every month this year except March.

Additionally, during the early months of the pandemic, the port deployed only 25 workers in a bid to ensure that the operations at the port did not come to a complete stop.

During that time however, the port's more than 240 workers were paid their full wages or salaries.

ABWU Assistant Gen-

eral Secretary Chester Hughes has been unwilling to accept that productivity at the port declined in 2020 due to the pandemic and resulting slowdown in economic activity. He contends that there is no agreed measurement of productivity at the port.

Hughes has said the union suggested a respected regional authority to consult with APA on the matter, however, APA has not acted on its suggestion.

# **OAS** seats Venezuelan opposition representative despite **Antigua and Barbuda's protest**

Antiqua Barbuda and forced a vote at the Permanent Council of the Organization of American States (OAS) concerning the representation of Venezuela by the spokesperson for Juan Guaidó who is recognised by only 50 countries as the 'Interim President' of Venezue-

Antigua and Barbuda is of the view that the representative of the Venezuelan opposition leader ought not be allowed to speak in the councils of the OAS.

"Juan Guaidó's agent was foisted on the OAS in 2019 by a bare majority of 18 countries even though he is spokesperson for only one political party in Venezuela," said Antiqua and Barbuda's Ambassador, Sir Ronald Sanders.

In a formal note to the Chairperson of the Permanent Council, Ambassador Sanders said, "Allowing the views and positions of only

one political party to be expressed in any forum of the OAS is contrary to natural justice and democratic principles since it denies a similar opportunity to other political parties in opposition and government in Venezuela."

The ambassador said that in calling for a vote, "Antigua and Barbuda was standing up for democratic principles and the Charter of the OAS which some appear to have sacrificed on the altar of narrow political objectives that questions the credibility of the OAS.

"When the vote was taken, only 17 legitimate country representatives, along with Guaidó's agent, voted in favour of him making a presentation to the Council. This means there was not even a basic majority of 18 countries anvmore."

This means that the move failed and Guaido's representative was allowed to speak.

Antigua and Barbuda pro-

tested the decision to allow the representative to participate in the vote.

CARICOM countries were divided on the vote.

The Bahamas, Haiti and Jamaica voted with Guaido's agent while Antigua and Barbuda and St. Vincent and the Grenadines voted against. Seven CARICOM countries abstained and two were absent.

Mexico, Argentina, Bolivia, the Dominican Republic and Nicaragua did not vote with Guaido's agent.

Venezuela formally withdrew from the OAS in 2019, having given two years notice in keeping with the rules of the Charter of the Organization. Since then, the OAS has been divided over the seating of Juan Guaido's representative who has no authority to speak for or act on behalf of the government or other political parties in Venezuela.

# OAS accommodation of Guaidó attack on Trinidad and Tobago wrongly allowed but rightly resisted

Events at the Organization of American States (OAS) continue to reveal that, notwithstanding the efforts by some of its 33 member states, the Organization is the handmaiden of powerful governments which control it through various methods, including coercion.

Nothing symbolises this more glaringly than a presumptuous assault on the Government of Trinidad and Tobago by the agent of one small political party, purported to be the Government of Venezuela. The sordid event occurred in the OAS Permanent Council on December 16.

Some background is necessary. For various reasons, linked to the ambitions of political and business elites in certain countries, Juan Guaidó was selected as "Interim President" of Venezuela. The people of Venezuela had no say in Guaidó's selection or in his adornment with the title of "Interim President". Guaidó and his party cannot deliver any basic function of a government. They do not have the capacity to sell a one cent stamp to a Venezuelan, or to respond to governments that need to engage with the authorities in Venezuela.

Factually, Venezuela is not a member of the OAS. On 27 April 2017, the Venezuelan government properly notified the OAS Secretary-General of its withdrawal from the Organization in accordance with its rules. Consequently, the Charter ceased to be in force with respect to Venezuela whose membership of the Organization ended on 27 April 2019.

However, determined to exercise power over Venezuela, in April 2019, 18 governments - some willinally, others out of fear or by coercion - imposed Guaidó' s agent as the representative of Venezuela at the Organization, by a bare majority vote. In effect, a small political party was given equal standing with sovereign governments - an unprecedented and alarming event. The other 15 governments rejected this imposition, making clear that they would be bound by no declaration or resolution which is adopted by a majority that included the Guaidó agent. Further, they made it pellucid that no attention would be paid to anything he said in the Organization.

The OAS is a house divided against itself. It is also financially bankrupt, in large part because, despite being regarded by a few member states and the Secretary-General as the 'government' of Venezuela, Guaidó' s group has not paid a cent of the \$3.3 million in membership fees for 2019 and 2020. The recording of these monies as due from a country that is not a member of the Organization is another of the fallacies of the OAS.

Against this background, when

Guaidó's representative requested - on his own and with none of his patron governments - the placement on the agenda of the Permanent Council of a presentation by himself on "Venezuelan Migration and Its Recent Tragic Consequences", the delegation of Antiqua and Barbuda objected. The presumptuousness of the request to place any item on the agenda of the Permanent Council by an agent of one political party in a country, and the precedent it would set, had to be resisted.

The agent's intention was to escalate an attack on Trinidad and Tobago, launched by Guaidó on November 24, regarding the recent deaths of 16 Venezuelans who had left Venezuela illegally in a boat that appeared to have In a public statement capsized. Guaidó stated: "The cruel treatment to which they (Trinidad and Tobago) subject Venezuelans who have been forced to migrate as a result of the dictatorship is pain-

ful and inhuman", and then he threatened, "Parliament will initiate an investigation and the world is watching the events in Trinidad and Tobago".

Consequently, Antiqua and Barbuda told the Permanent Council that, apart from the fact that Venezuela is not a member of the OAS, "the purported representative of Venezuela is merely the spokesperson for only one of many political parties in Venezuela. Allowing the views and positions of only one political party to be expressed in any forum of the OAS is contrary to natural justice and democratic principles since it denies a similar opportunity to other political parties in Venezu-Despite the efforts of the ela". Nonetheless, what was established is that support for the Guaidó farce is weakening as more countries opted to divorce themselves from the obvious abuse.



When Polonius asked Hamlet what he was reading and Hamlet replied, "Words, words, words" he wasn't joking at all. There are some words that do double, triple and multiple duties and, like body builders full of supplements, they have homonyms (words with identical spelling and pronunciations but with different meanings) and even homographs (same written word but different meanings). One common example is the four-letter word "love" which we apply to any object, emotion or event from spouses to cars, animals and the latest object of affection that catches our fancy. The Bible tells us to love our neighbour as ourselves but in tennis, love-all is a tie, something that I get every Christmas. Some of us love life itself and, as one of my teachers said to me a very long time ago, "Deyal, you really love to play the arse you know." And I replied, "Holy Mother of God, bray for our sinners now..." and made things much worse for mvself.

There is a category for words with multiple meanings in the

record for the word which tops the charts in this group was set by the Oxford Dictionary and it is the word "set". According to Guinness, "The word with the most meanings in English is the verb 'set', with 430 senses listed in the Second Edition of the Oxford English Dictionary, published in 1989. The word commands the longest entry in the dictionary at 60,000 words, or 326,000 characters." If you want to know some of the applications of "set", get ready, on your marks and get set. You could put something on the table so you set it down or you alue it and it is set, sometimes for life. Or it could be part of a movie set or the house in which you finally settle down. You can even set it in emeralds as a fancy bracelet or, like this article, set it in Times New Roman 12. If the 12 Old Romans ever get to find out I prefer the new ones, there will be a terrible set-to and that could set-up a war. My wife, Indranie, sets countless plants and when she tries to get me involved, I set off on some urgent business, setting an example that our daughter Jasmine sometimes follows but I really set the record, not straight, but when her face sets up at my first mention of having to go out, I leave before Indranie makes a set of noise. Despite all I've written so far about "set", the matter is not settled and there are a whole set of meanings still to come, over 400 of them. But I don't want to upset any of you so I will settle for the ones I drew to your attention.

While the Merriam-Webster

a "low shoe laced or tied over the instep", I suppose it springs from jealousy because Oxford already has the successor to "set" as the word with the most meanings waiting in the wings. In 2037, seventeen years from now, Oxford will release or complete the first print run of its newest English Dictionary in which it will set a new record with the word "Run" which will have 645 meanings in all. Right now, let me move from the low-down to a rundown of what these many meanings include. Computers "running" programmes, vehicles "running" on gas, election candidates "run" for office, and then run their mouths, or fail to run their Ministries properly and pretty soon are run out of power but not before giving you a run for your money until they run aground. Some are little runts and there was a Trinidad athlete who got so mixed up that, as my friend Bengo, disappointed by the country's poor showing in an Olympic event, observed angrily, "His mouth runs and his feet smell."

There are at least 10 words, including "go" and "put" which have hundreds of definitions. But before I go further, let me put my cards on the table and tell you that my word of choice, especially in this Christmas season, the one that I never take lightly is "light." I grew up right after the Second World War and we had to use candlelight, not just for carolling at Christmas, but for everything else. We also had "pitch-oil", paraffin or kerosene lights to read by and, the occasional "gas-lamp" but

thev cost more than we could afford. I was eight, filling water by the standpipe over the road, when the yellow truck of the Electricity Commission arrived to "connect" us with electricity and the whole neighbourhood came to watch and comment. I was elated because, as a serial reader and a reader of serials, the "torchlight" and lamplight hurt my eyes after a while. When my mother opened the door of the new fridge my father had bought, you should have seen her face light up!

However light and its mystique go back to the beginning of time

when the Lord said, "Let there be lights in the firmament of the heaven to divide the day from the night" and the faces of Adam and Eve lighted up and remained liaht thev hearted for a while until the self-conscious Eve took flight from the light. While the Three Wise Men followed a starlight, we were having fun with star-lights in the yard on Christmas Eve. Once, when my father did not pay the light bill, we faced conundrum - we were de-lighted. Everv year we celebrated Divali, the Hindu Festival of Lights, and "lighted up" for Christmas. Every morning my mother

woke up my father and I before daylight, and the light of dawn met me trudging through dewy Savannah the grass on my way to the bus-stop. Even so, and even now, I remain light hearted and delight in small victories and holidays like Christmas which set my heart alight with the combination of family present and presents, and memories of time past. This is definitely not a time, when we are allowed by wives busily "dressing up" the place, including the Christmas tree lights, to be taken lightly. It is the one time in the entire Caribbean when God, regardless of how

we call Him, is totally among us and in our hearts and minds. As Maya Angelou wrote "Amazina Peace", "Hope is born again in the faces of our children" and, in the "The Liahts of Christmas," Marjorie Morrison says,

So, Christmas lights of red and green,

Of amber, blue, and white,

We look beyond the lovely scene,

To God our Christmas Light.

factory, pulling all those factors of production together and making something of it," he said.


At the same time, Holness implored Jamaicans to be more receptive towards entrepreneurs and the value they bring to the country through the opportunities they create and the resources they garner.

## Sandals chief questions resort link to Grenada COVID-19 outbreak



(Travel Pulse magazine): Sandals Resorts International was prominent in travel news this week following a COVID-19 outbreak in Grenada that local press reports linked to the company's Sandals Grenada property. Company officials have challenged the reports, the first to connect any of the all-inclusive resort giant's properties, which have resumed operations in nine countries since the pandemic, with a coronavirus outbreak.

We spoke with Adam Stewart, the Deputy Chairman of the family-run company, among the Caribbean's largest employers and a crucial hospitality operator across the tourism-reliant region, to discuss how Sandals is handling COVID-19 risks in general and the Grenada reports.

TP: How did Sandals officials become aware of the COVID-19 cases linked to resort guests and staff?

AS: "This scenario started with our aeneral manager, Peter Fraser, executing on our Sandals Platinum Protocols of Cleanliness, created specifically to reduce the risks associated with COVID-19. Peter requested that random sample testing take place at our resort prior to any direct concern being identified as a proactive measure to ensure we are monitoring for any potential risks.

"Peter is a top-class hotelier. So when the Ministry of Health gave us three unannounced health inspections since we re-opened, the resort passed all three with flying colors. [Subsequently] Peter called several times to request random testing be conducted and finally this began last week. This is an important point, as it was the proactivity of our Sandals protocols and local management that helped to identify cases early. The tests found some positive results, though all were asymptomatic, and after secondary testing some have even come back negative."

AS: "At that point, as the investiaation and contact tracina was just starting to take place, some officials and local media began claiming this cluster's source was Sandals. This is not based on any facts or public health study and instead was speculation. As of today, the source is not yet known and we are fully supporting the contact tracing and fact-finding efforts, which are ongoing, to try to identify a source as well as any key learnings available from this situation.

# Calls for education on **COVID-19 vaccines**



Barbados MP Dr. Sonia Browne

(Barbados Nation): Barbadians should take COVID-19 vaccines seriously, but Government also has to do extensive public education, says St. Philip North MP Dr. Sonia Browne.

The medical practitioner called for public education on the issue, and also urged colleagues in the House of Assembly to lead by example in showing the public that the pandemic was not over.

She was speaking on Tuesday during debate on the Barbados Humanitarian Service Award Bill, 2020, which will see front line workers beina awarded for their work durina the crisis.

Browne, who is Chairman of Committees, said: "It's okay to tell the Barbadian public to 'take the vaccine'; 'don't mind the rumours; 'it's for your own good', but we have to spend a lot of time on education.

"It cannot be only governmental policy, we have to coordinate well with the medical professionals so that we have an educational system in place before we bring information to the public."

She said there were people who "have real fears of vaccination, ...basically because they don't understand it and we need to address that". (SC)

# Stranded Trinis home in time for Christmas

(Trindad Guardian): Over 100 Trinidad and Tobago nationals were expected back home last evening, as the Government continued its repatriation exercises for the Christmas period. In fact, over 400 nationals, some of them stranded abroad by the COVID-19 virus since the borders were closed in March, will be back before home before Christmas Day - although they will have to spend the festive season in quarantine.

During a COVID-19 meyesterday, briefing Principal Medical Officer

Dr. Maryam Abdool-Richards explained that several repatriation flights had been scheduled before Christmas Dav.

She assured that the exercises to bring nationals back home will not burden the parallel health care system, as there are available spaces throughout state quarantine facilities.

She said at present, the Ministry of Health had 13 state and state-supervised facilities with two of the facilities being reserved for high-risk populations such as the elderly and persons who may not be able to

quarantine amonast typical population.

According Abdool-Richards' timeline, hundreds nationals of from high and medium-risk countries were expected to be granted border exemptions over the coming days.

"It is important to note that we have three repatriation exercises scheduled for the next 5-6 days. This evening (yesterday), we have a repatriation exercise of approximately 132 persons from New York City. On December 18th, we have another repatriation exercise with persons from Barbados and yet another exercise on the 19th from Miami."

Abdool-Richards another exercise has also been planned to repatriate nationals from Cana-

Meanwhile, there is still no confirmation on which COVID-19 vaccine will be procured by the Government despite the fact that it is already making preparations for its arrival. Abdool-Richards said consultations were ongoing over which treatment will be the most effective.



#### Second vaccine nears FDA approval in US



(BBC World News): A US panel of experts has voted to recommend the emergency approval of a second coronavirus vaccine.

The Food and Drug Administration (FDA) is expected to follow the recommendation, which means the Moderna vaccine could start being administered in the US as early as next week.

The vote came days after the country began its rollout of the Pfizer-BioNTech

The US has recorded more Covid cases and deaths than any other country.

Earlier this week, its coronavirus death toll passed 300,000.

The advisory panel on Thursday voted 20-0 with one abstention that the benefits of the Moderna vaccine outweigh the risks for those aged 18 and over.

The same committee last week backed the Pfizer/BioNTech vaccine, leading to its authorisation for emergency use the following day.

The vote came after regulators reported earlier this week that the Moderna vaccine was safe and 94% effective.

The US has agreed to purchase 200m doses, and 6m could be ready to ship as soon as the vaccine gets FDA approval.

The Moderna vaccine requires temperatures of around -20C for shipping similar to a normal freezer.

The Pfizer jab requires temperatures closer -75C, making transport logistics much more difficult.

Like the Pfizer jab, the Moderna vaccine also requires a second booster shot. Moderna's second injection comes 28 days after

### Nigerian security forces rescue more than 300 schoolboys kidnapped by gunmen

KATSINA, Nigeria (Reuters) - Security forces on Thursday rescued nearly 350 schoolboys who had been kidnapped in northwestern Nigeria and taken into a vast forest, the governor of Katsina state said, bringing relief to many families.

It was not immediately clear whether all the missing boys had been recovered.

"I think we have recovered most of the boys," Governor Aminu Bello Masari said in a televised interview with state channel NTA.

Hours earlier a video start-

ed circulating online purportedly showing Islamist militants from Boko Haram with some of the boys. Reuters was unable to immediately verify the authenticity of the footage, the boys, or who

The abduction gripped a country already incensed by widespread insecurity, and evoked memories of Boko Haram's 2014 kidnapping of more than 270 schoolairls in the northeastern town of Chibok.

Last Friday night, gunmen raided the Government Science Secondary School in Katsina on motorbikes and marched the boys into Rugu forest, in the biggest such incident in the lawless region in recent years.

Masari said a total of 344 boys held in the forest had been freed in neighboring Zamfara state. He did not say how many had been missing or how they were freed.

He said security forces had cordoned off the area where the boys were being held and were given instructions not to shoot.

"We thank God that they took our advice and not a single shot was fired," he said.



#### Facebook Criticises Apple Privacy Policy In Newspaper Ads



(AP News): Facebook is again pushing back on new Apple privacy rules for its mobile devices, this time saying in fullpage newspaper ads that the social media giant is standing up for small businesses.

In ads that ran in The New York Times, The Wall Street Journal and other national newspapers, Facebook said Apple's new rules "limit businesses" ability to run personalised ads and reach their customers effectively".

"While limiting how personalised ads can be used does impact larger companies like us, these changes will be devastating to small business-

es, adding to the many challenges they face right now," the ad states.

The ads come after Apple said earlier this week it would begun spelling out what kinds of personal information is being collected by the digital services displayed in its app stores for iPhones and other products made by the trendsetting company.


Apple also has plans to impose a new mandate that will require all iPhone apps to obtain permission before tracking a person's activities on the device. That surveillance is currently done automatically by many apps, and would force people to go to the time and trouble to block the tracking in the settings of each app. Apple says ment.

it will oust apps from its stores if they try to bypass the new anti-tracking rule when it becomes effective next year.

In many instances, the data scooped up by apps is used to sell ads targeted at a particular person's interest and location, especially if their services are being offered for free.

Apple announced the changes were coming six months ago as part of an effort to help its customers gain a better understanding of how apps monitor their habits, tastes and whereabouts. At the time, Facebook complained that the changes would hurt businesses' ability to personalise ads.

# **Deb Haaland: Historic Native** American 'pick for Biden cabinet'



(BBC News): President-elect Joe Biden will nominate a Native American to serve as his interior secretary, leading the agency governing public lands, US media say.

If confirmed, Congresswoman Deb Haaland will be the first indigenous person to lead the department, which also plays a key role in Native American affairs.

She will also be the first Native American in a cabinet secretary role.

Native rights groups and

progressive **Democrats** had pushed for the New Mexico lawmaker's nomination in recent weeks.

"It would be an honour to move the Biden-Harris climate agenda forward, help repair the government to government relationship with Tribes that the Trump Administration has ruined, and serve as the first Native American cabinet secretary in our nation's history," Ms Haaland said in a statement guoted in the New York Times.

Ms. Haaland, 60, is a

member of the Laguna Pueblo tribe and made history as one of the first two Native American women ever elected to Congress in 2018.

Speaker of the House of Representatives Democrat Nancy Pelosi described Ms Haaland as one of the most respected members of Congress.

Fellow progressive Democratic Congresswoman Alexandria Ocasio-Cortez praised her nomination as "historic on multiple levels".

"She brings a commitment to climate and justice to the position, and the historic weight of having a Native woman, no less a progressive one, in charge of federal lands is enormous."

As Secretary of the Interior, Ms. Haaland would play a key role in implementing the administration's environmental pol-These include a icies. promise to move the federal government away from

fossil fuels. Ms. Haaland's state of New Mexico is a part of the US Climate Alliance and has already set its own bold climate goals.

Ms. Haaland also comes with two years of experience on the House Natural Resources Committee.

In all, she would oversee 500 million acres of federal lands, 62 national parks and work with 1.9 million Indigenous Americans from 574 federally recognised tribes. The interior secretary also manages the Bureau of Trust Funds Administration, which handles Native American finances, and Bureau of Indian Education.

Her appointment would also have real cultural significance, as the interior department has historically clashed with Native American groups. For instance, many of the nation's national parks, like Yellowstone, were cut out of Indigenous land by the US government.



# Macron tests positive for COVID-19, **European leaders rush for tests**



PARIS (Reuters) President **Emmanuel Macron tested** positive for the coronavirus on Thursday, prompttrack-and-trace effort across Europe following numerous meetings between the French leader and EU heads of government in recent days.

Macron, who will turn 43 on Monday, is running France remotely and has gone into quarantine at the presidential retreat of La Lanterne close to the Palace of Versailles, the

presidency said.

A presidential official described Macron as tired and having a cough. His wife Brigitte tested negative but was also self-isolating, staying at the Elysee palace in central Paris.

In the early evening, Macron spoke to a conference on French foreign aid policy via video link. Dressed in a roll-neck sweater and suit jacket, the president sat behind a desk and wore a facemask, showing no visible sign of the illness.

"This diagnosis was made following a PCR test performed at the onset of the first symptoms," Macron's office said, declining to give further details of his condition or the symptoms he had.

Macron will cancel all upcoming trips including a Dec. 22 visit to Lebanon where he has led international efforts to resolve a deep-rooted political crisis.

Closer to home, Macron's COVID-19 infection spurred other leaders to take their own tests.

Macron joined all but two of the European Union's 27 leaders at a summit in Brussels late last week to discuss climate change, the EU budget and Turkey.


The presidential official said it was almost certain Macron was infected at the summit given the timing of his symptoms.

Macron, German Chancellor Angela Merkel and others were seen initially mingling in the summit room with their face masks on, and Macron was filmed giving fist-bumps to other participants. The German government said Merkel tested negative for the coronavirus after the EU summit.

More recently, Macron had lunch with European Council President Charles Michel, Spanish Prime Minister Pedro Sanchez and OECD chief Angel Gurria on Monday. He also held talks with Portuguese Prime Minister Antonio Costa on Wednesday.







# Serena, Federer eye special 40th birthday gifts in 2021



Federer has Roger his eyes on an elusive singles Olympic gold medal.

This is despite fears over his long term fitness as he endured a 2020 wipeout and saw Rafael Nadal equal his record of 20 Grand Slams.

Federer played just one tournament this year, a bumpy run in the semi-finals of the Australian Open, before knee surgery put him on the sidelines.

On tour since 1998, Federer will be 40 on August 8, just a week

after the men's final at the rescheduled Tokvo Olympics.


Federer said his plan is to be there for the Olympics.

# **Manchester United striker charged** by FA for social media post



Manchester United striker Edison Cavani has been charged with misconduct by the Football Association (FA).

The charge results from Cavani's comments in an Instagram story left by a friend after United's 3-2 win over Southampton on November 29 in which he scored twice.

The social media language used by Cavani could be deemed racially insensitive.

Uruguay international Cavani used a Spanish phrase in the post, which was later deleted after he was told of its potential to cause offence.

The FA opened an investigation and on Thursday

announced the 33-yearold had been charged with bringing the game into "disrepute".

The FA statement read: "It is alleged that, contrary to FA rule E3.1, a comment posted on the Manchester United player's Instagram page was insulting and or abusive and or improper and or brought the game into disrepute.

"It is further alleged that the comment constitutes an agaravated breach, which is defined in FA rule E3.2, as it includes reference, whether express or implied, to colour and or race and or ethnic origin."
