### **Apartheid in a time of COVID redux**

Permit us, dear reader, to do a revisit of the last editorial of the similar title as this one, published on Monday 8th February. We at *PointeXpress* are not in the business of beating dead horses, but we strongly believe that something more needs to be said about the system of 'vaccine Apartheid' that is being proposed by Western hegemony.

The previous article placed the issue in a historical context which helped to demonstrate that the manner in which Europe and North America (including Canada) are behaving is nothing new. The point was further made that the behaviour is not dissimilar to that of Donald Trump, a president from whom many leaders in the West tried to distance themselves. But the measure of an individual is never to be in the words that wax lyrical from their lips. Instead, a person should be measured by their actions.

For reasons of brevity, it was neigh impossible to segue into the relationship between vaccine Apartheid and reparatory justice. And while one might argue that the link is tenuous at best, we aver the opposite to be true.

If one were to examine the philosophical underpinnings of the move to monopolize access to the vaccines, one would realize that these underpinnings also emboldened the West with

a sense of entitlement that somehow some lives are more valuable than others. It was the philosophy that led to the genocide of the indigenous peoples of the Americas, the Trans-Atlantic Slave Trade, the various economic and 'drug' wars being waged against Africa and Latin America, the blockade of Cuba, and many, many more examples.

In the case of the European enslavement of West African peoples, the case has been made for reparations for the hundreds of years of forced labour, which labour enriched Europe. One does not have to dig very deep to understand the atrocities inherent in the dehumanization of millions of people. A key argument used to justify the enslavement of West African peoples held that Africans are naturally inferior to Europeans. Therefore, even if slavery is cruel, the suffering of slaves is no different from that of an animal. Africans, then, were believed to be so inferior that they deserved

to be enslaved for their own good. Consequently, the thinking goes, slaves are better protected and cared for in a system where

their lives are run by others. Gentle reader, in that explanation you have the nucleus of the argument of how racism took

root in society. At the end of the Trans-Atlantic Slave Trade, compensation was paid to the White owners for 'loss of property'-their slavesbut not one kobo was paid to the people who were forced to work for free. It was the case of White being Might being Right! It is this philosophy that drives the

current vaccine Apartheid.

The reason why descendants of enslaved Africans must continuously call for reparatory justice is that it helps to correct the injustices of the past and allows descendants to develop a foundation for self-sufficiency, and not one of dependency. Just and equitable access to vaccines is also a part of the struggle for reparatory justice as it assists in neutralizing the ideology that some lives are more valuable than others-the kind of ideology that underpins racism. Left unaddressed, it would lead to what Emperor Haile Selassie I warned about in a famous speech before the United Nations General Assembly on 4th October 1963:

"That until the philosophy which holds one race superior and another inferior is finally and permanently discredited and abandoned; That until there are no longer first-class and second-class citizens of any nation; That until the colour of a man's skin is of no more significance than the colour of his eyes; That until the basic human rights are equally guaranteed to all without regard to race; ... Until bigotry and prejudice and malicious and inhuman self-interest have been replaced by understanding and tolerance and good-will; ... We Africans will fight, if necessary, and we know that we shall win, as we are confident in the victory of good over evil."

Simply put: a passive war for fairness and equity.

## Antigua and Barbuda to receive 40,000 COVID-19 vaccines from India

As the race increases for COVID-19 vaccines around the world, Indian High Commissioner Dr K. J. Srinivasa announced that Guyana and several other Caribbean countries will benefit from an initial donation of 500,000 Oxford-AstraZeneca vaccines by the government of India, as the south Asian country 'ups the ante' on its vaccine-diplomacy efforts.

According to news reports in Guyana, "On Monday, during a virtual engagement with members of the media, Indian High Commissioner to Guyana and the Caribbean, Dr K. J. Srinivasa noted that a quantity of these vaccines are already being transported."

"I am working closely for the number of vaccines for Guyana, Antigua, St Kitts and many other countries in the region," Dr Srinivasa highlighted.

Chief of Staff in the Office of the Prime Minister, Ambassador Lionel 'Max' Hurst, confirmed that 40,000 vaccines are designated for Antigua and Barbuda. According to the Chief of Staff, "The government of India wrote to the government of Antigua and Barbuda that they are pleased to send 40,000 Covishield (AstraZeneca-Oxford) vaccines to our country (manufactured by Serum Institute of India) as a donation and goodwill gesture to our friendly nation in the region."

Media reports have indicated that currently, the High Commission is working with the local health authorities in Guyana to get approval for this Oxford-AstraZeneca vaccine, which is called Covishield in India.

The Oxford-AstraZeneca vaccine is reportedly sixty-two per cent effective. However, it is also reportedly ninety per cent effective with a lower dose than the required two doses.

The High Commissioner, who is also India's representative to the Caribbean Community (CARICOM), said that India is trying to work out a common procedure whereby Caribbean countries can work in tandem for this approval process.

While the 500,000 vaccines being donated to the Caribbean is just an initial amount, Dr Srinivasa emphasized that India wants to provide some support to all of the "friendly countries" in the region. This, he explained, is a core component of India's vaccine-diplomacy efforts.

India is a renowned manufacturer of vaccines and has been dubbed the 'pharmacy of the world.' Beyond the Oxford-AstraZeneca vaccine, which is being manufactured by the Serum Institute in India and is already being distributed in that country, there are about five other vaccines being developed in India.

The Covaxin vaccine, being manufactured by Bharat Biotech International Limited (BBIL), is one such vaccine. This vaccine has already been granted emergency-use authorization in India and is being distributed to health workers, though its clinical trials are not yet complete.

Obtaining vaccines from this country is not limited to those doses being donated, however. There are also avenues for governments to purchase vaccines from India.

"Our external supplies which are either gifts or commercial supplies are based on our domestic requirements, but we continue to work closely with our partner countries and we are preparing a schedule [whereby] in the coming weeks and months in a phased manner, these countries will get their vaccines," Dr Srinivasa said.

The country has been donating several million vaccines to a number of countries as of this year.

# Thirty-four new confirmed cases

The Ministry of Health and the Mount St. John's Medical Centre (MSJMC) are reporting that there are thirty-four (34) new laboratory confirmed COVID-19 cases in Antigua and Barbuda as of Tuesday 9th February 2021. Of the two hundred and fifty-two (252) samples pending in the previous dashboard, fifty-one (51) were sent to MSJMC. The two hun-

dred and one (201) samples which were sent to CARPHA are still pending.

Subsequent to the publication of the dashboard for Monday 8th February 2021 with the cut off time of 6 p.m., fifty-six (56) additional samples were processed by MSJMC.


Therefore, the total samples processed by MSJMC is one hundred and seven (107) of which seventy-three (73) were negative and thirty-four (34) positive. The thirty-four(34) cases are non-import-ed. Investigations have be-gun and contact tracing andtesting are ongoing.

The fifty-six (56) additional samples are reflected in the total samples taken and total persons tested columns of the dashboard.

Meanwhile, one recovery has been recorded bringing the total to one hundred and ninety (190). One non-imported COVID-19 related death has also been recorded.

Six (6) additional persons have been hospitalized bringing the total to thirty-four (34)

Consequently, the total number of persons with laboratory confirmed COVID-19 cases in Antigua and Barbuda is three hundred and fifty (350), which is inclusive of one hundred and fifty-one (151) active cases.

### Sixty-five-year old man latest COVID-19 victim

Mount St. John's Medical Centre (MS-JMC) has confirmed the death of a sixty-five-year-old patient due to COVID-19-related illnesses.

The health institution said the patient was admitted to the hospital on 23rd January 2021 in severe respiratory distress. His illness was complicated by several comorbidities. His health continued to deteriorate, and he was placed on a ventilator seven days post admission. Despite the medical team's best efforts to save him, the patient died of complications of COVID-19 on 8th February 2021.

"Another family and community are mourning the death of a loved one and we too are saddened and offer our deepest sympathy," said Dr. Albert Duncan, MSJMC Medical Director. "Our hospital is doing everything we can to stay ahead of the coronavirus surge in the community which inevitably leads to more hospitalized COVID-19 patients."

According to Dr. Duncan, the hospital is under more pressure from COVID-19 than at any time since the start of the pandemic. "This is worrisome," said Dr. Duncan. "This is what will put everything - all healthcare related to COVID-19 or not - at risk if the infection rate does not slow down."

The Medical Director added, "Since the onset of the COVID-19 pandemic we have asked a lot of the public and many of you have been understanding and patient and we are immensely grateful. Still, the risk remains, COVID-19 cases continue to rise across the country and have affected even members of the hospital's team and their families. It is critically important that we remain vigilant. Increased testing is great but testing alone is not sufficient in keeping this pandemic at bay. Don't drop your guard because of a negative test result. Mask wearing, physical distancing and other preventive behaviours are still crucial. We will maintain our efforts, and our ongoing resourcefulness in how we do our work, in order to keep our community safe."

Mount St. John's Medical Centre is reminding the public of the continuing importance of COVID-19 precautions. For persons who believe they may have COVID-19, they are asked to take these steps:

 Stay away from other people to avoid spreading the virus - and contact your doctor, especially if you have a high-risk underlying

# Italian philanthropist to fund Sir Novelle school's expansion

The Sir Novelle Richards Secondary School is to undergo major expansion over the next few months through a generous donation from an Italian businessman and philanthropist.

Making the announcement in Parliament this week, Minister of Education, Sports and Creative Industries, Daryl Matthew, said that following overtures from government the businessman, Leonardo del Vecchio, who is the founder and chairman of Luxottica, the world's largest producer and retailer of alasses and lenses, with 77,734 employees and over 8,000 stores, made a donation of US\$1.5 million (EC\$4 million).

"Over the weekend, the government received confirmation from del Vecchio's representatives who want to sign off on the donation this week Friday. Construction on the project is imminent as the ministry has all the drawings for the project which will see the addition of a new wing at the school, which will allow it to fully accommodate all students up to CAPE level," Matthew stated.

He said the Ministry of Works is currently working along with the Ministry of Education and he hopes that construction will start quite soon. He is also promising that the extension will be completed in record time, similar to the way in which the original school plant was completed within a ten- to twelve-week period.

"Based on the timeline in which the original construction was completed this will serve as an example for us. My predecessor did an excellent job and I now have a big shoe to fill. The benefactor wants to return to Antigua in August and he wants to see the project completed in that time," he explained.

The minister also announced that the development at the Sir Novelle Richards will not stop with the addition of a new wing. He said there are plans to add a state-of-the-art science laboratory at the institution. "We have already secured funding from the Caribbean Development Bank to construct and fully equip the science lab," he revealed.

According to Minister Matthew, the Sir Novelle Richards Secondary is not the only educational institution that has attracted private sector funding. The Antiqua and Barbuda Institute for Continuing Education (ABICE) is receive a donation from the principals of the Peace, Love and Happiness (PLH) development in Barbuda, who want to vastly improve the physical plant and the course offerings at the institution.

### Vendors may get some slack for now, but changes are coming

The St. John's Development Corporation (SJDC) will this year place an increased focus on management of the city, according Minister for Tourism Charles Henry Fernandez.

The minister, who has portfolio responsibility for the SJDC, made the remarks on Tuesday during his contribution to the 2021 budget debate in the House of Representatives.

He had earlier reported that stayover tourism arrivals for 2020 were fifty-eight per cent lower than the previous (and record-setting) year, due to the economic devastation caused by the COVID-19 pandemic. Providing figures, Fernandez said the number of stayover arrivals had "contracted from over 300,000 in 2019 to 125,318 in 2020 ... a fifty-eight per cent decline ..."

He added that "performance of the cruise industry last year was even more catastrophic ... During this catastrophic pandemic year we recorded 259,426 passengers - all during the first quarter of 2020. This was a sixty-five per cent decline from the previous year. The yachting sector was the least affected. Due to the many yachts spending months of lockdown here, the yachting visitors [declined by thirty per cent] at the end of 2020

to 13,268 from figures of 19,074 in 2019."

He noted that SJDC in 2020 had "suffered from the downturn, the closure of the cruise port, and this severely affected its cash flow." But despite this, he said, more attention will be paid to "vending, infrastructure and general aesthetics."

On the subject of vending, Fernandez suggested that authorities need to be flexible and avoid being too harsh or draconian when confronting the challenges it sometimes poses to order and regulation.

"Because of the pandemic, we have to be careful how we look at vending. There are a lot of families ... a lot of people out there that would tell you they have it very hard, and you'll see a number of places that have popped up. People have it really hard. So, what do you do? Do you lock them down and say 'this has to be this way'? Or [do you] give some kind of ease at this point in time? We're trying to balance it ... We realize the importance of it to people and we are allowing it to go on; at the same time trying to see how we can manage it."

Fernandez added that SJDC would "continue its mandate to guide the implementation of a program for the renewal and modernization of the city of St. John's, bearing in mind its cultural and architectural history."

He noted that the planned construction of a

sewage treatment plant for the capital would be a key upgrade in the city's quest for further modernization.

"As the nation prepares to celebrate its fortieth anniversary of Independence, John's Development St. Corporation will coordinate general improvements throughout the city ... intended to result in major aesthetic improvements in the City of St. John's. The Corporation will ensure that the City of St. John's is well maintained, attractive, and continues to be viable for all stakeholders."

Going forward, registration will be a must for all vendors, the Minister announced. "Not saying we're going to remove them off the street, but all will be required to be registered with the Corporation to ensure that the Government and other statutory bodies increase oversight of these activities. Vending will also be done in a way to ensure that all operators are in compliance with the established COVID-19 protocols."

St. John's Development Corporation, in 2020, will also "seek to have renovation commence on the Multi-Purpose Center" which Fernandez described as being "in need of urgent repairs."

He disclosed that assistance would be sought from the People's Republic of China which provided the facility many years ago as a gift to Antigua and Barbuda.

### Diaspora Desk to strengthen ties with overseas nationals

The Ministry of Foreign Affairs has established a Diaspora Desk whose mandate is to implement government's policy for closer ties with nationals living in the United States, Canada, the United Kingdom and elsewhere. Portfolio Minister E.P. Chet Greene told the House of Representatives that over the past year a number of meetings were held with a number of stakeholders within the diaspora to plan the 2021 Diaspora Programme which culminates with Antigua and

Barbuda's fortieth anniversary of Independence. "Beginning last year, we embarked on a programme of reaching out to our diaspora communities. The focus is to transition and transform the relationship with these communities and their native land. It's not just about remittances; it's about meaningful investment in the national economy. It's about preserving our culture among the second, third and fourth generations in the diaspora," he remarked.

According to Greene, the Diaspora Desk has held a number of consultations and meetings with various diaspora communities with another meeting slated for next week Friday. The first major engagement between the Diaspora Desk and the diaspora communities is being planned for Independence this year. "2021 will mark the fortieth anniversary of Independence and the need for the ministry to make a more concerted effort to foster stronger relations with Antiguans and Barbudans in the diaspora. Our first diaspora business forum will take place this year on the occasion of the Independence celebrations," he noted.

Greene views these developments as 'the best opportunity' to engage nationals living overseas in the nation's development in a meaningful way. The minister gave a commitment that the government is serious about finding pathways for members of the diaspora to fully participate in the nation's growth and development.

### 'Vampire Killer' shares his side of the story in wounding trial

The trial against alleged 'Vampire Killer' Delano Forbes continued yesterday in the St. John's Magistrates' Court where the 26-year-old got the opportunity to tell the court what happened on October 7th within the Her Majesty's Prison. The Sweetes man is accused of wounding a prison officer by the name of Dwight Peters on that day with a disinfectant can.

On January 25, the complainant, another prison officer and a police investigator gave evidence in the matter.

Peters said that it was Forbes' bad behaviour that prompted him to try to shackle the murder accused.

But the prisoner refused and another officer by the name of Alpheus Jackson tried to assist. He said that Forbes then slipped on some water and pulled Jack-

son down with him and started to wrestle on the ground.

Peters said that when 6 stitches and he bent down to restrain off from work.

him, the prisoner struck him in his head resulting in an injury that required 6 stitches and a week off from work. Jackson also gave similar evidence and an investigator, Javid Alfred corroborated their story. Forbes however, had a different story to share yesterday in court. He said that he asked

Peters to let him see the Superintendent of Prison but was denied.

As a result, he refused to be restrained.

Forbes continued saying that Jackson entered and also tried to shackle him but he slipped and fell to the ground.

He said when Peters tried to shackle him on the floor, he hit his dead on a table.

Since Forbes choose to give evidence from his defense box, prosecutors were not allowed to question him.

The trial therefore came to an end and February 16 was set as the date for the Magistrate to return her decision in the matter.

The management of Client Communications Services (CCS), a tenant operating out of Canada Place, has adopted "proactive and

definitive" steps to ensure the health and safety of its employees - and by extension, other building tenants - by immediately enacting their work-fromhome (WFH) policy.

"Out of the abundance of caution and until further notice, the company's staff complement has been informed that it has begun implementing the necessary steps to ensure they can effectively work from home, by providing the requisite tools and equipment to facilitate the process," a company statement said.

It noted that this is the second time that the gravity of the COVID-19 pandemic has forced tenants of Canada Place, located at Lauchland Benjamin Drive, to enact their WFH contingency plans. "Like other Canada Place tenants, CCS had to make the decision of advising staff to work remotely, after confirmation that a worker in the building tested positive for Covid-19. That individual has since been isolated," it revealed. The release said that as a responsible organization, CCS has been strictly complying with all the protocols set out by health officials, including temperature checks at entrance, insisting on the wearing of company-provided masks and shields correctly and at all times, and consistent sanitizing of high touch surfaces.

The company's administration also employs several office procedures in managing staff who may have potentially been exposed. "CCS wishes to assure its employees and the public of its commitment to safety, transparency and reducing the spread of the virus, as we all navigate this COVID-19 pandemic," the statement concluded.

The new measures took effect on Monday this week.

# Jamaica woman pleads guilty to sister's murder

(Jamaica Observer): Thirty-nine-year-old Nadeen Geddes yesterday pleaded guilty in the Hillary session of the Trelawney Circuit Court to the murder of her sister, thirty-six-year-old Tamara Geddes, who was shot in her bedroom in the Reserve community in the parish last year.

The thirty-six-year-old Geddes was reportedly gunned down in the presence of her ten-year-old daughter on Friday 19th June 2020.

Monday, Nadeen's two daughters—twenty-one-yearold Shanice Ruddock and a fifteen-year-old—also pleaded guilty to the charge of misprision of a felony in the case when they appeared

before Justice Martin Gayle. They were both offered bail in the sum of \$100,000 with surety by Justice Gayle.

Rexon Knott, twenty-four, another defendant, who was jointly charged with murder and conspiracy to murder in



the matter, pleaded not guilty and was set free as the court had insufficient evidence to proceed against him.

However, the court heard that co-accused Brian Shelly, Owen Irving, and Tashana Young, whose files were incomplete, were remanded in custody until Monday 22nd February.

Both Geddes and her two daughters are expected to return to court on Friday 26th February for sentencing.

Meanwhile, before the start of the matter involving her sister's killing, Nadeen Geddes also pleaded guilty to conspiracy to murder thirtythree-year-old Tennisha Miller of Carey Park, also in Trelawney.

Miller is now facing the capital charge for the fatal stabbing of Nadeen's brother, thirty-eight-year-old Gregory Geddes, a raft captain of Reserve district. The raft captain was killed during a dispute with Miller at a bar in Martha Brae in December 2019.

Yesterday, Ernie Smith, who represented Ruddock in court, indicated that on the day of her sentencing he will be seeking leniency on behalf of his client.

"She had been set for sentencing for the 22nd of February, but in the meantime his lordship has offered her bail of \$100,000 until the matter comes up for sentencing. I will be making a certain application to his lordship and suggestions as to what ought to be the most appropriate sentence to be imposed in all the circumstances," Smith told reporters.

"It was clear from the evidence that she knew that her mother had done something wrong with others, but unfortunately she did not tell the police. She did not tell the police, firstly, out of respect for her mother and, secondly, out of fear, being a young person. She was twenty at the time.

"So, having regard to the nature of the evidence that was before the court, she entered a plea of guilty to imprison of felony; in a nutshell what that means is that knowing that a felony had been committed, she did not make a formal report to the relevant authorities," he said.

The Hillary session of the Trelawney Circuit Court commenced yesterday with fifty-two cases on the list, including seventeen new cases and thirty-five traversed.

Murders and lottery scamming offences topped the list.





# Guyana: Govt. engineers will be fired for sloppy project estimates



(Kaieteur News): "Government engineers are not being paid to waste taxpayers' dollars." This was the assertion of Minister of Public Works, Juan Edghill, as he made it clear that the government is prepared to sever ties with those engineers who prepare sloppy estimates. Sloppy estimates, the Minister explained, can eventually result in contractors being overpaid for works under government projects.

The minister, who was at the time responding to a question during a telephone interview with Kaieteur News, pronounced on the PPP/C's plan to prevent overpayment on contracts. Under the previous administration, the Ministry of Public Works (then Ministry of Infrastructure) was flagged by the Auditor General (AG) for instances of overpayment.

But the PPP/C, while in government previously, had committed similar indiscretions, which were also cited by the AG.

Minister Edghill is of the firm belief that the administration in its current form will not misuse tax dollars. Achieving this, he said, will be guided by looking at some key areas.

### Substandard estimates

Edghill explained that for a contractor to be overpaid for works, the engineer designated to that project would have had to conduct substandard estimates and evaluations. He said, that includes over-measuring and, in some cases other miscalculations, and engineers simply not being on the work grounds to execute their duties. The role of a government engineer is to manage these projects and ensure correct calculations are made.

The minister noted that for a contractor to receive money, someone has to sign off on the works conducted and ensure they are done at the right volumes, and that person is the engineer. Any engineer who signs off on work and is found to be absent from the work grounds, inherently failing to ensure proper estimates are done, will be fired and dismissed from the project immediately, according to Minister Edghill.

Government engineers, he added, are not being paid to "simply hand contractors money." They are therefore expected to ensure they save public funds from being expended wildly by doing proper estimations.

### Overpayment on contracts and repayments

Minister Edghill also acknowledged the previous administration's failure to collect monies overpaid to contractors on projects. He noted that the Public Works Ministry would be robustly going after overpayments made on projects.

In the 2019 AG report, it was revealed that the

previous administration overpaid some \$166 million of taxpayers' dollars on contracts. The report stated that several Ministries, government departments and regional administrations were found to be doing so. The Public Infrastructure Ministry accounted for \$63.7 million, and \$73.7 million was overpaid by regional administrations.

In the report, it was noted that as of September 2019 only \$20 million was recovered meaning that a significant portion is still outstanding.

### Zero tolerance policy for non-repayment

Edghill listed his administration's third principle as a zero-tolerance policy for non-repayment from contractors. He spoke about contractors who refuse to repay overpaid funds to the state, noting that once a contractor refuses to repay the overpaid sum, they cannot be considered for future projects from the government.

Additionally, Edghill had previously said that once a contractor refuses to repay, his administration would pursue all avenues to recover the sums, which include pursuing legal action if necessary.

Since taking office in August last year, Edghill's ministry would have dismissed a number of contractors from projects who were guilty of delayed works.

The ECCB launched its family of EC polymer notes in May 2019 with the new \$50. The \$100, \$20 and \$10 have since been issued.

The release of the five-dollar bill, which was initially projected for September 2020, has been delayed due to a decrease in demand for the note.

The Acting Director of the Currency Management Department Rosbert Humphrey, says that although five-dollar notes are in circulation more than any other denomination, it is the least demanded note.

Humphrey further explains that the polymer five-dollar notes may not be issued in all of the ECCB member countries at the same time, as the commercial banks in each country have a different level of stock which would determine when the new notes are released.

Humphrey also encourages the public to continue to take care of the EC polymer banknotes.

He advises against creasing, crumpling and applying heat, as these actions can compromise the features of the polymer banknotes. "It's your money, take care of it," Humphrey says.

### Volkswagen is exploring flying vehicles in China

(CNN): Volkswagen (VLKAF) is looking into flying vehicles in China, becoming the automaker latest to probe the possibilities of personal air travel. Europe's largest automaker said in a statement on Tuesday that "vertical mobility" could be the next step after self-driving technology. "Therefore we are investigating potential concepts and partners in a feasibility study [in China] to identify the possibility to industrialize this approach," it added.

China is the world's largest autos market and is also Volkswagen's single biggest customer. The news comes as the German carmaker makes a big push into electric cars. It delivered more than three times the volume of battery electric vehi-



cles last year than it did in 2019, while plug-in hybrid deliveries surged one hundred and seventy-five per cent to 190,500 units. But "vertical mobility" throws up many more than hurdles electric mobility, including safety and reliability. Flying vehicles would need to operate in crowded airspace, near small drones and traditional airplanes, and would also need a

regulatory framework, which could take years.

In an interview posted to LinkedIn on Tuesday, head of Volkswagen China Stephan Wöllenstein told Volkswagen chairman Herbert Diess that the company also plans to develop a drone that could be licensed, which would help it to participate in the future market for individual mobility "that's taking place up in the air and not down on the streets." Volkswagen joins a growing list of companies exploring the potential of flying vehicles. At the Consumer Electronics Show in Las Vegas last month, Uber (UBER) and Hyundai (HYMTF) unveiled plans for an electric flying taxi. Meanwhile, companies

such as Porsche (POAHF), Daimler (DDAIF) and Toyota (TM) have all backed startups in what is known as the electric vertical takeoff and landing (eVTOL) industry. In September, Japanese company Sky Drive Inc. conducted Japan's first public demonstration of a flying vehicle. And Ger-

many's Lilium, which is also developing an eVTOL aircraft, in November announced its first US hub near Orlando, Florida.

### U.S. Justice Department asks most Trump-appointed prosecutors to resign

(**Reuters):** The U.S. Department of Justice on Tuesday asked most federal prosecutors appointed during former President Donald Trump's term to resign, though a few handling politically sensitive Trump-era investigations are expected to remain in place.

While most top prosecutors will depart, as is routine when a new president is elected, Acting Attorney General Robert Wilkinson intends to ask Delaware U.S. Attorney David Weiss, who is overseeing a tax probe of President Joe Biden's son Hunter Biden, to remain in office, a department official told Reuters.

John Durham, appointed as special counsel by former Attorney General William Barr to investigate the origins of federal investigations of links between Trump, his entourage and Russia, will also continue his work but will resign his position as U.S. attorney in Connecticut, the official said.

"We are committed to ensuring a seamless transition," Wilkinson said in a statement.

A second law enforcement official told Reuters that the Justice Department is also expected to ask Michael Sherwin, the acting U.S. attorney for the District of Columbia to continue to play a major role in overseeing his office's investigation into the 6th January Capitol siege.

The White House on Tuesday said the decision to leave in place a few officials who are handling sensitive investigations underscored Biden's commitment to maintaining an independent Justice Department.

"The president has also made clear that he wants to restore the independence of the Department of Justice and to ensure it remains free of any undue political influence," White House Press Secretary Jen Psaki said.

Meanwhile, U.S. senators are also reviewing applications for possible U.S. attorney candidates, staff in several congressional offices told Reuters.

Customarily the two senators from each state help vet candidates and must sign off on the nomination before it can proceed, though that practice fell by the wayside during the Trump administration.

## Ghana Parliament shuts down over COVID outbreak among MPs, staff



(Aljazeera): Ghana's parliament has shut down for at least three weeks over a surge in coronavirus cases among lawmakers and staff.

At least seventeen members of parliament and one hundred and fifty-one support staff have been infected with the coronavirus, which had already forced lawmakers to limit their assembly meetings.

The speaker of the house, Alban Bagbin, announced on Tuesday that the legislature would be in recess until 2nd March to make way for "disinfection and sanitization of the premises."

"I have, in consultation

with leadership, decided that sitting of the House be adjourned for three weeks," said Bagbin, adding that parliament's appointments committee would continue to meet to consider the ministerial nominees of President Nana Akufo-Addo, who was re-elected in December. The West African country has reported 73,003 coronavirus cases, including four hundred and eighty-two deaths, since the pandemic began.

Large social gatherings such as funerals, weddings and parties are banned and the country's land and sea borders have remained closed to human traffic since March 2020 while beaches, night clubs, cinemas and pubs continue to remain shut.

Last month, Ghanaian soldiers were forced to intervene in parliament to quell a clash between opposing parties in chaotic scenes during the vote for the speaker.

The new parliament is split down the middle between the two main parties, posing the risk of political gridlock.

### Myanmar coup: Police fire rubber bullets as protesters defy ban

Police in Myanmar have fired rubber bullets during a demonstration in the capital Nay Pyi Taw, as thousands defied a ban on protests. Water cannon and tear gas have also been used against protesters, but reports of live bullet usage are unconfirmed.

One woman is in hospital in a critical condition with a head wound.

Protesters are standing against a military coup that removed the elected government last week. Tuesday was the fourth consecutive day of protests. A ban on large public gatherings and night-time curfews has been instigated in some cities, with military leader Min Aung Hlaing warning that no-one is above the law.


The demonstrators are demanding the release of elected leader Aung San Suu Kyi, along with senior leaders of her National League for Democracy Party (NLD). She was arrested when the military seized power and declared a yearlong state of emergency on 1st February.

The NLD said its party headquarters in Yangon had been "raided and destroyed" by the military. In its first acknowledgement of the protests, Myanmar's state TV said police had also been injured while trying to disperse "aggressive" protesters. It said a police truck was destroyed in the city of Mandalay.

Yangon resident Nelly, eighteen, (not her real name), described the scenes outside her house as "total chaos." "My biggest fear is our safety, because there are lots of people on the roads protesting but there is also a lot of violence from police officers. We don't know when we'll be shot at or when they will arrest us," she told BBC Outside Source on World Service radio.

Earlier on Tuesday, police began using water cannon against protesters in Nay Pyi Taw - but the crowd refused to retreat. "End the military dictatorship," people yelled. Some threw projectiles at police, witnesses said.

Warning shots were eventually fired into the air, before rubber bullets were fired at protesters. According to BBC Burmese, who spoke to an unnamed medical officer from a Nay Pyi Taw hospital, a woman suffered a serious head injury and another demonstrator had chest injuries. It is not yet clear how exactly they were wounded.

JOHN'S Antigua, ST. February 9th, 2021 - 105 million persons around the world have been ravaged by the merciless hands of the global adversary, the corona virus. After almost a year following hospitalization, physiotherapy and lots of prayers and will power, Keith Dover, APUA inet Technician and one of Antiqua and Barbuda's first COVID-19 victims returns to work!

Dover was featured in APUA's internal newsletter, the Pulse, where he shared his story about his experience with COVID-19. "I was in ICU on [a] ventilator for 9 weeks and then moved on the ward for 4 weeks," Keith recalled. "There were times when my emotions got the better of me but with good family and friends around me I kept going". His story is one that echoes across many countries around the world. It's a story of faith, strength and sometimes immeasurable pain. "It [COVID-19] affects every part of your body. It has the potential to cause negative long lasting

effects to your body; it is here to kill."

As of Tuesday February 9th, 2021 Antigua and Barbuda records its 8th COVID-19 related death. But today APUA celebrates life, the return and recovery of its very own. Dover is now working in an office setting for the first time in 22 years. He is presently training and learning about all the software and programmes that run the Installation and Repairs Department within the Telecomms Business Unit.

Keith appeals to his colleagues to "Stay safe, be responsible... Don't let your guard down with this virus. It is not just a flu or common cold... Follow the protocols and let's ride this thing out until it goes away. Let us take care of ourselves and those around us."

APUA welcomes back Keith and wishes him all the best in his continued recovery. The Authority continues to urge members of the public to adhere to the nation's COVID-19 protocols and wishes all continued safety.

# Government enjoying a fruitful partnership with CWI



In his presentation in Parliament on Monday Minister of Sports, Daryl Matthew, highlighted the successful relationship the government has been enjoying with Cricket West Indies (CWI).

The government of Antigua and Barbuda entered into a partnership with CWI to purchase the former Sticky Wicket property, now rebranded as the Coolidge Cricket Ground. Matthew noted that the opposition United Progressive Party have been criticizing the project, claiming it was a bad investment.

But the former president Antigua of the and Barbuda Basketball Association unearthed the facts, pointing to CWI US\$47,209,147 the have invested in the local economy over the past three years. Matthew, known for his participation in sports as an administrator and player, said the investment was evident in salary and wages, customs duties, sales tax, match fees, deductions to statutory bodies, CWI A team tour, security and much more.

The Minister of Sports stated the nation is in line to host cricket every month for 2021, simply because the government has invested in facilities, supported CWI, and put protocols and procedures in place to host cricket in a safe environment.

The Super50 is presently being played at the Coolidge Cricket Ground and the Sir Vivian Richards Cricket Stadium, while being broadcast on ESPN all across the world, Matthew explained.

Hoteliers have also seen tangible benefit through increase occupancy at a time when numbers have generally been low. Some hotels will have no less than one hundred rooms occupied over the next thirty days, the minister said.

Sri Lanka will be touring the region in March with the entire tour being facilitated right here on island, Matthew noted. Matthew said plans are in place to establish a studio at Coolidge that will be utilized to record, edit, and broadcast West Indies cricket all over the world.

The partnership with CWI has been a resounding success and is a testament to the government's dedication, vision, competency and understanding of the role cricket has played and continue to play in the life and culture of Antiguans and the region.

# Yasco will be completed in two weeks

Education, Minister of Sports, and Creative Industries, Daryl Matthew, said that the Yasco Mundo track will be completed in two weeks with the technicians presently on island working daily. They are being assisted by members of the Antiqua and Barbuda Defense Force.

Matthew rebuked criticism from a local sporting organization, who in their January newsletter pointed to the completion of the Antigua and Barbuda Labour Party headquarters, located west of Yasco, while the track remained incomplete.

The Wings Sports Club attempted to chide the government for not finishing the country's main track and field facility. The club accused the government of using COVID-19 as an excuse. However, the pandemic and subsequent lockdown of the country on 13th March 2020 brought sports and other public projects to a halt, including the laying of the track.

The newsletter failed to indicate that two technicians had previoulsy started work on the track but, because of the worldwide coronavirus outbreak, requested to leave immediately, fearing being stuck in Antigua away from their families.

Matthew said since then the government, through the Ministry of Sports, has been in regular contact with representatives of Mundo and has kept the media updated.
