Local News Browne defends parliamentarians' salaries, benefits

prime minister has spoken up in defence of the salaries and benefits which the remuneration form packages of the members of his Cabinet and other parliamentarians.

Gaston Browne sparked national debate when he revealed at the weekend that some members of his Cabinet had requested a pay raise.

Many people hold the view that even if a raise

is deserving, now is a most inopportune time to even entertain that discussion as unemployment and under-employment as a result of the COVID-19 pandemic are still major issues for hundreds across the nation.

The overwhelming view on various discussion forums appears to be that ministers of government should be making personal sacrifices at this time in a show of solidarity with

> Prime Minister Browne, however, says that ministers, and other members of parliament, do not make nearly as much as people perceive and added that even perks of the job, such as free utilities, do not make a significant enough financial impact to justify their revocation when the massive size of the Antigua and Barbuda economy - more than \$4billion - is taken into account.

In support of his argument, Browne added that under-paying senior government officials could inadvertently result in unindividuals scrupulous abusing their power.

"Lee Kuan Yew (Former Prime Minister of Singapore) had a famous saying, if you don't pay your parliamentarians properly, your leaders, then you're gonna end up with a number of charlatans. You know, people who can't do the job, who would pretend as though they know, just like those elements in the UPP.

"How do you even justify, for example, that in the public sector you have

making 15, 20, \$25,000 a month, a minister makes 10 [thousand], less than a number of public servants and you're gonna argue that the \$10,000 a month or the \$1,000 a month that he gets in utilities that I should take that back? I don't know that that's precisely fair," proffered Browne.

He continued, "Many of my ministers would have said to me since last term at some point we have to review the Parliamentary pay. I mean, I don't know when that will be clearly we can't do it now because of the COVID situation and so on - but we also have to increase the pay of public servants. But I don't know that we can continue to increase public servants' pay and at some point do not revise the pay for parliamentarians."

Mr. Browne added that if one were to objectively analyse the emoluments of government ministers based on their duties against that of some public sector workers and the standard set by the private sector, they are, in fact, sorely underpaid.

Gaston Browne: George Walter should never have been a national hero

Never one to avoid sharcontroversial views, ing Prime Minister Gaston Browne has declared that Sir George Walter should never have been bestowed the honour of National Hero.

During his Browne and Browne programme on Pointe FM, the prime minister said the decision to make Antigua and Barbuda's second premier a national hero was just another example of the poor judgement of the former United Progressive Party (UPP) administration in bestowing accolades upon persons undeserving of them.

According to PM Browne, Sir George's legacy is not one which bears the hallmarks attributable to those deserving of the honour of a country's National Heroes.

"I'm gonna make a controversial statement here, but I strongly believe in it. When you look at for example, the decision of the UPP government to make George Walter a National Hero, I mean, that was just totally undeserving.

"George Walter served for a brief period of time as General Secretary of the Antigua Trades and Labour Union and he was given a nice little cushy job. He stayed there and undermined Sir Vere [Bird Sr.] when they had the little problem there with the workers and

the workers were demanding salaries and wages that the government couldn't pay.

"George Walter exploited that situation and became [premier], served for one term, went to jail for misbehaviour in public office and they made him a National Hero!" Browne said.

Browne said, in his mind, the decision to elevate Sir George is rooted in the fact that the UPP is envious of the irrefutable legacy of contributions members of the Antigua and Barbuda Labour Party have made.

"They can't stand on their record. They can't stand on their achievements - neither personal nor public - but they want to envy people within the Labour Party whenever we elevate our people who serve and who would have slaved to build this country."

The ABLP leader's comments were triggered by criticisms levelled against his administration by UPP



In her view, that honour should have been given to Sir Prince Ramsey, a beloved and regionally renown medical doctor who received great celebrity for his decades of contributions to the treatment and care of people living with HIV/ AIDS.

Private actors, if left unchecked, can fragment educational systems. That is why we need strong government regulation.

Rarely does a topic on education elicit such passionate debate as the one about private and public schools. Some 350 million students across the world are educated in non-state schools, ranging from faith-based institutions and schools run by NGOs to for-profit schools. Nonstate actors also run school buses, supply uniforms, produce textbooks and manage school canteens. Technology companies have made advances into education as well, especially during the COVID-19 pandemic – from online testing to virtual classrooms.

There are many reasons why the private sector is playing such a significant role in education. One of the attractions is that there is a potential market for them. Globally 1.6 billion children and young people head to class each day around the world and \$5 trillion is spent on education every year.

So what are the consequences of the presence of the private sector in education?

There is no denying that many nonstate actors are delivering where there is need: in conflict situations, in crises, in many countries where the public education system is dysfunctional. But there is also no denying that while governments are bound by their public commitments to education equity, the private sector is not.

To investigate the role and impact of non-state actors in education worldwide, UNESCO put together the 2021/2 Global Education Monitoring Report. Entitled "Who Chooses? Who Loses?", it explores how the right of all children to have 12 years of free education, to which all counties committed in 2015 in the Education 2030 Framework for Action, can be compromised by a stronger role of private actors.

In the report, we cite many examples of strong collaborative partnerships between private and public actors, designing skills systems tuned to the labour market, for instance. But there are also many occasions in which the governance and oversight of the multitude of actors in education have gotten out of control and have led to the fragmentation of education systems.

The big challenge now is to make sure that the presence of the private sector in education is not making it harder for school children who, due to poverty, are falling behind in their education. Despite some well-meaning regulations, it can be hard to guarantee that private schools will support governments' agendas to help such children.

Our report shows that in about 40 countries, the children of the richest households were 10 times more likely than the poorest to attend private primary school. Recognising the potential dangers for equity, over a quarter of countries have banned for-profit provision in primary and secondary education.

Such measures, however, are rarely imposed in early childhood education, a period that is critical to the development of a child and their potential later on in life. At this level, private providers are even more present than in primary and secondary education. In many countries, this renders kindergartens unaffordable for the poorest families – precisely those who need such services the most, as they are more likely to have no other options for childcare. For example, in the United

States, where poverty disproportionately affects Black people and where there is a significant lack of state-funded early education institutions, Black families with two young children have to spend 56 percent of their income on average on pre-kindergarten and kindergarten education.

Our report calls on governments to make sure that, whoever is involved in education and whatever they are doing, they are respecting and abiding by the values of equity and allow every child to fulfil their potential. There are a few solutions we recommend.

First, governments should follow their public commitments and invest in free, good quality, state education. They should make sure that the poorest families, which do not have the funds to pay for better education elsewhere, can always access a good quality school where they are. But one in three countries is still spending on education below the two internationally agreed benchmarks: at least 4 percent of GDP or at least 15 *cont'd on pg 6*

COVID-19 outbreaks at ABTB Inspection Centre, ACB force shut down; PM's staff undergo testing

The Antigua and Barbuda Transport Board (ABTB) Inspection Centre and Antigua Commercial Bank Caribbean are the latest organisations forced to shut down due to COVID-19.

On Monday just after 12pm, the ABTB announced it would suspend services to the public after it was discovered that several of its employees attached to the Vehicle Inspection Centre tested positive for the COVID-19 virus.

Five workers returned positive test results after complaining of feeling ill. ABTB General Manager, Hubert Jarvis, indicated a medical team was called in and rapid COVID-19 tests were administered to all employees. Additionally, the building was sanitized and those who have tested negative will return to work today and normal hours of operation will resume.

Mr. Jarvis spoke of the culture that exists at the ABTB, where employees are encouraged to vaccinate against the COVID-19. According to him, a large percent of the workforce is fully vaccinated and approximately 50 percent of workers have received booster shots. He is confident that those who contracted the virus did not do so at work, but rather over the

percent of total public spending.

As a result, costs for public schools are often offloaded to parents. In Uganda, for example, families regularly pay informal fees to go to school even though this is against the law. Eliminating such costs has been proven to have substantial benefits. A scholarship programme in the Gambia that covered informal fees for uniforms and books increased the enrolment of girls by 13 percent.

Second, governments should ensure that regulations covering state and non-

The general manager is appealing to employees and members of the public who seek the services of the Transport Board to adhere to the protocols that are in place, which include the wearing of masks above the nose, sanitizing and social distancing. Meanwhile, at the weekend, ACB Caribbean announced its branch located at the corner of High and Market Streets will be closed until further notice. The bank's statement provided no details other than to inform that there had been "COVID exposure" at the branch.

The Office of the Prime Minister was also affected by the most recent wave of infections. Last week, seven members of staff tested positive for the virus after tests were carried out. However, the office remains open.

It found that while an array of rules exists on paper, they are not properly enforced. This is most obvious in countries such as Nigeria where the proliferation of unregistered low-fee schools of low quality is jeopardising the education of many children.

Regulations that actually promote equitable education are not common. About 55 percent of countries try to prevent selective student admission pro-

percent of countries have quotas to support access to schools for disadvantaged students.

Our report calls on all governments to take a serious look at schools, teachers and students together as they are part of the same education system. Governments cannot turn a blind eye to privilege or to disadvantage - as they have so often done during the pandemic.

Regulations should work for everyone and should promote equity and quality for all, not fancy ideas for some.

Local News Substitute teachers' contracts extended, plans in motion to make them civil servants

The contracts of more than 100 substitute teachers have been extended as plans are finalised for them to be made civil servants.

The confirmation comes from Director of Education, Clare Browne.

109 substitute teachers were recruited in October after government's vaccine mandate created a void in the public school system caused by some educators, who were on leave without pay, because of their unvaccinated status.

The temporary workers, who began performing duties on 1st October, 2021, were strategically placed throughout the public school system, to ensure there were no interruptions to the teaching and learning process.

Their agreement with the Ministry of Education ended on 31st December. but officials have seen the need for their continued contributions and have renewed their contracts for three months, commencing this month.

Director of Education, Clare Browne said: "Once the teachers who were on unpaid leave were allowed to return with testing in December, the government also allowed the substitute teachers to remain.

"We have since asked the Cabinet in a formal way, through a circulation note, for the Cabinet to allow us to hold the substitute teachers for the next three months, until such time."

He explained the communication dispatched to Cabinet is simply a formality, since the decision making body had already agreed to allow the Ministry of Education to continue to retain the substitute teachers.

Clare Browne revealed the extension will allow his department to put mechanisms in place that will allow for a smooth transition of the substitutes to permanent employees.

A fire in the wee hours of Monday morning has left Elvis Weaver, the St. John's five people homeless.

According to Fire Chief for response to a fire in Nut-Fire Station received a call

grove at 3:40am on Monday 10th January, 2022.



Upon arriving on the scene, they discovered three wooden structures engulfed in flames. The structures affected were 21 by 13 feet, 32 by 17 feet and 10 by 10 feet in size.

Chief Warner said all the structures were supplied with electricity.

Pointing out the extensive damage which had been done, he added that he was uncertain whether the buildings were covered by insurance.

The cause of the fire did not appear to be immediately clear, however, investigations into the reason for the blaze are ongoing.

XPZ Supermarket reconstruction delayed

Reconstruction of popular Chinese supermarket, XPZ, is scheduled to begin by the end of 2022.

The supermarket on Sir Sydney Walling Highway was destroyed by fire on 1st June, 2021, leaving the owners estimating their losses at approximately \$10 million.

A former employee, a national of China, is in jail awaiting trial charged with arson.

Speaking to Pointe Xpress from China, the supermarket's manager, David (only name given), said demolition at the site has begun. He said their rebuilding plans were delayed due to the COVID-19 pandemic.

He added, however, that efforts to clear away the debris of the previous structure are ongoing and promised that the supermarket would be rebuilt bigger and better than before at the same location.



An excavator has been seen removing the twisted metal from the premises.

The owners of XPZ operate another business located in St. John's that sells clothing, however the supermarket was the larger of the two businesses and attracted many customers who found the prices attractive and the location convenient.

Scores of employees were placed on the breadline following the fire.

tion, we want to do the paperwork to get them over as fully established teachers in the education system," Mr. Browne revealed.

He offered high praise for the level of work they put in during the last three months, saying the ministry has benefitted from the

mandate.

"Many if not all the principals would have written, indicating how well these substitute teachers immersed themselves in the work and how they have really helped to ensure that at a time when students needed to have teachers, they would have ensured that student learning continued."

Director Browne views the move to make the substitute teachers permanent employees as "just reward".

Mr. Browne insists the substitutes were carefully selected and are well qualified, with many being holders of bachelor's and master's degrees.

"These are persons that had applied for teaching. We went through a vigorous interview process, they would have been trained (concentrated), they went out and delivered and the principals are attesting to the quality of their performance," the director added.

How to Recover From a Toxic Relationship

Few things feel as freeing as leaving a truly toxic relationship. It's such a relief to escape the constant criticism, continual conflict, and emotional manipulation. But what if you discover that you've taken the poison with you?

Unfortunately the toxicity of bad relationships very often outlasts the relationship itself, like a "gift that keeps on giving" (in the worst of ways) long after the relationship is over. Maybe you find that you've internalised the harsh voice of an emotionally abusive parent, and now your self-talk carries the same messages and tone that your parents did. Perhaps you find that your ex-spouse's harsh judgments of you are colouring your relationship with your current partner. Or you might have left a gaslighting partner, only to realise that you continue to doubt what your senses and intuition are telling you.

The dynamics we experience and the negative messages we hear can be sticky, attaching to our psyches and continuing to affect us even decades later. Our minds are often the longest captives of toxic relationships.

But that doesn't mean we can never be completely free. I've seen hundreds of people manage to free their minds from their past relationships in my work as a clinical psychologist. While the work is never quick or easy, it can be tremendously rewarding. The following principles can be very helpful in the final phase of liberation.

Be patient with yourself. Keep in mind that it takes time to retrain your brain. You're a work in progress. Messages you received throughout childhood can be especially long-lived. Even if your toxic relationship was in adulthood and relatively brief, the patterns you learned can be hard to break. Give yourself compassion when you find that the toxic relationship is continuing to colour your thoughts and reactions. Being impatient with yourself just reinforces the toxic voice; instead, allow yourself the time and space needed to heal.

Notice how you speak to yourself. Be on the lookout for what your internal voice is telling you. Be curious, like a scientist, as you explore the patterns of your mind. It's very important that you write down the thoughts you find. Actually getting the thoughts out of your head with pen and paper is much more effective than simply noting them mentally. You'll be in a much better position to start developing more useful ways of thinking.

Adopt a gentler voice. Begin to replace your harsh, critical thoughts with more supportive ones. Not sure what to say? Imagine how you would speak to a dear friend, or to your own child. Practice using this gentle response deliberately when you catch the old way of speaking to yourself. For example, if you make a silly mistake, replace "You're such an idiot!" with, "Everyone makes mistakes. What can you learn from this one for next time?"

Lead with kindness. Don't wait until you catch the harsh internal voice to practice self-kindness. Instead, be proactive as you reprogram your mind. Start training your thoughts in the morning, before your feet even touch the floor. Write down three thoughts you want to strengthen, and leave them on your bedside table. When you wake up, read and repeat the thoughts to yourself before you get out of bed. For example, you could practice thoughts like, "I am enough to face whatever this day brings." See what happens when you fill your mind with thoughts that serve you well. (Adapted from The CBT Deck.)

Find your strength. Do more of the things you enjoy and are good at—the activities that bring you alive. You may have given up these activities during your toxic relationship, since manipulative people typically don't want to see you thrive. Witnessing your own com-

petence is a powerful antidote to seeing yourself as weak or inadequate.

Embrace who you are. Toxic relationships often lead us to hide or deny important parts of ourselves. For example, if you're naturally exuberant, a constantly critical parent might have led you to bury that joyful part of yourself. Find moments of stillness to listen for what is longing to be expressed. Look inward for urges you might be squashing. Begin to make space for more of your experience.

Be where you are. Toxic relationships can lead you to feel bad, not only about who you are, but about even existing, as though you don't have the right to take up any space at all. But your existence is nothing to apologise for. You have a right to be here, because the universe has seen fit to welcome your presence. Don't try to shrink your body or excuse yourself for being where you are. Stand firm in the space you occupy, unapologetically. It's yours. As you breathe in, say to yourself the words, "I Am." As you exhale, say to yourself, "Here." Exactly where you belong.

Finally, take heart—with attention and practice, your mind can be yours once again. In the process, count it a victory each time you catch the old patterns. The fact that you're noticing them means you're learning, you're growing, and you're coming home to yourself.

US expands interview waivers for certain nonimmigrant Caribbean visa applicants

CMC — The United States Department of State has announced that consular officers in the Caribbean and other places are now temporarily authorised, through December 31, 2022, to waive in-person interviews for certain individual petition-based nonimmigrant work visas and their qualifying derivatives.

The categories for the qualifying derivatives include Persons in Specialty Occupations (H-1B visas); Trainee or Special Education Visitors (H-3 visas); Intracompany Transferees (L visas); Individuals with Extraordinary Ability or Achievement (O visas); Athletes, Artists and Entertainers (P visas); and Participants in International Cultural Exchange Programs (Q visas).

Additionally, US Secretary of State Antony Blinken has extended con-



sular officers' current ability to waive the in-person interview, through December 31, 2022, for other categories of nonimmigrant visas: Temporary Agricultural and Non-agricultural Workers (H-2 visas); Students (F and M visas); and Student Exchange Visitors (Academic J visas).

"The Department of State recognises the positive impact of temporary work visa holders on the US economy and is committed to facilitating nonimmigrant travel and reducing visa wait times. We recognise the many contributions of international visitors to our communities and campuses," said the department in a statement.

It also added that the authorisation to waive the in-person interview for applicants renewing a visa in the same visa class within 48 months of the prior visa's expiration has been extended indefinitely. The State Department said that the COVID-19 pandemic resulted in "profound reductions" in the department's visa processing capacity and that it is taking these temporary steps "to further our commitment to safely and efficiently reduce visa wait times while maintaining national security as our priority."

The State Department said it made its determination with the concurrence of its Department of Homeland Security partners.

"Embassies and consulates may still require an in-person interview on a case-by-case basis and dependent upon local conditions," the State Department said. "We encourage applicants to check embassy and consulate websites for more detailed information about this development, as well as current operating status and services."

St. Vincent and the Grenadines granted permission to export medical cannabis

Gleaner - St Vincent and the Grenadines is now the first member state of the sub-regional grouping the Organisation of Eastern Caribbean States (OECS), to be granted permission for the export of medicinal cannabis.

On Friday, the government announced that the island would export its first shipment of medicinal cannabis to Europe.

The announcement follows the recent approval of the first export certificate for medicinal cannabis.

The export permission was granted to Caribbean Cannabis Company trading as Medicinal.

The company already has several products marketed locally and has worked with traditional cultivators in building out their supply chain.

The granting of the permit came after an import certificate was issued by the Federal Institute for Drugs and Medical Devices for the product to legally enter Germany.

According to Agriculture Minister Saboto Caesar, the jurisdiction has worked over the last three years, with international agencies, friendly governments, and local public and private sector stakeholders, to make this a reality.

Caribbean nationals who are not US citizens and live in New York City, will be allowed to vote after Mayor Eric Adams allowed legislation to automatically become law on January 9.

Caribbean nationals are among the more than 800,000 non-citizens and "Dreamers" who could vote in municipal elections as early as next year.

Opponents have vowed to challenge the new law, which the City Council approved one month ago. Unless a judge halts its implementation, New York City is the first major U.S. city to grant widespread municipal voting rights to non-citizens.

More than a dozen communities across the U.S. already allow non-citizens to cast ballots in local elections, including 11 towns in

Non-citizens still will not be able to vote for president or members of Congress in federal races, or in the state elections that pick the governor, judges and legislators.

The Board of Elections must now begin drawing an implementation plan by July, including voter registration rules and provisions that will create separate ballots for municipal races to prevent non-citizens from casting ballots in federal and state contests.

It's a watershed moment for the nation's most populous city, where legally documented, voting-age non-citizens comprise nearly one in nine of the city's seven million voting-age inhabitants. The movement to win voting rights for non-citizens prevailed after numerous setbacks.

The measure will allow non-citizens who have been lawful permanent residents of the city for at least 30 days, as well as those authorised to work in the U.S., including "Dreamers," to help select the city's mayor, city council members, borough presidents, comptroller and public advocate.

"Dreamers" are young immigrants brought to the U.S. illegally as children who would benefit from the never-passed DREAM Act or the Deferred Action for Childhood Arrivals program, which allows them to remain in the country if they meet certain criteria.

The first elections in which non-citizens will be allowed to vote are in 2023.

Cuban asylum seekers in Greece 'forcibly expelled' to Turkey

At least 30 Cubans, hoping to claim asylum in Europe, were forcibly expelled from Greece to Turkey towards the end of last year, according to interviews conducted by Al Jazeera and rights organisations.

Al Jazeera spoke to two Cubans who also said that, during their expulsion from Greece, police officers and border guards subjected those they were expelling to violence.

Allegations made to Al Jazeera and rights organisations include accounts of forced undressing, beatings, detention without food or water, confiscation of passports, money and other personal belongings, refusal to register asylum claims, and forced water immersion prior to and during the expulsion process.

Al Jazeera also viewed photos and testimonies of the asylum seekers taken by NGOs on the ground to verify those claims.

Those expelled now say they are left in limbo in Turkey

without identification or access to legal reparations, despite some of them having reported the forced expulsion to the Cuban consulate and Turkish authorities after their arrival.

Joel (name changed to protect identity), 38, a doctor from Havana looking to claim asylum in Spain, says he feared being killed during his expulsion from Greece.

In a video call with Al Jazeera from Istanbul, Joel recounted the two-day ordeal.

In the early hours of October 29 last year, Joel and two other Cubans crossed into Greece from North Macedonia on a 48-hour journey which had taken them from Havana to Moscow, then to Belgrade, then by bus and on foot across Serbia and North Macedonia.

Later that day, Joel says all three were removed from a bus travelling from Thessaloniki to Athens by Greek police.

He recalled being taken to three different detention centres where the trio, as well as other Cubans, Syrians, Afghans and Pakistanis had their belongings taken, and were forced to undress, searched, beaten and detained without food or water.

"I told the officers I was a doctor from Cuba and was there to seek political asylum. They just looked at me and laughed," he said.

After spending the night in detention, the entire group was driven to the forest near the Turkish border.

Joel recounts they were forced to walk in a line, led by gun-carrying officers wearing balaclavas.

"I thought we were being taken to be killed," he said, adding that as they arrived at the Evros River – which marks the border between Greece and Turkey – an officer hit a young man who was brought there fully naked.

The officer then dragged the man to the river and pushed his head under water, pulling it out only when called out by other officers.

a time, was then loaded onto boats manned by plainclothes officers, taken halfway across the river before being made to swim the rest of the way into Turkey by the officers.

In a testimony given to Border Violence Monitoring Network (BVMN), Joel said the officers in the boat said "When you get to the other side [of the river] you are free, and you can walk towards the light and find the closest village."

West African nations sever links with Mali over election delay

Accra, Ghana (CNN) - West African nations will close their borders with Mali, sever diplomatic ties and impose tough economic sanctions in response to its "unacceptable" delay in holding elections following a 2020 military coup, the 15-state regional bloc said on Sunday.

The fresh measures from the Economic Community of West African States (ECOWAS) represent a significant hardening of its stance towards Mali, whose interim authorities have proposed holding elections in December 2025 instead of this February as originally agreed with the bloc.

In a communique issued after an emergency summit in the Ghanaian capital Accra, ECOWAS said it found the proposed timetable for a transition back to constitutional rule totally unacceptable.

This schedule "simply means that an illegitimate military transition government will take the Malian people hostage," ECOWAS added.

Polish official fired after calling Holocaust law 'stupid'

AlJazeera - A Polish diplomat charged with improving contacts with Jews worldwide has been fired after he criticised his own government's approach to regulating Holocaust speech, the country's foreign ministry said on Monday.

Jaroslaw Nowak, the plenipotentiary for contacts with the Jewish diaspora described a Holocaust speech law passed by his country's governing party as "stupid," in an interview last week with Jewish News, a weekly newspaper published in the United Kingdom.

Nowak also said Poland should pass a law on property restitution, a statement implying further criticism of the ruling authorities, who recently passed a law cutting off the chances for restitution or compensation for those who had properties seized by the communists. Among those affected are Holocaust survivors and their heirs.

Foreign Minister Zbigniew Rau fired Nowak on Saturday, the ministry spokesman, Lukasz Jasina, announced on Monday on Twitter. He did not give a reason.

The development came days after

legislation passed in 2018 seeking to ban certain statements about Poland and the Holocaust "is one of the stupidest amendments that was ever done by any law".

The legislation sought to fight back against claims that Poland, a victim of Nazi Germany, bore responsibility for the Holocaust. The law outraged Israel, where many felt it was an attempt to whitewash the fact that some Poles did kill Jews during the German occupation during World War II.

The legislation originally called for prison terms of up to three years for falsely attributing German crimes to Poland. It was later amended to remove the criminal provisions.

Last year, Poland also approved a law that sharply restricted the rights to reclaim property seized by the country's former communist regime, including Holocaust survivors and their families.

That law also provoked a serious diplomatic dispute with Israel, which still remains unresolved.

Nowak said he believed that Poland will, at some point, "have to do something about" restitution.

Ibrahim Keita in August 2020, after which the interim authorities promised an 18-month transition to civilian rule.

Goita staged a second coup in May 2021 when he pushed aside the interim president and took the job himself.

The tougher response from ECOWAS reflects the pressure the organisation is under to show it can protect democracy from a backslide to military rule after West and Central Africa saw four coups within 18 months.

The new measures will be gradually lifted only after an acceptable election timeframe is finalised and progress is made towards implementing it, ECOWAS said.

Under previous sanctions, Mali's ECOWAS membership is suspended and members of the transitional authority and their relatives are subject to travel bans and asset freezes.

Immediately after Keita was ousted, ECOWAS temporarily closed its borders with Mali and halted financial flows - short-term sanctions that caused a sharp fall in imports to the landlocked country.

Mali's political upheaval has also deepened tensions with former colonial power France, which has thousands of soldiers deployed across West Africa's Sahel region to battle Islamist insurgents.

New cadre of media practitioners to benefit from workshop

Efforts are being made to develop young sports writers and commentators in Antigua and Barbuda.

Commissioner of Sports, Colin "Tin Tin" James, said he is in the process of organising a media workshop to develop a new cadre of young sports journalists.

James, a veteran journalist, said the workshop is being planned to coincide with Antigua and Barbuda hosting of the first cricket Test between the West Indies and England at the Sir Vivian Richards Cricket Stadium from March 8th to 12th.

"Apart from the cricket publication that I am working on for the Test match, simultaneously, I am also in the process of organising a sports writers and commentators workshop," James said.

"We are hoping to use the international broadcasters who are coming to Antigua in late February and early March to interact with them and try to get a cadre of young, impressionable sports reporters, sports writers and sports commentators to be part of this workshop."

James said although planning of the media workshop is yet to be finalised, he has already contacted several key people whom he would like to include in the project.

"It is still a work in progress at this time. We have made some contact with some key people already. We are getting some good responses in terms of resource people and very shortly we will be announcing the date based on that," James said.

"As you know, ESPN is going to cover the series for the Cricket West Indies so we intend to get a resource person from ESPN. You will have the British media whether it be sky or the British newspapers such as the Telegraph, Daily Mail, Times, Guardian and the Independent so we can also get someone from those newspapers.

"We are also looking at the possibility of getting another American net-

work involved. Obviously the BBC (British Broadcasting Corporation) will be around so we would involve them as well.

"So the whole idea is to get the 5th formers in the various secondary schools and those who are attending 6th form at the Antigua State College or just about anyone who wants to be a part of it.

"As a matter of fact, you can be in any form at a secondary school and be a part of this workshop. By the end of January (2022) we should have the date finalised and we should be announcing it.

"The workshop will focus on writing and broadcasting in print, radio, television, social media and sports commentating."

Novak Djokovic supporters pepper-sprayed after tennis pro gets visa reinstated

FOX - A crowd of Novak Djokovic supporters were pepper-sprayed in Melbourne late Monday night after surrounding a car believed to be carrying the tennis pro after a judge ruled to reinstate his visa, reports say.

Federal Circuit Court Judge Anthony Kelly ruled the government's decision to cancel Djokovic's visa was "unreasonable" and that he had not been given enough time to speak to his lawyers before the decision was made on the basis that he did not provide sufficient evidence for a medical exemption.

A large crowd of supporters, some carrying Serbian flags, gathered outside his attorney's office after Djokovic's release was ordered. As a black car began to exit, the crowd surrounded it with some even dancing on the vehicle and banging on its windows.

According to The Age, police began using pepper spray on some supporters. As the crowd dispersed, some began confronting officers and throwing bottles.

The vehicle in question was reportedly carrying Djokovic or someone connected to his coaching staff.

The World No. 1 took to Twitter on Monday to thank his supporters, adding that his hope to be able to participate in the Australian Open set to begin on January 17.



The five members of the Ireland team who have returned positive COVID-19 results remain in isolation under the care and supervision of the medical teams.

CWI announced that further updates will be provided as soon as possible.
