## MP Marshall: Serpent is a shame to the farming community

Armed with photographs of overgrown, litter strewn and, most conspicuously, agriculturally bare farm land, Minister of Agriculture, Samantha Marshall slammed UPP St. George's hopeful, Algernon "Serpent" Watts, describing him as a "shame" to the farming community.

Minister Marshall said she personally visited the 26 acres of farm land allocated to Watts and was dismayed by the mounds of garbage on the wild, unused expanse.

The 26 acres under Watts' control are divided among 4 lots: 6 acres at Pares, 5 acres at Diamond's Estate, 10 acres at Potworks and 5 acres at

Sanderson's.

Marshall described one lot of trash-filled land as a "Ratta Condominium" while another was described as a "forest". She called yet another a "land fill" as she showed slide after slide of farm land devoid of agricultural produce or livestock.

The minister said on her visit to the four lots she saw only one papaya tree as any signal of agricultural activity.

An incensed Marshall noted that each of the properties were equipped with water storage facilities or had access to water which makes the uncultivated state of the lands more egregious.

"He is a shame to the farming community!" said a visibly upset Marshall during her contribution to the 2022 Budget.

"You see, [farming] takes commitment! You know that this (the state of the lands) is embarrassing! You have to have commitment as a farmer to get up, go out, do what you have to do. If you're busy like me, leave it alone.

"And you say you're the shadow [agriculture] minister?! What farming you can talk 'bout when you are one who abandoned 26 acres of land that have access to water, or you can store water.

"Mr. Algernon Watts, as the Minister of Agriculture, do the right thing; just turn back in the lands and let's move on and give somebody who can produce," said Marshall.

## More than 100 hospitality scholarships to become available

Ministry of Tourism, in partnership with the Ministry of Education and the Antigua and Barbuda Hospitality Training Institute (ABHTI), will make more than 100 scholarships available this year to Antiguans and Barbudans who wish to pursue careers in the hospitality industry.

This was the word from Tourism Minister Charles Fernandez last Thursday as he explained his ministry's thrust to develop the country's human resource capacity as part of the government's move to expand and revitalise the tourism industry.

"We have agreed to fund 100 scholarships for persons in short courses annually starting with persons on the job programme who are desirous of moving on to work," Fernandez said during his contribution to the 2022 Budget debate.

"We went to Cabinet last year to arrange for money to come from the Marketing Fund and this is one such area where we will be given Antiguans and Barbudans an opportunity to earn while they learn. It will not be a willy-nilly thing," he continued.

These certificate programmes will last for six weeks.


An additional 25 scholarships will go to those desirous of pursuing tourism related fields at the tertiary level.

In his report to the Parliament on his ministry's activities, he also addressed the challenges faced by ABHTI in the face of the COVID-19 pandemic.

These included the suspension of in person classes. This, however, was overcome by a transition to online tutoring.

"ABHTI forged new collaborations with the Mill Reef Club and the Rotary Club of Antigua to secure 180 laptops for the students when laptops became a scarce commodity, and training was provided for the lecturers to ensure the optimal use of the Google Classroom.

"Students were challenged to become creative

and innovative with their studies as they experienced first-hand the challenges presented to the tourism sector," Minister Fernandez reported.

He added that this year, as the world returns to a degree of normalcy, efforts will be made to provide the ABH-TI's students with opportunities for real world training experiences.

These internship opportunities, he reported, have proven very successful as approximately 50 percent of participants move on to find employment upon completion of their ABHTI programme with a participating hotel, resort or other industry players.

## Plans unveiled for Golden Grove Primary School's expansion

More school expansions are in the works as officials announce a "revolution in education".

Minister of Education and Sports, Daryll Matthew, has unveiled plans for the expansion of Golden Grove Primary School.

Contributing to the budget debate in the House of Representatives on Friday, Matthew highlighted the issue of overcrowding in the public school system and said government is working towards creating adequate space to allow for an effective teaching and learning process.

One school where the need is urgent is Golden Grove Primary, where students and teachers operate in clustered and claustrophobic conditions.

"The most overcrowded public school in Antigua and Barbuda is the Golden Grove Primary School. The Golden Grove Primary School currently has in excess of 420 persons occupying a tiny, tiny footprint."

Understanding the need for adequate space, Matthew said he went about seeking solutions to the problem and negotiations have commenced in acquiring the land adjacent to the school that will allow for expansion, with the construction of a new wing.

Unveiling an architect's rendering of the proposed new wing, the education minister told parliament of the plan to redevelop the Golden Grove School plant.

"These aren't pie in the sky conceptual drawings. These are drawings that were done by our in-house team of architects...and this project has been designed, has been spec'd out to ensure that it meets the needs of the students for the expanding

school and budgeted," he noted.

While a date was not announced when construction work is expected to begin, Mr. Matthew did reveal the cost for the expansion is estimated at US \$ 1.5 million and intends to lobby Prime Minister and Minister of Finance, Gaston Browne for donations to aid in the work that will be undertaken.

"I know the prime minister, rightfully so, wants to see Sir Novelle Richards [Academy] built out, and we had the commitment to build out Saint Mary's Secondary.

"But I'm putting the prime minister on notice that I'm going to be coming knocking on his door very hard, because the people of Golden Grove and Nut Grove and Ottos and Browne's Avenue we need a school," Matthew stated.

He believes as a result of overcrowding at Golden Grove Primary, the students are at a disadvantage in preparing for the "challenges and needs that are required for developing Antigua and Barbuda".

Minister Matthew denied claims made in a recent letter published in a section of the media that government is moving to forcibly acquire the land earmarked for the expansion of the school.

He read from a letter written to cont'd on pg 5

In announcing the first consultation with carnival stakeholders for 11th February, the statement read:

"Carnival 2022 will be held from July 27th to August 2nd with Festival Commission organized pre-carnival events to include T-Shirt Mas, a formal gala celebrating the 80th birthday of Sir McLean "King Short Shirt" Emanuel and a Teen Rave and Car Show competition."

At Friday's consultation, scheduled for 5pm at the Multi-Purpose Centre, fete promoters will be engaged in discussions.Similar meetings are expected to

be held in the coming days on Tee-Shirt Mas, Carnival Monday and Tuesday Mas, Soca and Calypso Monarch and Panorama competitions.

Minister Michael Browne who has portfolio responsibilities for carnival presented a proposal to Cabinet for Carnival 2022 which will be discussed during the consultations, following which a decision will be made regarding the annual summer festival and what activities will make up the 2022 event.

Assurances have been given that all activities once approved will be held with the health and safety of patrons in mind.

Carnival 2022 will be held under the theme, "Experience Greatness - Again!"

## The Pinocchio effect

Researchers have found that when you lie your nose actually heats up. This is called the "Pinocchio Effect". According to "Science Daily" (December 3, 2012), the University of Granada, using thermography to study heat distribution in different people, found that when people lie there is an increase in the temperature around their noses and the corners of their eyes.

While there is supposedly a limit to the Pinocchio Effect in that if your nose grows more than twelve inches long it wouldn't be a nose any longer, it will be a foot, there is the story of Snow White who sat on Pinocchio's nose and screamed, "Lie to me! Lie to me!"

When it comes to lying, some of us are truly snow white. One research project found that sixty-percent of the people surveyed reported telling no lies during a typical day, with another 25 percent telling between one or two lies.

However, despite the fact that 85 percent appear to be either totally or relatively honest, about one percent admitted telling more than 20 lies per day. Actually, a study funded by British Vodka Maker WKD, a company known for its slogan 'Have you

got a WKD (for "wicked") side?', shows that men are much more WKD than women since we tell over 109,000 lies in a lifetime while women average only about 65,000.

A University of Amsterdam study of more than 1,000 people between 6 and 77 years old found that teenagers are the group most likely to lie successfully.

Unfortunately, the researchers did not include politicians in the survey. Dr Philip Seargeant of the Open University, commenting on the "affectionate relationship between lying and politics" in the U.S., pointed out that "over these last few years we've witnessed this relationship grew ever more intimate until today it's reached a stage where it's often completely shameless.

Lying - and doing so in a wanton and blatant way – is now such a part of everyday politics that it's barely newsworthy anymore. We're at the point where, as an article on CNN reported a few weeks ago, the Government of the United States are 'now lying about lying' and seemingly to do so with impunity."

British journalist, Andrew Brown, writing in the online paper FP (Foreign Policy) quips, "In Britain's hierarchical culture, the crime for upper classes

isn't telling lies- it's getting caught." He sees lies in politics as an exercise of power. Some like those in Putin's Russia (or Caribbean countries where Prime Ministers are treated like gods), are not meant to be believed. They are intended to make it plain that the liar has power and those lied to can do nothing about it. Mr. Brown believes that there are two audiences in British politics - one comprising the elite who understand the truth and who deserve to do so, and the other is everyone else. In that context, for lies to do their necessary work of holding society together it must never be admitted in public that they are in fact lies.

Interestingly, no political leader has yet entered the World's Biggest Liar Competition in Cumbria, England, most likely because it was postponed in 2020 and 2021 while the 2022 date is yet to be announced. If, however, we could set up our own politicians or enter some of those we know or read about, who would we bet on?

Very high on the list is Boris Johnson, the British Prime Minister. Almost a year ago, in April 2021, the British "Guardian" headlined, "Accusations of lying pile up against Boris Johnson. Does it matter?" and added, "Analysis: MPs and broadcasters are losing cont'd on pg 7

their reluctance to openly call out the PM's deceit." The paper described a "jaw-dropping" moment when the SNP (Scottish National Party) leader, Ian Blackford, asked Johnson a question that "was unsurprising and yet somehow extraordinary". It was, "I can't possibly call the PM a liar in this house but are you a liar Prime Minister?"

The full list of accusations against PM Johnson has more gates, terminals and "hangers" than Heathrow- "Christmas partygate" about a big party he held in his official residence when the country was subject to strict COVID measures; "Wallpapergate" or who paid for the renovation of the PM's Downing Street flat; the Hillsborough disaster; an extramarital affair; and his failure to keep his promise to build 40 hospitals by 2030.

In the US, Donald Trump was accused of making tens of thousands of false or misleading claims estimated at about 21 per day. Wikipedia says, "Characterised as the 'firehouse of falsehood' propaganda technique, commentators and fact checkers have described it as 'unprecedented in American politics...As part of attempts to overturn the 2020 United States presidential election, Trump and his allies repeated and falsely claimed there had been massive election fraud and that Trump had

really won the election. Their effort was characterised by some as an implementation of 'the big lie'." CNN added, "Trying to pick the most notable lies from Donald Trump's presidency is like trying to pick the most notable pieces of junk from the town dump."

CNN is convinced that Trump's most dangerous lie was his boast that "the coronavirus was under control"; the most ridiculous subject of a lie was Trump's boast that the head of the Boy Scouts had called him to say that his address, considered by many to be "bizarrely political", was the "greatest speech that was ever made to them"; the most traditional big lie was that "Trump didn't know about the payment to Stormy Daniels"; and the most depressing lie was that "Trump won the election".

Even Pinocchio and his buddies Snow White and Superman got into the act. They were out for a little stroll in Disneyworld one afternoon and came across a sign: "Beauty contest for the most beautiful woman in the world." Snow White decided to enter and returned extremely elated. She had won First Place. Then they saw an ad for a contest to decide who was the strongest man in the world. Superman flew off and returned boasting, "I won first prize by miles." Then they saw a third sign. "Contest - Who is the greatest liar in the world?" Pinocchio was sure he, too, would win a first prize. After half an hour he returned with tears in his eyes. His friends ask him, "What happened?" Pinocchio replied angrily, "Who the hell is Donald Trump?"

Fortunately for all of us here in Trinidad and Tobago, we don't have a problem like that with our leader. No siree! Less than a week ago, the NEWSDAY newspaper ran this headline, "PM responds to OWTU (Oilfield Workers Trade Union) head's claims over meeting invite: I am not a liar." However, it seems that "I am not a liar" was not a direct statement from the Prime Minister in a Facebook (FB) post in which he sought to "defend his character".

The Prime Minister's response to being called a liar was, "I am accustomed to this." Incredibly, several other media outlets also added the "I am not a liar" reference although it was not in the FB post. To me, it makes clear the extremely high regard in which our PM is held by the local journalism organisations. They were so certain that he is not a liar that they added the quote on their own accord. All I can say to this is, "Pinocchio, Donald Trump and Boris Johnson, eat your hearts out!"

## Autopsy conducted on Golden Grove fire victim, body remains unidentified

An autopsy conducted on the body found inside one of the houses that burned to the ground in Golden Grove last month has determined that the victim died as a result of extensive burns to the body.

The report indicated that 100 percent of the body was severely burned.

Initial reports after the discovery of the body suggested it was burnt beyond recognition.



There was no indication of whether the pathologist had been able to determine if smoke inhalation played a role in the person's death. It is suspected that the body is that of 16-year-old Dequan Cummings, the son of the owner of one of the homes.

The family owned properties were occupied by five individuals who were all accounted for following the fire, however, Dequan had been staying alone in one of the properties before it went up in flames in the wee hours of 10th January.

Police indicated that DNA samples had been collected to conclusively determine whether the remains were those of the missing teen.

## Ministry of Tourism, ABTA join on as Wadadli Island Girls' Platinum Sponsor

As Team Wadadli Island Girls prepare for the Pacific Rowing Challenge in June 2023, they have received much needed financial support from the Ministry of Tourism and The Antigua Barbuda Tourism Association (ABTA).

Late last week it was announced that the Ministry of Tourism and ABTA are now the Platinum Sponsors of the national, all female rowing team. Both entities will provide cash backing to the tune of \$100,000 which will be used, in part, for the purchase of a practice vessel, a new competition vessel.

The Pacific Rowing Campaign will depart Monterey, California in June 2023 when the 20 teams registered so far will travel 2800 miles across the Pacific ending in Nawiliwili Bay, Kauai, Hawaii.

The fastest female team to row this route was Ocean Sheroes who completed the row in 35 days, 17 hours and 32 minutes in 2021. This feat also secured the Ocean Sheroes, who competed in the Great Pacific Race, a Guinness World Record for the fastest all-fe-

male four to row 2,400 nautical miles.

The average crossing time for all crew sizes is 62 days.

When Team Wadadli Island Girls complete the challenge next year, they will make history as the first black female team to do so.

According to Minister of Tourism Charles Fernandez, the sponsorship forms part of his ministry's goal to invest in the development of local talent in different forms which in turn will promote Antigua and Barbuda through its participation in international events.

The minister indicated he will also be making a contribution to the team in his personal capacity and is encouraging other members of the public and corporate citizens to do likewise.

tive Agreement was a significant occasion for the Company. Mc Collin described the negotiations as cordial and productive.



### The dark origins of Valentine's Day

Valentine's Day is a time to celebrate romance and love and kissy-face fealty. But the origins of this festival of candy and cupids are actually dark, bloody—and a bit muddled.

Though no one has pinpointed the exact origin of the holiday, one good place to start is ancient Rome, where men hit on women by, well, hitting them.

Those Wild And Crazy Romans

From Feb. 13 to 15, the Romans celebrated the feast of Lupercalia. The men sacrificed a goat and a dog, then whipped women with the hides of the animals they had just slain.

The Roman romantics "were drunk. They were naked," says Noel Lenski, a historian at the University of Colorado at Boulder. Young women would actually line up for the men to hit them, Lenski says. They believed this would make them fertile.

The brutal fete included a matchmaking lottery, in which young men drew the names of women from a jar. The couple would then be, um, coupled up for the duration of the festival — or longer, if the match was right.

The ancient Romans may also be responsible for the name of our modern day of love. Emperor Claudius II executed two men — both named Valentine — on Feb. 14 of different years in

the 3rd century A.D. Their martyrdom was honored by the Catholic Church with the celebration of St. Valentine's Day.

Later, Pope Gelasius I muddled things in the 5th century by combining St. Valentine's Day with Lupercalia to expel the pagan rituals.

But the festival was more of a theatrical interpretation of what it had once been. Lenski adds, "It was a little more of a drunken revel, but the Christians put clothes back on it. That didn't stop it from being a day of fertility and love."

Around the same time, the Normans celebrated Galatin's Day. Galatin meant "lover of women." That was likely confused with St. Valentine's Day at some point, in part because they sound alike.

Shakespeare In Love

As the years went on, the holiday grew sweeter. Chaucer and Shakespeare romanticized it in their work, and it gained popularity throughout Britain and the rest of Europe. Handmade paper cards became the tokens-du-jour in the Middle Ages.

Eventually, the tradition made its way to the New World. The industrial revolution ushered in factory-made cards in the 19th century. And in 1913, Hallmark Cards of Kansas City, Mo., began mass producing valentines. February has not been the same since.

Today, the holiday is big business: According to market research firm IBIS World, Valentine's Day sales reached \$17.6 billion last year; this year's sales are expected to total \$18.6 billion.

But that commercialization has spoiled the day for many. Helen Fisher, a sociologist at Rutgers University, says we have only ourselves to blame.

"This isn't a command performance," she says. "If people didn't want to buy Hallmark cards, they would not be bought, and Hallmark would go out of business."

And so the celebration of Valentine's Day goes on, in varied ways. Many will break the bank buying jewelry and flowers for their beloveds. Others will celebrate in a SAD (that's Single Awareness Day) way, dining alone and binging on self-gifted chocolates. A few may even be spending this day the same way the early Romans did. But let's not go there.

## Marcus Garvey - (1887–1940)

#### Who Was Marcus Garvey?

Marcus Garvey was an orator for the Black Nationalism and Pan-Africanism movements, to which end he founded the Universal Negro Improvement Association and African Communities League. Garvey advanced a Pan-African philosophy which inspired a global mass movement, known as Garveyism. Garveyism would eventually inspire others, from the Nation of Islam to the Rastafari movement.

#### **Early Life**

Marcus Mosiah Garvey, Jr. was born on August 17, 1887, in St. Ann's Bay, Jamaica. Self-educated, Garvey founded the Universal Negro Improvement Association, dedicated to promoting African Americans and resettlement in Africa. In the United States, he launched several businesses to promote a separate Black nation. After he was convicted of mail fraud and deported back to Jamaica, he continued his work for Black repatriation to Africa.

Garvey was the last of 11 children born to Marcus Garvey, Sr. and Sarah Jane Richards. His father was a stonemason, and his mother a domestic worker and farmer. Marcus Sr. was a great influence on Garvey, who once described him as "severe, firm, determined, bold, and strong, refusing to yield even to superior forces if he believed he was right." His father was known to have a large library, where young

Garvey learned to read.

At age 14, Garvey became a printer's apprentice. In 1903, he traveled to Kingston, Jamaica, and soon became involved in union activities. In 1907, he took part in an unsuccessful printer's strike and the experience kindled in him a passion for political activism. Three years later, he traveled throughout Central America working as a newspaper editor and writing about the exploitation of migrant workers in the plantations. He later traveled to London where he attended Birkbeck College (University of London) and worked for the African Times and Orient Review, which advocated Pan-African nationalism.

Founding the United Ne-

#### gro Improvement Association (U.N.I.A.)

Garvey's Philosophy and

Garvey returned to Jamaica in 1912 and founded the Universal Negro **Improvement** Association (U.N.I.A.) with the goal of uniting all of African diaspora to "establish a country and absolute government of their own." After corresponding with Booker T. Washington, the American educator who founded Tuskegee Institute, Garvey traveled to the United States in 1916 to raise funds for a similar venture in Jamaica. He settled in New York City and formed a U.N.I.A. chapter in Harlem to promote a separatist philosophy of social, political, and economic freedom

for Black people. In 1918, Garvey began publishing the widely distributed newspaper Negro World to convey his message.

#### **Black Star Line**

By 1919, Garvey and U.N.I.A. had launched the Black Star Line, a shipping company that would establish trade and commerce between Africans in America, the Caribbean, South and Central America, Canada and Africa. At the same time, Garvey started the Negros Factories Association, a series of companies that would manufacture marketable commodities in every big industrial center in the Western hemisphere and Africa.

In August 1920, U.N.I.A. claimed 4 million members and held its first International Convention at Madison Square Garden in New York City. Before a crowd of 25,000 people from all over the world, Marcus Garvey spoke of having pride in African history and culture. Many found his words inspiring, but not all. Some established Black leaders found his separatist philosophy ill-conceived. W.E.B. Du Bois, a prominent Black leader and officer of the N.A.A.C.P. called Garvey, «the most dangerous enemy of the Negro race in America.» Garvey felt Du Bois was an agent of the white elite.

worst adversary of Garvey; history would soon reveal F.B.I. Director J. Edgar Hoover's fixation on ruining Garvey for his radical ideas. Hoover felt threatened by the Black leader, fearing he was inciting Black people across the country to stand up in militant defiance.

Hoover referred to Garvey as a "notorious negro agitator" and for several years, desperately sought ways to find damning personal information on him, even going so far as to hire the first Black F.B.I. agent in 1919 in order to infiltrate Garvey's ranks and spy on him.

"They placed spies in the U.N.I.A.," said historian Winston James. "They sabotaged the Black Star Line. The engines... of the ships were actually damaged by foreign matter being thrown into the fuel."

Hoover would use the same methods decades later to obtain information on Black leaders like Martin Luther King Jr. and Malcolm X.

#### **Charged and Deported to Jamaica**

In 1922, Garvey and three other

U.N.I.A. officials were charged with mail fraud involving the Black Star Line. The trial records indicate several improprieties occurred in the prosecution of the case. It didn't help that the shipping line's books contained many accounting irregularities. On June 23, 1923, Garvey was convicted and sentenced to prison for five years. Claiming to be a victim of a politically motivated miscarriage of justice, Garvey appealed his conviction, but was denied. In 1927 he was released from prison and deported to Jamaica.


Garvey continued his political activism and the work of U.N.I.A. in Jamaica, and then moved to London in 1935. But he did not command the same influence he had earlier. Perhaps in desperation or maybe in delusion, Garvey collaborated with outspoken segregationist and white supremacist Senator Theodore Bilbo of Mississippi to promote a reparations scheme. The Greater Liberia Act of 1939 would deport 12 million African Americans to Liberia

at federal expense to relieve unemployment. The act failed in Congress, and Garvey lost even more support among the Black population.

#### **Death and Accomplishments**

Garvey died in London in 1940 after several strokes. Due to travel restrictions during World War II, his body was interred in London. In 1964, his remains were exhumed and taken to Jamaica, where the government proclaimed him Jamaica's first national hero and re-interred him at a shrine in the National Heroes Park. But his memory and influence remain.

His message of pride and dignity inspired many in the early days of the civil rights movement in the 1950s and 1960s. In tribute to his many contributions, Garvey's bust has been displayed in the Organization of American States' Hall of Heroes in Washington, D.C. The country of Ghana has named its shipping line the Black Star Line and its national soccer team the Black Stars, in honor of Garvey.

## Are you being tracked by an AirTag? Here's how to check

Useful advice for anyone worried that one of Apple's trackers is following them without consent.

When the Airtag launched in 2021, Apple's Bluetooth tracker with ultra-wideband was lauded as a step toward the future of augmented reality and a great way to find everyday objects, like your lost TV remote. Cybersecurity experts expressed concern that the tracking device would be exploited by stalkers. As we get closer to AirTag's one-year anniversary, those warnings appear prescient.

Model Brooks Nader says an AirTag was secretly slipped into her coat during a night out in New York City. In Connecticut, a man was arrested and charged with stalking after police found an AirTag in the victim's car. Police in multiple states have issued warnings about the potential criminal uses of AirTags.

Newer AirPods have tracking abilities similar to AirTags, but the higher cost of Apple's earbuds limits their disposability as a tracking device.

On February 10, Apple updated its support page for AirTags with additional information and a firm denouncement of using the device to track people. Reporting from

9to5Mac suggests further AirTag updates will be rolled out this year.

Even though Tile and other competitors to the AirTag exist, the vastness of Apple's ecosystem sets the device apart. If you are concerned that a secret AirTag may be recording your location, these signs may help detect the tracker.

#### Signs an AirTag Is Tracking You

The type of smartphone you own affects how easily you can discover hidden AirTags. Owners of iPhones running iOS 14.5 or newer should receive a push alert whenever an unknown AirTag is nearby for an extended period of time

and away from its owner. Apple's website does not provide an exact time frame for when this alert is triggered.

When you click on the iPhone alert, you may be given the option to play a sound on the AirTag to help locate the device.

Check that you will receive these alerts by going into the Find My app, choose the Me tab in the bottom-right corner, and make sure Item Safety Alerts is green and toggled to the right under Notifications.

Months after the release of the AirTag, Apple launched the Tracker Detect app for Android phones. Unlike the security features available for the iPhone, the Android app does not automatically look for unknown AirTags. Users must initiate the scan.

According to Eva Galperin, director of cybersecurity at the Electronic Frontier Foundation, the reason for the app's limited functionality is complicated.

"This is actually a limitation of how the Android ecosystem works and how Android apps can work," she says.

"I have called on Apple and Android to work together to incorporate the level of mitigations that Apple provides in iOS into the Android operating system, but this requires a lot of cooperation between two groups who are normally rivals."

While some guides to finding AirTags recommend using Bluetooth scanners, Galperin does not consider this method to be reliable for tracker searching.

"I have tried using various Bluetooth scanners in order to detect AirTags, and they do not work all the time," she says.

Millions of Americans still do not own a smartphone. Without a device on hand, you must rely on visual and audible clues to

find any hidden AirTags. The circular white disc is slightly larger than a quarter.

As reported by The New York Times, Ashley Estrada discovered an AirTag lodged under her license plate, and her video documenting the incident was viewed over 20 million times on TikTok.

When the AirTag was first released, the tracker would emit a beeping noise if away from the owner for longer than three days. Apple has since shortened the time to 24 hours or less.

Despite the update, you might not want to rely only on sound to detect AirTags. Numerous videos on YouTube offer DIY instructions to disable the speaker, and noiseless versions of the trackers were even listed for a short time on Etsy.

#### What if I Find One?

The best way to disable an AirTag is to remove the battery. To do this, flip the AirTag so the metallic side with an Apple logo is facing you. Press down on the logo and turn counterclockwise. Now you will be able to remove the cover and pop out that battery.

Apple's support page for the AirTag suggests reaching out to the police if you believe you are in a dangerous situation.

"If you feel your safety is at risk, contact your local law enforcement, who can work with Apple to request information related to the item. You might need to provide the AirTag, AirPods, Find My network accessory, and the device's serial number."

One way to figure out the serial number is to hold the top of an iPhone or other near-field-communication-enabled smartphone to the white side of an AirTag. A website with the serial number will pop up. If you feel hesitant about scanning the AirTag or do not have the ability, a serial number is printed on the device beneath the battery.

### Who Does This Affect?

In the viral stories shared online and in po-

lice reports, women are often the victims of AirTag stalking, but Galperin cautions against framing unwanted tracking as solely an issue for women.

"I have been working with victims of tech-enabled abuse for many years," she says, "and I would say that about twothirds of the survivors that come to me are women. But a third of them are men. I suspect that number would be higher if there wasn't such a stigma around being an abuse victim or survivor."

She emphasized how men, women, and nonbinary people can all be victims of abuse, as well as perpetrators.

"When we paint it all with this really broad brush, we make it really hard for victims who don't fit that mold to come forward," says Galperin.

## OECS leaders support efforts to exonerate Marcus Garvey

CMC - Leaders of the Organisation of Eastern Caribbean States (OECS) have agreed to co-sign a letter being sent to United States President Joe Biden as they announced their support to the continued advocacy efforts for the posthumous exoneration of Marcus Garvey, the Jamaican-born Black nationalist and leader of the Pan-Africanism movement.

Garvey was known as the founder of the Universal Negro Improvement Association (UNIA). Formed in Jamaica in July 1914, the UNIA aimed to achieve Black nationalism through the celebration of African history and culture.

Garvey was born in St Ann's Bay, Jamaica on August, 17, 1887, the youngest of 11 children. To facilitate the return to Africa that he advocated, in 1919 Garvey founded the Black Star Line, to provide transportation to Africa.

But in 1922, Garvey was arrested in the United States for mail fraud in connection with the sale of stock in the Black Star Line.

He was sent to prison and later deported to Jamaica. In 1935, he moved permanently to London where he died on 10 June 1940. In 1964, his body was returned to Jamaica where he was declared the country's first national hero.

A statement issued by the St Lucia-based OECS Commission, said that the leaders of Antigua and Barbuda, Dominica, Grenada, St Lucia, St Vincent and the Grenadines, St Kitts-Nevis, Montserrat as well as Anguilla and the British Virgin Islands discussed the Garvey issue at their recently held summit.

It said that the request was made by former Jamaica Prime Minister P J Patterson of the P J Patterson Centre

for Africa-Caribbean Advocacy at the University of the West Indies Mona Campus, as the Centre prepared to launch an appeal to US President Joe Biden for the posthumous exoneration o Garvey.

"The efforts are being supported by the Marcus Garvey Institute, which launched a petition making the request of President Biden.

"The petition to posthumously exonerate the late Marcus Garvey is seeking 100,000 signatures in the month of February (Black History Month), a milestone which will trigger a response from the US President Joe Biden.

"As part of their contribution towards this effort, the OECS Heads of Government agreed to co-sign a letter addressed to President Biden calling for the posthumous exoneration of Marcus Garvey.

"The heads also agreed to lead a National Appeal for signatories to the petition in their respective countries," the OECS Commission said.

Grenada's Prime Minister Dr Keith Mitchell, who is also the OECS chair-

man, has pledged his full support towards the efforts and has encouraged citizens and organizations to get behind the campaign.

In St Vincent and the Grenadines, Prime Minister Dr Ralph Gonsalves has launched a Memorandum addressed to the people of his country, the Caribbean, Africa, the United States and the wider global community, calling for support for the campaign.

"Garvey, by his thoughts, ideas and deeds, is in the top drawer of the pantheon of heroic personalities in our hemisphere and globally. We must honour and revere him and his main body of work. We must support his exoneration," Gonsalves wrote in the Memo.

OECS Director-General, Dr Didacus Jules has added his voice to the campaign, making a special appeal to the US President in support of Garvey's exoneration.

"Mr President, I am respectfully urging your consideration for the posthumous exoneration of the Hon. Marcus Mosiah Garvey a National Hero of

## Opposition wants gov't to urgently evacuate Jamaicans from Ukraine

The Gleaner - The Opposition is urging the Government to urgently evacuate Jamaicans including students in Ukraine, now at the centre of geopolitical tension with Russia.

The Opposition says it is gravely concerned about a possible imminent invasion by Russia as diplomatic efforts towards a peaceful settlement by the United States, Germany, France, and others wane.

"Undoubtedly, with the commencement of the war, the skies will be closed to commercial traffic. The

chaos with such an event will see hundreds of thousands of people internally displaced within conflict zones, potentially engulfing the entire country," said Lisa Hanna, the Opposition Spokesperson on Foreign Affairs and Foreign Trade.

The government has been encouraging Jamaicans in Ukraine to prepare to evacuate if necessary.

She said the Opposition is paying close attention to the situation and is expecting that the Government will prioritise the safety of Jamaicans in Ukraine.

## Bermuda to end mass COVID-19 vaccination next month

Loop - The mass vaccination program against coronavirus (COVID-19) in Bermuda will come to an end on March 31.

"Starting today, Monday, February 14, Pier 6 hours of operation are 2 pm to 6 pm on weekdays and 10 am – 2 pm on Saturdays.

After March 31, the COVID19 vaccine will be available through physicians' offices, as well as participating pharmacies. However, there will likely be a charge for this service," Health Minister Kim Wilson said during last evening's COVID-19 update.

Approximately 71.9 percent of the population is fully immunised and 69.4 per cent have received their booster.

Meanwhile, the island recorded its 120th death as a result of COVID-19. This was the second death recorded this week.

Wilson did not reveal any further information on the deceased in her condolence message to family and friends.

Another 88 infections have been recorded to push active cases to 272.

According to data released by Wilson, 32 are imported while the remaining infections were either transmitted locally or are under investigation.

Jamaica and an outstanding Caribbean Leader who in the early twentieth century built the largest ever mass political movement of black people globally – the United Negro Improvement Association.

Honourable Garvey was unjustly convicted for "mail fraud" in the United States, served nearly three years of a five year sentence before being deported to Jamaica. In my per-

sonal capacity as well as in my official capacity as Director-General of the Organisation of Eastern Caribbean States (OECS), I respectfully appeal for his posthumous exoneration," Jules wrote.

The OECS Commission said it is urging all citizens, organizations, civil society and residents in the diaspora to join the efforts to exonerate "one of the all-time great leaders in the Caribbean and globally".

### **Biden warns Putin US will react** 'decisively and impose swift and severe costs' if Russia invades Ukraine

(CNN)-President Biden warned Russian President Vladimir Putin that the US and its allies will respond "decisively impose and swift and severe costs" on Russia should Putin decide to invade Ukraine.

In a roughly hour-long phone call, the White House said Biden made clear to Putin what he would be risking with an invasion.

A senior administration official told reporters following the call that the discussion was substantive but the US fears Russia may still launch a military attack anyway.

"President Biden was clear that, if Russia undertakes a further invasion of Ukraine, the United States together with our Allies and partners will respond decisively and impose swift and severe costs on Russia. President Biden reiterated that a further Russian invasion of Ukraine would produce widespread human suffering and diminish Russia's standing," the White House said in a statement, adding Biden "was clear with President Putin that while the United States remains prepared to engage in diplomacy, in full coordination with our Allies and partners, we are equally prepared for other scenarios."

The call between the two leaders comes hours af-

ter the US moved some of its forces out of Ukraine and ordered the evacuation of most of its embassy staff on Saturday as fears mount that a Russian invasion of the country could take place in the next few days.

The moves were yet another sign that the US fears Putin could order an invasion at any time, just one day after Biden's national security adviser warned Americans in Ukraine to leave and that military action could begin with an aerial bombardment that could kill civilians.

A senior administration official told reporters Saturday afternoon that the call between the two presidents was "professional and substantive," but "there was no fundamental change in the dynamic that has been unfolding now for several weeks."

"The two Presidents agreed that our teams will stay engaged in the days ahead," the official told reporters after the call. "Russia may decide to proceed with military action anyway. Indeed, that is a distinct possibility."

The official said that Biden reiterated the US' ideas on how to enhance European security while also addressing some of Russia's security concerns, but noted that it "remains unclear whether Russia is interested in pursuing its goals diplomatically."

Asked whether Russia has made a decision to invade, the official said, "I think the honest answer to that question is we don't have full visibility into President Putin's decision making."

"But you know, we are not basing our assessment of this on what the Russians say publicly," the official continued. "We are basing his assessment on what we are seeing on the ground ... which is a continued Russian buildup on the border with Ukraine, and no meaningful evidence of de-escalation, or really of any interest in de-escalation."

Russian presidential aide Yury Ushakov described the call Saturday as "balanced and businesslike," but said the US and NATO had failed cont'd on pg 21

## Philippine poll shows Marcos Jr's lead widening in presidential race

The son and namesake of late Philippine dictator Ferdinand Marcos strengthened his lead over his closest rival ahead of the presidential election in May, results of a new poll released on Sunday (Feb 13) showed.

Ferdinand Marcos Jr garnered a 44-point lead over Philippine Vice President Leni Robredo in the Jan 19 to 24 survey by independent pollster Pulse Asia, an 11-point increase compared with the previous poll in early December.

A total of 2,400 respondents were asked to pick their first choice for president and vice president if the election were held during the survey period, with 60 per cent expressing preference for Marcos, while 16 per cent chose Robredo.

In the December poll with the same sample size, Marcos was on top with 53 per cent compared to Robredo's 20 per cent.

Boxing superstar Man-

ny Pacquiao and Manila city mayor Francisco Domagoso trailed, each getting 8 per cent, while Senator Panfilo Lacson took 4 per cent.

In the Philippines, the president and vice president are elected separately.

Marcos' running mate, Sara Duterte-Carpio, the daughter of incumbent President Rodrigo Duterte, remained the top choice for vice president, taking a 21-point lead over her closest rival, Senate President Vicente Sotto.

The latest Pulse Asia survey was conducted before the Philippines' Commission on Elections last week dismissed a series of complaints seeking to disqualify Marcos, removing a major hurdle for him in the May 9 contest.

The complaint's petitioners have vowed to

challenge the decision and can appeal to the Supreme Court.

The election body also rejected a complaint seeking the cancellation of Marcos' certificate of candidacy.

As frontrunner, Marcos appears poised to complete a remarkable rebranding of the family name 36 years after a "people power" uprising ended his father's autocratic rule.

to address Russia's main security concerns.

Ushakov said the conversation "took place in an atmosphere of hysteria about the supposedly imminent Russian invasion of Ukraine by American officials, everyone knows this."

Ushakov added: "The pressure around the topic of the invasion was carried out in a coordinated manner and the hysteria has reached its climax."

According to Ushakov, Biden told

Putin he was "committed to the diplomatic path and had laid out a range of considerations that he sees as addressing many of Russia's concerns." Putin said the US and its allies had been "pumping up" Ukraine with new weaponry and encouraging provocations by Ukrainian forces in the Donbas region and in Crimea, Ushakov said.

The Russian Ministry of Foreign Affairs had on Friday accused Western countries and the press of spreading a "large-scale disinformation campaign" about an allegedly impending Russian invasion of Ukraine "in order to divert attention from their own aggressive actions."

"At the end of 2021 and the beginning of 2022, the global information space faced a media campaign unprecedented in its scale and sophistication, the purpose of which is to convince the world community that the Russian Federation is preparing an invasion of the territory of Ukraine," the Ministry said in a statement published on its website.

## Tunisia: President issues decree to create new judicial watchdog

Al Jazeera -Tunisia's president has issued a decree establishing a new provisional Supreme Judiciary Council, effectively replacing the body he abolished and granting himself additional powers to control the country's top judicial organisation.

The decree, published on the official gazette on Sunday, says the president controls the selection, appointment, promotion, and transfer of judges and can act in certain circumstances as a disciplinary body in charge of removals. Contrary to international law, none of the judges appointed in the new council will be elected.

It also forbids judges from going on strike, a form of dissent used to protest President Kais Saied's February 6 announcement that the council would become "a thing of the past".

Later on Sunday, protesters took to the streets of the capital Tunis as part of a march organised by the country's biggest political party Ennahda and a separate civil society organisation that had been scheduled prior to the decree being made public.

Waving Tunisian flags, some chanted "Shut down the coup... take your hands off the judiciary".

Nadia Salem, one of the protesters, told Reuters news agency that "what has happened is the completion of the coup... Tunisia has become a nascent dictatorship after being a nascent democracy".

On Thursday, Saied had appeared to be backpedaling when Justice Minister Leila Jaffel told national television the judicial body would be reformed rather than abolished.

But Anas Hamadi, president of the Association of Tunisian Judges, told Al Jazeera that Sunday's presiden-

tial decree meant Saied abolished the "legitimate council" and "installed a new council obedient to the executive power" despite the absence of legal grounds in doing so.

"The work of this council is subject to the will of the president, there are no elected members," Hamadi said. "The president has the right to veto over the work of this body and to overturn its decisions.

"This is a blatant and clear overtaking of the judiciary power that goes against democratic principles."

Sunday's protests follow a twoday strike launched on Wednesday by the Association of Tunisian Judges that was widely observed nationwide.

Hamadi said a "crisis cell" has been created within the association to discuss the actions going forward, after the president "prohibited the right to strike" enshrined in article 36 of the constitution.

The International Court of Justice (ICJ) said on Twitter the decree "con-

solidates power in the hands of the President," effectively ending "any semblance of judicial independence in the country."

"It brings Tunisia back to its darkest days, when judges were transferred and dismissed on the basis of executive whim," the ICJ said, calling the decree "unconstitutional and illegal."

Tunisia, often lauded as the only democracy to emerge from the 2011 Arab Spring revolts, has seen some of its gains reversed since Saied was elected president with almost 73 percent of the vote in a runoff election in October 2019.

Saied, who has put fighting corruption at the heart of his programme, said that removing the judicial council was necessary as Tunisians wanted the country "cleansed".

He has said his actions were temporary but has not specified a fixed term for the newly formed provisional council.

### Valieva's entourage under investigation by World Anti-Doping Agency

Reuters - The world's top anti-doping authority will investigate the entourage of 15-year-old Russian figure skater Kamila Valieva who tested positive for a banned drug, plunging her into a doping scandal at the Beijing Winter Olympics.

Valieva, whose Olympic future will be decided after a Court of Arbitration for Sport (CAS) hearing that started at 8:30 p.m. Beijing time (1230 GMT), effortlessly completed a clean run-through of her short programme in practice on Sunday.

Watching from the sidelines were her three coaches, Eteri Tutberidze, Sergei Dudakov and Daniil Gleikhengauz, as well as the team doctor Filipp Shvetsky and a physiotherapist.

The World Anti-Doping Agency (WADA) said in a statement to Reuters on Sunday that it would ask its independent Intelligence and Investigations Department to investigate the coaches, doctors and other adults surrounding the athlete.

Earlier, the International Olympic Committee (IOC) said it had formally asked WADA to launch an investigation.

WADA also said that the Russian Anti-Doping Agency (RUSADA) has started investigating the entourage because Valieva is a minor.

From the hotel where the athlete's fate was being decided, CAS Director General Matthieu Reeb told reporters that he expected Valieva to testify via video link and that the hearing could go on all night.

"We don't know how long it will take," Reeb cont'd on pg 25

## Haitian rides 'Magic Powder' to Winter Olympics

Call it love at first snow-flake.

Long before he became Haiti's first Winter Olympian, at the Beijing Games on Sunday, Richardson Viano was a scared orphan who'd just arrived in France from the poor Caribbean nation.

His new adoptive parents were driving him to their home in the French Alps.

Their route that day in 2005 — from the airport where he had just disembarked, so nervous about his unfamiliar surroundings that he clung to his new dad's leg — took them over a high Alpine pass.

It was resplendent with fresh snow and bathed in sunshine, so Andrea and Silvia Viano decided to stop to let 3-year-old Richardson take in the view.

"I said, 'Look Richie, this is where you are going to live,'" his mother recalled. "'See the snow and everything?""

He'd later coin his own phrase for it: "The magic

powder."

It magically lifted his mood that day, when a snowflake landed on his nose.

"It melted with the warmth," his mother remembers. "He started laughing."

And so was planted the first seed of what became a passion for skiing that, at the Yanqing Alpine Skiing Center in the mountains northwest of downtown Beijing, turned Viano into

an Olympic history-maker for the island of his birth.

"It's a great honor," the 19-year-old said. And, he hopes, an inspiration for others in Haiti.

"If other Haitians can ski, that would be incredible," he said. "I want to give them a message of hope, of strength, no matter the sport. What's important is to never give up, to fight. Anything can happen if you believe."

Well, yes, and no.

With his mother on hand

to watch him race, he tumbled a few gates into the men's giant slalom course that was hard to see in falling snow and fog.

He was far from alone in being caught in treacherous conditions. Of 87 starters, 33 didn't complete the first of two runs — Viano among them.

"The magic powder' was treacherous today," his mother said. "It would have been nice if that snowflake could have brought him a bit more luck."

Viano hopes to do better in the men's slalom on Wednesday. And the big picture of his life so far is still impressive.

"It's an amazing adventure when I think about it: leaving Haiti, arriving in the mountains, starting to ski a bit by chance.

"My dad was a mountain guide and he put me on skis as soon as I arrived, in 2005, and I've skied pretty much all the time ever since," he said.

"It really is a passion."

The bowling performances have been commendable but the Windies batting line-up continued their struggle as they were dispatched 3-0 by India on Thursday. In South Asia the team looked lacking the technical ability needed to put partnerships together at critical times or spend prolonged periods at the crease.

West Indies who lost the ODI series to Ireland last month for the first time because of their poor performance with the bat, perhaps more than ever looked susceptible to losing wickets in huge clusters making it impossible to chase moderate targets.

Simmons told the media Thursday, "This is difficult, the last six games have been difficult in this format. We started putting things together last year when we played Sri Lanka, it was difficult against Aus-

tralia, but we started putting things together. For this type of performance to come now, it's hard to take from the batsmen.

"It's not outwardly showing, but it's hurtful and the players know that. We have to make sure that we do the right things moving forward to get this batting line-up or whoever the batting line-up is to function as a batting line-up, to have big partnerships and assess the thing properly."

Simmons accused the batters of not assessing the situations properly noting the mode of dismissals is the biggest issue.

"We can't keep going like this," he noted."
