# Ministry of Education: We are ready for National Assessment

The annual Grade 6 National Assessment examinations begin today in primary schools across Antigua and Barbuda.

Education Officer - Measurement and Evaluation, Ineta Francis said, all systems are a go for the examinations. "We are one hundred percent ready to administer the exams starting today," she declared.

Francis explained that the process is quite lengthy and starts very early in the year. "The process starts in January and concludes at the end of June or early July when the results are made public. It's a very long process as much has to be put in place in order for this two-day exam period to come off well; the way it ought to," she explained.

This year, thirteen hundred and thirty (1,330) students will write the exams. They are drawn from government primary schools

- 744, and private primary schools – 585, with one child who has been homeschooled. The number is 36 less than those who wrote the exams last year.

"These students have been preparing themselves from the time they hit Grade 6. The first part of the process is for them to complete their School-Based Assessment projects.

"Those would have already been handed in, to

the teachers in the schools.


Today, Wednesday, June 7, marks the start of the written exams which continue into Thursday. The papers for Language Arts 1 & 2 followed by Science are the subjects listed for today. The Mathematics papers are scheduled for Thursday.

### Government welcomes the return of visa-free travel to Canada

Foreign Minister, E. his government "was very Paul Chet Greene, has welcomed the news that many hundreds of Antigua and Barbuda nationals can more easily travel to Canada, with immediate effect.

pleased by the announcement of Canada's minister of immigration, refugees, and citizenship of Canada, who named Antigua and Barbuda among thirteen (13) countries whose

The minister said that

nationals can travel to Canada on its electronic travel authorization (eTA) program."

Under the eTA program, nationals of Antigua and Barbuda who have either been issued a Canadian visa in the last 10 years or who currently are in possession of a valid United States, non-immigrant visa, can now apply for an eTA instead of a visa when traveling to Canada by air.

Applying for an eTA is done on the Internet, requiring no travel expenses.

Minister Greene said that this decision by Canada is one for which the Antigua and Barbuda government has been working "assiduously," given the burden that had been placed by the requirement to travel to Barbados or Trinidad, to secure a visa.

"We are very glad that our efforts have borne fruit and that this burden has been lifted for many hundreds of Antiguans and Barbudans," the minister said.

Introducing visa-free air travel will make it faster, easier, and more affordable for Antigua and Barbuda nationals to visit Canada for up to six months, for either business or leisure.

Minister Greene pointed out that while persons who have not traveled to Canada in the last 10 years or who do not have a US visa, will still have to apply for a Canadian visa, the majority of the Antigua and Barbuda traveling public qualify for the eTA.

# National Agriculture Health and Food Safety Policy coming

Antigua and Barbuda is moving towards establishing an Agriculture Health and Food Safety Policy for the country, designed to improve the national agriculture and food safety systems.

The announcement is contained in remarks delivered by Agriculture Minister, E.P Chet Greene to commemorate the observance of World Food Safety Day (WFSD), today June 7.

"This policy will include measures for establishing participation in the work of Codex as part of the agriculture, health, and trade mandates. The development of stronger synergies between these sectors through the use and application of standards will be key for advancing the achievement of key Sustainable Development Goals to include but not limited to Goal 2 – Zero hunger, and Goal 12 – responsible production

and consumption," he remarked.

He added that as the Ministry of Health does its part to bring recognition to the WFSD activities to highlight and recognize the benefits of safe food, the Ministry of Agriculture and the government are encouraging all residents to increase their interactions with Agriculture, Health and the Bureau of Standards to avail themselves of the information and resources that are accessible to all.

"The information, resources, and awareness activities can ultimately assist each individual to realise an improvement in food safety and the general quality of life," he stated.

He recalled that the road to the inaugural World Food Safety Day started with the Codex Alimentarius Commission at its 39th session in 2016, unanimously agreeing to promote a proposal to proclaim WFSD on a permanent basis within the framework of the United Nations.

Minister Greene is also congratulating the Codex Alimentarius Commission on its 60th anniversary and for spearheading efforts to establish WFSD as a permanent observance. Since then, he revealed that the Commission has been exercising its mandate to develop standards, guidelines, and codes of practice that contribute to the safety and quality of food, and fairness of international food trade.

"When these standards, guidelines, and codes of practice are applied, consumers can trust the safety and quality of the food products they buy, and importers can trust that the food they ordered will be in accordance with suitable quality and safety specifications," he concluded.

The Antigua and Barbuda Bureau of Standards, in its capacity as the National Codex Contact Point (NCCP), said it is celebrating World Food Safety Day (WFSD) with its stakeholder counterparts in the Ministries of Agriculture and Health, under the theme 'Food Standards save lives.'

WFSD 2023 also marks the 60th Anniversary of the Codex Alimentarius Commission, which is the body responsible for setting international standards for food safety, food and guidelines for food trade.




#### How Food Becomes Contaminated

Foodborne disease is a universal problem caused by consumption of contaminated food and drink.



- Pathogens can be introduced into food from infected humans who handle food without thoroughly washing their hands. This is especially relevant to persons whose job is to prepare food.
- Pathogens thrive in warm & moist conditions. Generally, refrigeration prevents virtually all microbes from growing while heating food sufficiently kills most microbes.
- Cooked foods can be re-contaminated by transferring pathogenic microbes through raw foods, contaminated utensils and surfaces.



 Pathogenic microbes in animal's intestines can cause contamination during slaughter.

#### Common Culprits

More than 200 pathogens are associated with foodborne disease & they include bacteria, viruses & parasites. Harmful bacteria are the most common cause. Below are a few examples.



#### E.coli

- 1-3 days after ingestion
   Found in animals & human's intestinal tract
   Watery diarrhea, abdominal cramps, some
- vomiting
  Water or food contaminated with human faece

#### Salmonella

- 6-48hrs after ingestion
   Diarrhea, fever, abdominal cramps, nausea vomiting
- Found in animals, raw poultry & birds
   Eggs, poultry, meat, unpasteurized milk, cheese, contaminated raw fruits & vegetables

#### Staphylococcus aureus

- 1-6hrs after ingestion
   Severe nausea & vomiting, Abdominal cramps diarrhoea & fever
   Found in human nose, throat & skin
- Found in numan nose, throat & skin
   Improperly refrigerated meats, potato & egg salads, cream pastries

#### Listeria monocytogenes

- 3 days 10 weeks after ingestion
   Meningitis, sepsis, muscle aches, nausea diarrhoea, Stillbirths
- Found in soil, water & some animals raw milk, & dairy products, soft cheeses made ith raw milk, ready-to-eat deli meats & hot dogs

#### Bacillus cereus

-10-16 hrs after ingestion

- Abdominal cramps, watery diarrhoea, nausea

- Found in soil, vegetation, cereals & spices

- Improperly refrigerated cooked rice & pasta,
Meats, stews, gravies

#### Lab Diagnosis

The detection of microbes in food are an essential part of any quality control or food safety plan. The contaminated food is homogenized and placed on specialized growth medium.

#### **EC Broth**

- *E.coli* under long-wave UV light glows bright green/blue.



#### XLD Agar

- Salmonella appears red with black centers.



#### **Baird Parker Agar**

- S.aureus appears black with clear zones.



#### Oxford Agar

- L.monocytogenes appears brown/ black.



#### MYP AGAR

- B.cereus appears pink/red.

### **Health Ministry widens mask mandate**

The Ministry of Health is extending the mask mandate it reintroduced over a week ago, in response to reports that the cases of the COVID-19 virus are on the rise. The ministry said in a press release. that in May the World Health Organization (WHO) declared the end of the public health emergency for the COVID-19 virus. However, it noted, the threat of COVID-19 and its associated risks remain, and is very evident, as the virus has not been eliminated.

"The Ministry remains steadfast in its commitment to providing the best possible healthcare to citizens and resi- · Clarevue Psychiatric Hospital dents of Antigua and Barbuda, in a safe environment.

"Therefore, effective immediately, persons visiting or working on the premises of public Healthcare Institutions, will be required to wear a clean, properly fitted mask covering the nose and mouth," it added.

# Soil-testing project launched with a bang!

The national soil-testing project that will seek to identify soil types across both islands – Antigua and Barbuda – is now underway with a team of technicians, in Barbuda, carrying out the exercise.

A team of fifteen persons consisting of Partnership Initiative for Sustainable Land Management (PISLM) and Ministry of Agriculture technicians, will be there for the next four days as part of the samplings of the various soil types, on the sister island.

The project launched on Monday by the Ministry of Agriculture (MoA) in collaboration with PISLM under the theme 'Caribbean Small Island Development States (CSIDS) Multi-country Soil Management Initiative for Integrated Landscape Restoration and Sustainable Food Systems: (CSIDS\_SOILCARE Phase1)". The project has several phases that are expected to span over the next



four years.

In her opening remarks, Parliamentary Secretary Senator Knacyntar Nedd-Charles, who joined via ZOOM, expressed gratitude for this and such projects that would foster sustainability, offer more yield, and healthier foods for everyone to benefit from. Further, she explained her profound approval of Barbuda's inclu-

sion in the CSID project.

The project implementation, executing agency support, and overview were delivered by Simone Dias, the PISLM project assistant. During her statement, Dias identified several other stakeholders including GEF, FAO, the Department of Environment (DoE), and Farmers

To conclude her remarks

on behalf of the project coordinating office, she extended heartfelt gratitude to the DoE, MoA, and the government for the support given to the CSID project thus far.

The technicians will be on the ground here in Antigua, from Monday 12th to Wednesday 21st of June. It is intended that a total of a hundred and twenty (120) samples will be collected.


# High Court re-opens today for limited hours

The High Court Building in St. John's is re-opening today (Wednesday, June 7) after being closed to have the building fully cleaned for allergens.

High Court Registrar, Cecile Hill, said following extensive cleaning of the interior and continued work being done on the air conditioning units, the Public Servants Association President, Joan Peters, met with the staff on Tuesday and informed them that she is pleased with the work that was done and that they could now return to work.

The staff at the High Court had been complaining that allergens in the building had been making them sick, and it was because of their intervention that the Court was closed for deep cleaning.

However, Hill said over the next three days the court will operate from 9:00 am to 1:00 pm. This changes next Monday when the office hours return to normal.

### Guyanese government worried at the low intake of HPV vaccines

CMC - Health Minister for the management of Dr Frank Anthony says the low adoption rate of HPC vaccines in Guyana has become a cause for concern even as cervical cancer is the second most common cancer affecting women in the country.

Health authorities here said that the vaccines serve as a vital safeguard against HPV infections and cervical pre-cancers.

Speaking at the launch of the national expansion of the HEARTS Initiative

cardiovascular Anthony noted that since the introduction of the programme in Guyana, the number of persons who are vaccinated remains at a minimum.

"It's not a lack of resources ...we have to start by getting more people to take HPV vaccines," he said, noting "how are we going to prevent cervical cancer from happening if we don't have a broad base programme?



"This is something, I recall HPV vaccination was started...a long time

ago. Up to now, we have not been able to scale it up to where it ought to be," Anthony said, emphasising the critical need for medical professionals to re-evaluate the implementation of the programme, recognising the pivotal role they play in bringing real change in the country.

"It's not that we don't have the tools to prevent, it's that we're not implementing the tools to the scale that we need to implement it, to make that impact and to bring that change," the health minister said.

According to the Centres for Disease Control and Prevention, all HPV vaccines protect against at least HPV types 16 and 18, which places individuals at the greatest risk of developing cervical cancer.

HPV is a sexually transmitted virus that can cause a range of health issues, including genital warts and cancer.

# 'Ducking hell' to disappear from Apple autocorrect

Apple has said it will no longer automatically change one of the most common swear words to 'ducking'.

The autocorrect feature, which has long frustrated users, will soon be able to use AI to detect when you really mean to use that expletive.

"In those moments where you just want to type a ducking word, well, the keyboard will learn it, too," said software boss Craig Federighi.

He announced the development at Apple's developers' conference in California.

iPhone users have often complained about how autocorrect forces them to



rewrite their own messages
- with the term "damn you
autocorrect" becoming an
acronym, a meme, an Instagram account and even a
song.

The changes to the function will happen thanks to the use of a transformer model, which learns context by tracking relationships in data, like the words in this sentence, using mathemati-

cal techniques.

Initially flagged in a 2017 paper from Google, transformers are some of the most powerful classes of AI models, and autosuggest - or predictive text - systems are beginning to become more mainstream.

The autocorrect change will be part of the iOS 17 operating system upgrades

which are expected to be available as a public beta in July, with the general release in September.

It should mean that iPadOS 17 also carries the new function.

Elsewhere at the developers' conference, Apple unveiled an augmented reality headset, Apple Vision Pro which will retail at \$3,499 (£2,849).

Apple chief executive Tim Cook said the new headset "seamlessly blends the real world and the virtual world".

It will be available early next year in the US and in other countries later in 2024. On Monday, Apple's market valuation reached just under \$3 trillion - a new company record.

# Cuba Gooding Jr settles rape lawsuit ahead of civil trial

Actor Cuba Gooding Jr has settled a lawsuit with an unnamed woman who accused him of raping her in a New York City hotel room in 2013.

It came as jury selection was about to begin in a federal civil trial that was expected to include damaging testimony against him.

The Oscar winner, 55, has denied the allegation and insists his interactions with the woman were consensual.

He has been accused of groping and unwanted touching by dozens of women.

The terms of the settlement have not been disclosed.

Last year, Mr Gooding pleaded guilty to kissing a woman without her consent.

That case saw him spared from jail or a criminal history, with charges relating to three other accusers dismissed as part of a plea agreement with prosecutors.

He was ordered to complete six months of alcohol and behavioural counselling.

But the testimony of those three women, who say the actor abused them between 2009 and 2019, was due to be heard at this civil case in Manhattan.

The now-settled lawsuit was filed in 2020 on behalf of a woman identified only as Jane Doe. The plaintiff sought \$6m (£4.8m) in damages.

She alleged that, in the summer of 2013, Mr Gooding had introduced himself to her at a local restaurant and invited her to drinks at The Mercer Hotel in Soho, where he was staying.

At the hotel, she claimed, the actor told her he needed to change clothes, invited her up to his fifth-floor room and began to undress.

The woman said she had tried to leave but that Mr Gooding blocked

her path, pushed her onto the bed, "wouldn't stop" touching her, "aggressively removed" her underwear and penetrated her twice.


A lawyer representing the defendant at the time called the allegations "completely false and defamatory".

The presiding judge ruled last week that he would allow testimony from three of Mr Gooding's other accusers because they were "sufficiently similar" to the plaintiff's allegation.

One woman, Kelsey Harbert, said last year that Mr Gooding's previous plea deal had been "more disappointing than words can say".

Jury selection in the trial was set to begin at 10:00 EDT on Tuesday, but neither Mr Gooding nor attorneys for either side showed up.

An entry on the court's electronic docket for the case reads: "TRIAL OFF. Reason for cancellation: The parties have resolved the matter."

# St Kitts PM: Security forces to ramp up fight against gun violence

The number of crimes being committed with illegal firearms in St Kitts and Nevis has become worrisome, with Prime Minister Dr Terrance Drew announcing that the island's security forces will be taking further steps to tackle the upsurge in gun violence.

In a national address this afternoon, the prime minister said the security forces will implement the following:

- \* Increased security presence in communities through various methods
- \* Further engagement of regional and international security experts to work along with St Kitts and Nevis' forces
- \* Strengthening of the intelligence capabilities of the security forces

- \* Expansion of the CCTV infrastructure island-wide
- \* Enhancement of evidence-gathering capabilities to ensure that perpetrators are brought to justice.

He also announced that the Cabinet has agreed to table legislation in the National Assembly to increase the penalty for illegal firearms offences from 15 years to 25 years in prison. In addition, the National Security Task Force has been commissioned to take the lead on a behaviour-changing initiative, "Crime and Violence as a Public Health Issue".

The prime minister lamented that the country has been shaken by the recent upsurge in gun violence, and from reports, a majority of which are linked to gang-related violent crimes, highly

concentrated in the Central Basseterre community.

PM Drew told citizens the present upsurge in criminal activity is a natural and direct result of the monetisation of crime management.

He said similar methods were tried and failed in Jamaica, Trinidad & Tobago, Mexico, Haiti and El Salvador, for example, and in every occasion, it resulted in what is being seen right now in the Federation of St Kitts and Nevis.

The prime minister made an appeal to all young men and women to move forward as law-abiding citizens with respect for the rights of livelihoods of others.

He also extended condolences to the families of those who have succumbed to violent crimes.

# Dengue worries: Grenada secures mosquito nets for pregnant women

Loop - The transmission of dengue fever through the Aedes Aegypti mosquito continues to pose a problem in Grenada with steps being taken to protect pregnant women.

The Community Nursing Division of the Ministry of Health, Wellness, and Religious Affairs distributed approximately 1,000 mosquito nets at health centres across Grenada, Carriacou, and Petite Martinique

in the six health districts, as part of its strategic response and ongoing efforts to prevent the spread of dengue among pregnant women and the public.

The ministry says the nets are highly recommended for use by pregnant women who are in their 3rd trimester (last three months of the pregnancy).

# Death toll climbs as rains continue to affect Haiti

CMC - The death toll from the heavy rains, which have been pounding the French Caribbean Community (CARICOM) island of Haiti since the last weekend, climbed to 42 with 11 others missing, Haitian authorities have confirmed.

Head of the Civil Protection Office (DPC), Jerry Chandler, in a provisional report said that at least 12,779 families have been affected with an estimated 13,633 houses flooded in several departments.

"The biggest impact was the West region (metropolitan area). The other ecologically vulnerable regions of the country that have suffered heavy damage are: the North West; Nippes and the South-East."

The provisional report showed that 85 people have been injured following the rains, which have been pounding the country since June 1 and expected to continue during this week.

Prime Minister Dr Arield Henry has already indicated that his government is seeking international assistance to respond to the

needs of the population affected by the rains that have caused several rivers to overflow their banks resulting in floods, and landslides in many areas.

"My government, in concert with national and international institutions, is taking urgent measures in order to meet the demands of the hour," he said in a Twitter posting.

Chandler said that security remains a concern as the authorities attempt to respond to the disaster while trying to manoeuvre through gang-controlled territory to bring aid to the population.

He said damage assessment is ongoing and emergency response teams are being mobilized and trying to support affected communities. Alongside UN aid groups, civil protection volunteers are slowly deploying shelter, food and sanitation facilities, as well as drinking water for those affected.

The Acting Humanitarian Coordinator for Haiti, Jean-Martin Bauer, said although it is not a hurricane or a tropical storm but a strong depression, considerable damage has been reported in the affected areas.

"The humanitarian

community is working alongside national institutions to come to the aid of those affected," he said, adding "I'm particularly concerned about this situation when the Haitian population is already facing great vulnerabilities

"The humanitarian response plan is still too weak financed with only 20 per cent of the necessary budget received. I call for solidarity with the Haitian people from all donors to ensure the financing of this plan which will be critical in the response to these floods and the preparation for the next bad weather," Bauer added.

The World Food Programme (WFP) said it would "start providing hot meals to displaced people in the coming hours and are mobilising ready-to-eat rations and dry food".

# Ukraine dam: Thousands flee floods after dam collapse near Nova Kakhovka

BBC - Thousands of people are being evacuated downstream of a major dam which has collapsed in Russian-held Ukraine.

President Zelensky said 80 towns and villages were at risk of flooding after the destruction of the dam at Nova Kakhovka, which he blamed on Russia.

Water is surging down the Dnipro river and is said to pose a catastrophic flooding risk to the city of Kherson.

Russia has denied destroying the dam - which it controls - instead blaming Ukrainian shelling.

Neither Ukraine nor Russia's claim has been verified by the BBC.

The Kakhovka dam is crucial in the region. It contains a reservoir, which provides water to farmers and residents, as well as to the Zaporizhzhia nuclear power plant. It is also is a vital channel carrying water south to Russian-occupied Crimea.

Video footage shows a torrent of floodwater gushing through a breach in the dam. Several towns are already flooded, while people in areas further downstream were forced to flee by bus and train.

Around 40,000 people need to be evacuated, Deputy Prosecutor-General Viktoriya Lytvynova said on Ukrainian television - 17,000 people in Ukraine-controlled territory west of the Dnipro River and 25,000 on the Russian-controlled east.

Also speaking on Ukrainian television, Interior Minister Ihor Klymenko said about 1,000 people had been evacuated so far and "24 settlements" had been flooded.

He accused Russia of shelling the southern region of Kherson, where people were being evacuated from, and issued a warning about the dangers posed by mines being exposed by

the rising water levels.

One local resident Andriy, who lives close to the dam - which has been under Russian control throughout the invasion - said he believed Russia wanted to "drown" his city.

In Kherson, a woman called Lyudmyla - who was loading her belongings including a washing machine onto a trailer that was attached to an old car said: "We're afraid of flooding. We're taking our things a little higher up."

She called for Russian forces to be "kicked out of here... they're shooting at us. They're flooding us or doing something else".

Another resident of the city, Serhiy, said he feared "everything is going to die here".

"All the living creatures, and people will be flooded out," he said, gesturing at nearby houses and gardens.

On the Russian-controlled riverbank, Vladimir Leontyev, the Moscow-installed mayor of Nova Kakhov-ka where the dam is located, said the city was underwater and 900 people had been evacuated.

He said 53 evacuation buses were being sent by the authorities to take people from the city and two other settlements nearby to safety.

Nova Kakhovka's Russian-installed mayor said water levels had risen to over 11m (36ft) and that some residents had been taken to hospital, but gave no further details.

The Kazkova Dibrova zoo on the Russian-held riverbank has been completely flooded and all 300 animals are dead, it said in a post on its Facebook page.

There are concerns about the impact on the Zaporizhzhia nuclear power plant, which uses water from a reservoir behind the dam for cooling.

The situation there is said to be under control and the International Atomic Energy Agency (IAEA) has said it is monitoring the situation closely.

The UN agency said it saw "no immediate nuclear safety risk" at Europe's biggest atomic plant.

It is not yet clear what caused the breach in the dam, but Ukraine's military intelligence has accused Russia of deliberately blowing it up early this morning.

This seems plausible, as Moscow may have feared that Ukrainian forces would use the road over the dam to ad-

vance into Russian-held territory, as part of their counter-offensive.

For Russia, anxious to defend conquered territory in southern Ukraine, the dam represented an obvious problem.

Just as Ukrainian forces attacked road and rail bridges further downstream last autumn in a successful effort to isolate Russian forces in and around Kherson, Russia may have decided to destroy the dam to hold up Ukraine's counter-offensive, which it fears could come from multiple directions.

However, a Russian official claims Ukraine carried out the attack on the dam to detract from what they said were the failures of its counter-offensive and to deprive Crimea of fresh water.

A major Ukrainian push has long been expected. Kyiv has said it would not give advance warning of its start but a recent increase in military activity is being seen as a fresh sign that the counter-offensive may have begun.

Senior Ukrainian military commander Serhiy Naev said the dam blast would not stop Ukraine from advancing.

On Monday, Ukraine's deputy defence minister Hanna Maliar said Ukrainian forces had advanced around the "epicentre of hostilities" in Bakhmut, but did not say whether the counter-offensive had begun.

Bakhmut has for months been at the heart of fierce fighting. It has little strategic value - but is important symbolically both for Kyiv and Moscow.

In the aftermath of the attack on the dam, Mr Zelensky said he had called a meeting of the country's security and defence council.

Blaming "Russian terrorists" for the partial destruction of the dam, Mr Zelensky said "it's only Ukraine's victory that will return security".

Yuri Sak, an adviser to Ukraine's ministry of defence, told the BBC Radio 4's Today programme that phone intercepts suggest Russia wants to target more dams.

"They're actually calling to blow up more dams on the Dnipro river," he said.

Ukraine has branded the attack on the dam "ecocide" and said that 150 tonnes of engine oil has spilled into the Dnipro river.

Ukraine's hydroelectricity operator has said that a power station linked to the dam had been "completely destroyed... the hydraulic structure is being washed away".

World leaders have laid the blame for the blast at Russia's door, with some calling it a war crime. UK Prime Minister Rishi Sunak said that if Russia was found to be responsible for the collapse of the dam it would "demonstrate the new lows that we will have seen from Russian aggression".

The head of Nato, Jens Stoltenberg, said the destruction of the dam demonstrated once again the brutality of Russia's war in Ukraine, while Charles Michel, the president of the European Council, said he was "shocked by the unprecedented attack".

The Geneva Conventions explicitly ban targeting dams in war due to the danger it poses to civilians.

# Prince Harry: Hearings begin over US visa records

A federal judge has begun hearing arguments in a case that hopes to make public the Duke of Sussex's US immigration records.

The lawsuit, from the conservative Heritage Foundation, seeks to compel the government to release the records to show whether drug use was disclosed.

Prince Harry, 38, has publicly admitted to using cocaine, marijuana and psychedelic mushrooms.

A decision in the case, being heard in Washington DC, may take weeks.

Application forms for US visas specifically ask about current and past drug use.

Drug use can lead to non-immigrant and immigrant visa applications being rejected, although immigration officers have discretion to make a final decision based on a number of factors.

It is not clear what visa Prince Harry used to enter the US. His wife, Meghan Markle, is a US citizen. The couple have lived in California since 2020.

At the heart of the Heritage Foundation's lawsuit is an admission by Prince Harry, in his memoir Spare, that he repeatedly used drugs as a teenager in the UK and as an adult.

In the lawsuit, the Heritage Foundation argues that "widespread" coverage of the duke's admitted drug use calls into question whether the government properly followed immigration law when it admitted him into the US, and whether he was given preferential treatment.

Current or past drug use could, in theory, make one inadmissible to the US.

During an hour-long court hearing on Tuesday, Heritage Foundation law-

yer Samuel Dewey said the case was about the Department of Homeland Security (DHS)'s "compliance with the law".

The judge in the case, Carl Nichols, will first have to determine whether DHS' headquarters must expedite the process of finding relevant documents. Several components of DHS, including Customs and Border Patrol, have already denied the foundation's request to reveal the documents, citing privacy concerns.

Judge Nichols told DHS to decide by 13 June whether it will release the documents or expedite a Freedom of Information Act request.

If they reject the request, he will hear arguments in court to determine whether it is in the public interest to make the immigration documents - or parts of them - available.

"We're not at that stage yet," Judge Nichols said.

DHS, for its part, has argued that there is no need for the rapid release of Prince Harry's documents.

It has also argued that that there was nothing to suggest "widespread" public interest in seeing the immigra-

tion documents.

A lawyer representing DHS in the case, John Bardo, said that the Heritage case was based on a "bunch of articles" in the British press that "simply speculate" about Prince Harry's visa status and do not call into question the government's integrity. He added that a person's visa status is confidential.

He argued that the issue of the duke's visa is only of interest to "certain social circles" in the US and has been largely ignored by mainstream US media outlets.

Nile Gardiner, a former aide to Margaret Thatcher who works as a foreign policy analyst at the Heritage Foundation, told BBC News last week that the foundation believes the case is "symbolically important".

"If Prince Harry was treated differently than anyone else applying, I think it would undermine confidence in the US immigration system and how it is enforced," he said.

"It's important that US officials are seen to be applying the law robustly, effectively and fairly," Mr Gardiner added. "Otherwise the system doesn't work at all." cont'd on pg 21

skyline due to the wildfire smoke from Canada that has travelled south.

Public health officials have cautioned people not to exercise outside and to minimise their exposure to the smoke as much as possible, as the air poses immediate and long-term health risks.

Deteriorating air quality has also forced at least one region in Quebec - the Atikamekw community of Opitciwan, 350km (217

miles) north of Montreal - to transfer people with asthma and other respiratory issues away from the smoke.

Canada continues to see a more active wildfire season than normal. Federal officials cautioned on Monday that this summer may bring Canada's largest fires yet because of dry and hot conditions that are forecast for much of the season.

Court documents filed by the Heritage Foundation cite a number of examples of British celebrities being refused entry or returned to the UK.

In 2010, for example, the documents said musician Pete Doherty was refused entry at an airport in New York and sent back to the UK, despite having a visa. Mr Doherty has several prior drug convictions.

In 2014, celebrity chef Nigella Lawson was prevented from boarding a flight from the UK to Los Angeles after admitting to taking cocaine "two times in my life" in evidence during an unrelated court case.

A spokeswoman for the US embassy in London said at the time: "There are several ways of legally travelling

into the United States and Ms Lawson has been invited to come to the embassy and apply for a visa for travel to the US." Ms Lawson was eventually granted a visa.

The US case is separate from an ongoing civil case in the UK in which Harry has sued Mirror Group Newspapers over allegations of phone hacking.
