PM scoffs at Dr. Daniel's assertions

UPP's boycott of the National Budget debate in the House of Representatives this week, various spokespersons for the party have been making public pronouncements in what appears to be an attempt to make up for the lost opportunity to participate in the debate.

One such person is Dr. George Daniel, said to be one of the key advisors to the party's leadership.

He can be heard stating that St. Kitts Nevis spends twice as much as a percentage of its GDP on a capita basis than does Antigua and Barbuda.

It is not clear whether

In the wake of the his assertion was supported by data, however, in a quick response, Prime Minister Gaston Browne, said the UPP and its spokespersons are making the case for the ABLP government in that it has been frugal in spending the people's money.

"I think between himself and D. Gisele Isaac. I want to send them one of our 40-foot containers of hams and turkeys each because they have made the case for the ABLP; we could not have said it any better.

He made the point that Kitts-Nevis spends twice the amount than Antigua and Barbuda on a per capita basis which means



Prime Minister Gaston Browne that the counter claim that there has been profligacy by my administration is unfounded.

He was trying to make the case that we mis-managed public finances while quoting statistics from St. Kitts in which it has been shown with empirical evidence that they spend more than we do on a per capita basis," he remarked.

PM Browne, who also holds the finance ministry portfolio, said the government has been quite frugal in how it spends the people's money.

"One of the reasons why we have to be frugal is that we collect the least tax of any country in the Eastern Caribbean and beyond.

"What we have done is to empower the people of Antigua and Barbuda with strong disposable incomes

so they can spend and invest more.

"That policy works well for the ABLP to the extent that we continue to outperform other countries within the Caribbean.

"We have enjoyed stronger rates of growth and admittedly, government's finances have been difficult and we have not been able to meet or obligations because of this low taxation. as we have the lowest rates in the Caribbean," PM Browne explained.

Browne stated that the adjustments being made to the ABST rate is to allow government to be able to meet some of its obligations and the minor increase on the rate of taxation to GDP is not considered to be onerous for the people.

Senate meets today for 2024 Budget debate

The debate on the National Budget 2024 for Antigua and Barbuda moves to the upper house of parliament, the Senate, today.

Leader of Government Business in the Senate, Samantha Marshall will lead off the debate on the \$1.9 billion budget presented by Prime Minister and Finance Minister Gaston Browne to the House of Representatives last Friday.

The budget is projecting continued robust economic performance for Antigua and Barbuda over the next twelve months as international and regional institutions have forecast growth north of 8 percent for 2024.

The budget also indicated that the tourism sector will continue to perform well both from the standpoint of increased visitors as well as new capacity being added to the room stock.

This will give an additional boost to the construction sector with the start of several major hotels developments next year.

Additionally, the budget has shown that Antigua and Barbuda is regaining the job losses it suffered during the COVID-19 pandemic of 2020-21.

Records from the Social Security Scheme indicated that approximately five thousand jobs were lost when

The budget also indicated that many hotels closed and several pritourism sector will continue to vate sector businesses closed, some permanently, due to the pandemic.

The latest figures now indicate that three thousand of those jobs have been regained since the end of the pandemic.

Prior to the pandemic, contributors to the scheme stood at 45thousand....in 2020 (the start of the pandemic) it fell to 40-thousand. At the end of September this year it was at 43-thousand.

However, all eyes will be on the opposition benches to see it members on the opposite side will take the position of those in the lower house by boycotting the debate.

Persons who receive a monthly pension payment from the Social Security Scheme are expected to have a good Christmas holiday season as the scheme has completed all pension payments this week.


This has been confirmed by the Director of the Scheme, David Matthias, who said that pension cheques have been dispatched to the banks and other financial institutions from Monday of this week.

He said all the financial institutions have been paid by the scheme and they are




David Matthias expected have deposited the funds to the accounts of pensioners.



Lapsus\$: GTA 6 hacker handed indefinite hospital order

An 18-year-old hacker who leaked clips of a forth-coming Grand Theft Auto (GTA) game has been sentenced to an indefinite hospital order.

Arion Kurtaj from Oxford, who is autistic, was a key member of international gang Lapsus\$.

The gang's attacks on tech giants including Uber, Nvidia and Rockstar Games cost the firms nearly \$10m.

The judge said Kurtaj's skills and desire to commit cyber-crime meant he remained a high risk to the public.

He will remain at a secure hospital for life unless doctors deem him no longer a danger.

The court heard that Kurtaj had been violent while in custody with dozens of reports of injury or property damage.

Doctors deemed Kurtaj unfit to stand trial due to his acute autism so the jury was asked to determine whether or not he committed the alleged acts - not if he did so with criminal intent.

A mental health assessment used as part of the sentencing hearing said he "continued to express the intent to return to cyber-crime as soon as possible. He is highly motivated."

The jury was told that while he was on bail for hacking Nvidia and BT/EE

and in police protection at a Travelodge hotel, he continued hacking and carried out his most infamous hack.

Despite having his laptop confiscated, Kurtaj managed to breach Rockstar, the company behind GTA, using an Amazon Firestick, his hotel TV and a mobile phone.

Kurtaj stole 90 clips of the unreleased and hugely anticipated Grand Theft Auto 6.

He broke into the company's internal Slack messaging system to declare "if Rockstar does not contact me on Telegram within 24 hours I will start releasing the source code".

He then posted the clips and source code on a forum under the username TeaPotUberHacker.

He was rearrested and detained until his trial.

Earlier this month, the trailer for GTA 6 was released clocking up 128m views on YouTube in just 4 days.

In sentencing hearings, Kurtaj's defence team argued that the success of the game's trailer indicated that Kurtaj's hack had not caused serious harm to the game developer and asked that this be factored into the sentencing.

But Her Honour Judge Lees said that there were real victims and real harm caused from his other multiple hacks on individuals and the companies he attacked with Lapsus\$.

Rockstar Games alone told the court that the hack cost it \$5m to recover from plus thousands of hours of staff time.

Another Lapsus\$ member, who is 17 and cannot be

named because of his age, was found guilty in the same trial, which lasted six weeks at Southwark Crown Court.

He worked with Kurtaj and other members of Lapsus\$ to hack tech giant Nvidia and phone company BT/EE and steal data before demanding a four million dollar ransom, which was not paid.

They also stole directly from individuals through their cryptocurrency wallets.

The 17-year-old was sentenced to an 18 month long Youth Rehabilitation Order, including intense supervision and a ban on using VPNs online.

As well as hacking offences the boy was sentenced for what the judge described as "unpleasant and frightening pattern of stalking and harassment" of

Angola leaves Opec oil cartel in output quota row

Angola has announced it is leaving the oil producers' organisation Opec over a dispute on output quotas.

It follows last month's decision by the 13-member cartel and 10 allied nations to further slash oil production in 2024 to prop up volatile global prices.

Angola currently produces about 1.1 million barrels per day, of the 30 million from the whole of Opec.

Oil prices fell on the news, with Brent prices down over \$1 to \$78.5 a barrel by 12:50 GMT, Reuters reports.

Angola's decision to withdraw from Opec came at Thursday's cabinet meeting.

"We feel that at this moment Angola gains nothing by remaining in the organisation and, in defence of its interests, it decided to leave," Mineral Resources and Petroleum Minister Diamantino Azevedo said afterwards.

"If we remained in

Opec... Angola would be forced to cut production, and this goes against our policy of avoiding decline and respecting contracts."

The minister added that the decision was not taken lightly.

Angola and Nigeria are the two biggest oil exporters in sub-Saharan Africa.

The AFP news agency reports that both countries have been unhappy at being asked to cut production at a time when they need to increase their foreign currency earnings.

Angola has vast mineral and petroleum reserves, and its economy is among the fastest-growing in the world - but economic growth is highly uneven.

Much of its oil wealth lies in its separate Cabinda province, where a decades-long separatist conflict simmers.

Angola - which had been an Opec member for 16 years - is not the first country to leave the cartel. Ecuador, Indonesia and Qatar have all done the same.

Opec is a grouping of

oil producers which decides how much crude oil to sell on the world market, along with an expanded group called Opec+.

Following Russia's full-scale invasion of Ukraine in February 2022, oil prices soared, hitting more than \$120 a barrel in June last year. They fell back to a little above \$70 a barrel in May this year - but have steadily risen since then as producers have tried to restrict output to support the market and after recent attacks on cargo vessels in the Red Sea.

two young women.

Kurtaj and the 17-year-old are the first members of the Lapsus\$ group to be convicted but it is thought others are still at large.

The gang's audacious attacks in 2021 and 2022 shocked the cyber-security world. The group from the UK, and allegedly Brazil, was described in court as "digital bandits".

The gang - thought to mostly be

teenagers - used con-man like tricks as well as computer hacking to gain access to multinational corporations such as Microsoft, the technology giant and digital banking group Revolut.

During their spree, the hackers regularly celebrated their crimes publicly and taunted victims on the social network app Telegram in English and Portuguese.

It prompted US cyber-authorities to issue a lengthy report into Lapsus\$

and other teen hacker gangs.

It concluded that Lapsus\$ "made clear just how easy it was for its members (juveniles, in some instances) to infiltrate well-defended organisations".

It is not clear how much money Lapsus\$ has made from its cyber-crimes.

No companies publicly admitted paying the hackers and the hackers did not provide the passwords to seized cryptocurrency wallets.

Guyanese court issues summons for US-based political activist

New York-based Guyanese political activistRickford Burke has been served with a court summons that requires him to appear before an East Coast Demerara magistrate next year.

Burke, who is the President of the Caribbean Guyana Institute for Democracy (CGID) and a critic of the present government, was served with a "defendant summons" by ASP Rodwell Sarabo of the Guyana Police Force (GPF) and US process server Mark Wesserman at his home in Brooklyn, New York on December 16.

In a press statement yesterday, GPF said Burke has to appear in the Vigilance Magistrate's court on March 28th,

2024.

Burke has been charged with a series of crimes including incitement of hostility or ill-will on the grounds of race, sedition, inciting public terror and seditious libel.

Two wanted bulletins were issued for Burke on December 3, 2021, and September 29th, 2022. Police filed charges against him on August 28th, 2023.

Meanwhile, Burke has filed a complaint with police in New York.

In a Facebook livestream last evening, he alleged "two men armed with firearms" rushed into his home and attempted to "push a piece of paper" into his face as he was leaving to go to church.

Burke claimed he saw Sarabo and Wesserman digging through his mail.

He said no document was served to him but he found it on the stairs leading to his home.

Burke accused the government and GPF of attempting to abuse the court by filing malicious cases against him.

Customs agents nab significant number of Caribbean migrants

CMC - The United States Customs and Border Protection (CBP) agency said 1,086 Caribbean migrants had been apprehended between December 1 and December 14, this year.

CBP said that they were detained during exercises involving its Air and Marine Operations (AMO) Southeast Region, US Coast Guard, Homeland Security Task Force-Southeast as well as local and international law enforcement partners.

On December 1, 63 migrants were detained near Cabo Rojo, Puerto Rico on a "dangerously overloaded vessel" with two pregnant women among those apprehended.

According to the CBP on December 5, the Miami Air and Marine Branch and Jacksonville Air and Marine Branch Multi-Role Enforcement Aircraft crews located "multiple smuggling vessels near the Turks and Caicos Islands.

"The crews communicated the location to an Operation Bahamas Turks and Caicos (OPBAT) team who coordinated for Turks and Caicos Islands maritime police to conduct the interdiction.



"Partner nation maritime teams apprehended 306 migrants over multiple events in a single day working with Air and Marine Operations aircrews who conducted aerial monitoring," said the CBP, adding this event accounts for nearly 30 per cent of apprehensions in the first two weeks of December.

In another encounter on December 11, the authorities said they apprehended another 306 migrants.

"This event highlights the cooperation between Air and Marine Operations branches. Aircrews from Jacksonville and Miami continued to work together throughout the day to keep eyes on suspicious vessels in order to guide maritime units to their location," said Drew Gellerson, Director of Air and Marine Operations, Jacksonville Air and Marine Branch.

CBP said "another significant enforcement event" occurred on December 11 near Key Largo, Florida.

CBP said 47 Caribbean migrants, who "indicated they had departed Cuba approximately eight days prior and displayed an 'SOS' flag when they were discovered by responding authorities," were also detained on December 11.

"Our crews train relent-

lessly to be prepared for situations like this," said Travis Curtin, Acting Deputy Director of Marine Operations, Miami Air and Marine Branch.

"We will continue to work as a team with our international, federal, state, and local partners to stop illicit maritime traffic."

Last year, CBP said enforcement actions resulted in 967 arrests and 134,981 apprehensions of undocumented migrants, as well as the seizure or disruption of 250,616 pounds of cocaine, 1,475 pounds of fentanyl, 25,625 pounds of methamphetamine, 1,342 weapons, and US\$21.7 million.

Prague shooting: Gunman dead after killing 14 at Charles University

A gunman has shot dead 14 people and injured another 25 at a university in Prague, officials say, in the deadliest attack in modern Czech history.

Police say the 24-yearold gunman was also "eliminated" following the shooting at Charles University in the historic centre of the capital.

University staff were told to barricade themselves in rooms during the attack.

Prime Minister Petr Fiala said he had cancelled upcoming engagements in light of the "tragic events" on Thursday.

The shooting started at about 15:00 local time (14:00 GMT) at the university's Faculty of Arts building on Jan Palach Square.

Dramatic footage later emerged on social media showing some people jumping to safety from one of the building's ledges several storeys up, and gunshots are also heard.

In a separate video, terrified crowds are seen fleeing the area popular with tourists.

At a briefing on Thursday evening, the country's police chief and the interior minister said the gunman had been a student at the faculty.

They said he was from a village 21km (13 miles) outside Prague. The suspect's father had been found dead earlier on Thursday. The



gunman's motives were not that something

gunman's motives were not immediately known.

Preliminary information suggested that no police officers were injured in the attack, the authorities said.

The police said they were also working on the theory that the gunman may have been responsible for the deaths of two people last week in a forest near Prague.

Sergei Medvedev, a professor at the university, told the BBC he had been in one of the university's auditoriums when the shootings began.

"I was giving a lecture at the moment and at first didn't quite realise what happened because there were some sounds. The students... heard it better because I was so much concentrated on my talking, on my lecture," he said.

"Then... we understood

that something big is happening. There was nothing online yet, nothing in the Czech press and the [news] networks. Then at some point, the special operation groups went storming in, they searched the room briefly and then went out... they told us to stay inside.

"One hour later, another police squad broke in and then put us on the floor, briefly searched us then evacuated from the building."

US tourist Hannah Mallicoat told the BBC that she and her family had been on Jan Palach Square during the attack.

"A crowd of people were crossing the street when the first shot hit. I thought it was something like a fire-cracker or a car backfire until I heard the second shot and people started running," she said.

"I saw a bullet hit the ground on the other side of the square about 30 ft (9m) away before ducking into a store. The whole area was blocked off and dozens of police cars and ambulances were going towards the university."

Britain's Joe Hyland, 18, told the BBC he had heard four gunshots.

"Everyone was sprinting and running for cover. I have a bad knee, am on a crutch. So I hobbled as quickly as possible," added Mr Hyland, who was on his first holiday with friends. "We got to the metro and went down there because we thought it would be safest."

Charles University students said they had barricaded themselves in classrooms.

Rudy Giuliani files for bankruptcy after \$148m defamation verdict

Rudy Giuliani, a longtime associate of former President Donald Trump, has filed for bankruptcy just days after he was ordered to pay \$148m (£116m) in a defamation case.

He was ordered to pay the sum after a judge found he defamed two Georgia election workers over false claims they tampered with votes in 2020.

The filing shows he owes millions of dollars in legal fees and unpaid taxes.

A spokesman said the move should "be a surprise to no-one".

In a statement, the spokesman for Mr Giuliani, Ted Goodman, said "no person could have reasonably believed that [Mr Giuliani] would be able to pay such a high punitive amount".

He added that Thursday's bankruptcy filing in New York would give Mr Giuliani the "opportunity and time to pursue an appeal, while providing transparency for his finances under the supervision of the bankruptcy court".

Mr Giuliani, 79, said

earlier this year that he was having financial difficulties because of his increasing legal fees and expenses.

Last week, an eight-person jury ordered him to pay \$20m to Georgia poll workers Ruby Freeman and her daughter Wandrea «Shaye» Moss.

The pair said Mr Giuliani's false claim that they tampered with votes had a traumatising impact on their lives. Ms Freeman said she would "always have to be careful" because of lingering fears she might be recognised publicly.

Ms Freedom and Ms Moss were also awarded more than \$16m each for emotional distress. Another payment of \$75m in punitive damages was ordered to be split between them.

Addressing reporters outside the court after he was ordered to pay the sum, Mr Giuliani said: "I don't regret a damn thing."

On Wednesday, a judge ordered him to start paying the two women immediately and expressed concern he might not comply with the judgement.

It is unclear how the bankruptcy declaration will impact on the payments, but US bankruptcy law does not allow the dissolution of debts stemming from "wilful and malicious injury" inflicted on another party.

The bankruptcy filing lists nearly 20 creditors, including Ms Freeman, Ms Moss and Hunter Biden who sued him in September.

Other creditors include the Internal Revenue Service (IRS), which he owes more than \$700,000 in income tax, and two voting software companies that sued him over his false claims of election fraud.

A law firm that previously represented Mr Giuliani, Davidoff Hutcher & Citron LLP, is also included. The firm sued Mr Giuliani for \$1.4m in unpaid legal fees in September.

in four matches with a 6-0 drubbing of Celtics at the Radio Range playing field in Ottos.



Matthew defends Antigua government's support for sports

The Minister of Sports, Daryll Matthew, has stridently defended his and his government's support for sports in Antigua and Barbuda during his presentation to the 2024 Budget Debate in the Lower House of Parliament on Tuesday.

Matthew, who is also the Minister of Education and Creative Industries, said, contrary to many detractors, the government of Antigua and Barbuda continues to support sporting organizations with financial support via its Athletes Development Assistance Review Panel (ADARP) programme throughout the year.

The minister said the Ministry of Sports surpassed the EC\$500,000 it had budgeted for 2023 by disbursing EC\$867,062.11¢ in financial support to sporting organizations via its ADARP programme this year.

"I am going to speak about sports, and there are some persons in this country who waxed eloquently about nothing happening in sports, and sports are dead, and the minister is the worst minister of sports ever, and Antigua can't get anywhere in sports," Matthew stated.

"Mr. Speaker, when people speak about support for sports, I want to read the facts. And we have a committee called ADARP. The chairman is Aldo McCoy, and I asked him to send me a report on the spending that we had in 2023.

"I will call out the national associations, and I will indicate how much is approved for that association. Let's not forget, sir, the budgeted amount for ADARP was EC\$500.000 for 2023."

According to Matthew, the disbursements are as follows: the Antigua and Barbuda Little League Baseball EC\$10.000; the Antigua Masters Cricket Club EC\$6,500; the Antigua and Barbuda Amateur Bodybuilding and Weightlifting Federation EC\$22,166.10¢; and the Antigua and Barbuda Athletic Association EC\$96,210.

The Uprising Boxing Gym EC\$10,520; the Antigua and Barbuda Basketball Association EC\$73,000; the Antigua and Barbuda Swimming Association EC\$113,268.49¢; the Antigua and Barbuda Triathlon Association EC\$25,091; and the Antigua and Barbuda National Domino Association EC\$30,000.

The Antigua and Barbuda Golf Association EC\$9,500; the Antigua and Barbuda Junior Golfers EC\$26,959.52¢; the Antigua and Barbuda Cycling Federation EC\$15,000; the Antigua and Barbuda Netball Association

EC\$15,000; and the Antigua and Barbuda Amateur Volleyball Association EC\$10,000.

The schools' volleyball team that traveled to St. Maarten got EC\$31,831, and the Antigua and Barbuda Contract Bridge Association received EC\$5,000 for hosting an OECS tournament in Antigua this year.

But Minister Matthew disclosed that the largest single disbursement of EC\$363,245.72¢ was given to the Under-19 Schools' cricket team's that embarked on a tour to the United Kingdom during the summer.

Matthew added, "The

Antigua and Barbuda Cricket Exchange Programme, which is a programme we have with some clubs and schools in the United Kingdom where we send about five or six youngsters to England for about four months just playing cricket, costs EC\$4,320.

"I believe that was just to cover airfare because Ambassador Karen-Mae Hill, our High Commissioner to the UK, and her office in London did a lot of the facilitation for that programme."

A total of EC\$750,000 has been budgeted for disbursement by ADARP in 2024

European Super League back in spotlight after landmark ruling

BRUSSELS (Reuters) - UEFA and FIFA contravened EU law by stopping the formation of a Super League, the European Court of Justice (ECJ) said on Thursday, but though breakaway organizers welcomed the ruling, major leagues and clubs moved quickly to support the status quo.

The decision stirred up the arguments that swirled around the original Super League plan in 2021 as the ECJ has ruled against the principle of the governing bodies restricting a new league, but crucially added that the judgment did not necessarily mean such a league must be approved.

The 12 leading European clubs that proposed forming the breakaway league (ESL), which sparked widespread protests among fans, had been threatened with sanctions by UEFA if they went ahead with the plan, leading to nine of them pulling out.

Sports development company A22, formed to assist with creating the ESL, had claimed UEFA and

global governing body FIFA held a monopoly position which was in breach of the EU's Competition and Free Movement Law.

Soon after the verdict A22 released plans for a new competition that would feature 64 men's teams and 32 women's teams competing in a midweek league, threatening UEFA's flagship Champions League tournament.

In its ruling, the EU's top court said that FIFA and UEFA abused their dominant position by forbidding clubs to compete in a European Super League, although that project may still not be approved as the court did not rule on it specifically.

UEFA, FIFA, Football Supporters Europe, LaLiga, the European Club Association, European Leagues and FIFPro Europe said in a joint statement, "There is no place for any type of 'super league' in Europe. Sporting merit is what counts."

UEFA has organized pan-Europe-

an competitions for nearly 70 years and sees the ESL project as a significant threat to the lucrative Champions League, for which teams qualify on merit.

Real Madrid, Barcelona, Juventus and nine other top clubs announced the breakaway plan in April, 2021.

But the move collapsed within 48 hours after an outcry from fans, governments, and players forced Manchester United, Liverpool, Manchester City, Chelsea, Tottenham Hotspur, Arsenal, AC Milan, Inter Milan, and Atletico Madrid to pull out.

A22 CEO Bernd Reichart said in an interview with Reuters that the new competition would win over fans by providing a tournament that was more competitive and by making it free to view on television.

Shares in Juventus, listed on the Italian Stock Exchange, rose more than 10 percent on prospects for a revived ESL, with trading having to be halted because of excessive volatility.

ABSF concludes 2023 calendar with open water contest

President Edith Clashing said the Antigua and Barbuda Swimming Federation (ABSF) wrapped up its 2023 calendar of events with an open-water championship earlier this month.

Clashing, who elected to lead the ABSF for a new four-year term in March, said the Open Water Swimming Championship that took place at Dickenson Bay was a successful event to wrap up the 2023 season.

"This month we have basically ended our calendar of events by holding an Open Water Swimming Championship at Dickenson Bay. I was determined that it would take place, and I must say that it went off quite well," Clashing said.

"It was held without the large numbers as we normally would have had because he had about 18 swimmers heading off island to a pool championship in Trinidad a week or so after, and their coaches didn't want them to



do the open water swim.

"So we were down to 40 swimmers when we would have had about 60 swimmers had they participated. But it went very well, and we ran three races.

"We did a 3K, a 1K and a 500 meter for the novice swimmers to give them a chance to stretch their limbs to see if they could manage the distance."

Reuben Edwards of Vipers was the overall champion for the 3K race in the male division. Edwards, who contested the Boys 11 to 12 category, won the race in a time of 44 minutes and 31.22 seconds.

Ania Lewis of Storm was the overall champion for the 3K race in the female division. Lewis, who contested the Girls 18 to 24 category, won the race in 50 minutes and 10.91 seconds.

Alaysia Liddie Wadadli Aquatic Racers (WAR) was the overall champion in the 1K race in the female division. Liddie, who contested the Girls 11 to 12 category, won the race by clocking 19 minutes and 55.65 seconds.

James Tranter of Vipers was the overall champion in the 1K race in the male division. Tranter, who contested the Boys 11 to 12 category, won the race in a time of 17 minutes and 15.79 seconds.

Clashing said 20 swimmers, who represented Antigua and Barbuda at a recent meet in Trinidad, performed quite well.

"Those 18 swimmers that would have gone off to overseas invitationals, I can tell you, the Antigua and Barbuda swimmers held their own and they did quite well," Clashing said.

West Indies name Test squad for tour of Australia

Antiguan and Leeward Islands fast bowler Alzarri Joseph has been elevated as vice-captain of the senior West Indies Test team.

Joseph was named as deputy to Barbadian skipper Kraigg Brathwaite in a 15-member squad, which was announced by the Cricket West Indies (CWI) Senior Men's Selection Panel on Wednesday, to travel to Australia to play a two-Test series as part of the ICC World Test Championship (WTC) from January17 to 29, 2024.

Joseph was also named as vice-captain of the West Indies team in the recent CG United One-Day International Series against England.

The 27-year-old was elevated to the position after leading the Leeward Islands Hurricanes to the final of last month's CG United Super50 Cup last, which was won by hosts Trinidad &

Tobago Red Force.

The West Indies squad will arrive in Australia on December 30 and will hold a preparation camp from January 2 to 9 in Adelaide, followed by a Four (4) Day First Class warm-up match against a Cricket Australia XI at the Karen Rolton Oval (KRO) in Adelaide from January 10 to 13 January.

The selectors have named several uncapped players in the squad. These are batter Zachary McCaskie, wicket-keeper Tevin Imlach; all-rounders Justin Greaves, Kavem Hodge and Kevin Sinclair; as well as fast bowlers Akeem Jordan and Shamar Joseph.

Jayden Seales is unavailable for selection due to a shoulder injury. Jason Holder and Kyle Mayers are unavailable as they have expressed a preference to explore T20 franchise opportunities in January.

Speaking about the make-up of the squad, CWI Lead Selector, Dr. Desmond Haynes said, "The squad has been affected by the unavailability of some key players. However, we have cont'd on pg 23
