## New water rates for commercial customers take effect from April 1

APUA has announced its first increase in water rates in more than three decades as mounting production costs have left it with no other alternative but to introduce limited rate hikes.

This is contained in a press statement issued by the APUA's Water Business Unit on Thursday afternoon.

“The Water Business Unit of the Antigua Public Utilities Authority (APUA) has maintained its Water Rates for more than three (3) decades. As we navigate through the challenges of climate change and longer drought periods, we have been relentless in finding and implementing alternative solutions to



combat the challenges of water scarcity.

“The Water Business Unit has been innovative by expanding our water

production to a dependable but costly option by harvesting water from the sea,” the release stated.

It added that within the past ten years, APUA made significant investments by adding new Reverse Osmosis Plants, extending its transmission and distribution lines, upgraded to High-density polyethylene (HDPE) pipes, and continual maintenance and upgrades to its network.

“These efforts are all in alignment with our mission, of providing services that are reliable, affordable

and of international quality.

“As we continue to expand our network; to include an urgent need to update our aged infrastructure it has become indispensable for us to adjust our billing rates in an attempt to offset production, distribution, operating and capital costs,” the release continued.

APUA said it understands that rate adjustments or increases may not always be welcomed at first. However, it wants to reassure its customers of its dedication to maintaining the most competitive and marketable rates while striving to uphold international service standards.

The rate increases will not affect domestic customers of APUA.

## Critical CARICOM heads meeting today

Two critical issues are going before CARICOM Heads of government who are meeting virtually today to make decisions on these issues; the ongoing instability that exists in Haiti and the decision on the freedom of movement within the community.

The meeting is the Thirty-Sixth Inter-Sessional where the Chairman of the Conference of Heads of Government, Mohamed Irfaan Ali, President of the Cooperative Republic of Guyana, will preside.

A four-member team from Antigua and Barbuda will participate in the virtual meeting.

The delegation will be led by Prime Minister, Gaston Browne and will include, Foreign Affairs Minister, E.P Chet Greene, CARICOM Amba-

sador, Dr. Clarence Henry and Senior Foreign Service Officer, Kurt Williams.

Dr. Henry said the meeting is 'Decision Day' for the Community as the heads are expected to discuss at length a report prepared by the Inter-Governmental Task Force and reviewed by the Legal Affairs Committee for the implementation of the decision of the Conference to work towards free movement of all community nationals.

This has been one of the most topical subjects that came out of this month's 46th Conference of the Heads of Government where Antigua and Barbuda indicated that it will maintain the current Skills Certificate regime and delay the implementation of the full freedom of movement.

Prime Minister Gaston Browne is on record indicating that the country cannot make that move at this time as it would cause undue strain on the social systems such as healthcare and education.

The other critical issue will be a report on the attempts to work towards finding lasting solutions to the Haitian crisis.

This week, CARICOM Heads, meeting under the chairmanship of Dr Ali, were able to get the Haitian Prime Minister Dr. Ariel Henry to resign, paving the way for setting up of an interim National Council.

The meeting will also hear an update on the preparations to host the World Cup T20 matches in six Caribbean territories.

Ministry of Works took custody of these buildings located on Friars Hill Rd, rent free in 2021. The Lessor (IF), gave notice to one of its retail tenants and a storage tenant to vacate a portion of the building, resulting in loss of revenue.

Ministry of Works rents from all and sundry irrespective of their political affiliation. Whenever the government rents a building, the leasehold improvements are paid for by the government and the monthly rent for building is also payable.

In this case, IF, rented the building for \$1.00 monthly \$12 per year. The commercial rent would have been in the region of \$70K monthly (84K) @ \$5 per square foot, which is the standard rental rate that government pays.

2.5 years later, the ministry still enjoys rent free occupancy of the building; significantly exceeding the costs of the improvements.

The lessor evidently has not benefited from any revenue from the government; but instead, lost revenues from the previous rentals.

Richard, the government has been the beneficiary of a rent-free space for 2.5 years and continuing.

## Three face off in ABLP Primary

The ruling Antigua and Barbuda Labour Party has started the process of selecting its candidates for the next general election, constitutionally due in January 2028.

The party will hold its second primary elections for the year on Friday evening in the All Saints West constituency to select a candidate who will be the party's standard bearer/caretaker during the interim period.

ABLP General Secretary, Sen. Mary Clare Hurst announced the names of the candidates who will compete in the primary. They are business executive, Regis Burton, agriculturalist/radio host, Lamin Newton and environmentalist, Arry Simon.

Sen Hurst said the primary election is an internal party matter and only registered

members of the party who are registered in the constituency are eligible to participate. All three candidates along with the ABLP secretariat have finalized on the electoral list for the primary.

It will take place at the Sea View Farm primary school from 4:00 pm to 7:00 pm. Following the vote, the secretariat team, led by Sen. Hurst, who will serve as the Supervisor of the Election, will count the ballots in collaboration with the party's auditors, PKS. More than seven hundred and fifty persons are registered to vote in the primary.

The primary marks the party's determination to select its candidates well ahead of the next general election thereby allowing them to solidify their presence and con-

nection with the respective constituencies.

Earlier, Michael Joseph was selected in a similar process as the standard bearer/caretaker for the St. John's

Rural West constituency from a field of five persons.

Sen. Hurst said the party will hold other primaries in other constituencies in the coming months.



# Delays continue for case involving police shooting

Sergeant Karim Warner will have to wait a bit longer before hearing his fate as his legal matter has been adjourned for another 13 days.

The matter was adjourned after Warner's lawyer failed to show up in court this week.

The officer was charged following a shooting incident where he allegedly fired up to 12 shots at two occupants of a vehicle.

It has been alleged that there have been efforts to sweep the matter under the rug, nonetheless, Warner was arrested and charged with firing shots in a public place.

According to reports, Warner was involved in an incident where he was trying to reclaim a vehicle he had leased to an individual.

He allegedly used GPS tracking to locate the vehicle in Willikies, where he con-

## Hearing adjourned for woman accused of causing death of Police Constable

May 28 is the new committal date that has been set for Dayneri Ferrer Vincent-Urlwin, the woman accused of causing the death of police constable Robert Dyer last September.

The collision occurred around 11:20 am on September 4, leading to Dyer's official pronouncement of death at approximately 12:45 pm.

This is just the latest addition in a string of adjournments in the Magistrates Court.

Vincent-Urlwin appeared in Traffic Court on Wednesday, but the matter was adjourned for the third time as the file is said to be under review by the Direc-

tor of Public Prosecutions.

Constable Dyer served 10 years in the Royal Police Force of Antigua and Barbuda beginning April 12, 2013.

He was posted to B Division Parham before he was transferred to the traffic department, serving as a motorcycle outrider. He was also previously a motorcycle escort to the Governor General.

Dyer was laid to rest on October 10, a few days later than the original date due to the passage of Tropical Storm Phillippe.

Vincent-Urlwin could face up to five years in prison if the matter proceeds to the High Court.

fronted the occupants who refused to return it.

Tensions reportedly escalated, leading Warner to discharge his weapon and fire a

dozen shots at the departing vehicle, striking it multiple times.

He will return to court on March 27.

## Vybz Kartel: Jamaica dancehall star's murder conviction overturned

Jamaican dancehall artist Vybz Kartel's conviction for murder has been overturned.

The 48-year-old was given a life sentence in 2014 for the killing of Clive "Lizard" Williams on the Caribbean island.

His successful appeal, heard by the Privy Council in London, argued that a juror accused of trying to bribe others should have been thrown off his trial.

Authorities in Jamaica will decide whether the case should be retried.

The musician, real name Adidja Palmer, is one of the country's most popular artists and has collaborated with performers such as Jay-Z and Rihanna.

His 64-day trial was one of the longest in Jamaican history, and ended with Kartel being ordered to serve a minimum of 35 years in jail.

This was later reduced to 32-and-a-half years.

The trial heard that victim Clive Williams and another man, Lamar Chow, were given two unlicensed firearms belonging to Kartel for safekeeping.

When they failed to return them at an agreed time, prosecutors said, they were summoned to Kartel's house in August 2011.

Chow told the trial they were attacked and the last thing he saw was Clive Williams - who was nev-

er seen alive again - lying motionless on the ground.

The house burned down days later and a body was never recovered.

Kartel and his co-accused Shawn Campbell, Kahira Jones and Andre St John had maintained their innocence since the original trial.

Their appeal hearing last month before The Privy Council, which serves as the highest court of appeal in Jamaica and other Commonwealth countries, was their last chance to reverse the verdict.

Delivering the council's ruling, a panel of justices said that a juror

accused of attempting to bribe fellow jury members was not removed.

The judge let them remain on the case and have a say in the final verdicts.

Allowing this juror to stay, the council said, was "fatal to the safety of the convictions which followed" and "an infringement of the [defendants'] fundamental right to a fair hearing".

The men had also argued that jurors were sent to reach a verdict late in the day, putting them under "undue pressure" to do so.

They had also argued that a key piece of mobile phone evidence - a

text message allegedly sent from Kartel's phone - presented in court had been obtained in breach of guidelines.

However, the panel did not rule on these matters, finding that the allegations of bribery alone were serious enough to dismiss the guilty verdicts.

Vybz Kartel is known worldwide for hits including Clarks, Ramping Shop and Summer Time, and his success led to him launching lines of shoes, alcohol and condoms.

The singer also became the first dancehall artist to star in his own reality TV show, Teacha's Pet.

# Andrew Tate and brother Tristan appear in a Romanian court over UK arrest warrant

Controversial influencer Andrew Tate and his brother Tristan have appeared in a Romanian court after the UK issued warrants for their arrest.

The internet personalities were detained by Romanian police on Monday night on arrest warrants over alleged sexual offences in Britain.

Bucharest's Court of Appeal postponed a decision on the warrant.

Andrew Tate, 37, and Tristan, 35, "categorically reject all charges", their representative said.

The men remain in custody.

Romanian Police said two arrest warrants were issued by British authorities for exploiting people in the UK.

A representative for the Tate brothers before the hearing described the arrest warrant as a "bewildering revival of decade-old accusations" leaving the brothers "dismayed and deeply troubled".

"They categorically reject all charges and express profound disappointment that such serious allegations are being resurrected without substantial new evidence," the statement said.

"They are fully committed to challenging these accusations with unwaver-

ing determination and resolve."

Their representatives claim the allegations cover 2012 to 2015.

Andrew, wearing a black hoodie, and Tristan arrived at court in handcuffs escorted by police.

They did not say anything to the gathered press, but as they were leaving court Andrew smiled when asked if he is ready to go back home.

Following the hearing, the brothers' lawyer Eugen Vidineac told reporters he knew little information regarding the warrant and did

not know if new evidence was provided by the authorities.

In December, the Tate brothers, who are dual UK-US nationals, were ordered by a Romanian court not to leave Romania after the brothers made a request to visit their mother in hospital in the UK.

The brothers are being investigated by Romanian authorities over separate allegations of rape, human trafficking and forming a criminal gang - charges they deny.

They are accused of exploiting women via an adult

content business, which prosecutors allege operated as a criminal group.

Two female Romanian associates were also named alongside the brothers in an indictment published in June, and seven alleged victims were identified.

Mr Tate has repeatedly claimed Romanian prosecutors have no evidence against him and there is a conspiracy to silence him.

He is a self-described misogynist and was previously banned from social media platforms for expressing misogynistic views.

## Suriname President Santokhi and government ministers under investigation

CMC - The Office of the Attorney General has requested a preliminary investigation into a potential corruption case against President Chandrikapersad Santokhi and two of his ministers, including the Finance Minister, Stanley Raghoebarsing.

This follows reports that the government allegedly paid an estimated US\$7.5 million to Pan-American Real Estate, a local company, using false documents.

“It is important to emphasise that no one has yet been identified as a suspect,” the Public Prosecution Service said on Wednesday.

The issue first came to light last November when an anonymous whistleblower armed with various documents, filed a criminal complaint with the Attorney General Office.

In January, the whistleblower delivered even more potentially incriminating evidence to the Office of the Attorney general, and the police Anti-Corruption Unit was subsequently given the task of investigating the matter.

During the investigation, several individuals were questioned by the police, including Vice President Ronnie Brunswijk and the two ministers.

The Public Prosecution Service said it has received a police file on the case and on that basis a preliminary judicial investigation has been requested from the examining magistrate.

“After analysing the police investigation results and partly in view of the nature of the case, a preliminary

nary judicial investigation has been requested,” the Public Prosecution Service added.

Santokhi and the two cabinet ministers have told reporters that they are not guilty of any criminal offense and that everything took place in accordance with the current

legal accounting rules.

According to the whistleblower, Public Works Minister Riad Nurmohamed submitted falsely prepared documents at the meeting of the Council of Ministers to facilitate the payment to Pan-American Real Es-

## Dominican Republic Foreign Ministry organises humanitarian air corridor from Haiti

CMC - The government in the Dominican Republic has established an international corridor to facilitate the humanitarian departure of Dominicans, diplomats from friendly nations, and representatives of international organisations from neighbouring Haiti as tension continues to mount across the country.

This was revealed by Foreign Minister Roberto Álvarez, who said that while the Dominican embassy in Haiti remains operational to assist Dominican residents, the consulates are currently closed.

Álvarez emphasised that this endeavour involves collaborative efforts across various institutions, with the Foreign Ministry serving as the central axis

owing to its international responsibility.

He further disclosed that the evacuation of diplomatic personnel from nine countries, along with representatives from international organisations such as the World Bank and the European Union, has been

orchestrated from the Dominican diplomatic headquarters in Haiti.

However, citing security concerns, Álvarez refrained from disclosing the identities of the countries availing themselves of this logistical support or confirming whether they

remain in Dominican territory.

The chancellor clarified that Dominican Ambassador Faruk Miguel remains stationed in Haiti and highlighted the bolstered security measures in response to the ongoing crisis situation.

He added that despite the violence and political turmoil in Haiti, none of the over two thousand Dominicans residing there have been evacuated for humanitarian reasons.

Regarding binational markets, which serve as critical hubs for Dominican merchants and foreigners deprived of access to food due to instability in their country, Álvarez affirmed their continued operation.

The payment was allegedly blocked twice by Vice President Brunswijk, who presides over the meetings. But the whistleblower is claiming that the minister ultimately bypassed the ministerial meeting and submitted the suspected falsely prepared documents to the meeting of the government council and a meeting of the cabinet chaired by the president.

During that meeting, Santokhi said to have approved the payment of the amount of approximately US\$7.5 million.

Initially, the finance minister had refused to make the payment because he believed that the work carried out by Pan-American Real Estate did not qualify as a public private partnership project as had been suggested.

According to the minister of public works, the former government of Desi Bouterse, had entered into an agreement with Pan-American Real Estate for the construction of houses for low-income groups in 2019 in which the then government had committed to the paving of the roads at a real estate development project of the company.

Nurmohammed said these agreements were allegedly not fulfilled, resulting in the company having to pave the roads itself and was now seeking to recover the funds from the present administration.

Political observers say whether this case will result in prosecution of the president and his two ministers remains to be seen.

Members of government and former political office holders can only be prosecuted by law if they are charged by Parliament at the request of the Attorney General, where President Santokhi's coalition enjoys a majority.

## 60 migrants die in dinghy in Mediterranean, survivors say

At least 60 migrants have died after a rubber dinghy ran into trouble in the Mediterranean Sea, according to survivors.

The 25 survivors were picked up by the Ocean Viking, a vessel operated by the humanitarian group SOS Méditerranée.

They told their rescuers that they had set off from Zawiya on the Libyan coast several days before being rescued.

The engine of the dinghy broke down after three days, leaving the boat adrift without food or water.

The survivors said that the victims included women and at least one child. They are believed to have died from dehydration and hunger, not drowning.

SOS Méditerranée said the Ocean Viking team had spotted the dinghy, which set off last Friday, with binoculars on Wednesday and had staged

a medical evacuation in co-operation with Italian coast guards.

It said the survivors were “in very weak health condition” and were all under medical care.

Two of them, who were unconscious and in critical condition, had been flown to Sicily by helicopter for further treatment, the group added.

The remaining 23 are still on board the Ocean Viking, along with more than 200 other migrants who were rescued from two other boats.

The vessel is heading for the port of Ancona, about four days away, but the team has requested a closer port of safety.

“The people who were on the boat in distress, lost at sea for almost a week, went out of water and food very quickly, according to the survivors,” said an SOS Méditerranée spokeswoman on board the ship.

“People died along the way. I met a man who lost his wife and one-and-a-half-year-old baby. The baby died the first day, the mother the fourth day. They were from Senegal and had been in Libya for more than two years.”

The EU’s border agency Frontex told the BBC that it raised the alarm last Friday after spotting a vessel with more than 50 people onboard near the coast of Libya. It did not specify if it was the same rubber dinghy picked up by the Ocean Viking.

Frontex says one of its aircraft out on a routine trip spotted the vessel within Libya’s rescue zone and so alerted the Libyan authorities.

The EU agency says it also issued a mayday alert to all other boats in the area to help the vessel - and contacted Italian and Maltese rescue coordination centres too.

## Father of Michigan school gunman convicted of manslaughter

The father of a Michigan school shooter who killed four students has been convicted of manslaughter.

The trial heard that James Crumbley, 47, had ignored his 15-year-old son's mental health needs and bought him the handgun he used in the November 2021 attack.

The jury deliberated for just over a day before coming to the verdict.

Jennifer Crumbley, his wife, is due to be sentenced next month after being convicted on the same charges.

Crumbley was in court for the verdict and appeared to show little reaction as it was read out.

The case against the Crumbleys marks the first time parents have been charged with manslaughter over their child's role in a shooting in the US.

Their son, Ethan, killed fellow students Tate Myre, 16; Hana St Juliana, 14;

Madisyn Baldwin, 17, and Justin Shilling, 17. He is serving a sentence of life in prison without parole.

Seven people were also injured in the shooting.

Ven Johnson, an attorney representing the victims' families, said in a statement that the verdicts against James and Jennifer Crumbley "won't bring back the lives of these four students, but it represents one more step towards holding everyone responsible accountable under the law".

In her closing arguments to the jury of six men and six women earlier this week, prosecutor Karen McDonald called the attack at the Oxford High School "preventable and foreseeable".

She added that Crumbley's alleged actions were "rare and egregious".

He did not take even the slightest measures to ensure his son was not a threat

after giving him a semi-automatic pistol as a gift, said the prosecutor.

When Crumbley heard about the shooting, he rushed home from his job as a DoorDash delivery driver, looking for the weapon, the trial heard.

His defence lawyer, Mariell Lehman, argued

that "James had no idea that his son was having a hard time".

Crumbley did not testify, unlike his wife, who took the stand during her trial and tried to blame her husband. She faces up to 60 years in prison.

Jennifer Crumbley and her husband bought the 9mm Sig Sauer pistol their son used just days before the shooting.

They were charged by police within days of the killings. Police had to search for the pair and found them in an industrial building in Detroit following a tip from the public.

Initially, the parents were supposed to be tried together but in November sought separate trials.

Frontex says its aircraft needed to return to dry land to refuel and it didn't know what happened to the vessel after the initial observation.

The International Organisation for Migration (IOM) said last week that 2023 was the deadliest year for migrants since records began a decade ago, with at least 8,565 people dying on migration routes worldwide.

The UN agency said the figure was 20% up on the year before.

Its report found that the Mediterranean

crossing continued to be the most dangerous journey, with at least 3,129 deaths and disappearances during 2023 - the highest toll since 2017.

Julia Black, a IOM Project manager, told the BBC that "not as many people are crossing now but almost as many people are dying".

"With the 300 deaths recorded this year so far that's nearly the same as last year, so I am greatly concerned that we are going to see a record-breaking year in terms of the number of deaths in the Mediterranean."
