Tremendous!

That has been the response of residents of Antigua and Barbuda who have responded to the government's call for interested persons to make available their properties to host delegates attending the Fourth Conference of Small Island Developing States (SIDS)4 here from Mary 27-30.

Project Development Officer in the Ministry of Tourism, St. Clair Soleyn has reported that the response has been tremendous from individuals who have accepted the call to help provide accommodation for the anticipated 5,000 delegates who will attend the conference.

"It is difficult for me to put a figure as to the number of people who have responded so far because these calls have been coming in almost constantly.

"This is all happening within a matter of days as it was only last Thursday that the Information Minister, Melfod Nicholas, made the announcement of the government's deci-



sion to abandon the cruise ship option to host the delegates," Soleyn told Pointe Xpress.

The Ministry of Tourism is asking these individuals to make contact and to have their names registered so that its inspection teams can visit these properties to conduct inspections.

"We have had to add an extra two teams to do these inspections just to keep up with the demands.

"All accommodations must be licensed and inspected in order to make it to the official list of properties approved by the government," he explained.

According to Soleyn, the ministry has a set of guidelines which all properties for rental must meet.

These are the same that apply to all hotel properties which are inspected regularly.

For the SIDS4 conference the ministry wants to ensure that the properties meet a standard that is equivalent to what obtains in a 2-Star hotel property.

Each property must have the following; security

hot and cold running water

available internet

clean and well-maintained rooms

they must also provide linen and cutlery since these are short-term accommodations.

a card machine to process credit/debit card payments

The project development officer sad he is confident that Antigua and Barbuda will meet the challenge and deliver an excellent conference for the thousands of delegates.

"We need 1,000 rooms and so far, it looks like we will meet that target.

"We will have a townhall meeting next Wednesday to explain to these persons some of what we are looking for and what we expect from them," he stated.

The key areas of concern for Antigua and Barbuda as host of SIDS4 are; accommodation, health, transportation, technology, security and involvement from NODS.

Soleyn also disclosed that there are plans to develop a special app that delegates will be able to download to access information about Antigua and Barbuda such as a map to get around and other pertinent information.

> He applauded the leadership of the Police and Defence Forces as well as the pioneers who had the vision of the Regional Security System, forty (40) years ago. At that time four Carib

bean islands including Antigua and Barbuda, signed a memorandum of agreement after they identified a need for a collective response to security threats to the region.

The vision caught the attention of other regional island nations and is now a regionally recognized entity which has shown its value to the constituents it serves, on countless occasions.

The Citation lauded each officer individually for 'outstanding meritorious service whilst serving as a member of the Regional Security System's contingent in the peace support and security related operations in support of the government and people of St. Lucia during the operational period March 17 to August 1, 2023'.

Each officer was said to have demonstrated professionalism, compassion, humanitarianism and commitment during the operations in St. Lucia despite the conditions.

Deputy Commissioner of Police, Everton Jeffers also offered words of gratitude and appreciation to the 16 officers, all of whom received the RSS Medal during the ceremony.

Police investigate suspicious death as possible homicide

The police have confirmed that the body of the man – Oscar Reyes, they are treating the death of a Golden Grove resident as a 'suspicious death' which may be upgraded to a homicide.

Informed sources say a post mortem examination will be carried out on 69, to determine definitively the cause of death. The body was discovered around 3:30 on Monday afternoon and several hours later a medical doctor performed the legally required 'pronouncement of death' at the scene.

Reyes was a Phillipino national who reportedly lived alone at Golden Grove.

The police are continuing their investigations into the matter.

A&B's Director of International Trade among experts invited to discuss Transformative Actions and Partnerships to deliver the SDGs

Under the auspices of the UK's Foreign Commonwealth & Development Office and Wilton Park, Miss Joy-Marie King, Director of International Trade, participated in a meeting of experts in the field of sustainable development, convened at Wiston House Sussex, United Kingdom, during the period 6-8 March, 2024.

This meeting was held under the theme "Towards 2030: Transformative Actions and Partnerships to Deliver the SDGs" where and strategies policies were developed and explored with the intention of fast-tracking the SDG goals. The deliverables of Agenda 2030 and the Sustainable Development Goals (SDGs) are currently off track and this has been continuously emphasized during this and prior meetings.

In her presentation to the grouping that focused on tabling recommenda-

tions to drive momentum on the SDGs within the context of the upcoming 4th Small Island Developing States Conference, Miss King spoke to the synergies between the SIDS, SDGs, Climate Change and the Oceans sustainability agendas and the inconceivable absence of an International Trade perspective from the discourse.

According to King, "this absence could prove rather costly to SIDS successfully achieving its agenda premised upon five priority areas - sustainable inclusive and equitable economic growth; mitigating climate change; protection of the biodiversity of SIDS; improve human health and social development; and foster partnerships among SIDS, UN Agencies, and development partners."

She further indicated that SIDS4 provides the ideal opportunity to allow the following:

The inclusion of international trade technicians and experts in the SIDS Agenda discourse in addition to explicitly exploring the linkages of international trade to the SIDS Agenda....

Merging of agendasthat of the SIDS, SDGs, Climate Change and Ocean Sustainability in light of their high level of complementarity. For far too long these agendas have operated in silos.

For every single challenge identified under each agenda, the solutions lie within the implementation of the SDGs. Therefore, these synergies ought to be explored and exploited soonest as 2030 is close upon us.

The prioritization of specific SDGs including the identification of policies that could have a significant multiplier effect in delivering across multiple SDGs, whilst minimising tradeoffs

Call for collaboration, policy coherence, initiatives and complementarity of work among multilateral organisations as these organisations effectively can either undermine the agendas of each other or rather complement each other allowing for the more efficient use of scarce resources.

Within the context of prioritizing the protection of biodiversity of SIDS, the conference ought to urge the WTO to complete its negotiations on Fisheries Subsidies in full accordance with SDG 14.6 and that the global north divert the financial resources originally earmarked to fund these harm*cont'd on pg 5*

ful socks are expected to be on display in the streets and offices of Antigua and Barbuda as the world stops to commemorate World Down Syndrome Day.

Each year, medical officials at the Paediatric Unit at the Sir Lester Bird Medical Centre flash their crazy-coloured socks to bring awareness to the disease and this year will be no different.

World Down Syndrome Day has been observed each year on March 21, since 2006.

International statistics say that around one in every 800 babies will be born with Down Syndrome - a condition in which a person has an extra chromosome - and which has no known cause.

In 2022, Antigua and Barbuda had one baby born with the condition out of 931 live births.

And while numbers remain limited for those affected, medical officials over the years have called for continued improvement of services to assist those affected and their families.

are presently There three special needs institutions on the island while 16 children with Down Syndrome are enrolled in either public or private schools.

Presently, families spend thousands of dollars for treatment services like sight and speech classes.

This year's theme is 'End the Stereotypes'.

A stereotype is a set idea that people have about what someone or something is like.

For people with Down syndrome and intellectual disabilities, stereotypes can stop them from being treated like other people. They get treated like children, they are underestimated and often times excluded.

Getting the private sectors of the SIDS involved in the discussion including framing of priorities and achievement. Additionally, let them become advocates seeking the support of the private sector counterparts in the global north some of which they do business with.

The launch of a Global public advocacy campaign clearly outlining the challenges faced by SIDS, justifications for merging agendas including that of the SDGs and what every nation, private sector entity, international agency and citizens of the world can do to aid the SIDS in achieving its agenda;



For every multilateral organization that a SIDS State is a member of, it needs to bring the SIDS agenda to the forefront;

Re-intensification of the sharing of best practices and replication of policies and strategies among SIDS even if these require tweaking in response to individual domestic realities; and

The availability of quality data needs to be prioritized and SIDS initiatives bolstered by sound research to avoid any watering down by countries outside the grouping. The meeting conclusions and recommendations catered to policy makers will serve as a stepping stone for other high-level discussions scheduled in 2024 including the Hamburg Sustainability Conference and the Summit of the Future.

In 2004, the UPP won a resounding victory at the polls, defeating the ABLP; but by 2009, they had lost so much support that they barely retained the government by a narrow margin.

It was believed that, had it not been for mitigating circumstances, the UPP Government would have lost the elections.

The polls were opened very late, the polling stations ran out of ballot forms, and the printing machines overheated, and the printers ran out of ink --- causing the UPP to win by default.

The opposition habitually opposed every project the government pursued to advance the economic progress of the country.

They demonstrated against the Old Road project, which had to be scaleddown. They opposed the dredging of the harbour, and complained to neighbouring Islands, that the Antigua Government was dumping dredged materials cont'd on pg 12

They demonstrated and picketed at Heritage Quay on Thursdays whenever cruise ships were in port. And during the Covid19 pandemic, they criticized the government for closing down the country, and when the country was reopened, they criticized the government for doing so.

On Antigua, the antagonism is even more acute. The People's Republic of China, with whom Antigua and Barbuda has had diplomatic relations for more than forty years, who has contributed tremendously to the economic development of the country, has granted a housing development proj-



ect for the worst slum area in the country, Booby Alley.

For more than six years, the Antigua Government and the PRC have not been able to make this project a reality.

The residents of the area have been conditioned by the opposition to believe that the development was to their detriment.

Therefore, they revolted, demonstrated, and protested, by blocking the streets with old furniture and household equipment, and burning car tires.

The chief instigator being a pretender to the City West Constituency, a senior citizen of diminutive stature, and a spent politician who places excessive emphasis on every word he speaks; to the extent that some are inclined to believe that: Puer cum diabolo ambulat! (latin: The little boy walks with the Devil!)

Antigua needs a competitive alternative party, not just an opposition, because a confident government appreciates a challenge that gives them the satisfaction of knowing that they can defeat a formidable foe.

The divorce between US singer Ariana Grande and Dalton Gomez is now official, after nearly three years of marriage.

A Los Angeles Superior Court judgment on Tuesday finalised the split between the 30-year-old pop star and the 28-year-old real estate broker.

Under their settlement. Grande will make a one-time payment of \$1.25m (£980,000) to Mr Gomez.

Grande filed for divorce six months ago, citing irreconcilable differences.

The couple's relationship began in January 2020 shortly before the Covid-19 pandemic, and they wed in a "tiny and intimate" ceremony at her home in Montecito, California, in May 2021.

In addition to the one-time payment, the settlement also awards Mr Gomez

half the proceeds from the sale of their Grande and Justin Bieber's collabora-Los Angeles home.

Grande will also pay up to \$25,000 towards his lawyers' fees, and no future alimony.

According to court papers, the two separated more than a year ago and had a prenuptial agreement in place. There were also no legal disputes, and they had no children, allowing the divorce to be finalised quickly.

Mr Gomez, who was raised in southern California, has been working in the luxury real estate market for a decade, according to his profile on the AKG website.

He and Grande were first spotted kissing in February 2020 at a restaurant in Los Angeles.

In May that year, they made their first public appearance together as a couple in the lockdown music video for

That December, the pop star announced her engagement in an Instagram post, captioning it "Forever n then some".

Grande, a two-time Grammy Award winner, released her seventh studio album, titled Eternal Sunshine, on 8 March.

She will also be starring in the film adaptation of the musical Wicked, as the good witch Glinda, along with English Tony-award winning actress Cynthia Erivo, Oscar-winning Malaysian actress Michelle Yeoh and US actor Jeff Goldblum. The film is scheduled to be released in November.

Regional News Haiti central bank raid leaves at least three dead

Police in Haiti have killed at least three people while repelling an attack on the country's central bank.

A "group of criminals" targeted the Bank of the Republic of Haiti (BRH) on Monday, an employee told AFP, leaving up to four dead and a guard injured.

The bank itself thanked security forces for "protecting our community".

Haiti has been rocked by weeks of violence after gangs raided prisons, released thousands of inmates and forced the prime minister to resign.

In a statement on X, BRH said: "Following an incident yesterday near [our] site on Rue Pavee, security forces and the bank's security team acted with professionalism and efficiency."

The bank is one of a few key institutions still running in Haiti's capital Port-au-Prince, where hundreds of hospitals have closed.

BRH added that it was "deeply grateful to our officers and the state police for their vigilance".

The employee, who spoke to AFP on the condition of anonymity, said "three or four" of the criminal gang had been killed in the attack.

They also told the news agency that the injured

guard had sustained gunshot wounds.

BBC News was not able to independently verify these claims.

Police have been trying to recapture areas of Portau-Prince held by notorious gang leader Jimmy Chérizier, nicknamed "Barbecue".

The power struggle has led to an uptick in violence including gun fights - on the streets of Haiti, a country which struggled with gang violence long before the recent crisis.

Haitians told the BBC they could see no end to what is happening in the Caribbean country, with Port-au-Prince and the surrounding region under a month-long state of emergency.

Last week, following mounting pressure, Ariel Henry agreed to step aside as prime minister to allow the formation of an interim government.

Mr Henry had not been allowed back into Haiti after leaving in late January for visits to Guyana and Kenya, where he had signed a deal on the deployment of an international security force to help tackle the violence.

The Caricom group of Caribbean nations subsequently outlined plans to set up a transitional presidential council, comprising - among others - seven voting members, two observers and a religious leader.

One of those put forward to be a member was Leslie Voltaire, a government minister under former

Haitian President Jean Bertrand Aristide.

He told BBC World Service's Newshour programme that Haiti was in "a grave crisis" - but refused to accept that "bandits" could one day rule the country.

"They [armed gangs] say that they have put Ariel Henry out, but they cannot enter into the palace, they cannot enter into the prime minister's office," Mr Voltaire said.

Describing the chaos, he said "something" had to be done - and fast - "because now all the ports are blocked, the airport is blocked, and even if you want to go to the beach you cannot go".

He continued: "There is a lot of kidnappings, a lot of cont'd on pg 15

CMC - Guyana has told the United Nations Human Rights Committee that its citizens will decide on the issue of the death penalty, even as there are no plans by the government to boost the capacity to execute anyone under the current laws.

Governance Minister, Gail Teixeira said a similar process was undertaken between 1999- 2001 and the popular view was that the death penalty should remain on the books.

"So, there is no view in Guyana right now that we go back to executions of any kind and so it is a ad hoc or informal moratorium that we have maintained from 1997 to now," she told the UNHRC during her virtual address.

"To further strengthen our argument, the government has put no heads of prison service, no heads of the Ministry of Home Affairs, put any investments of funds into developing any capacity to execute anyone," she added.

Guyana has not carried out an execution since 1997 and political and legal observers said that although the death penalty has not been removed from the Constitution or the statute, the matter will have to go back to Parliament.

Guyana and other Caribbean countries have come under pressure from several international agencies, including the International Commission against the Death Penalty, to abolish the death penalty that they consider to be cruel and inhumane punishment.

In 2022, The Guyana Court of Appeal refused to strike down the death penalty as unconstitutional.

During her appearance, Teixeira told the UNHRC that Georgetown could not at the moment implement Public Disclosure and Whistleblowers laws.

"We are unable to, at this point, to activate the Public Disclosure and Whistleblower Act because there are genuine problems of implementation," she said, noting however that witnesses are offered "safe haven" protection by police.

With regards to the implementation of the now repealed State Assets Recovery Act (SARA) following the closure of the agency in 2020, Teixeira said that "monolithic" body "had to be repaired" because its head could have become the Chief Immigration Officer, Police Commissioner, Director of Public Prosecutions among others.

Instead, she said government was relying on the Guyana Police Force's Special Organised Crime Unit (SOCU), Customs Anti-Narcotics Unit of the Ministry of Home Affairs and the Director of Public Prosecutions through strengthening of the Anti-Money Laundering and

Supreme Court says Texas can arrest and jail migrants

The Supreme Court has allowed Texas to enforce one of the toughest immigration laws enacted by any US state in recent memory.

The measure allows police to arrest and prosecute those suspected of illegally crossing the US-Mexican border.

The Biden administration has challenged the law, calling it unconstitutional.

Crossing the US border illegally is already a federal crime, but violations are usually handled as civil cases by the immigration court system.

One reason the Texas law, SB4, is so controversial is because courts have previously ruled that only the federal government can enforce the country's immigration laws, not individual US states.

SB4 gives local and state police officers the ability to stop and arrest anyone suspected of having crossed the border illegally, except in schools, healthcare facilities and places of worship.

Punishments would range from misdemeanours to felonies and potential imprisonment, or fines of up to $$2,000 (\pounds1,570)$.

Penalties for those who illegally re-enter Texas after having been deported could go up to 20 years in prison, depending on a person's im-

migration and criminal history.

On Tuesday, the Supreme Court said the measure can take effect while a lower federal appeals court weighs its legality. A day earlier the nation's highest court placed a temporary pause on SB4.

President Joe Biden's White House sharply criticised the latest decision.

"SB4 will not only make communities in Texas less safe, it will also burden law enforcement, and sow chaos and confusion at our southern border," White House press secretary Karine Jean-Pierre said in a statement.

But Texas Attorney General Ken Paxton hailed the Supreme Court decision as a "huge win" against the Biden administration and the American Civil Liberties Union (ACLU), which has also challenged the law in court.

"As always, it's my honor to defend Texas and its sovereignty, and to lead us to victory in court," he wrote in a post on X, formerly Twitter.

The ACLU vowed that it "won't back down until this extreme anti-immigrant law is struck down for good".

Top Mexico diplomat Roberto Velasco Álvarez posted on X that Mexico will not accept migrants being sent back across the border by the state of Texas.

"The dialogue on immigration matters will continue between the federal governments" of Mexico and the US, he wrote in Spanish.

The court's three liberal justices - Sonia Sotomayor, Elena Kagan and Ketanji Brown Jackson - disagreed with the majority ruling.

"The court gives a green-light that will upend the longstanding federal-state balance of power and sow chaos," Justice Sotomayor wrote in the dissenting opinion.

She also wrote that the law could "disrupt sensitive foreign relations, frustrate the protection of individuals fleeing persecution, hamper active federal enforcement efforts" and keep migrants from reporting abuse or trafficking.

As well as arguing that SB4 infringes on the federal government's authority to secure the US border, the justice department has warned it could harm relations with Mexico, which has condemned the law as "anti-immigrant".



Dozens jailed in France's largest cyberbullying case

Twenty-eight people have been jailed for up to 18 months for the harassment of an influencer in France's largest cyberbullying case to date.

Judges found the accused guilty of harassing Magali Berdah, spurred on by a campaign by the French rapper Booba against "thieving influencers".

The court in Paris heard that the harassment had "real consequences" to Ms Berdah's mental health.

Booba is facing a separate trail and denies aggravated harassment.

Ms Berdah has built a prominent career in France as a lifestyle and fashion expert, while also marketing other social media stars through her company Shauna Events.

Her lawyers said posts from Booba, real name Élie Yaffa, encouraged a "mob" of people online to send

hateful and insulting messages to their client, something Booba denied.

The court said that each of the defendants "made a conscious choice to join in" with the cyberbullying.

The accused, aged between 20 and 49, received jail terms ranging from four to 18 months, some of which were suspended.

Ms Berdah, known as

"the queen of influencers" in France, hailed the sentencing as a "beautiful victory" after previously telling the court that the bullying brought her "within a whisker of throwing (herself) out of the window".

"My life was destroyed for two years because of this," she said. "Finally, I've been recognised as a victim."

Following the Supreme Court decision, the appeals court said it would hear arguments on Wednesday.

Whoever loses there would have the option of taking the case back to the Supreme Court.

The implementation of SB4 comes amid rising public concern over the US-Mexico border.

A Gallup poll released in February showed that nearly one-third of Americans believe immigration is the single greatest problem the country faces, ahead of the government, the economy and inflation.

Her lawyers said the convictions showed "no one is safe behind their keyboard".

The defendants were fined 700 euros (£598) and were ordered to pay an additional combined 54,000 euros (£56,100) in compensation to their victim.

Booba denied in December that he had put himself at the head of an online "mob".

The rapper made headlines in 2018 after being involved in a brawl at a Paris airport with fellow rapper Kaaris, for which both received an 18 month suspended jail sentence.

Ms Berdah is due in court on a separate charge of money laundering and her marketing company Shauna Events is being investigated for fraud.
