

luxury tourism product," he stated.

PM Browne also commended the owners and managers of the Royalton Chic for their vision and the outstanding work that they have done. "I want to congratulate Stephen Hunter, the senior executives as well

as the staff on a job well done. Congratulations on your vision to transform this property into one of the finest hotels in the Caribbean region and I have no doubt that this will be great value for money so I'm absolutely excited about this product," he declared.

# Royalton Chic to welcome first guests on April 29

The new Royalton Chic hotel, constructed on the site of the former Rex Halcyon Cove Hotel, is gearing up to welcome its first guests on April 29.

Regional Manager for Royalton, Craig Marshall reported that the construction work is completed and all that is now being done at the property is the 'tidying in' ahead of the arrival of the first guests later this month.

"We are just excited that in a few weeks we will begin welcoming our guests. We have lots in store for them



from seven restaurants and five bars in a very luxurious setting including our signature Diamond Club where the amenities include butler service, concierge service, all at an upgraded level. So regardless of where you are staying, you are going to have an amazing time at

Royalton Chic Antigua," he emphasized.

Marshall revealed that the current staff complement is approximately 350 residents but the plan is to increase that number to 500 persons by the time the season starts.

"We will be having our 'soft' opening in April and May but by June with the ICC T20 World Cup Cricket and the number of rooms we have already sold, we will be up in the higher levels of occupancy," he noted.

The Regional Manager reported that the company has spent in the region of US\$70 million on the project with further opportunities for investments in another year or so.

According to Marshall the resort will benefit from group business especially coming out of the US and indications are that the property will enjoy very brisk business during the summer months.

#### **ABUT, government sign new** collective bargaining agreement

The Antigua and Barbuda Union of Teachers says it is 'elated' to have signed a new collective bargaining agreement with the Antigua and Barbuda government.

The signing ceremony took pace on Thursday with the Chief Establishment Ofresenting the government and the ABUT represented by its President, Casroy Charles and Secretary General, Sharon Kelsick.

The agreement covers the 14 percent increase that all classes of public sector

ficer, Francia Shepperd rep- workers received and it is backdated to January 2018. It expires in December 31, 2024.

> Shepperd stated that this is the first agreement signed between the two parties since 2008, and she is particularly pleased that as

an executive that was elected in 2022, it has been able to finally reach and sign an agreement with the government.

The new collective bargaining agreement also covers several of the issues over which the union and the government have been at loggerheads over the past several years.

These include increased security at the nation's schools, duty-free allowances for teachers on the purchase of a motor vehicle as well as a re-classification of all teachers.

"It was a hard-fought battle and it took a long time to be completed but we finally got to this point and much of this has been based on the good working relationship between the Chief Establishment Officer and ourselves.

"We wish to also thank our negotiation team led by former president, Dr. Colin Greene, the executive of the ABUT and our membership for supporting us all the way," she remarked.

The ABUT has a membership of approximately 1300 teachers from the public sector as well as members from a number of private schools in the country.

Kelsick described the process as providing many challenges but the negotiation team 'worked hard' and now they are seeing the 'fruits of their labour'.

#### **Antigua and Barbuda undergoes European Union audit of fisheries sector**

The European Union, one of the main export markets for Antigua and Barbuda lobsters, is currently conducting an audit of the fishing sector of the country.

According to Chief Fisheries Officer, Ian Horsford, the audit started in November 2023 and it is still ongoing. Antigua and Barbuda successfully completed six such audits in the past.

Horsford sits in the National Trade Council and this week he told the council of the challenges his department faces in exporting fish and fish projects to markets such as the EU and the United States.

"Under EU regulations, in terms of food safety, they are looking at whether or not Antigua and Barbuda continues to meet the requirements for exporting fisheries products to the EU. They are therefore looking at the competency of our staff, the processes we use to ensure that the food is safe to enter their markets as well as to ensure that the products that reach the EU are legal," he explained.

According to Horsford it is critical that Antigua and Barbuda 'passes' this latest audit as a 'failure' would mean a total ban on exports of fish products to the EU. He said the EU market remains an important market for fisheries he further explained. products from Antigua and Barbuda although the dollar-value for the products exported has declined significantly.

"In the past, our total value for the lobsters and fish that we exported to the EU was around \$10 million. That is down to roughly EC\$3 million today. The main reason for the decline is that we no longer are able to export fish. Our exports have now been confined to live lobsters only,"

Horsford added that the EU is considered 'the gold standard' when it comes to food safety and getting a certificate from the EU means you can also export to third party countries that are not part of the bloc. "For example, when we were able to access mainland China, a lot of this hinged on our ability to export into the EU," he revealed.

Currently, he noted, only two OECS countries

have access to the EU market. These are Antigua and Barbuda and Grenada.

According to Horsford some of the things that Antigua and Barbuda take for granted, such as running water at the facility from which the products are exported, are critical to the EU and American inspec-

Horsford added that entering the US market for fisheries products also poses a different set of challenges.



# Embassy raid sparks outcry: Urgent healing action needed

On April 10, the Permanent Council of the Organization of American States (OAS) passed a resolution firmly denouncing the government of Ecuador for authorising an intrusion of the Mexican Embassy in Quito by Ecuadorian police and for the use of force against diplomatic staff.

The resolution arose because, on the evening of April 5, the Ecuadorian police intruded into the Embassy to arrest a former Vice President of Ecuador, Jorge Glas, who had sought refuge in the Mexican Embassy and had been granted political asylum by the government of Mexico just hours before the raid. The police action against Glas was brutal.

Tension. between the governments of Mexico and Ecuador which already existed, escalated the day before the violation of the Mexican Embassy when the Mexican President, Andrés Manuel López Obrador, made a statement implying that the election of Ecuadorian President Daniel Noboa was influenced by the assassination of a presidential candidate. Fernando Villavicencio. President López Obrador suggested that the murder created a "rarefied atmosphere of violence" and affected the election outcome.

The Mexican President's remarks were described pub-

licly by the Ecuadorian government as "very unfortunate", but subsequent events demonstrated that President Noboa resented the remarks more deeply. He promptly ordered that the Mexican Ambassador be declared "persona non grata" on April 4, the day before the police raid on the Mexican Embassy.

All of this was fuel for a conflict between the two governments that was already in play. The Mexican Embassy in Quito had given Jorge Glas refuge since 17 December 2023 on the basis of his claim that criminal charges against him were acts of political persecution by the Noboa government. Prior to the police violation of the Mexican Embassy, Ecuadorian authorities had sought permission from Mexico to enter the embassy and arrest Glas, who had been sentenced to six years in prison in 2017 after being found guilty of receiving bribes from the Brazilian construction firm, Odebrecht, in exchange for awarding it government contracts. However, Mexico did not agree.

It was in the height of these difficulties that the Ecuadorian police intruded into the Mexican Embassy to seize Glas in contravention of Article 22 of the Vienna Convention on Diplomatic Relations, which underlines the sacrosanct nature of diplomatic premises and mandates the host country to pro-

tect them from any intrusion or violation.

This contravention alarmed the overwhelming majority of member states of the Organization of American States (OAS), which rightfully regard the rights and immunities granted to diplomatic missions not as a mere legal formality, but as the bedrock of peaceful and respectful international relations. By invading the Mexican Embassy, the Ecuadorian government eroded the role of essential communication that embassies represent and the critical work of diplomatic personnel in fostering constructive relationships with host governments.

Therefore, whatever concerns the Ecuadorian government had about Mexico granting Glas political asylum, invading the Embassy, violently seizing and beating him and manhandling Embassy officials, cast the government of Ecuador squarely in the wrong.

This was not a matter other governments could overlook. It had to be condemned in order to send a strong message to the Ecuadorian government and all governments that such violations of inter-

national law are unacceptable.

Hence, on April 10, after consultations between member states, 29 of the 32 active OAS member states voted in favour of the Resolution which condemned Ecuador's action. Only Ecuador opposed, and only one country, El Salvador abstained.

Mexico was absent from the meeting, likely due to the presence at the meeting of a Vice Minister from Ecuador with which Mexico had severed diplomatic ties immediately following the assault on its Embassy.

Having rightly condemned the government of Ecuador for intruding into the Mexican Embassy, thereby violating international law and eroding a pivotal cornerstone of peaceful international relations, a continuing dispute between Mexico and Ecuador has repercussions which must be avoided in the interest of the two countries and the broader hemisphere.

The ongoing dispute between Mexico and Ecuador risks disrupting unanimity within the OAS's Group of 10 and could extend its divisive effects to the Latin American and Caribbean group (GRULAC) at the United Nations, potentially hampering consensus on important issues. Recognizing the critical need for resolution, the OAS resolution encourages dialogue, with the Permanent Council offering its support to mediate efforts towards reconciliation.

Navigating such a path may be difficult in the present circumstances where both Mexico and Ecuador feel aggrieved with each other. Indeed, on April 11, the Mexican government filed an Application instituting proceedings against Ecuador before the International Court of Justice (ICJ), contending that "Ecuador has violated Mexico's rights under customary and conventional international law, as well as fundamental principles upon which the international legal system is based".

Mexico has asked the court to in-

dicate provisional measures pending a final judgment in the case, including that "Ecuador refrains from any act or conduct likely to aggravate or widen the dispute".

In its full hearing of the case, the ICJ, the Court may have to assess the merits of a counter claim from Ecuador, which has publicly stated that the Mexican asylum offer to Jorge Glas was wrongful under international law because individuals facing criminal charges should not be granted asylum.

The Ecuadorian government bases this contention on Article III of the 1954 Caracas Convention on Diplomatic Asylum which is legally binding only on 14 States that have ratified it – 13 from Latin America and one (Haiti) from CAR-ICOM.

However, the 1954 Convention may have been superseded by the Convention on Diplomatic Relations which came into effect in April 1964 and to which 193 states are signatories, including Ecuador and Mexico. Additionally, Article IV of the 1954 Convention also states, "It shall rest with the State granting asylum to determine the nature of the offense or the motives for the persecution".

It will be for the ICJ to decide whose legal arguments concerning granting asylum is right, but what cannot possibly be justified is the invasion of an Embassy. On that, Ecuador will undoubtedly be rebuked.

Notwithstanding these circumstances Mexico and Ecuador, in their own interest, should try to overcome this problem which, while framed in legal terms and now before the ICJ, has strong political overtones.

## OJ Simpson, NFL star acquitted in 'trial of the century', dies aged 76

OJ Simpson, the former American football star turned actor who was controversially cleared of double murder, has died aged 76.

San Francisco-born Orenthal James Simpson rose to fame in college before playing in the NFL.

In 1995, he was acquitted of the murder of his former wife Nicole Brown and her friend in a trial that gripped America.

In 2008, he was sentenced to 33 years' imprisonment on unrelated charges of armed robbery. He was released in 2017.

Simpson died of cancer on Wednesday "surrounded by his children and grandchildren", a family statement read.

In 1994, Simpson was arrested as a suspect in the murder of his ex-wife Nicole Brown and her friend Ron Goldman. The pair were found stabbed to death outside Ms Brown's home in Los Angeles. Simpson became an immediate person of interest in the case.

On the day he was due to turn himself in, he fled in a white Ford Bronco with a former teammate, and led the police on a slow-speed chase through the Los Angeles area.

That chase engrossed audiences in the United States and abroad as it was



broadcast live on "rolling" 24-hour news channels still in their relative infancy.

In the ensuing court case, dubbed the "trial of the century" by US media, prosecutors argued Simpson had killed Brown in a jealous fury. Evidence included blood, hair and fibre tests linking Simpson to the murders.

The defence argued Simpson was framed by police who were motivated by racism.

In one of the trial's most memorable moments, prosecutors asked Simpson to put on a pair of blood-stained gloves allegedly found at the scene of the murder, but Simpson struggled to fit his hands into them. It led to one of Simpson's lawyers, Johnnie Cochran, telling the jury in his closing arguments: "If it doesn't fit, you must acquit."

The jury ultimately sided with Simpson, who had declared he was "absolutely 100% not guilty". The acquittal proved hugely controversial.

The families of Ms Smith and Mr Goldman did not give up - they pursued a civil case against Simpson in 1997 and a jury found Simpson liable for the two deaths. He was ordered to pay \$33.5m (£25.8m) in damages to their families.

In 2006, Simpson sold a book manuscript, titled "If I Did It", and a prospective TV interview, giving a "hypothetical" account of the murders he had always strenuously denied.

Public objections ended both projects, but Mr Goldman's family secured the book rights, added material imputing guilt to Simpson and had it published.

Simpson's final disgrace

came in 2008, when he was convicted of armed robbery for breaking into a Las Vegas hotel room with four accomplices, holding two sports memorabilia dealers at gunpoint and stealing items related to his NFL career.

He was sentenced to 33 years in jail, but was granted parole after serving the minimum of nine years.

Before his legal problems, Simpson was wellliked, known as an athlete, actor and the face of several major companies.

He was a college football star at University of Southern California before signing with the Buffalo Bills in 1969, where he played until 1977.

He became one of the greatest ball carriers in NFL history. In 1973, he was the first NFL player to "rush"

Four Colombian nationals have been indicted by a US federal grand jury in Puerto Rico for their alleged roles in a drug smuggling operation that was busted near Trinidad and Tobago.

- running to advance the ball for his team - more than 2,000 yards in a season. He retired in 1979 to concentrate on a career in film and television. His credits include roles in the Towering Inferno, Capricorn One and the Naked Gun series.

Broadcaster Bob Costas, who worked with Simpson on NBC's American football coverage, said that while he was not the first African American star, "he was the first to do it in a big way, an African American who broke through".

The Heisman Trophy organisation, which names college football's player of the season, said in a tweet that it mourned the 1968 winner and extended sympathies to his family.

Attorney Carl Douglas, who represented Simpson alongside Robert Kardashian and Johnnie Cochran, said that he was "shocked and surprised" to learn of the football star's death. The attorney said that his and Simpson's names will "forever be linked together in some way".

In a statement, the Pro Football Hall of Fame outlined Simpson's achievements as an NFL player, and said records of those contributions would be preserved in its archive.

Fred Goldman, Ronald's father, described Simpson's death as "no great loss".

"The only thing I have to say is it's just further reminder of Ron being gone all these years," he told NBC News. "It's no great loss to the world. It's a further reminder of Ron's being gone."

Gloria Allred, an attorney who represented Nicole Brown Simpson's family during the murder trial, said that Simpson's death served as a reminder that the justice system failed abused women and allows "celebrity men to avoid true justice", according to a statement obtained by CNN.

Caitlyn Jenner, once part of Simpson's social circle, echoed Mr Goldman, posting two words on Twitter/X: "Good riddance."

Puerto Rico on April 2, 2024, before US Magistrate Judge Marcos Lopez.

a semi-submersible.

# Key power plant near Kyiv destroyed by Russian strikes

A major power plant near Kyiv was completely destroyed by Russian strikes early on Thursday, energy company Centrenergo said.

Trypillya power plant was the largest electricity provider for three regions, including Kyiv, officials said.

"The scale of destruction is terrifying," said Centrenergo chairman Andriy Hota.

Russia has long been deliberately and systematically targeting Ukraine's energy system.

Mr Hota told the BBC that Thursday morning's strikes destroyed "the transformer, the turbines, the generators. They destroyed 100%".

A fire broke out in the turbine workshop of the Trypillya plant - located 50km (31 miles) to the south of Kyiv - following Thursday's large-scale airborne attack.

The Centrenergo boss said the plant was targeted by multiple missiles. Staff on shift were able to escape, he said, because they ran for cover as soon as the first drone hit.

Residents were urged to shut their windows, charge all their devices and stock up on water.

More than 80 missiles and drones targeted sites across Ukraine in the early



hours of Thursday. Many targeted energy infrastructure and almost a third made it through Ukraine's air defences.

Hours later, Centrenergo confirmed its Trypillya plant had been put out of use. Mr Hota said his company's entire generative capacity in Ukraine was now destroyed.

It was one of Ukraine's largest providers of electricity and heat. It operated two other power plants - one in the Kharkiv region which was destroyed in late March, and one in an area of the Donetsk region that was taken over by Russia in 2022.

The Kharkiv and the Trypillya plants used to generate some 8% of the country's electricity, according to Mr Hota. The Trypillya thermal plant provided power to the three

central regions of Zhytomyr, Cherkasy and Kyiv.

The destruction of the Trypillya plant would not be a critical issue for Ukraine in the summer, he believed, although by winter it would become a "giant problem".

While the plant can be rebuilt with help from spare parts from Europe, he says it will remain vulnerable to attack without Ukraine's allies providing powerful air defences.

"We can repair. We can do the impossible. But we need protection."

At least two more thermal power plants suffered "significant damage" overnight in the west of Ukraine, placing even more strain on electricity supply nationwide.

The DTEK power company was already down to 20% capacity after repeat attacks in March.

The company told the BBC that the latest missile and drone strike on these "purely civilian power stations" would make the task of providing critical power to the grid harder.

"Attack by attack, Russia is trying to strangle Ukraine's energy system and with it our hard-won freedom," DTEK said.

The Kharkiv region in the north-east has been hard hit again after its power plants suffered major damage in late March.

The mayor there described the situation as "very difficult" and announced more blackouts for households and businesses.

For a time on Thursday, the Kharkiv metro stopped running to save power. It has since resumed, but the power supply is dipping and surging so the trains are cont'd on pg 17

#### **South Korean opposition wins** parliamentary vote in landslide

South Korea's liberal opposition party has won a landslide majority in the country's general election to retain control of parliament.

The Democratic Party (DPK) and smaller opposition parties jointly won 192 of 300 seats in the National Assembly.

The vote is widely seen as a midterm referendum on President Yoon Suk Yeol, who has three years left in office.

His party leader Han Dong-hoon has resigned and Prime Minister Han Duck-soo has offered to resign.

This is a crushing defeat for Mr Yoon and his People Power Party (PPP), which has been struggling to achieve its agenda in a legislature dominated by the DPK. The DPK's win means they will be able to fast-track and push legislation through parliament.

Both the DPK and PPP

use breakaway satellite parties to maximise their vote under South Korea's electoral system, which assigns some seats to smaller parties whose seat counts fall short of their overall support.

"This isn't the Democratic Party's victory but a great victory for the people," said DPK leader Lee Jae-myung on Thursday.

> "Politicians on both

sides of the aisle must pool our strength to deal with the current economic crisis. The Democratic Party will lead the way in solving the livelihood crisis," he told reporters.

Today's result could embolden Mr Lee, who narrowly lost the 2022 presidential election to Mr Yoon, to make another presidential

Mr Yoon is under pressure to address a number of issues including rising food prices, a rapidly aging population and an ongoing doctor's strike.

In recent weeks, he has been criticised for appearing to be out of touch with the impact of inflation on

Just last month, he was criticised for commenting during a visit to a Seoul supermarket that a bundle of green onions priced at 875 won (£0.51; \$0.65) was "reasonable".

The item had been priced at discount because of subsidies and would normally have cost between 3,000 and 4,000 won.

The comment sparked a backlash, with bundles of green onions later being used as props at farmers' protests and DPK election rallies.

only working very intermittently.

President Vladimir Putin said on Thursday that Russia had been "obliged to respond" to the strikes on Ukrainian energy sites following Kyiv's attacks on Russian targets, although this is a war he launched without cause two years ago.

"Unfortunately, we observed a series of strikes on our energy sites recently and were obliged to respond," he said.

"I want to emphasise that, even for humanitarian reasons, we did not carry out any strikes in winter. What I mean is that we didn't want to leave social institutions

without power - hospitals and the like. But after a series of attacks on our power facilities, we had to respond."

"Strikes on energy", he added, were part of Russia's aim of "demilitarising" Ukraine - one of his stated goals when the invasion began in February 2022.

In a separate development, four people died and several more were injured in the southern city of Mykolaiv in a rare series of daytime strikes on Thursday.

The Ukrainian Southern Military Command said on Telegram that private houses, cars and industrial facilities were damaged in the "insidious" attack.

It was the first defeat in four matches for Five Islands FC, which had won their previous three matches.


Reigning Under-9 division champions, the GNFC Rebels, won for the third time in four outings, snatching a 2-1 victory against the Young Warriors FC.
