# PM 'clears the air' regarding the Peter Kelsick matter

Prime Minister Gaston Browne has cleared the air regarding the issue surrounding Peter Kelsick, operator of Sneaky Pete's, an establishment located on the beach at Dickenson Bay.

Opposition sources have been critical of the government on the matter but, PM Browne took to Facebook to give a full account of the matter and he has urged Kelsick to 'stop peddling lies'.

"Peter Kelsick needs to stop peddling lies and deceitful partisan rhetoric.

He reached a bilateral deal with Royalton, for the demolition of his abandoned, derelict plywood shack, which was located literally on the beach, six feet away from a block of rooms for the new Halcyon Chic Hotel. "My understanding is that he accepted a compensation package from Royalton that is 40 times the value of his ramshackle building.

He wants to have his cake and eat it. He is now opportunistically trying to extract personal sympathy and political value for his UPP cronies," the prime minister wrote.

According to PM Browne, Kelsick has had 40 years squatting on the public beach without paying a red cent. He added that as a man ostensibly in his 70's, he had 40 years to build a savings for his retirement.

"Instead of pursuing a sustainable business model, he operated a one-man business which declined and aged with him during the 40 years of operation.

He didn't have the foresight or interest in succession planning. Now that he has advanced in age, he doesn't have the energy to operate the business and was forced to close it four years ago, leaving the abandoned, derelict structure to further decay," he remarked.

The country's leader described the structure was an eyesore to locals and visitors alike.

"This deceit and banal partisan politics will not be allowed to go unchallenged.

No one disenfranchised or dispossessed Mr Kelsick of anything. He was treated fairly and was offered a decent *cont'd on pg 3*

# Antigua and Barbuda, US hold fruitful talks on SIDS4

Antigua and Barbuda and the United States continue to build on the strong and cordial relations that exist between the two countries over the past several decades.

This week, the US Ambassador to Barbados and the Eastern Caribbean, Roger Nyhus, and a team from the Embassy have been holding bilateral discussions with senior officials of the Antigua and Barbuda government.

On Tuesday, Prime Minister Gaston Browne held discussions with Ambassador Nyhus, and while details of the discussions have not been made public, those discussions likely touched on

Antigua and Barbuda areas of cooperation between the United States continuous build on the strong and buda.

The Ambassador also paid a courtesy call on Governor General, Sir Rodney Williams on Tuesday.

On Wednesday, Foreign Minister E.P Chet Greene, who just returned from an extended overseas trip to Bangladesh, Malta and the UK, met with the US Ambassador and team.

Meanwhile, FM Greene was in London Tuesday night for a social event that took place at Lord's Cricket Ground to honour Antigua and Barbuda's Four Knights – Sir Vivian Richards, Sir Andy Roberts, Sir Richie Richardson and Sir Curtly Ambrose.

The event marked the start of a marketing campaign in the UK to encourage cricket lovers there to journey to Antigua and Barbuda for the ICC Cricket T20 World Cup matches taking place in June at the Sir Vivian Richards Stadium.

### Chinese Embassy condemns Newsweek Magazine article

The Chinese Embassy in St. John's has written a letter to the Editorial Board of Newsweek Magazine condemning an article it published last weekend that made certain allegations regarding the relationship between Antigua and Barbuda and the People's Republic of China.

The full letter is published below.

#### Journalistic objectivity should be adhered to

Dear editor,

I read an article Newsweek carried on April 19, titled "China Building New Outpost on U.S. Doorstep".

The article has made irresponsible remarks and leveled groundless accusations about the bilateral cooperation between China and Antigua and Barbuda, trying to discredit and smear the Chinese Embassy in Antigua and Barbuda.

Since it is driven by preconceived notions, and is in no compliance with Journalistic objectivity, I would like to share the following points of fact:


Firstly, it has always been consistent and clear that China's foreign policy sticks to equal treatment and winwin cooperation. In the era of globalization, as a major developing country, China is committed to promoting common development with other countries while focusing on its development.

China welcomes cooperation with all countries, including Antigua and Barbuda and the US, following the principles of mutual respect, fairness and justice, and non-interference in each other's internal affairs, and advances mutually beneficial cooperation based on compliance with laws and regulations.

China's goals are to enable its people to live a better life, share the fruits of development with the rest of the world, and promote building a community with a shared future for mankind, rather than engage in geostrategic competition with any country. Cooperation between China and Antigua and Barbuda has always been oriented towards people's livelihood from the very beginning when we had diplomatic relations 41 years ago.

From as early as the 1990s on, landmark projects were completed with the joint efforts of both sides, the Big Creek Bridge, the Multipurpose Cultural and Exhibition Center, the Sir Vivian Richards Stadium, the new terminal building of the V.C. Bird International Airport, and the Deep Water Harbor port, to name a few.

All these projects have directly benefited the people of Antigua and Barbuda and played a positive role in promoting the economic and social development and tourism



industry.

In the course of cooperation, China never attaches any political strings to such cooperation, never imposes its will on others, never makes empty promises, and never targets any third party.

The so-called "traded its sovereignty", "pursuing colonization" and "stealth through locking countries in with loans" in the article, completely distort the facts and unduly mislead the public.

Secondly, Developing countries should be treated as equal partners. China always holds that all countries, regardless of size, should be treated as equals. all countries have the right to independently choose their development partners.

Between China and Antigua and Barbuda, based on fully respecting each other's will and cultural traditions, to help each other and deepen South-South cooperation is simply natural, fully justified, and always done above board.

China has always opposed confrontation in this

region, for this is entirely the opposite of what the region urgently needs, nor is this consistent with the development trend of the world.

The Caribbean island nations are the homeland of their peoples, not the "back-yard" nor "front yard" of any country. Their right to independent development cannot be deprived, and their region should not become an arena for competition among major countries.

It is hoped that no country should engage in zero-sum games or exclusive arrangements, more countries would provide practical assistance for the island countries and bring more benefits to their peoples. The so-called "diplomatic fortress", "intelligence center", "listening post", or "military purposes", are completely fabricated and cannot stand the test of facts and time.

Thirdly, in today's world, countries are more interconnected and interdependent than ever before, and mankind is living in the same global village.

The Ministry of Education, sports and Creative Industries is advising the general public that an advertisement making the rounds on social media regarding free online university courses is 'FAKE'. The advertisement bears the Coat of Arms of Antigua and Barbuda, what appears to be a medical logo and also another symbol that is unrecognisable and reads as follow:

"Ministry of Education and universities team up to offer free online university courses. Suitable for people aged 18 to 60 years old. Get your certificate in 4 weeks, Laptops will be provided free."

It also urges people who are between 18-30, 31-45, 46-60 and over 60 years to

apply and that students with excellent grades will receive scholarships and completion of the program leads to a degree.

The Ministry's headquarters continues to field calls from residents seeking further information on the "2024 Online Courses".

However, education officials have no knowledge of such an arrangement.

Therefore, persons are asked to refrain from sharing personal information as it relates to the advertisement.

Any scholarship offering being announced by the Ministry of Education, Sports and Creative Industries will be done through mainstream media outlets and via the Ministry's social media platforms.

# Megan Thee Stallion: Cameraman accuses rapper of 'hostile' workplace

Megan Thee Stallion has been accused of fat-shaming her former cameraman - and having sex next to him in a car - in a new lawsuit.

The US rapper is alleged to have made an "intolerable" work environment by ex-employee Emilio Garcia.

In a claim filed in Los Angeles, Mr Garcia also claims a change to his contract left him with unpaid wages.

Megan's lawyers told BBC Newsbeat the claim was "an attempt to embarrass her".

"This is an employment claim for money with no sexual harassment claim filed and with salacious accusations," they said, adding that they will deal with the lawsuit in court.

Mr Garcia claims to have started working for the Savage rapper in 2018 as her personal cameraman, and remained in the role full-time until June 2023.

In the legal documents, his lawyers say that he was trapped in a moving car with Megan - real name Megan Pete - while she had sex "right beside" him.

It allegedly happened during a trip to Ibiza in 2022, when he says he was left "embarrassed, mortified and offended".

Mr Garcia has also filed claims that during the same trip, he was taunted about his weight - being told to spit out his food and that he didn't need to be eating.

The court documents say Megan's behaviour "created a hostile work environment" for Mr Garcia, "making the conditions of his employment intolerable".

The lawsuit also includes a number of allegations of breaches of employment law, for which Mr Garcia is seeking financial compensation.


The allegations include a change to his contract which saw him paid "per task" rather than a monthly rate, which he says meant he earned "significantly less".

He also claims he missed out on healthcare benefits after his role was "misclassified" as an independent contractor.

Mr Garcia says that after the trip to Ibiza, he was booked for fewer photoshoots until June last year when he was told by Megan's management, Roc Nation, that his services were no longer required.

He alleges this was "in retaliation for his complaints of wage and hour violations".

BBC Newsbeat has contacted Roc Nation, which is also named in the court documents alongside Megan, but it has not yet commented on the allegations.

### TikTok vows to fight 'unconstitutional' US ban

TikTok says it will challenge in court an "unconstitutional" law that could result in it being sold or banned in the United States.

President Biden has signed into law a bill which gives the social media platform's Chinese owner, ByteDance, nine months to divest the app or it will be blocked in the US.

The law has been introduced because of concerns TikTok might share user data with the Chinese government - claims it has always denied.

"We are confident and we will keep fighting for your rights in the courts," said TikTok boss Shou Zi Chew.

"The facts, and the Constitution, are on our side... rest assured, we aren't going anywhere."

In a video posted on the platform, he lambasted the bill and called for people to share their stories of how TikTok had improved their lives.

"Make no mistake, this is a ban - a ban on TikTok, and a ban on you, and your voice," he said.

In a separate statement TikTok added that it believed "the facts and the law" were "clearly" on its side.

"The fact is, we have invested billions of dollars to keep U.S. data safe and our



platform free from outside influence and manipulation," it said.

The measure was passed as part of a package of four bills which also included military aid for Ukraine, Israel, Taiwan and other US partners in the Indo-Pacific region.

It had widespread support from lawmakers, with 79 Senators voting for it and 18 against.

"For years we've allowed the Chinese Communist party to control one of the most popular apps in America... that was dangerously short-sighted," said Senator Marco Rubio, the top Republican on the Intelligence Committee.

"A new law is going to require its Chinese owner to sell the app. This is a good move for America," he added. TikTok has said ByteDance "is not an agent of China or any other country". ByteDance insists it is not a Chinese firm, pointing to the global investment firms that own 60% of it.

Experts have told the BBC the bill is "a big deal" but have warned it faces multiple hurdles.

It could take several years before the app is blocked as legal action, likely all the way to the Supreme Court, would delay the process.

In November, a U.S. federal judge in Montana blocked an effort to ban Tik-Tok within the state.

The popularity of the app with young Americans could also be problematic.

"About two in three young people in the US have a TikTok account," said Andrew Przybylski, professor

of human behaviour and technology at Oxford University.


"The primary challenge is going to be on freedom of speech and freedom of expression.

"The UN Charter on the Rights of the Child is quite specific: young people have a right to information and a right to play, so I think it can be challenged on those grounds."

Jennifer Huddleston from the Cato institute, in Washington, said any sale might be delayed because of the "considerable" regulatory scrutiny it would attract.

"Nine months is a rather quick timeframe for this size of a transaction - it's something that is likely to have further regulatory scrutiny even without the requirements in this propos-

# CARICOM continuing efforts to find solution in Haiti - President Ali

CMC - Caribbean Community (CARICOM) chairman, Dr Irfaan Ali says the regional integration movement is continuing efforts to formulate a Haitian-led solution to the current turmoil in the French-speaking CARICOM member state.

President Ali said Guyana and the rest of CAR-ICOM remain resolute in their pursuit of peace and stability in the region.

"We also as a country support every effort to build safe societies, societies in which any act of terror, or

"So, we will continue to work until all members of the human family can achieve that important human desire of living in peace and building prosperous and harmonious societies," he told the handing-over ceremony for GUY\$110.8 million (One Guyana dollar=US\$0.004 cents) in humanitarian aid for Palestine.

Ali said that the situation in Haiti is also being monitored.

In 2023, the Eminent Persons Group (EPG) was formulated to extend the Community's Good Offices to the Government of Haiti and Haitian stakeholders. The group has engaged a wide range of actors, including Haitian politicians, political parties, the religious community, the private sector, the diaspora, and civil society.

To facilitate this return to normalcy, Prime Minister, Ariel Henry has since resigned, paving the way for creating a Transitional Presidential Council.

"We have been spending a lot of time supporting efforts there. We have also dedicated resources as a government," Ali said, adding that the EPG will receive continuous support from Guyana, as the group aims to aid the return of fully functioning state institutions.

Recent reports indicate that gang violence has surged in Haiti, as the country continues to spiral.

According to a recent UN report, more than

2,500 people were killed or wounded across Haiti from January to March.

A US military plane – which landed in Port-au-Prince, on Tuesday – bringing non lethal material for the country's security forces.

The airport has been closed since March 4, this year, and ports have been out of service in an area almost totally controlled by gangs.

The United Nations Tuesday reported that its humanitarian colleagues say that the procurement of essential supplies, including food and medicines, is becoming increasingly challenging – with the international airport closed, main ports barely functioning and roads leading out of the capital blocked.

"Fuel availability has also become a pressing issue with prices soaring on the black market and transportation costs on the rise," the UN spokesman added.

al," she said.

"The question remains - what does it mean to even sell TikTok in the US, is that truly possible, and what would a buyer look like?"

Exactly who would be able to buy and operate it is also a big question the price would likely be in the tens of billions of dollars, meaning there would be few potential buyers.

Brooke Erin Duffy, associate professor of communication at Cornell University, said TikTok users in the US had been bracing themselves for a ban "for quite some time".

"The Senate decision injects a heightened level of uncertainty into the livelihoods of countless content creators, influencers, and small business owners," she said.

If it is not sold in time, the app could be blocked in the country - the US says this is because it is concerned TikTok could be used to spy on Americans, or to spread propaganda.

TikTok gathers similar kinds of data to other apps, but the US is concerned this data could fall into the hands of the Chinese government - claims the company has always contested. Elsewhere, the firm has agreed to suspend its TikTok Lite rewards programme, which pays users to spend time on the app in France and Spain.

European Commissioner Thierry Breton said the feature was "toxic and addictive", particularly when used by children, and threatened to block it unless action was taken.

The EU said its investigation into the feature would continue.

# Archbishop Malzaire calls for an end to the public discord in Grenada

CMC - The leadership of the Province of Castries, Antilles Episcopal Conference, says it is "deeply saddened by the situation unfolding in Grenada where a priest there has announced plans to launch a petition to remove the Bishop, Clyde Harvey from office.

In a statement, signed by Archbishop Gabriel Malzaire, the Metropolitan Archbishop of Castries, the Province of Castries said that it was also saddened by "the continued public display of disregard for leadership, and the policies and processes of the Church".

Less than a week after the Roman Catholic Church in Grenada announced that a truce had been brokered ending a feud between Bishop Harvey and Father Gerald Paul, the priest has announced plans to get the Trinidadian born bishop removed from Grenada.

"I will defy that suspension, I will be saying mass here every Sunday and continuing my church activities as usual," Father Paul said, adding that "I am going to be writing to Rome and to the (Papal) Nuncio, the Pope's representative, who represents all the churches in the Caribbean... and also I will be writing to Rome to tell my part of the story.

"Secondly, I will begin a campaign to unseat Clyde Harvey as Bishop of Grenada," he told the congregation, saying "we have had enough of that foolishness".

Earlier this month, Bishop Harvey said that Father Paul had "not been suspended because of what he had said about Gaza" but for his continued "lack of respect" for the church and his "pronouncements that often stray from the truth".

"I wish to state...Father Gerard

Paul had not been suspended because of what he said about Gaza. His sentiments have been echoed by many in and out of the Catholic Church. The Church is very concerned and will continue to speak out about the unjust situations in the world, including Gaza, Ukraine, Haiti and Sudan," Bishop Harvey said in a video statement.

The Trinidadian-born Bishop said that the church would continue with that policy, while being active in caring for persons "in the midst of these situations".

The controversy began on March 27, 2024 at the Cathedral of the Immaculate Conception and subsequent statements made by Father Paul on various media platforms in which he accused the church here for not condemning the situation in Gaza.

"I call upon the Church today to get its freedom and to get its voice and speak up for justice," the priest said, while calling the Gaza War a 'wholesale slaughter' of Palestinians and Muslims," he added.

In his statement, Archbishop Malzaire said the series of "errant actions" which occurred at and following a church service on march 27 this year "has brought disrepute to the Church and immeasurable hurt to the faithful.

"It has now become necessary for the leadership to intervene and to take action in accordance with the right order of the Church," he said, adding that Bishop Harvey "is the rightfully appointed bishop" and "must be respected as such.

"As required by Canon law, he submitted his resignation on attaining his 75th birthday. The Holy Father, Pope Francis, by letter of January 2024, asked him to remain as bishop of the diocese with full duties and rights until a new bishop is chosen and duly appointed".

Archbishop Malzaire said that consistent the policies and processes of the Church, "it is expected that any instruction which Bishop Harvey... issues to members of the clergy in the Diocese of St. George's in Grenada must be adhered to.

"Any objection to such instruction must follow the requisite internal processes of enquiry and resolution. It is not the practice nor the desired position of the Church to address internal differences publicly".


He said as Archbishop of the province, he is prepared "to urgently hear and consider any objections" which Father Paul may wish to make concerning his suspension "or any complaints against the bishop.

"It must be clear that the removal of a bishop must also follow due process. The Church is governed by its own system of laws and procedures and these must be respected and followed. Until such time that the actions of Bishop Harvey are overturned by a lawful process, then they stand and should be respected and followed".

Archbishop Malzaire said he is calling on the faithful in Grenada to ensure that "the present tensions in the diocese may soon give way to a stronger, united Christian community".

# Argentina seeks arrest of Iranian minister over 1994 bombing

Argentina has asked Interpol to issue an arrest notice for the Iranian interior minister, Ahmad Vahidi.

The request comes less than two weeks after a court in Argentina held Iran responsible for the 1994 attack on a Jewish community centre in Buenos Aires, in which 85 people were killed.

Mr Vahidi was in Pakistan earlier this week as part of an Iranian delegation which is now in Sri Lanka.

Argentina said it had also asked the two countries to detain Mr Vahidi.

The Argentine Foreign Ministry said in a statement that Interpol had issued a so-called "red notice".

While a red notice alerts police in member countries about internationally wanted fugitives, it does not constitute an arrest warrant.

Interpol cannot compel police to arrest someone for whom a red notice has been issued, it is up to the member country to decide whether to make the arrest. The Iranian delegation, which includes President Ebrahim Raisi, arrived in Sri Lanka earlier on Wednesday.

However, AFP news agency reported that Mr Vahidi was not seen accompanying the president upon arrival in Sri Lanka.

Iran's official news agency reported that Mr Vahidi was back in Iran on Tuesday, without referring to the red notice.

The Argentine Foreign Ministry said it wanted Mr Vahidi as "one of those responsible for the attack on [the Israeli-Argentine Mutual Association cultural centre] Amia".

Argentina has in the past accused Mr Vahidi, who led the overseas operations arm of the Islamic Revolutionary Guard Corps (ICRGC) at the time of the attack, of being one of the masterminds behind the bombing.

The attack on the cultural centre was the deadliest in Argentina's history. Three hundred people were injured in the explosion, which killed 85.

Iran has always denied any involvement but on 11 April, Argentina's Court of Cassation - the country's highest criminal court - ruled that Iran had planned the attack and that the Iranbacked group Hezbollah had carried it out.

The court called it a "crime against humanity".

The Iranian Foreign Ministry dismissed the ruling, saying the court had made "baseless and unsubstantiated claims" for the sake of "political goals and objectives".

Argentina is home to Latin America's largest Jewish community.

The community was the target not only of the Amia bombing but also of a previous bomb attack, in which a suicide bomber drove a lorry loaded with explosives in to the Israeli embassy, killing 29 people.

Argentina has long blamed Iran and the Islamist group Hezbollah for that attack as well as the one on Amia.

# Spain's PM Pedro Sánchez halts public duties as wife faces inquiry

Spanish Prime Minister Pedro Sánchez has suspended public duties to "stop and reflect" on whether to remain in the job, after a court opened a preliminary inquiry into his wife.

In a statement, the Spanish leader said he urgently needed to decide "whether I should continue to lead the government or renounce this honour".

The court said it was responding to corruption claims against Begoña Gómez.

Mr Sánchez said his wife would defend her honour and work with the judiciary.

The complaint against Begoña Gómez was raised by anti-corruption campaigners Manos Limpias (Clean Hands), who have taken part in a number of high-profile court cases in recent years and are led by a man linked to the far right.

The Spanish prime minister said he would make a decision on his future before the media on Monday 29 April, after reflecting whether it was worth remaining in office "despite the mud" that the right and far right were trying to turn politics into.

In a lengthy statement on X, Mr Sánchez complained of a "strategy of harassment" over months aimed at weakening him politically and personally targeting his wife.

The court did not give details of the accusations against Begoña Gómez other than to say it had begun investigating allegations of influence peddling and corruption on 16 April.

However, El Confidencial website said on Wednesday that the inquiry was looking into her links to private companies that had secured government money or public contracts.

In particular, it cited a "sponsor-

ship agreement" involving tourism group Globalia and a foundation she ran in 2020 called IE Africa Center. In 2020, Globalia secured a €475m (£407m) bailout for its airline Air Europa, as part of a series of government rescue packages for companies during the Covid-19 crisis.

Spain's conservative Popular Party (PP) demanded explanations in parliament earlier on Wednesday, to which the prime minister said simply that he believed in justice "despite everything".

Spanish media said he had left parliament for his Madrid residence visibly upset. Hours later he accused PP leader Alberto Núñez Feijóo of working with far-right party Vox to bring him down.

"I am not naive. I realise they are denouncing Begoña, not because she has done anything illegal - they know there is no case - but because she is my wife," he complained in his statement.

Political allies expressed support for Mr Sánchez, who has been in power since 2018, but his decision to suspend public duties comes at a tense time for his Socialist party ahead of European Parliament elections in June and elections in the Catalonia region of north-eastern Spain next month.

He was due to take part in a Catalan campaign launch in Barcelona on Thursday.

Pedro Sánchez leads an awkward coalition that includes two Catalan separatist parties, which were persuaded to join the government in return for an amnesty that covered a banned Catalan referendum on secession in 2017.

Without the support of the Catalan Republican Left (ERC) and Together for Catalonia (JxCat) he would not have been able to stay in power, following an inconclusive election last year.

Opposition parties were outraged by the amnesty, which also means the former Catalan regional leader Carles Puigdemont will stand in next month's regional vote, seven years after he fled imminent arrest and went into exile in Belgium.

Mr Puigdemont is still facing a terrorism case but believes the amnesty will enable him to return to Spain.

# Usain Bolt named Ambassador for 2024 ICC Men's T20 World Cup

The International Cricket Council (ICC) has announced Olympic legend Usain Bolt as an ambassador for the upcoming ICC Men's T20 World Cup, which will be played in the West Indies and USA from June 1 to 29.

The announcement comes a few weeks ahead of the start of the biggest cricket carnival spectacle ever that will inspire a new generation of fans. As an ambassador, Bolt will play a key role in promoting the event, starting with a cameo appearance in next week's release of the event's official anthem music video alongside iconic artists Sean Paul and Kes.

The eight-time Olympic gold medalist will also attend T20 World Cup matches in the West Indies and be part of fan engagement events promoting the sport within the United States.

Usain Bolt expressed his excitement about his new role, saying, "I am thrilled to be an ambassador for the upcoming ICC Men's T20 World Cup.
