Judge alone trials to be permanent

The government is going to parliament today to enact legislation to make permanent the law providing for trials at the High Court to be presided over by a judge sitting alone without a jury.

Attorney General, Sir Steadroy Benjamin will introduce the Criminal Proceedings (Trial by Judge Alone) (Amendment) Bill, 2024, when the House of Representatives convenes a sitting at the parliament chambers today.

The amendment is designed to make trial by judge alone a permanent feature of the legal system of Antigua and Barbuda. The original law was introduced in 2021 during the COVID-19 pandemic and given a two-year

life-span. Last year, it was extended by a year to expire on June 7 this year. By way of the amendment, government is moving to have the law made permanent before it expires next month.

"The rational for making the judge alone trial permanent is that it has helped to reduce significantly the backlog of cases that has been an issue for the High Court for several years. Additionally, whilst there have been issues with juries in the past, having a judge sitting alone makes for timely efficiency in the court system," legal sources told Point Express newspaper.

The Ministry of Legal Affairs held discussions with the Bar Association as well as criminal lawyers to get some input in the proposed legislation. The main recommendation coming from the Bar Association was that the accused should have a choice in determining whether he/she wanted to be tried before a jury or a judge alone. On the other hand, the criminal lawyers did not have much concerns with its extension.

The original law had a list of offences that would be tried by Judge Alone and according to the legal sources, there have been no significant changes under the proposed legislation. The legislation lists all indictable offences under the Larceny Act, the Forgery Act, the Misuse of Drug Act, cont'd on pg 3

Antigua experiences another day of heavy rains

atmosphere gave rise to heavy downpours on several parts of Antigua on Thursday forcing the cancellation of a number of events.



own benefit. So, we want to bring that to an end. That is the first step and I believe the Minister will devise some other systems that are lawful which would impose some liability on children", Chief of Staff in the Prime Minister's office Lionel 'Max' Hurst added.

According to the Cabinet notes, the 'Abandonment of the Elderly and Protection of their Assets' Act, would provide legal safeguards to ensure that the rights and well-being of elderly citizens are protected and respected, even in cases when their own relatives have failed to provide the necessary care and support.

Money-laundering and Prevention Act, the Proceeds of Crime Act, the Firearms Act and the Prevention of Terrorism Act as among those matters that will fall under Judge Alone trials.

"Once an offence goes before the High Court for trial, then it would be subject to Judge Alone trial," the legal sources stated.

Meanwhile, another legislation – the Legal Aid and Advice Centre Bill, 2024,

will have its first reading in the House of Representatives today. Debate on this legislation will take place at a later sitting as the Ministry of Legal Affairs is still accepting recommendations from the public on how best to operationalize the arrangement. The idea is to set up this centre that will help the less fortunate with legal representation before the courts. It will also provide for a public defender as part of the arrangement.

Tomlinsons cemetery work progresses

Work at the new public cemetery is said to be moving along swiftly.

A brief update was given in this week's Cabinet Notes.


According to the Notes, the fence is near completion and is to be followed by paved roads, a parking lot, and an administrative building.

Plans for the Tomlinsons public cemetery were revealed back in 2003 by the Antigua and Barbuda Labour Party (ABLP) but it was delayed for several years. The delays were previously blamed on funding issues and the Covid-19 pandemic but in 2023 those plans came back on stream and fast for-

warding to this year, work on the fence surrounding the grounds began.

The new public cemetery is set to be constructed under the name Tomlinsons Park or Tomlinsons Garden Cemetery and is expected to feature a non-denominational church, crematorium, and an ecumenical center spread across about 10 acres.

The need for an additional public cemetery is quite dire in the country as reports over the past few months have revealed that not only is the St. John's public cemetery almost at capacity but several of the community cemeteries were also running out of burial spaces.

New Catamaran Haul Out and Boatyard Facility opens at Jolly Harbour Marina and Boatyard

The Jolly Harbour Marina and Boatyard (JHMB) announced the official opening of its Marina and Boatyard expansion project. The event marked the unveiling of a second mega travelift and the introduction of a new boatyard, enabling the marina to offer haul out and storage services to boats up to 34 feet wide and 75 feet long.

With this significant development, JHMB now boasts dual operations, including two haul/launch areas, two 75-ton travelifts, two boat movers, and three individual boatyards capable of providing safe and secure storage for up to 240 boats. This expansion positions JHMB to provide comprehensive services to yachties, catamaran

operators, visitors, and residents alike. The main marina docks accommodate boats up to 80ft long, and the Super Yacht dock can accommodate vessels, alongside, up to 200ft.

Established in 1992, Jolly Harbour Marina and Boatyard was recently acquired by Sabana Holdings in May 2021. Ms. Jo Lucas, General Manager of JHMB, highlighted the evolving landscape of the yachting community, noting a substantial shift from single

hull vessels to multi hulls, particularly catamarans. She remarked, "We have always been able to cater to catamarans on the docks but we were faced with limitations in offering boatyard services... Having observed the very clear trends... the owners of JHMB decided it was time to expand to accommodate them by offering haul out and yard maintenance and storage services."

The project, which commenced in mid-December 2023 and was completed on April 30th, 2024, underscores the efficiency and dedication of the team involved. 


and most importantly safety and security.

Spotify paid the UK music industry £750m last year

Spotify says music by UK recording artists generated £750 million in royalties on its platform last year.

Almost 1,000 artists were played often enough to generate at least £100,000 in royalties each, the company added.

The figures were revealed as part of Spotify's "Loud and Clear" campaign, which aims to provide transparency on how it pays the music industry.

However, the company is unable to say how much of those royalty payments actually goes to musicians.

That's because every artist has a different contract with their record label and publishers, which determines how the money is divided.

The artist's share is often around 16%, a committee of MPs heard in 2021.

That would mean an artist whose music generated £100,000 on Spotify might only receive £16,000 in royalty payments, before tax.

However, Spotify is not the only source of revenue.

The Swedish company has about a 50% share of the UK music streaming market, according to the CMA, which means artists could make the same amount again via platforms like Apple Music, Amazon Music and Tidal.

Ed Sheeran was the most popular British artist on Spotify last year, with his songs played 6.35 billion times.

Coldplay came second with 5.58 billion streams, followed by Harry Styles with 5.11 billion streams.

However, British artists were unable to crack Spotify's Top 10 mostplayed chart, which was topped by Taylor Swift (on 29 billion streams) and also featured Puerto Rican star Bad Bunny, Mexico's Peso Pluma and

Colombia's Karol G.

The shift suggests that speaking English is no longer a pre-requisite for global music success.

More than half the artists who generated \$10,000 (£8,000) on Spotify last year are from countries where English is not the first language, the company said.

English is still the top language for music globally, accounting for 54.9% of the top 10,000 songs. But its share of the market is falling, with languages like Hindi and Japanese making gains.

"It's really interesting time for music," said Spotify UK's head of artists and industry partnerships, Bryan Johnson.

"In the past few years, we've seen genres like K-pop and Amapiano take off, and now Music Mexicana is really starting to travel.

"The choice now for fans and listeners is incredible."

He noted that 75% of all the royalties paid to UK artists came from international listeners - suggesting there is still a "huge export opportunity" as the streaming market matures.

Johnson added that independent

artists and labels received 40% of the UK's royalty payments - a total of £300 million.

They typically receive a higher share of the proceeds, with artists who self-release music (ie without the help of a record label or distributor) sometimes keeping 100% of the income their songs generate.

However, Spotify has come under fire recently for demonetising songs with fewer than 1,000 streams.

That means the copyright holders will not be paid at all, if the song falls below that threshold in a 12-month period.

Critics have complained that the policy means will "enrich the top of the pyramid" and starve working musicians of money.

But Johnson said the policy was designed to filter out "spam", and thwart fraudulent activity.

Spotify has previously noted that 1,000 plays only generates a "micro-payment" of around \$0.25 (£0.20) that artists rarely see - because distributors often set a minimum threshold before artists can withdraw money.

Venezuela may be first nation to lose all its glaciers

Venezuela may be the first nation in modern history to lose all its glaciers after climate scientists downgraded its last one to an ice field.

The International Cryosphere Climate Initiative (ICCI), a scientific advocacy organisation, said on X that the South American nation's only remaining glacier - the Humboldt, or La Corona, in the Andes - had become "too small to be classed as a glacier".

Venezuela has lost at least six other glaciers in the last century.

With global average temperatures rising due to climate change, ice loss is increasing, helping to raise sea levels around the world.

"There has not been much ice cover on the last Venezuelan glacier since the 2000s", Dr Caroline Clason, a glaciologist at Durham University, told Newsround. "Now it's not being added to, so it has been reclassified as an ice field."

In March, researchers at the University of Los Andes in Colombia told AFP the glacier had shrunk from 450 hectares to just two.

Luis Daniel Llambi, an ecologist at the university, told the Guardian that it had now shrunk to less than that.

While there is no global standard for the minimum size a body of ice must be to qualify as a glacier, the US Geological Survey says a commonly accepted guideline is around 10 hectares.

One study, published in 2020, suggested the glacier shrank to less than this sometime between 2015 and 2016 - though it was still considered Venezuela's last glacier by Nasa in 2018.

Dr James Kirkham and Dr Miriam Jackson, glaciologists with the ICCI and the International Centre for Integrated Mountain Development respectively, explained that "glaciologists recognise a glacier as an ice mass that deforms under its own weight".

They told the BBC in a

joint statement: "Glaciologists often use a criteria of 0.1 sq km [10 hectares] as a common definition, but any ice mass above that size still has to deform under its own weight [to count]."

They suggested that there may have been issues accessing the Humboldt glacier in recent years, which could have delayed the publication of the measurements.

Professor Mark Maslin, a professor of earth system sciences at University College London, said an ice field like the Humboldt roughly equivalent to the area of two football pitches - "is not a glacier".

"Glaciers are ice that fills valleys - that's the definition - and therefore I would say Venezuela has no glaciers whatsoever," he told the BBC.

In December, the Venezuelan government announced a project to cover the remaining ice with a thermal blanket it hoped would stem or reverse the thawing process.

But the move drew criticism from local climate scientists, who warned that the covering could contaminate the surrounding habitat with plastic particles as it degraded, according to Spanish newspaper El Pais.

Prof Maslin said mountain glacier loss was "not directly reversible" as to survive through the summer months they needed enough ice to reflect sunlight and keep the air around it cool.

"Once glacier's gone, the sunlight heats the ground, makes it much warmer and makes it much less likely to actually build

In 2024, the company expects that the new policy will divert \$40 million (£32 million) to more popular songs.

"This is not something that Spotify takes," said Johnson. "The money goes back into the pool... to emerging and professional artists."

This year marks the first time that Spotify has disclosed its figures for UK payouts. It says the total of £750 million has doubled since 2017.

Earlier this year, the company announced it had paid \$9 billion (£7.2 billion) in royalties worldwide last year, making it the biggest single contributor to the music industry's revenues.

YouTube, once the thorn in the industry's side, is thought to be the industry's second largest source of income. In February, it said it had paid out \$6 billion (£4.8 billion) to rights-holders last year.

Grenada's Tourism Minister assures hotel water needs will be met

Water restrictions, which will go into effect on Sunday in Grenada, are not expected to have a major impact on the country's vital tourism industry.

Minister of Tourism Adrian Thomas said contingency plans are in place to ensure hotels, schools and private residences have the water they need.

"You're going to have water every day. The point about it is you may not have it throughout the entire day. For the last couple of years, climate change has impacted Grenada extremely hard in regards to getting a long spell of dry seasons," he told Loop News in a interview on the sidelines of today's launch of the Pure Grenada Expo in Port of

Spain, Trinidad.

"This period now is tourist season. All the hotels are filled with people so you have more consumption of water and schools are in full gear. Things are busy in Grenada, so obviously water is being consumed. But once the rain starts to fall, the situation is going to be remedied."

He continued: "But let me say that we have large trucks that ensure that hotels in particular have water. So, in the hotel, we don't really have a problem that the guests cannot get water. And as a matter of fact, what the guests are doing, they are spending the entire day on the beach and it's just to rinse off their skin and go to bed."

Thomas said there is



no need for hoteliers to cut back on the number of guests they have at their properties.

At a media conference today, Terrence Smith, National Water and Sewerage Authority (NAWASA) Acting General Manager, announced that approval was given for the agency to impose limits on water use.

Smith said NAWA-

SA tried over the last few weeks to ensure there was equitable distribution of the limited supply of water to Grenadians.

But he noted "very little" water is left in Grand Etang Lake to pump to the Annandale Water Treatment Plant, which supplies a large part of Grenada.

Denise Boris, NAWA-SA's inhouse legal counsel, said from Sunday it will be illegal to fill swimming pools, large manmade ponds and use hoses to wash vehicles, irrigate gardens and wash homes.

Anyone caught breaking the water restriction can be fined EC\$500 or be imprisoned for one month if in default.

"This is not something NAWASA takes lightly and wants to go around enforcing the regulations. So, we are asking the general public to cooperate with NAWASA during this period and restrict the use of your water as we have asked you to do," Boris said.

ice up over the summer," he said.

Maximiliano Herrera, an extreme weather researcher, wrote on X/Twitter that the next countries that were likely to become glacier-free were Indonesia, Mexico and Slovenia. Prof Maslin said these suggested nations "make logical sense" because of their relative proximity to the equator and relatively low-lying mountains, which made their ice caps more susceptible to global warming.

"The warm zones are just expanding upwards and outwards with climate change," he said, pushing the point at which snow and ice can form year-round higher.

The author of several books on climate change said these smaller glaciers – like the one recently lost in Venezuela – did not

contain enough ice to substantially raise sea levels when they melt. But in some regions, glaciers play a crucial role in supplying communities with fresh water, particularly during hot, dry periods.

"Once you get rid of that, the problem is you're then purely reliant on spot rainfall," he said.

Dr Kirkham and Dr Jackson said: "The latest projections show that between 20 and 80% of glaciers globally will be lost by 2100 (with significant regional variation), depending on the emissions pathway followed."

They said that even though "a portion of this loss is already locked in", rapidly lowering CO2 emissions could save other glacial deposits, "which will have enormous benefits for livelihoods, and energy, water and food security".

IACHR welcomes Dominica High Court ruling in favour of equality

CMC - The Inter-American Commission on Human Rights (IACHR) is calling on all Caribbean countries that still maintain forms of criminalisation that interfere in aspects related to the private lives of individuals to repeal such laws that facilitate their persecution.

"In addition, the States of the region are urged to continue advancing social inclusion and real equality of LGBTI people. The IACHR reaffirms its commitment to States and Civil Society Organisations to assist in the processes to create a legal framework that protects LGBTI persons from all forms of violence and discrimination," IACHR said in a statement.

The IACHR called on all regional states to repeal legislation "that facilitate the persecution of LGBTI persons in any form and that encourage acts of violence due to prejudice and discrimination".

Section 14 of the Sexual Offences Act is a sweeping law criminalising gross indecency which is defined as any act (other than penile-vaginal sex) by anyone "involving the use of the genital organs, breast or anus to arouse or gratifying sexual desire".

The maximum penalty is 12 years in prison, if the act is committed with a person aged 16 or older.



criminalises buggery, which the act defines as anal sex between two men or between a man and a woman. The maximum penalty is 10 years imprisonment plus the possibility of forced psychiatric confinement.

Last month, in a 40page ruling, Justice Cenac-Phulgence agreed that the two sections contravened Sections 1 and 10 of the Dominica Constitution and persons' rights to liberty as enshrined in the Constitution.

The IACHR, which is an autonomous body of the Organisation of American States (OAS), said legislative provisions that criminalize private consensual same-sex relations are against international human rights standards, as they violate human dignity, privacy, and freedom of expression.

"It is also worth noting that the Dominica High Section 16 of the act Court in its decision high-

international lights Inter-American standards which stipulate that laws criminalising consensual intimate relations between persons of the same sex are against the principles of equality and non-discrimination in the American Convention."

The IACHR said with "this landmark decision, Dominica has aligned itself with other nations whose courts have struck down criminalisation provisions as human rights violations".

It said most Caribbean Community (CARICOM) countries now comply with Inter-American standards on decriminalisation.

The IACHR has noted that even when these laws are not enforced, they have a negative impact on society, "as they foster prejudice, encourage acts of violence, and enable a culture of impunity".

In 2020, the IACHR

emphasised that such criminal prohibitions interfere in aspects related to the private lives of individuals on the basis of a protected category of the American Convention without reasonable justification, in violation of human rights standards.

"Furthermore, they constitute barriers for persons with non-normative sexual orientations and gender identities to access other rights, such as freedom of association, freedom of expression, health, employment, access to justice, among others."

The lawsuit in Dominica was brought by an un-named "gay individual" identified only as "BG" against the Attorney General, the Bishop of Roseau, The Methodist Church and the Anglican Church.

The Dominica Association of Evangelical Churches was listed as an interested party.

Polish security finds cabinet meeting room bugged

Special services in Poland have discovered and removed bugging devices in a room where cabinet ministers were due to meet.

The weekly cabinet meeting normally takes place in the prime minister's office in Warsaw.

But Tuesday's session was relocated to the southern city of Katowice because several ministers, including Prime Minister Donald Tusk, were due to attend a major economic conference there.

Poland has seen increased spying activity since it became an international hub for military and humanitarian aid to Ukraine following Russia's 2022 invasion.

In a separate case this week a judge has sought asylum in neighbouring Belarus, and Mr Tusk said on Tuesday he had access to confidential documents.

"The State Protection Service, in co-operation with the Internal Security Agency, detected and dismantled devices that could be used for eavesdropping," wrote security services spokesman Jacek Dobrzynski on X. "The services are carrying out further activities in this matter."

Mr Dobrzynski told the TVN24 broadcaster the devices were found during a routine security sweep of the room. Poland's Internal Security Agency is now investigating what the devices were, and who could possibly have installed them.

Following the security check, the cabinet meeting went ahead in the building as planned.

A spokeswoman for the Silesia regional authorities, Alicja Waliszewska, told state news agency PAP that the device may have been part of the

room's old communication system that was no longer operational.

The discovery follows news on Monday that a Polish judge is seeking asylum in neighbouring Belarus.

Tomasz Szmydt, a judge at the Voivodship Administrative Court in Warsaw, told a news conference in Minsk his actions were in protest against Poland's "harmful" policy towards Belarus and Russia that could result in armed conflict between the countries.

Investigators are checking whether the judge had been spying. He was reportedly due to rule next month on cases concerning security clearance for confidential information on Nato, of which Poland is a member.

Commenting on the affair, Polish Foreign Minister Radoslaw Sikorski wrote on X: "A traitor. The only question is since when."

Mr Szmydt gained notoriety in Poland for his involvement in an online smear campaign that was allegedly run from the justice ministry against judges who opposed the judicial reform introduced by the previous Law and Justice-led government.

Donald Tusk has convened a meet-

ing of the Secret Services College for Wednesday to discuss potential Russian and Belarusian influence in Polish politics in recent years.

"We must be aware that services, in this case Belarusian ones, worked with a person who had direct access to the minister of justice... who had access to various classified documents to which no intelligence service should have had access," the prime minister told a news conference.

Former Justice Minister Zbigniew Ziobro has denied ever meeting the judge.

Mr Tusk added that "the fact that judge Szmydt's relationship with the Belarusians has a long history... must raise our greatest concern".

Last year, the Polish authorities charged several members of an alleged Russian spy network who were tasked with preparing sabotage acts to paralyse the supply of weapons and aid to Ukraine.

Cameras were discovered near the Rzeszow-Jasionka airport near the Ukrainian border that serves as a logistics hub and is protected by American troops and Patriot missile batteries.

US airman shot and killed by police in Florida

A US Air Force member was fatally shot by police who entered the wrong address, a lawyer for his family says.

Senior Airman Roger Fortson, who was 23 years old, died after a deputy sheriff shot him while responding to a disturbance call.

Police earlier said the deputy reacted in self-defence after he saw Fortson armed with a gun.

Citing a witness, the lawyer alleges that police burst into the wrong home. He is demanding a full investigation.

The airman was shot on 3 May at his home, located 5 miles (8km) from the Special Operations Wing at Hurlburt Field, Florida, where he is based.

Fortson was taken to a hospital where he died, officials said.

The deputy who shot him - whom police have not named - has since been placed on administrative leave, according to a statement on Tuesday by Okaloosa County Sheriff Eric Aden.

The incident is now being investigated by the Florida Department of Law Enforcement and the State Attorney's Office, Sheriff Aden added.

"At this time, we hum-

bly ask for our community's patience as we work to understand the facts that resulted in this tragic event," he said.

The lawyer for the Fortson family, Ben Crump, has called for transparency from the police on what transpired.

"Roger Fortson was the best America had to offer. He was a patriot. He was a US airman, special ops. He was fighting for our way of life. He was fighting for everybody," Mr Crump said at a news conference on Thursday. "They took a patriot from us."

His mother, Chantimekki Fortson, broke down crying as Mr Crump recounted the moments before the airman was shot.

"My baby was my everything," she said.

Mr Crump said at the time of the shooting Fortson was on a video call with a friend, who described what she heard to his family's legal team.

The friend said the airman heard a knock on his apartment door and asked who was there, but received no response. He then heard a second, "very aggressive knock" but did not see anyone when he looked through the peephole.

It is at this point that Fortson is said to have grown concerned and retrieved his gun, which the lawyer said was legally owned.

As Fortson returned to his living room, the witness said police burst through the door, saw that the resident was armed and shot him six times.

Mr Crump said the witness believed the officers were in the wrong apartment, as Fortson was alone at the time with no disturbance at his residence.

In a statement released on 4 May, the Okaloosa County Sheriff's Office said the deputy "reacted in self defence after he encountered a 23-year-old man armed with a gun and after the deputy had identi-

cial Operations Squadron, according to the US Air Force, and entered active duty in November 2019.

According to Mr Crump, he enlisted in the military after graduating from high school in Atlanta, Georgia with honours.

Mr Crump, a civil rights lawyer based in Florida, has worked on multiple high-profile cases of police-involved deaths of black Americans, including George Floyd, Ahmaud Arbery, Trayvon Martin, Tyre Nichols and Breonna Taylor.
