During an introductory meeting on Tuesday where Senator Joseph was introduced to the staff of the Social Transformation Department, Sir Molwyn expressed frustration at the slow pace of the completion of the facility.

"There are a few projects in Social Transformation that must now meet their maturity; one of them is the Boys Training School. I do not

Senior Minister of Health know the status of the facility as we sit here, but we need to wrap up the work at that facility. What does it require; how soon can it be open; and we have to address all aspects of the Boys Training School," he noted.

> Sir Molwyn recalled that at a recent visit he was dissatisfied that the environment around the facility is in need of attention. "I am big on facilities having aesthetic and pleasant environment and not having dump around where people have to function," he cautioned.

> The senior minister advised the junior minister that the completion of the Boys Training School is the 'first project' that he must under

take.

Sir Molwyn also drew attention to the different food programmes that are being implemented by the department. He questioned about the efficacy of these programmes and he asked that some assessment be done to determine whether or not they are meeting their goals.

He also commended the staff of the department for the work that they have been doing over the past years and urged them to continue to perform at a high standard as their work affects lives in Antigua and Barbuda.

"Your work is critical because it affects lives; it has to do with the elimination of poverty. This is critical as the



Senator Michael Joseph elimination of poverty goes beyond food to include housing etc. Our philosophy as a government is not to leave anyone behind. We cannot have a country where we say we are middle income and leave the lower income persons behind," he exclaimed.

Minister of State, Senator Joseph said he is prepared to utilise his training and his experience to fulfill the mandate laid down by the Cabinet and articulated by the minister. He said his years working with organisations such as the Red Cross give him a clear understanding of the needs of the vulnerable in the society and he is committed to work diligently to ensure improved standards of living for all.

Antigua and Barbuda and Jersey sign new Memorandum of Understanding

Antigua and Barbuda has signed a new agreement with Jersey in the Channel Islands, but this time the focus is on education, sports and the creative arts.

The Memorandum of Understanding was signed by Antigua and Barbuda's Minister of Education, Sports and the Creative Industries, Daryll Matthew, and Deputy Kirsten Morel, Minister for Sustainable Economic Development for Jersey's Department for the Economy.

This MoU builds on the successful 2022 agreement which initiated employment opportunities for Antigua and Barbudan nationals in Jersey in the hospitality sector. It expands the partnership into the creative industries, education, sports, arts, culture and heritage.

Over nine thousand passengers arrive aboard four cruise ships

The 2024-25 winter cruise season is getting busier with the arrival on Tuesday of four ships bringing over nine thousand visitors to the country.

The vessels are – Nautica of the Oceanic Cruises with 690 passengers, Rotterdam of Holland American Line with 2668, Britannia of P&O Cruises with 3648 passengers and MSC Magnifica of MSC Cruises with 2518 passengers.

It was the first time for the new season that four vessels call at the St John's Harbour in one day, a feat that will play out several times during the season.

Local News PAGE 7 Sandals and the Bahamas at odds over tax payments

Just as Antigua and Barbuda's Inland Revenue Department (IRD) has raised concerns over Sandals Resort and Spa's handling of the ABST, seems another Caribbean territory where the luxury resort chain operates, is encountering problems with the collection of taxes from the resort. The following article is a reprint from Tribune Business Editor, Neil Hartnell.

SANDALS is disputing assertions by the Bahamian tax authorities that its Emerald Bay resort only reported 40 percent of revenues earned as it defended its oneof-a-kind "business model".

Melissa John, the Exuma hotel's financial controller, in a September 8, 2023, letter to the Department of Inland Revenue (DIR) denied the property had failed to properly disclose "the true nature of transactions" which have sparked demands for \$30.844m in allegedly unpaid VAT and Business Licence fees combined.

The Department's audit findings, which covered six years between 2017 and 2022, claimed the tax arrears had arisen because Sandals Emerald Bay and its operator, Clearview Management Ltd, had under-reported gross revenue income for the period by more than \$284m.

The dispute, according to documents filed with the



Rather than funds flow up the corporate chain, from subsidiaries to parent company, in Sandals' case the monev trail appears to move in the opposite direction - from Sandals Resorts International 2000 to the resort where the relevant guest has booked their vacation.

The crux of the Department of Inland Revenue's assessment, and eight-figure tax demand, is that Sandals Emerald Bay over that sixyear period only declared the net income received from its parent and not the gross sum collectively paid by tourists to stay at the Exuma property. As a result, the resort both under-reported and underpaid VAT and Business Licence fees for that period.

"The total taxable supplies that were reported by Clearview Management were based on the net amount paid.. by Sandals Resorts International 2000 and not on the amount paid by clients to stay at the Sandals Emerald Bay resort," the Department of Inland Revenue asserted in a July 20, 2023, letter to the hotel's operator.

"Our position is that the taxable supply made by Clearview Management is the amount charged to the client for the room without any deductions for fees and/ or services charged by related parties." The Department of Inland Revenue is thus arguing that "taxable supplies",

upon which the amount of VAT due is calculated, should be based on Emerald Bay's gross - not net - income.

Arguing that Sandals Emerald Bay had breached the VAT Act by making "a false or misleading statement" in filing incorrect returns, the Department of Inland Revenue added: "In filing the returns for Clearview Management, you have reported taxable supplies of \$190.768m compared to the calculated revenue of \$474.919m.

"You have only reported 40 percent of the revenue actually earned during the audit period. You have done this by reporting the net amount of income you receive from your parent company, Sandals Resorts International 2000, instead of reporting the gross amount of income received and then deducting the amounts withheld as expenses.

"In addition, you have made a false or misleading statement by reporting the net amount of income and not disclosing the true nature of the transactions." These assertions, though, were rejected in their entirety by Sandals Emerald Bay's reply on September 8, 2023.

Ms John, in her letter to Shunda Strachan, the Department of Inland Revenue's acting controller, retorted: cont'd on pg 8

"Clearview Management has reported 100 percent of the gross income it has received from Sandals Resorts International 2000. We dispute the calculated revenue and the fact you estimate we have only reported 40 percent of the revenue earned.

"At no time have we made an omission, a false or misleading statement. In the conversations and correspondence with the Department of Inland Revenue, we have been open in how the Sandals business model works, which is different to other hotels which operate in The Bahamas. The income reported in [by] Clearview Management is the income it has earned."

Both the Government and Sandals were tight-lipped on the tax dispute. Michael Halkitis, minister of economic affairs, and Ryan Pinder KC, the attorney general, declined to comment on the matter the latter saying: "I don't comment on active matters before the courts." Simon Wilson, the Ministry of Finance's financial secretary, could not be contacted for comment and did not respond to messages, while Mrs Strachan, the Department of Inland Revenue's acting controller, also could not be reached. Department of Inland Revenue sources hinted that they were aware of the Sandals matter but said no more.

Tribune Business also reached out to Jeremy Mutton, Sandals Emerald Bay's general manager, and was told by the resort's spokesperson that Sandals' corporate office would issue a statement on the tax dispute. However, no statement was received before press time last night. The dispute is now before the Supreme Court after Sandals Emerald Bay's operator filed a Judicial Review challenge in mid-January 2024 as part of a two-pronged counter to the Department of Inland Revenue's demands.

One aspect involves challenging the sum demanded, which is for \$29.101m in VAT, \$1.688m in Business Licence fees, and the "maximum" possible penalty under the VAT Act of \$570,000, before the Tax Appeals Commission.

The other angle, which is the subject of the Judicial Review, is the demand by the Ministry of Finance and Department of Inland Revenue that Sandals lodge a \$30.844m cash bond - equal to the disputed tax sum - so that the appeal to the Tax Commission can proceed.

The VAT Act's section 81 (s) (c) stipulates that any challenge to a Department of Inland Revenue tax assessment must be "accompanied by payment of the total amount of tax assessed or security for such amount, in a form acceptable to the [VAT] comptroller at the time the assessment is lodged".

Sandals Emerald Bay had offered to pay the \$30.844m via a "letter of guarantee" from its bankers, CIBC Caribbean (Bahamas), which would serve as security for the disputed tax debt. This, though, was allegedly rejected by the Ministry of Finance and Department of Inland Revenue which continued to demand a cash bond.

Shell wins landmark climate case against green groups in Dutch appeal

Oil giant Shell has won a landmark case in the Dutch courts, overturning an earlier ruling requiring it to cut its carbon emissions by 45%.

The Hague court of appeal said it could not establish that Shell had a "social standard of care" to reduce its emissions by 45% or any other amount, even though it agreed the company had an obligation to citizens to limit emissions.

Three years ago, a court in The Hague backed a case by Friends of the Earth and 17,000 Dutch citizens requiring Shell to reduce its CO2 emissions significantly, in line with the Paris climate accords.

The ruling came as climate talks involving some 200 countries got under way in Azerbaijan.

Shell said it was pleased with the court's decision, but Friends of the Earth Netherlands said the ruling was a setback that affected them deeply.

The environmental group can now take its case against Shell to the Supreme Court - but a final verdict could be years away.

Donald Pols from the group said "it's a marathon, not a sprint and the race isn't yet over".

At the time, the 2021 ruling marked the first time a court had ordered a pri-

vate company to align its workings with the Paris climate agreement, meaning that it was not sufficient for a company simply to comply with the law - it had to comply with global climate policy too.

Under the terms of the Paris Agreement on climate change, nearly 200 nations agreed to keep global temperatures "well below" 2C above pre-industrial levels.

The appeals court judge said that companies such as Shell were obliged to contribute to combating climate change based on the human right to protection against dangerous climate change.

However, the court said Shell was already working to reduce its emissions and the court could not establish whether it should make a 45% cut or another percentage, as there was no current accepted agreement in climate science on the required amount.

Shell has argued that it is already taking "serious steps to reduce emissions". It complained the original ruling was unfair as it singled out one company for a global issue, and said it was unrealistic to try to hold Shell accountable for its customers' choices.

Shell said if people considered progress was too slow towards cutting emissions then they should lobby governments rather than Shell to change policies and bring about a green transition.

The oil firm says its aim is to reduce the carbon intensity of products it sells by 15-20% by 2030 from a 2016 baseline. Shell also aims to become a "net zero" emissions company by 2050.

Part of the historic legal case hinged on the interpretation of an "unwritten duty of care" that exists under Dutch law, which requires companies to prevent hazardous negligence.

Friends of the Earth Netherlands argued that there was an international consensus that human rights offered protection against dangerous climate change and that companies had to respect human rights.

Shell's successful appeal could have far-reaching implications for corporate climate responsibility.

A number of environmental groups around the world are now trying to force companies and governments to comply with the accords through the courts.

NatWest blocks staff from using WhatsApp and Facebook Messenger

NatWest Group has blocked messaging services WhatsApp, Facebook Messenger and Skype on company devices in the UK to stop staff using them to communicate with each other.

The bank had already told employees to stick to "approved channels" for conversations about business matters.

But now it has gone further and made the platforms inaccessible on work phones and computers.

So-called off-channel communications are a persistent problem in both business and politics, with concerns that services such as WhatsApp are used to reduce the scrutiny some conversations can be subject to.

Messages can be difficult to retrieve or even set to disappear - whereas those sent via approved channels are fully retrievable, meaning they can be looked into if there is any suspected wrongdoing.

"Like many organisations, we only permit the use of approved channels for communicating about business matters, whether internally or externally," NatWest said in a statement.

It said the change came into effect earlier this month.

Banks in the US have been handed fines worth more than \$2.8bn (£2.18bn) over the past few years over record-keeping rules - with workers unable to retrieve old messages from some messaging services.

JPMorgan Chase, Wells Fargo, Bank of America and Citigroup are among those to be issued with penalties.

It was reported in August that the UK banking regulator, the Financial Conduct Authority (FCA), is considering a probe into how bank workers use messaging services.

It follows a fine issued by energy regulator Ofgem to Morgan Stanley over calls made on private phones over WhatsApp - breaching rules on record-keeping.

Outside of banking, there have been issues with staff using apps in the public sector, with questions surrounding how ministers have used WhatsApp for government business in recent years.

The UK Covid inquiry revealed officials and ministers had deleted WhatsApp messages exchanged during the pandemic.

That included then-prime minister Boris Johnson, with then cabinet member Penny Mordaunt telling the inquiry that two years of messages with him had disappeared. Johnson told the inquiry he had lost around 5,000 messages.

FAA prohibits US airlines from flying to Haiti

AP - The Federal Aviation Administration announced Tuesday that it will prohibit US airlines from flying to Haiti for 30 days after gangs shot a Spirit Airlines flight and the United Nations said it will suspend flights, "obviously limiting the flow of humanitarian aid and humanitarian personnel into the country."

The bullets hit the plane when it was about to land Monday in the country's capital Port-au-Prince, injuring a flight attendant. It was part of a wave of violence that erupted in Haiti as the country swore in its new prime minister after a politically tumultuous process.

Life in much of Haiti's capital was frozen after the wave of violence, which came to a head when gangs shot a Spirit Airlines airplane Monday, forcing the airport to shut down. Photos and videos obtained by The Associated Press show bullet holes dotting the interior of a plane. A number of airlines suspended flights to Haiti through Thursday, but it was unclear how long closures could drag on.

Neither the former interim prime minister, Garry Conille, nor the newly inaugurated Alix Didier Fils-Aimé commented on the violence.

But Luis Abinader, who as president of the neighboring Dominican Republic has cracked down on Haitian migration, called firing on

the airplane terrorism.

"This was a terrorist act; the countries that are following and helping Haiti should declare these armed gangs as terrorist groups," Abinader said in a news conference.

On Tuesday, heavily armed police in armored cars outside the airport checked trucks used for public transportation passing by.

Schools were closed, as were banks and government offices. Streets, where just a day before gangs and police were locked in a fierce firefight, were eerily empty, with few driving by other than a motorcycle with a man who had been shot clinging to the back.

The sounds of heavy gunfire still echoed through the streets in the afternoon — a reminder that despite political maneuvering by Haiti's elites and a strong push by the international community to restore peace, the country's toxic slate of gangs kept its firm hold on much of the Caribbean nation.

The United Nations estimates that gangs control 85 per cent of the capital, Portau-Prince. A UN-backed mission led by Kenyan police to quell gang violence struggles with a lack of funding and personnel, prompting calls for a UN peacekeeping mission.

The violence comes after a transitional council, tasked with restoring democratic order to Haiti, which hasn't held elections since 2016, decided to fire Conille, who often was at odds with the council during his six months in office. The council rapidly swore in businessman Fils-Aimé as the new interim prime minister. Conille originally called the move illegal, but on Tuesday acknowledged Fils-Aimé's appointment in a post on the social media platform X.

"(I) wish him success in fulfilling this mission. At this crucial moment, unity and solidarity are essential for our country. Long live Haiti!" he wrote.

Fils-Aimé promised to work with international partners to restore peace and hold long awaited elections, a vow also made by his predecessor.

But many Haitians, like 43-year-old Martha Jean-Pierre, have little taste for *cont'd on pg 13*

Regional News Constraints five States in Corentyne Village

A mother and four of her children perished in a fire at their home in #64 Village, Corentyne Berbice, Guyana.

The victims have been identified as 34-year-old Hemwatie Singh, 14-yearold Kelvin Ramjatan, 10-year-old Brandon Ramjatan, 2-year-old Tomesh Ramjatan, and 11-year-old Cindy Ramjatan.

According to the police report, the fire of unknown origin broke out in the early hours of Tuesday morning at the two-story wooden house owned by 36-year-old Rohan Ramjatan, the husband of Hemwatie Singh. At the time of the incident, Rohan Ramjatan was in police custody, assisting with cattle rustling investigation.

The sole survivor of the tragedy is the couple's 17-year-old son, Kevin Ramjatan, who managed to escape the blaze unharmed. Kevin stated that he was sleeping on the veranda when he was awakened by the flames of the fire, which had started on the lower floor of the house where his father's car was parked.

Kevin immediately ran downstairs, where he found his mother and four siblings awake and attempting to flee the fire. However, upon seeing the large flames in front of the house, they turned

back and went upstairs, where they became trapped and are suspected to have perished.

Investigations revealed that the local electricity provider, GPL, had experienced power line issues in the area, with the wires being on fire the week prior and again on the night of the incident.

The Guyana Fire Service responded to the scene around 3:35 am and extinguished the blaze. Among the debris, the five charred bodies were later found and transported to the Skeldon Public Hospital's Mortuary for post-mortem examinations.

The Minister of Home Affairs, Robeson Benn, the Chief Fire Officer, Gregory Wickham, and the firefighters of the Guyana Fire Service have expressed their profound sadness over the tragic loss of life.

They have extended their heartfelt condolences to the family and friends affected by this devastating event.

The Guyana Fire Service, in collaboration with the Guyana Police Force, is conducting a thorough investigation to determine the cause of the fire and the circumstances surrounding this tragedy.

the political fighting, which experts say only give gangs more freedom to continue expanding their control as Haiti teeters on the brink of famine.

Jean-Pierre was among those to brave the streets of Port-au-Prince on Tuesday to sell the plantains, carrots, cabbage and potatoes she carried in a basket on her head. She had no choice, she said — selling was the only way she could feed her children.

"What good is a new prime minister if there's no security, if I can't move freely and sell my goods," she said, nodding to her basket of vegetables.

"This is my bank account, this is what my family depend on." It was a frustration that appeared to be international players that have pushed for a peaceful resolution in Haiti like the UN and the US.

On Tuesday, the US State Department lamented that Conille and the council "were unable to move forward in a constructive manner" and called on Fils-Aimé and the council to provide a clear action plan outlining a joint vision on how to decrease violence and pave the path for elections to be held to "prevent further gridlock."

"The acute and immediate needs of the Haitian people mandate that the transitional government prioritise governance over the competing personal interests of political actors," it wrote in a statement.

Internationa **Dozens killed in car rampage** through Chinese stadium

At least 35 people have been killed in a car attack in southern China, believed to be the deadliest known act of public violence in the country in decades.

Police say а man crashed his car into a stadium in Zhuhai on Monday where he ran down groups of people exercising on the sports track.

The "serious and vicious attack" also injured 45 people - among them elderly and children, local media report.

Police say the 62-yearold driver, identified as a Mr Fan, appeared to have acted out of unhappiness over a divorce settlement.

He was arrested as he tried to flee the Zhuhai Sports Center and is in a coma due to self-inflicted wounds, police said in a statement.

The incident has sparked a national outcry in China, where President Xi Jinping vowed "severe punishment" for the perpetrator, and called for "allout efforts" to treat the injured.

Details of those who were killed have not been disclosed by authorities yet, but mourners and members of the public had begun laying flowers and other tributes outside the stadium on Tuesday.

The venue - featuring a running track loop - had

been a popular exercise ground for locals. Witnesses told Chinese media it appeared Mr Fan had deliberately run people down.

One man named Mr Chen told Caixin news magazine he and his walking group had just completed a lap of the stadium when a car charged towards them at high speed, "knocking down many people".

Another person at the scene told Caixin: "It drove in a loop and people were hurt in all areas of the running track."

According to local police, who released a statement on Tuesday, they said their initial investigations suggested Mr Fan's actions were triggered by a property dispute following his divorce. He is still in a coma and so has not been questioned, police said.

The attack may be the deadliest act of random public violence in China in recent decades. A number have been reported this year including a mass stabbing and firearms attack in Shandong in February which killed at least 21 people. That incident was heavily censored by Chinese authorities.

Reports of Monday's attack were already being restricted online on Tuesday - with several videos taken by witnesses at the scene removed from Chinese social media platforms.

But some footage still circulating online showed dozens of people lying on the ground and being attended to by paramedics and bystanders.

In China it is common for censors to quickly take down social media videos which are linked to high-profile incidences of crime.

BBC journalists reporting from the stadium at Zhuhai on Tuesday were also harassed and told to stop filming.

China has seen a spate of violent attacks on members of the public in recent months that have been reported in local media to varying degrees.

In October, a knife attack at a top school in Beijing injured five people, while in September, a man went on a stabbing spree at a supermarket in Shanghai, killing three people and injuring several others.

Also in September, a 10-year-old Japanese student died a day after he was stabbed near his school in southern China.

Following Monday's car attack, Japan's embassy warned its nationals living in the country to avoid speaking Japanese loudly in public.

The incident in Zhuhai has also taken place during heightened security in the city, which is hosting a major military airshow this week. The attack on Monday night took place 40km (24 miles) from where the high-profile Airshow China kicked off on Tuesday.

China is showcasing its newest warplanes and attack drones at the show, which top Russian defence official and former defence minister Sergei Shoigu is expected to attend.

Several entrances and exits to the sports centre were closed during the airshow to facilitate "control", the centre's management said on Tuesday.



Israeli strikes in Mount Lebanon villages kill 23, ministry says

At least 23 people have been killed in Israeli air strikes on two houses in central Lebanon where displaced families were reportedly living, the Lebanese health ministry says.

Fifteen people, mostly women and children, were killed in Joun and eight others were killed near Baalchmay. Both villages are in the Mount Lebanon region and outside areas where the armed group Hezbollah has a strong presence.

The Israeli military said it was looking into the strikes, which came after it hit what it said were a number of Hezbollah targets in Beirut's southern suburbs.

Meanwhile, two people were killed by Hezbollah rocket fire in the northern Israeli town of Nahariya.

It came a day after Israel's defence minister ruled out a ceasefire with Hezbollah until its war goals were met.

The Israeli military went on the offensive against Hezbollah - which it proscribes as a terrorist organisation - after almost a year of cross-border fighting sparked by the war in Gaza.

Israel says it wants to ensure the safe return of tens of thousands of northern Israeli border area residents displaced by rocket attacks, which Hezbollah launched in support of Palestinians the day after its ally Hamas's deadly attack on Israel on 7 October 2023.

More than 3,200 people have been killed in Lebanon since then, including 2,600 in the seven weeks since Israel launched an intense air campaign followed by a ground invasion in the south, according to the Lebanese health ministry. Another 1.2 million people have been displaced.

On Tuesday morning, the Israeli military carried out at least 10 strikes on Beirut's southern suburbs, known as

Dahieh, after issuing evacuation orders for 11 locations.

Lebanese media reported that several buildings were levelled, including a medical centre in the Bir al-Abed area, but there were no reports of casualties.

The Israeli military said it struck Hezbollah targets, including command centres and weapons production sites.

In the evening, the Israeli military declared that it had "dismantled a majority of Hezbollah's weapons storage and missile manufacturing facilities" that had been "systematically concealed beneath civilian buildings" in Dahieh.

Most residents of Dahieh - one of the areas where Hezbollah has a significant presence, along with southern Lebanon and the eastern Bekaa Valley - have fled because their neighbourhoods have been targeted repeatedly since September.

On Tuesday night, the Lebanese health ministry said 15 people were killed, including eight women and four children, in an Israeli strike on a house in Joun, in the Chouf mountains near the southern coastal city of Sidon.

The state-run National News Agency reported that displaced families had been staying there. Residents and a security official said another house where displaced families had taken refuge was hit in Baalchmay, 30km (20 miles) to the north-east, killing eight people and injuring five.

Wael Murtada told the Associated Press that the home had belonged to his uncle and that those inside had fled from Dahieh about 40 days ago. He said at least three children were among the dead.

The targets of the two strikes were unclear.

Elsewhere in Lebanon, five people were killed in a strike in the southern village of Teffahta, according to the health ministry.

In the northern town of Ain Yaaqou, Lebanon's Civil Defence agency said its first responders had recovered the bodies of 16 people, including four Syrian refugees, from the rubble of a residential building that was destroyed by an air strike on Monday night.

The Israeli military said its forces had targeted a "military structure with a terrorist inside".

It also said Israeli soldiers were continuing ground operations in southern *cont'd on pg 16*

Barbados Pride prevail against Windwards Volcanoes in Super50 Cup

The Barbados Pride rebounded from their defeat at the hands of the Combined Campuses and Colleges (CCC) in their previous preliminary round match in the Super50 Cup with an eightrun win via the DLS method over the Windward Islands Volcanoes at the Queen's Park Oval in Port-of-Spain on Monday.

Lebanon to dismantle Hezbollah infrastructure, including rocket launchers.

About 55 projectiles were fired by Hezbollah from Lebanon into Israel on Tuesday, according to the Israeli military.

One rocket hit a warehouse in Nahariya, killing two Israeli men in their 50s.

"There was a lot of destruction and an active fire," paramedic Dor Vakinin told AFP news agency.

"We performed medical examinations on two men who were lying unconscious...Unfortunately, their injuries were too severe and after the examinations we had to determine the death of both of them."

Hezbollah said its fighters had fired a barrage of rockets at an Israeli military base north of the town of Acre, and that it had also targeted troops stationed in several Israeli border communities.

A Hezbollah drone also hit the playground of a kindergarten in a suburb of the Israeli city of Haifa, but no-one was hurt.

On Monday, new Defence Minister Israel Katz wrote on X that he had told a forum of Israel generals that "there will be no ceasefire" until Hezbollah could no longer carry out such attacks.

"We will continue to hit Hezbollah with full force until the goals of the war are achieved. Israel will not agree to any arrangement that does not guarantee Israel's right to enforce and prevent terrorism on its own," he added.

Katz said the goals were "disarming Hezbollah and its withdrawal beyond the Litani river", which runs about 30km north of the border with Israel, as well as "returning the residents of the north safely to their homes".

Earlier, Foreign Minister Gideon Saar had said there was "a certain prog-

ress" after being asked by journalists in Jerusalem about a possible ceasefire.

Hezbollah spokesman Mohammed Afif told a news conference in Beirut: "We hear a lot of talk, but so far, according to my information, nothing official has reached Lebanon or us in this regard."

Lebanon's government has called for a ceasefire based on the full implementation of UN Security Council resolution 1701, which ended the last war between Israel and Hezbollah in 2006.

The resolution called for Lebanese territory south of the Litani to be free of any armed personnel or weapons other than those of the Lebanese state and a UN peacekeeping force.

Israel has long complained that the resolution failed to prevent Hezbollah from building a formidable military presence in south and firing rockets over the border.

As the series moves to St. Lucia, experienced all-rounder Andre Russell has been ruled out due to a left ankle sprain sustained during the opening T20I at the Kensington Oval in Barbados on Saturday.

In his place, all-rounder Shamar Springer, fresh off two T20I games against Sri Lanka, will join the squad.

Fans are encouraged to come out in their numbers and rally around the home team for the last three crucial games at the Daren Sammy Cricket Ground in St. Lucia.

The West Indies will go into Thursday's third T20 International trailing England, who took a 2-0 lead by winning the first two matches at the Kensington Oval in Barbados.
