

ECCAA says its process to convert foreign pilot's licence is quite easy

The Antigua and Barbuda-based Eastern Caribbean Civil Aviation Authority (ECCAA) is highlighting the duties and services it provides by focusing on the issue of the conversion of foreign-issued pilots' licence.

In an article, ECCAA explains that it is the governing body of the Eastern Caribbean skies with aviation safety is its main business. It further explains that it facilitates the conversion of foreign licensing in accordance with the requirements of the International Civil Aviation Organisation (ICAO). This is among the services that it offers.

The article tells the story of Mr. Carrington, a pilot who successfully completed the process and is now the proud holder of an Antigua and Barbuda Commercial Pilot's Licence.

Mr. Carrington, who

underwent flight training ognized and used in the in the United States, obtained his licence to fly there. However, he wanted the option of flying in the Eastern Caribbean. For this, he needed the right documents.

"I have an FAA (Federal Aviation Administration) licence – an American licence issued by the US," Mr. Carrington explains. "However, in the Caribbean, the OECS (Organisation of Eastern Caribbean States) has its own civil aviation body...ECCAA.

"So, after job hunting, [I realized] there aren't many jobs you can get with an American pilot's licence in the region. And if you are not a US citizen, it's almost impossible to penetrate the U.S. job market coming from flight school."

Mr. Carrington said friends and family encouraged him to convert his F.A.A. licence to one rec-



Some of the documents include current and valid foreign licence and Medical Certificate, pilot logbook, ECCAA's application forms and fees and proof of nationality. 
Pineapple Beach by Sandals Resorts International. Her focus was delivering exceptional guest experiences and fostering a welcoming environment.

The magistrate's court on Wednesday imposed fines for drug offences

Two people who appeared separately in the magistrate's court on Wednesday received fines after they were convicted on drug related offences.

Senior Magistrate Ngaio Emanuel found Rondre Robinson of Swetes guilty for the possession of 145.5 grams of cannabis contrary to the Misuse of Drugs Act. Robinson was arrested at Sea View Farm on January 8, 2025, when he was found with the drug in his possession.

the court ordered that he pays within 18-months or serve a two-year jail

Magistrate Emanuel took into consideration the aggravating factors prior to handing down her ruing; the fact that Robinson had two prior convictions on similar charges influenced the decision.

Another man, Okive Banton, a Jamaican, who resides at Golden Grove Extension, was found in possession of

He was fined \$30,000.00 which 1.25 pounds of cannabis at Paynters. He was reprimanded and discharged on the charge of possession of cannabis, but on the charge of possession with intent to sell, he was convicted and ordered to pay a fine of \$40,000.00 within two years or serve a two-year prison sentence.

> Banton was found with EC \$2,160.00 and US20.00. The magistrate ordered that the money be forfeited to the state and that the drug be confiscated and destroyed.

Google faces UK investigation over search dominance

The UK's competition watchdog has launched an investigation into whether Google has too much power in online search.

Google accounts for 90% of UK web searches - the Competition and Markets Authority (CMA) is looking at whether it is using that dominant position to harm competition or choice for users.

It is its first investigation after gaining new powers to investigate and enforce changes at firms it determines to have "strategic market status" in digital markets.

The CMA says it wants to ensure the tech giant is "delivering good outcomes for people and businesses" and that there is a "level playing field" for rivals.

Google says it will cooperate with the investigation but has warned against what it calls «overly prescriptive digital competition rules.»

In a statement Google said: "We will continue to engage constructively with the CMA to ensure that new rules benefit all types of websites, and still allow people in the UK to benefit from helpful and cutting edge services."

It is the latest in a series of investigations Google faces worldwide.

In the US, the government wants it to sell its



browser, Chrome, to address what a judged ruled was its illegal monopoly in search and related advertising.

The CMA says potential changes it could impose include sharing data Google collects with other businesses, or giving publishers more oversight of how their data is used for its artificial intelligence (AI) features.

"Millions of people and businesses across the UK rely on Google's search and advertising services," said Sarah Cardell, the CMA's chief executive on Tuesday.

"And for businesses, whether you are a rival search engine, an advertiser or a news organisation, we want to ensure there is a level playing field for all businesses, large and small, to succeed." she added, especially given the potential for AI to "transform" the

market.

The CMA's announcement of its Google search and advertising investigation follows the digital market competition regime coming into force in January.

It gives the CMA powers to investigate firms it believes may dominate or occupy a key strategic position in a certain sector.

An explainer on its website says a company must meet several conditions before it can be determined to have «strategic market status».

These include having a UK turnover of more than £1bn or global turnover of £25bn, occupying a position of strategic significance or "entrenched market power" in relation to a certain digital activity.

The CMA says it will look at whether Google is

using its position in search to prevent rivals from innovating or entering the market, or if it is «selfpreferencing» its own services.

It will also look at whether Google is collecting large amounts of user data without proper, informed consent.

"It's our job to ensure people get the full benefit of choice and innovation in search services and get a fair deal - for example in how their data is collected and stored," said Ms Cardell.

It will have nine months to carry out its investigation and two options at its disposal if it finds Google to have strategic market status - imposing rules on how it behaves, or making interventions designed to boost competition.

Drake sues for defamation over Kendrick Lamar song

Rap superstar Drake is suing Universal Music Group (UMG) for defamation and harassment, over its release of the Kendrick Lamar diss track Not Like Us last year.

The song, which formed part of a furious back and forth between the two stars, accused Drake and his entourage of being "certified paedophiles" who should "be registered and placed on neighbourhood watch".

In papers filed in New York, Drake's lawyers accused the record label of launching "a campaign to create a viral hit" out of a song that made the "false factual allegation that Drake is a criminal paedophile, and to suggest that the public should resort to vigilante justice in response".

Universal has yet to respond to the allegations.

The move comes just 24 hours after Drake withdrew a separate legal action against UMG and Spotify, in which he accused the two companies of conspiring to artificially boost streams of Not Like Us, at the expense of his own music.

In that case, he argued that Universal had licensed the song "at drastically reduced rates to Spotify" and used bots to generate extra plays, generating "the false impression that the song was more popular than it was in reality".

In a statement at the time, Universal told the BBC: "The suggestion that [the company] would do anything to undermine any of its artists is offensive and untrue."

It added that "no amount of contrived and absurd legal arguments... can mask the fact that fans choose the music they want to hear."

Spotify also responded that there was "no economic incentive for users to stream Not Like Us over any of Drake's tracks".

The Swedish streaming company later filed an opposition brief to Drake's petition, stating that it "should be denied".

His lawyers withdrew the case on Tuesday, after meeting with representatives from both companies, according to court papers.

That appeared to draw a line under the legal action - until the story took a dramatic twist on Wednesday morning.

In a lawsuit filed at the US District Court for the Southern District of New York, Drake accused Universal - which distributes both his music and Lamar's - of prioritising "corporate greed over the safety and well-being of its artists".

Pinar Akman, professor of law at the University of Leeds, says it is "highly likely" the CMA will launch further, similar investigations under the Digital Markets, Competition and Consumer (DMCC) Act in coming months.

"There is a general trend of regulating digital markets with large players around the world and the DMCC Act represents the UK's response to that growing trend," she told BBC News.

Prof Akman added that the regime of-

fers more flexibility than regulation such as the EU's Digital Markets Act in tailoring any interventions or requirements to market specifics. It comes after the Prime Minister Sir Keir Starmer lauded AI's "vast potential" to transform public services.

In a speech on Monday, Sir Keir said recommendations from the AI Opportunities Action Plan - a set of proposals backed by several tech firms - would be implemented across a range of areas to help grow the economy and make AI "work for working people".

Protests and tensions surround bail hearing for murder-accused Lehrer

Residents of Soufriere and nearby areas gathered outside the Roseau High Court on Monday to protest the bail granted to US citizen Jonathan Lehrer, who faces charges in the murder of Canadian Daniel Langlois and his partner, Dominique Marchand.

Lehrer was granted bail last November under 13 conditions, including the revocation of his US citizenship.

However, his legal team is seeking to amend those conditions to allow him to travel to the US, further fueling public outrage.

Chanting "No bail for Jonathan," protesters expressed anger over the decision, especially after Lehrer was reportedly seen near the court.

Police set up barriers to control the situation as



demonstrators voiced concerns over perceived bias towards a foreign national and Lehrer's continued role in Dominica's Citizenship by Investment programme despite the serious charges.

The protests reflect deep frustration within the Soufriere/Scottshead community, with the case continuing to stir debate over justice and fairness in the legal process.

Meantime, local media report that amid growing pressure, the State's prosecuting team advised High Court Judge Colin Williams, who had approved Lehrer's bail, to recuse himself from the case, citing information that could compromise his impartial-

ity.

The Director of Public Prosecutions (DPP) filed an affidavit, after much debate, supporting the recusal, and the Chief Justice was notified.

As the situation unfolded, Justice Williams decided to step down, and a new judge will be assigned to handle the case.

the artwork for Not Like Us was based on an aerial photograph of Drake's \$100m Toronto mansion, dotted with red markers that are often used to represent the presence of registered sex offenders.

The court documents link that artwork to a shooting at the property shortly after the release of Kendrick's song, calling it "the 2024 equivalent of 'Pizzagate'".

The comment referenced a conspiracy theory about a US child sex ring operating out of a Washington pizza restaurant, which led to a gunman opening fire on the eaterie in 2016.

Not Like Us was widely regarded as the decisive blow in a long-running feud between Drake and Lamar, which dates back to the early 2010s.

In the lyrics, Lamar alleges that Drake "likes 'em young" and accuses him of using other, more credible rappers, to boost his profile.

Drake responded with a track called The Heart Part 6, where he rejected the allegations, saying, "I never been with no one under age". He also claimed to have fed Lamar "false" information through a double agent.

However, his retort failed to attract the same attention as Not Like Us, which debuted at number one in the US chart and attracted more than 1

billion streams on Spotify.

The song is nominated for five prizes, including record and song of the year, at the Grammy Awards on 3 February. A week later, Lamar will headline the Super Bowl halftime show.

However, the new lawsuit is not aimed at Lamar himself, according to Drake's lawyers.

"This lawsuit is not about the artist who created Not Like Us," the court documents says.

"It is, instead, entirely about UMG, the music company that decided to publish, promote, exploit, and monetize allegations that it understood were not only false, but dangerous."

Number of internally displaced people in Haiti tripled in 2024

The number of people internally displaced by gang violence in Haiti has tripled to more than one million, the United Nations' International Organization for Migration (IOM) warned on Tuesday.

The situation is particularly dire in the capital, Port-au-Prince, where displacement has risen by 87% between 2023 and 2024, IOM figures show.

Gangs control almost the entire city, leading to the collapse of the remaining health services and triggering food insecurity.

More than 5,600 people were killed in gang violence in Haiti last year alone.

IOM Spokesman Kennedy Okoth Omondi said many of the more than one million displaced people had had to flee multiple times as the gangs expanded their territory in Port-au-Prince.

An estimated 85% of the capital is now estimated to be under gang control.

Most of those displaced fled Portau-Prince for rural areas, where resources are limited, the IOM warned.

Its Director-General, Amy Pope, said that Haiti needed "sustained humanitarian assistance right now to save and protect lives".

Half of those displaced are children, according to the IOM's figures.

The agency described how families were "struggling to survive in makeshift shelters while facing mounting health and protection risks".

Haiti has been engulfed in a wave of gang violence since the assassination in 2021 of the then-president, Jovenel Moïse.

A UN-backed multinational security force arrived in Haiti in June to try and re-establish control but has so far made few inroads into gang-held territory.

The international police force, which is meant to bolster the Haitian National Police force, is underfunded and lacks the necessary equipment to take on the heavily armed gangs.

Meanwhile, the Transitional Presidential Council (TPC) - the body created to organise elections and re-establish democratic order in Haiti - appears to be in turmoil.

The TPC replaced the interim prime minister in November and seems to have made little progress towards organising log-delayed elections.

Kenyan minister alleges intelligence agency behind his son's abduction

A Kenyan government minister has alleged that the country's national intelligence agency was behind the abduction of his son last year, as criticism against the rising cases of abductions continues.

Public Service Cabinet Secretary Justin Muturi said that it took a call by President William Ruto to have his son released by the National Intelligence Service (NIS).

Muturi is the first member of the cabinet to publicly criticise the government's handling of the spate of abductions in Kenya.

In a statement to the police crime investigations unit on Tuesday, Muturi gave a detailed account of how his son, Leslie, was abducted on 22 June last year.

Mr Ruto and the intelligence agency have not commented on his allegations.

At least 80 people, including the minister's son, have been abducted in the last six months, according to a state-funded rights group.

The wave of abductions started after protests against tax hikes last June, and have continued since then.

Some of those abducted have been released following public pressure.

Earlier this week, the minister told journalists that he had not received answers about the abduction of his son, despite reaching out to top security officials.

Muturi said the Directorate of Criminal Investigations (DCI) subsequently urged him to record a statement with them, telling him the matter was still under investigation.

In his statement to the DCI, Muturi recalled calling the inspector-general of police, the interior minister, the DCI head, the head of the intelli-

gence agency and other top officials as he desperately looked for his son – but, he added, all were unable to help.

He said that he also messaged Ruto, but later decided to visit his official residence to raise the matter directly with him.

"I then narrated the ordeal [to the president] including my interactions with various senior government officials who had been unable to help. I expressed my belief that NIS was holding my son," Muturi said in the statement.

He said that the president made a joke about the issue and then made a call to the head of the intelligence agency, who promised to release his son in an hour.

"I heard the president ask [NIS director] Noordin Haji if he was holding my son.

"[He] confirmed that indeed he was holding my son and the president instructed him to release Leslie immediately," Muturi added.

Muturi has faced calls from some government-allied politicians to resign for publicly criticising the government in which he serves.

Foreign nationals have also been

abducted, including prominent Tanzanian activist Maria Sarungi Tsehai, who on Monday narrated how she was kidnapped by armed men and released several hours later.

Last year, Ugandan opposition leader Kizza Besigye was kidnapped in Kenya's capital, Nairobi, allegedly by Ugandan security officials, and taken across the border for trial by a court martial.

Muturi's public mentioning of Ruto's name in connection with abductions is a defiant challenge to the president, and is seen as being against the principle of collective responsibility in government.

It has also fuelled speculation of a fallout in government, with other ministers and officials often denying that the abductions are being carried out by the state.

Amid public uproar, the president said towards the end of last year that "we are going to stop the abductions", while advising parents to instil good values in their children.

He has also warned young people not to use social media to disrespect leaders, amid continued widespread online criticism of the government.

Gaza ceasefire deal agreed by Israel and Hamas, Qatar and US say

Israel and Hamas have agreed a Gaza ceasefire and hostage release deal following 15 months of war, mediators Qatar and the US say.

Qatari Prime Minister Sheikh Mohammed bin Abdul Rahman Al Thani said the agreement would come into effect on Sunday so long as it was approved by the Israeli cabinet.

US President Joe Biden said it would "halt the fighting in Gaza, surge much needed-humanitarian assistance to Palestinian civilians, and reunite the hostages with their families".

Israeli Prime Minister Benjamin Netanyahu said the deal's final details were still being worked on, but he thanked Biden for "promoting" it. Hamas leader Khalil al-Hayya said it was the result of Palestinian "resilience".

Many Palestinians and Israeli hostages' families celebrated the news, but there was no let up in the war on the ground in Gaza.

The Hamas-run Civil Defence agency reported Israeli air strikes killed more than 20 people following the Qatari announcement. They included 12 people who were living in a residential block in the Sheikh Radwan neighbourhood of Gaza City, it said. There was no immediate comment from the Israeli military.

Israel launched a campaign to destroy Hamas - which is proscribed as a terrorist organisation by Israel, the US and others - in response to an unprecedented cross-border attack on 7 October 2023, in which about 1,200 people were killed and 251 others were taken

hostage.

More than 46,700 people have been killed in Gaza since then, according to the territory's Hamas-run health ministry. Most of the 2.3 million population has also been displaced, there is widespread destruction, and there are severe shortages of food, fuel, medicine and shelter due to a struggle to get aid to those in need.

Israel says 94 of the hostages are still being held by Hamas, of whom 34 are presumed dead. In addition, there are four Israelis who were abducted before the war, two of whom are dead.

Qatar's prime minister called for "calm" on both sides before the start of the first six-week phase of the cease-fire deal, which he said would see 33 hostages - including women, children and elderly people - exchanged for Palestinian prisoners in Israeli jails.

Israeli forces will also withdraw to the east away from densely populated areas of Gaza, displaced Palestinians will be allowed to begin returning to their homes and hundreds of aid lorries will be allowed into the territory each day.

Negotiations for the second phase - which should see the remaining hostages released, a full Israeli troop withdrawal and a return to "sustainable calm" - will start on the 16th day.

The third and final stage will involve the reconstruction of Gaza - something which could take years - and the return of any remaining hostages' bodies.

Sheikh Mohammed said there was "a clear mechanism to negotiate phase two and three", with the agreements

set to be published "in the next couple of days, once the details are finalised".

He also said Qatar, the US and Egypt, which also helped broker the deal, would work together to ensure Israel and Hamas fulfilled their obligations.

"We hope that this will be the last page of the war, and we hope that all parties will commit to implementing all the terms of this agreement," he added.

President Biden said the plan, which he first outlined eight months ago, was "the result not only of the extreme pressure Hamas has been under and the changed regional equation after a ceasefire in Lebanon and the weakening of Iran - but also of dogged and painstaking American diplomacy".

"Even as we welcome this news, we remember all the families whose loved ones were killed in Hamas's 7 October attack, and the many innocent people killed in the war that followed," a statement added. "It is long past time for the fighting to end and the work of building peace and security to begin."

At a later news conference, Biden also acknowledged the assistance of President-elect Donald Trump, who put pressure on both parties by demanding hostages be released before his inauguration on Monday.

"In these past few days, we've been speaking as one team," he said, noting that most of the implementation of the deal would happen after he left office.

the agreement had been reached, beating the White House and Qatar to a formal announcement.

In a later post on social media, he attempted to take the credit for the "epic" agreement, saying it "could have only happened as a result of our historic victory in November".

Israeli Prime Minister Benjamin Netanyahu's office thanked Trump "for his help in promoting the release of the hostages, and for helping Israel end the suffering of dozens of hostages and their families".

"The prime minister made it clear that he is committed to returning all the hostages by any means necessary," it said, before adding that he had also thanked Biden.

Later, the office said an official statement from Netanyahu would "be issued only after the completion of the final details of the agreement, which are being worked on at present".

Israel's President, Isaac Herzog, said the deal would bring with it "deeply painful" moments and "present significant challenges", but that it was "the right move".

The agreement is expected to be approved by the Israeli cabinet, possibly as soon as Thursday morning, despite opposition from Netanyahu's far-right coalition partners.

Then the names of all the Palestinian prisoners due for release will be made public by the Israeli government, and the families of any victims will be given 48 hours to appeal. Some of the prisoners are serving life sentences after being convicted of murder and terrorism.

Hamas's chief negotiator and acting Gaza chief, Khalil al-Hayya, said the agreement represented "a milestone in the conflict with the enemy, on the path to achieving our people's goals of liberation and return".

The group, he added, would now seek to "rebuild Gaza again, alleviate the pain, heal the wounds".

But he also warned "we will not forget, and we will not forgive" the suffering inflicted on Palestinians in Gaza.

As news of the agreement emerged, pictures showed people cheering and waving Palestinian flags in the central Gaza town of Deir al-Balah and southern city of Khan Younis.

Sanabel, a 17-year-old girl living to the north in Gaza City, told BBC OS: "All of us are delighted."

"We have been waiting for this for a long time," she said. "Finally, I will put my head on my pillow without worrying... It is time to heal."

Nawara al-Najjar, whose husband was among more than 70 people killed when Israeli forces launched an operation to rescue two hostages, said: "After the ceasefire I want to give my children the best life."

"I want them to get over the fear we lived. My children are really scared. The terror has settled in their hearts."


The other goal for Jennings United was scored by Daviae Aaron in the 62nd minute. Akeel Barry scored the only goal for Lion Hill in the 25th minute.

British-Israeli woman whose 84-year-old father Oded is among the remaining hostages.

Her mother, Yocheved, was also abducted in the 7 October attack but was released after several weeks in captivity.

She told the BBC in London as news of the deal came through that it felt "like a bit of sanity", but she admitted: "I know that the chances for my dad are very slim."

"He's an elderly man, but miracles do happen. My mum did come back, and one way or another, we will know. We will know if he's still with us, if we can look after him."

She warned: "There are more graves to come and traumatised people to come back, but we will look after them and make them see light again... May this be the start of something better."

Moshe Lavi, the brother in-law of Omri Miran, a 47-year-old father-of-two young children, told the BBC that it was "a very mixed day for most families of hostages".

"We want to see our families come home from their mass captivity. But we also understand that this is a phase deal. Only the first phase was agreed upon," he

"We'll have to keep fighting, keep advocating as families with all leaders with our own government to understand they have to release all the hostages."

UN Secretary-General Antonio Guterres said the "priority now must be to ease the tremendous suffering caused by this conflict".

Warrican ready to play part in spin-friendly Pakistan

Jomel Warrican says he is eager to play a pivotal role in the upcoming two-match series against Pakistan, with hopes of assisting the Caribbean side to a positive finish in their International Cricket Council (ICC) World Test Championship campaign.

Having secured figures of two for 23 in the second innings of the three-day tour match against Pakistan Shaheens, Warrican, who is experiencing Pakistan for the first time, is optimistic about his impact in Multan conditions that are expected to favour spin throughout the series scheduled to begin on Friday.

"Preparation has been very well. We had a couple of days to train and played a practice game as well. I think the guys and myself took the opportunity to get familiar with the conditions and to prepare well for the Test series," he told Cricket West Indies (CWI) media on Tuesday.

"Some of the things that we observed are that it is clearly going to be spin-friendly conditions,

West Indies spinner and the outfield is going to be very quick as well. So we have to be tuned in and ready to counteract the spin," he added.

> The series, a first for the West Indies in Pakistan in 18 years, marks the conclusion of the current ICC Test Championship cycle as well as the end of head coach Andre Coley's tenure.

> Warrican emphasized the importance of finishing strong.

> "Anyone would look to have a brilliant climax. For us, we need those points to

From an individual perspective, the 32-year-old Barbadian has clear plans for how he intends to approach the series. While conditions may tempt spinners to go all-out aggressive, he believes balance and discipline will be crucial.

"I don't want to get carried away with the conditions. I just have to stick to the basics, be disciplined, put the balls in the right areas, and sometimes you just have to wait for something to happen," Warrican stated.

"With spinning conditions, we as spinners have to be 100 percent aggressive, but there also has to be a balance of sticking to the basics and being very disciplined," he ended.

Windies lose to New Zealand in ICC U/19 Women's T20 World Cup warm-up match

The West Indies Under-19 women endured a crushing 79-run defeat to their New Zealand counterparts in their second warm-up match at the International Cricket Council (ICC) Under-19 Women's T20 World Cup at the UKM-YSD Cricket Oval in Malaysia on Wednesday.

With their ICC Under-19 Women's T20 World Cup opener against reigning champions India just days away, the Caribbean side faced a reality check against a disciplined New Zealand unit.

Chasing a challenging target of 152, the West Indies struggled to 72 all out in 18.5 overs. Despite the efforts of Brianna Harricharan (16), Kenika Cassar (13 not out), and Asabi Callen-

der (10), the West Indies team failed to build any substantial partnerships.

New Zealand's bowlers kept the West Indies batters under pressure, with Anika Todd leading the attack, as she claimed two wickets for three runs from her solitary over. Six other bowlers chipped in with a wicket apiece.

Earlier, New Zealand captain Tash Wakelin elected to bat, and her openers Emma McLeod and Kate Irwin seized control with a commanding 89-run opening stand.

McLeod retired out after scoring an even 50 off 42 balls, which included four boundaries, while Irwin followed suit with a solid 46 from 41 deliveries, striking five fours.

to make a breakthrough as Eve Wolland (22 not out) and Anika Todd (20 not out) carried New Zealand to 151 for two. Both players added finishing touches with composed knocks, striking two boundaries each.

After the West Indies claimed a narrow nine-run win over Nepal in their first warm-up match, New Zealand's potential highlighted the Caribbean side's frailties, particularly in building partnerships and maintaining consistency with the ball.

As such, the West Indies camp, led by head coach Robert Samuels and assistant Shane Brooks, will need to regroup quickly, especially with their tournament opener against a formidable Indian side looming on Sunday.

CWI launches highperformance programmes

Cricket West Indies (CWI) started 2025 with three groundbreaking high-performance programmes aimed at elevating the standard of West Indies cricket across all levels.

The initiatives brought together international expertise and regional talent in an unprecedented effort to strengthen both playing and coaching capabilities.

The first two initiatives focus on advanced batting techniques against spin bowling and enhancing spin bowling capabilities with a focus on wrist spin. The specialized High-Performance Batting Spin and Spin Bowling Camp began on January 11 and runs until January 17. It features 30 of the region's most promising players.

Under the guidance of Chennai Super Kings Academy Head Coach Sriram Krishnamurthi and spin bowling coach Amar Rashid, the six-day intensive programmes aim to refine participants' skills.

For players like Matthew Nandu (Guyana), Kirk McKenzie (Jamaica), and Kevin Wickham (Barbados), this camp builds on their experience at the Chennai Super Kings Academy in India last December, where they trained alongside four other West Indies players

The third initiative is a Coaching Symposium, held at the Coolidge Cricket Ground in Antigua from January 13 to 15. The symposium aimed to

enhance the skillsets of regional franchise coaches while broadening their knowledge to support franchise and international players' development.

The symposium's key objectives included bringing clarity to coaches on the requirements for developing and managing players at the franchise level to meet the West Indies brand. It also aimed at empowering and enabling a collaborative learning community among coaches to achieve world-class outcomes.

The symposium featured newly appointed West Indies Head Coach Daren Sammy as one of six presenters over the three days. Coaches from the Chennai Super Kings Academy joined CWI Coaching Development Consultant James Davidson in delivering sessions.
