New 'paperless' border control to be operational by next month


The long-awaited transition to paperless entry as part of the country's border control system, will likely go into full operation sometime during the month of February.

Telecommunications
Minister, Melford Nicholas is reporting that new system is currently in the pilot phase and full implementation will come in February, although he shies away from naming a precise date in the month.

Minister Nicholas recalled that back in 2020 with the advent of the COVID-19 pandemic, the idea of having a system that would not involve too much physical contact, such as the handling of paper, became a real concern and it was then that the impetus came to make the move from the physical ED card, for both outbound and inbound passengers, took on a degree of urgency.

The first attempt to introduce a paperless system came from a platform developed by IMPASS, which forms part of the regional security apparatus. There were problems however, in having this system integrated with

the existing border control system developed by Canadian Bank Notes,

CBN.

The government encountered a number of challenges in securing a system; one of which included having outstanding monies for CBN, which had built-up during to the pandemic when government's revenues were down.

Fortuitously, the Minister revealed that there was a developer who resided locally and who approached him with a proposal to develop a system specifically to meet Antigua and Barbuda's

in the United States that is involved in developing these systems.

"He had done some work with the CIP in crafting a platform for them and it was he who went out to engage officials at the Immigration Department, Customs Division and the Antigua and Barbuda and Barbuda Tourism Authority and prior to SIDS4, he came forward to indicate that he could build a sophisticated system that would satisfy the requirements of these agencies," Nicholas stated.

According the IT Minister...the system from the developer comes highly recommended by the border control agencies and it has since been tested, to include its ability to interface with the border control system now in place that was developed by CBN.

He said the initial plan was to have the system rolled out in November but this did not happen but he is confident that all the kinks have been worked out for it to be operationalized during February.

When the system goes into effect, passengers will fill out their ED cards at least 24 hours prior to travel using their smart devices and at the end of which they will get a QR Code sent to the device. That is what will be presented at border control when departing or entering the country. When the card is completed the Customs Division will get a copy, so when the passengers arrive at Custom, the officer will be able to process them much quicker. It is anticipated that this will also lead to increased revenues at Customs.

APUA Water Business Unit Provides Update on the Ivan Rodrigues Reverse Osmosis Plant

ST JOHNS ANTIGUA, 21st January 2025 - The Antigua Public Utilities Authority (APUA) Water Business Unit wishes to provide an update regarding the status of the Ivan Rodrigues Osmosis Plant (IRROP), which was temporarily taken offline on Saturday, 18 January 2025, to facilitate routine maintenance. Unfortunately, this process encountered unforeseen technical issues, extending the plant's downtime.

The IRROP is the primary production source for potable water, currently yielding an average of 750,000 imperial gallons (IG) daily from three of its four operational units. It supplies water to the Grays Hill and Scotts Hill Reservoirs, serving communities west of Pigotts Playing Field, Paynters West, Ovals, Michael Village, Lower Ottos, Grays Green to Five Islands, Nut Grove, and elevated areas of Grays Hill. While water was temporarily diverted from alternative sources to serve these areas, this measure may not have fully met the usual demand in the affected communities.

We are pleased to advise that the plant is expected to resume operations by the end of today, Tuesday, 21 January 2025. While production and distribution will recommence promptly, customers are advised that it may take up to 48 hours for the distribution lines to fully recharge and normalize water delivery to all affected areas.

The APUA sincerely apologises for the inconvenience caused and expresses our gratitude to our valued customers for their patience and understanding as we diligently work to resolve this issue.

Increased security to protect tourists



The police are putting into place tighter security measures to protect visitors to the country, especially those arriving aboard cruise ships.

This follows the latest incident of a reported crime against tourists that happened on Monday. The police say they are searching for two male suspects who allegedly robbed two cruise ship visitors at the Fort James Beach.

"It was reported that a couple were at the said beach when two armed suspects robbed them of a fanny pack containing a mobile phone and money. The assailants were dressed in dark clothing and wearing masks. It was further reported that they sped away from the area in a small silver motor car with an unknown registration number. The alleged incident occurred around 9:30 am on Monday," according to a STRATCOM media release.

The police are appealing to anyone who may have seen any suspicious activity in the area to contact the Criminal Investigations Department at 462-3913 or call the St. Johns Police Station at 462-0045.

Meanwhile, the Police Adminis-

tration has strongly condemned this type of behavior toward visitors and residents alike, and has put tighter security measures in place to ensure everyone's safety.

In more developments, a Jennings man was taken into custody by police for questioning in connection with a report of robbery.

Police officers attached to the Criminal Investigations Department were on mobile patrol and saw the suspect in St. Johns and took him into custody. Further investigations are ongoing.

Traffic Department reports a busy year, 2024

The Traffic Department reported that it had a busy year in 2024, with increases in most categories. However, there was a fifty percent decline in road fatalities in 2024 compared with 2023.

Statistics released by the department showed that there were 2,610 traffic accidents reported during the year compared with 2,448 in 2023.

Head of the Department Supt. Elson Quammie reported that the issue of road fatalities showed improved



numbers with 5 reported for 2024 compared with 10 fatalities in 2023, a fifty percent reduction in the numbers.

The number of persons sus-

taining injuries from traffic accidents also went up; from 337 in 2023 to 410 in 2024.

Males continue to lead the pack in terms of the amount

of serious and other injuries they suffer from traffic accidents. In 2023, 206 males suffered injuries from traffic accidents compared with 239 in 2024. Female injuries from traffic accident were 131 and 178.

The number of traffic tickets issued by the department in 2024 dropped significantly from the previous year. There were over 11-thousand tickets issued (11,976) in 2023 compared with 8,618 in 2024.

Police intercept man on bail trying to abscond from the country

A man who was out on bail and who failed to notify the court that he was the holder of a US passport, was intercepted at the VC Bird International Airport on Monday as he tried to 'jump bail' and return to the U.S.

25-year old practice manager at a veterinarian clinic, Beresford Francis of Vernon's appeared before Senior Magistrate Ngaio Emanuel on December 5, 2024, on charges of

breaking and entering into a dwelling with intent to commit larceny.

Francis was granted bail with reporting conditions; these include reporting three times a week and to return to court on 11 February, 2025. His Antiguan passport was surrendered to the court as he indicated that he only had the Antigua and Barbuda passport. He failed to disclose that he had a US passport. Therefore, he kept same in his

possession.

The court also placed a travel ban at all ports of entry.

The court heard that Francis never signed in at Parham Police Station since bail was granted and was apprehended at VC Bird International Airport Monday trying to leave the country on his US passport without the court 's consent.

He appeared before the Senior Magistrate on Tuesday

morning when his bail was revoked forthwith. He was remanded to His Majesty's Prison.

The court commended the investigator, # 72 Constable Mathew, of the police force and the immigration department for their fast action and detention.

The court stressed the importance of all law enforcement agencies working together so that alleged defendants are subjected to the full court process.

Two men committed to stand trial in the High Court on drug charges

Two men – Deshawn Lattibeaudaire and Denfield Roberts of Jennings - were committed to stand trial at the May Assizes when they appeared before a magistrate on Tuesday.

The police are alleging that Roberts and Lattideaudaire were intercepted in Jennings on May 12, 2024, when

it was discovered by they had 52.9 pounds of the controlled substance, hashish in their possession. The drug had a street value of an estimated \$600,415.00.

During the hearing before Senior Magistrate Ngaio Emanuel, the prosecution submitted eight exhibits to support their case and called seven witnesses.

Attorney Lawrence Daniel appeared for Roberts while Sherfield Bowen, is representing Lattibeaudaire.

Both defense attorneys have reserved their defense until the matter comes up at the High Court.

ent for their commitment to nurturing the creativity and minds of the next generation of leaders. He further stated that their dedication to the arts is commendable and inspiring.



Dominica Calypso Association condemns violent attack on calypsonian Narrin 'Trendsetter' Murphy

In a statement following a shocking incident involving prominent calypsonian, Narrin Trendsetter Murphy, the President of the Dominica Calypso Association (DCA), David "Observer" Victor, has rallied the community to condemn acts of violence that tarnish the island's reputation for peace and safety.

The incident, which saw nine gunshots fired into Murphy's vehicle, has sparked outrage among Dominicans both at home and abroad. "Narrin did not deserve this, and neither does anyone else. We must work together to ensure that acts of violence have no place in our society," he urged.



Slain brothers refused to join Matelot gang

A relative of two brothers shot and killed near their home in Matelot on Sunday said the two victims' refusal to join a gang in the area made them targets.

The woman, who spoke with the Express via telephone under the condition of anonymity, also claimed that several reports were made to the police, but nothing was ever done.

Police said that around 3.50 p.m., Akeil Isaac, 26, and his brother Arnott, 16, had left their home to go and pick mangoes with two other men at Santa Cruz Road when they were ambushed by gunmen.

Four people were shot and were taken to the Sangre Grande Hospital where the brothers were pronounced dead on arrival.

The woman described what happened that evening.

'I heard they were home with two other friends and they left to go and pick mangoes by their grandmother. On the way up to the house, some men come out from the bush and shots rang out. About 12 shots ring out,' she said.

'I was at home when I heard the shots, and one of the youth men who got shot in his arm came by me and I asked him what happened and he said he didn't see anything,' she added.

She said she told him to remain at her home with her nine-year-old daughter and she made her way to the scene.

'When I gone up I meet the two men on the ground. One with his head open out and the next one face down because I think he got shot in his chest,' she said.

Asked what could have been the possible motive, she explained that there

were a lot of gangs in the area who were attacking other Matelot residents for not condoning the actions of these gangs.

She added, 'The reason I am saying this is because the two victims never used to deal with them and never used to talk to them or anything like that.'

She said that, on two occasions, gang members attacked her home by firing shots at it and they also attempted to burn it down.

'That was on April 7 last year and also December 4 last year, I reported the matter to the Matelot Police Station and I told them about the person who shot at my house and nothing had taken place,' she said.

The relative said, prior to the first attack, Arnott had saved a boy from a gang member who had been choking him. She said that, after that, the gang members began viewing him as a target.

She said when a report was made,

'Sangre Grande police never came. So the system has failed us inside of here and also these youth men doing these things has injected fear into people so people are afraid of coming out and saying certain things,' she added.

Asked if she was in fear, she replied: 'I am not feeling fear. I am not leaving my hometown, I am not leaving my home but all I need is for the authorities to come and for them to lock up and do what they need to do. Get these fellas and them. They have warrant so they could find their place,' she said.

'Find where they are because I have their nine-yearold sister who have to live with seeing her brothers on the ground. This is something she will have to live with,' said the relative. (Trinidad Express)

Belize takes steps to expand sugar exports within CARICOM

The Government of Belize initiated new efforts to strengthen its sugar export capabilities to CARICOM markets during a key meeting held recently in Belmopan between government officials and industry representatives.

Minister of State for Foreign Trade, Osmond Martinez, met with representatives from Belize Sugar Industries (BSI) and the Directorate General for Foreign Trade (DGFT) to develop strategies for expanding the country's presence in regional sugar markets.

"We are determined to work collaboratively with BSI and other stakeholders to capitalize on export opportunities and ensure that



Belize remains a key player in the regional sugar trade," Martinez said during the discussions.

The meeting addressed several critical areas within the regional trade framework, including the optimization of the Common External Tariff suspension regime and improved compliance with the Revised Treaty of Chaguaramas.

Officials also examined ways to enhance Belize's competitive position within the CARICOM Single Market and Economy.

The DGFT emphasized the significance of Belize's participation in CAR-ICOM's Monitoring Mechanism for Sugar and the Technical Working Group, which focuses on technical standards in the Common External Tariff Suspension process. These mechanisms are designed to promote transparency and fairness in regional trade.

Representatives from BSI expressed their support for the initiative, confirming their commitment to collaborate with the government in addressing challenges and pursuing opportunities in the CARICOM market.

The effort forms part of Belize's broader strategy to enhance regional trade relationships and promote economic development within CARICOM member states. (*Loop Caribbean*)

Kenya to send an all-female SWAT to Haiti

NAIROBI, Kenya, (CMC)

— Kenya says it will send an all-female Special Weapons and Tactics (SWAT) team to reinforce security efforts in Haiti where criminal gangs are seeking to overthrow the government of the French-speaking Caribbean Community (Caricom) country.

In a brief statement, the Ministry of the Interior said that "as part of the unwavering commitment to the people of Haiti, Kenya will continue to deploy additional officers from various specialised units".

It said this would include members of the General Service Unit (GSU), the Anti-Stock Theft Unit (ASTU) and "an all-female Special Weapons and Tactics (SWAT) team to reinforce security efforts and ensure sustained progress in restoring order". The female SWAT team comprises women who have undergone rigorous training and are designed to handle high-risk situations that require specialised skills. Additionally, the SWAT team is also trained to handle counter-terrorism operations, hostage rescues and armed confrontations.

The SWAT team was first deployed in 2012, and observers say its deployment to Haiti is expected to mark a significant milestone in Kenya's international peacekeeping efforts, as the country aims to strengthen its reputation as a trusted and reliable global peacekeeping partner. Haiti's Prime Minister, Alix

Didier Fils-Aimé, said the arrival of 218 Kenyan police and military personnel last weekend illustrates the determination of his government and the international community to eradicate armed gangs and restore peace and security.

"The arrival of these reinforcements marks a crucial step in freeing our country from the grip of criminal networks and restoring peace there," he said.

The arrival of the Kenyans over the last weekend brings the total strength of the United Nations Security Council-sanctioned Multinational Security Support (MSS) mission in Haiti to 807 military and police officers including 617 Kenyans, 150 Guatemalans, eight Salvadorans, six

Bahamians, 24 Jamaicans and two Belizeans.

The MSS is expected to reach a total of 2,500 and last weekend's reinforcement comes amid growing concerns over escalating gang violence in Haiti, where armed groups that control more than 80 per cent of the capital have forced more than a million people across the country to flee their homes. The United Nations Human Rights Office reported earlier this month that at least 5,601 people were killed in Haiti last year as a result of gang violence, an increase of over 1,000 on the total killings for 2023. It said a further 2,212 people were injured and 1,494 kidnapped. (Jamaica Observer)

Colombia's president to declare 'state of emergency' as violence in the country's north escalates

BOGOTA, Colombia (AP) — Colombian president Gustavo Petro said on Monday that he will declare a state of emergency, following a spate of guerrilla attacks in the country's northeast that has killed dozens of people and forced thousands to flee their homes.

In a message on X Petro said that he will "declare a state of internal commotion," a measure that enables the executive branch to pass certain kinds of legislation without congressional approval for three months. The measure will go into effect after a decree is signed by the President and his Cabinet, but it can also be invalidated by Colombia's constitutional court.

Internal commotion decrees were used in the early 2000s by the administration of then-President Álvaro Uribe to increase financing for the military through a special war tax. According to Colombia's constitution, this emergency measure cannot be used to suspend congress or eliminate civil rights. "I hope the judicial system supports us," Petro wrote on X.

Earlier on Monday Petro had warned that his nation's military will take offensive actions against the National Liberation Army after the rebels, known as the ELN, unleashed a wave of attacks in Colombia's Catatumbo region, in which at least 80 people have been killed.

"The ELN has chosen the path of war, and that's what they will get," Petro wrote in a message on X,

in which he accused the rebels of turning into a drug trafficking group and compared their methods to those of Pablo Escobar, the infamous cartel leader who bombed government kidnap civilians and extort businesses.

On Friday Petro suspended negotiations with the rebels after violence escalated in Catatumbo, a mountainous



buildings and murdered his enemies by hiring hundreds of hitmen.

Petro, who was a member of a guerrilla group during his youth, initiated peace talks with the ELN in 2022, after promising in his presidential campaign that he could get the rebels to demobilise within three months of taking office.

But talks have stalled over multiple disagreements about how the rebels would disarm and the kinds of economic reforms that the government would implement in exchange for their disarmament. The ELN has also criticised the government for staging separate negotiations with a breakout group in the country's southwest and angered officials by continuing to

region that produces around 15 per cent of Colombia's coca crop and is located along the border with Venezuela.

The ELN, which has an estimated 6,000 fighters, reportedly attacked civilians it accused of being collaborators of a rival group, the FARC-EMC, taking people from their homes and shooting them in the streets, while in rural areas firefights broke out between members of both groups.

In a statement issued on Monday ELN leader Antonio García said that his organisation does not intend to target civilians, but has been going after former rebel fighters who are now collaborating with the FARC-EMC.

Over the weekend, howev-

er, thousands of people fled towns in the Catatumbo region, fearing for their lives, including community leaders who had been threatened by the ELN. Among those fleeing were former members of the Revolutionary Armed Forces of Colombia, who demobilised in a 2016 peace deal with the government, and have now been targeted by the ELN.

The United Nations Office for the Coordination of Humanitarian Affairs in Colombia said Monday that the new wave of violence in Catatumbo has displaced 18,300 people, who are staying in shelters and hotels in the cities of Tibu, Ocaña and Cúcuta, where officials have warned of a looming humanitarian crisis.

Sandra Tijaro, a farmer in northeastern Colombia, said in an interview she fled her village on Friday after armed men showed up and told everyone to evacuate. She is now staying with her children at a shelter in Tibu.

"We want the armed groups to think about the welfare of rural folks," she said. "We are hard-working people who end up carrying the burden of this conflict."

The 2016 peace deal between the Colombian government and the Revolutionary Armed Forces of Colombia led to the demobilisation of 11,000 fighters.

However, it left a power vacuum in some rural areas that smaller rebel groups have tried to fill, with the government struggling to reduce violence against civilians. (Jamaica Gleaner)

Trump declares border emergency and seeks to end US birthright citizenship

From behind his desk in the Oval Office, President Donald Trump signed a flurry of executive orders and decrees aimed at cracking down on immigration.

From one order tackling the definition of birthright citizenship, to another declaring illegal immigration at the border a national emergency, Trump swiftly made moves on his promises to tighten the US-Mexico border.

But some of his plans - particularly around changing the definition of birthright citizenship - are likely to face significant hurdles.

He is already facing legal challenges from immigration advocacy groups, which have reacted furiously to his announcements.

One organisation said his plans "do not uphold American values", and another said Trump's administration was "actively trying to destroy our lives".

In his inaugural address earlier in the day, Trump vowed that "all illegal entry will be halted" and that millions of "criminal aliens" would be deported.

He also signed an order declaring Mexican drug cartels terrorist organisations. "I have no higher responsibility than to defend our country from threats and invasions," he explained. At another event at Washington's Capital One Arena, Trump formally revoked nearly 80 executive actions of his predecessor Joe Biden. He had previously vowed to scrap Biden's policies "within five minutes".

Following his inauguration, he also signed a proclamation that gave officials the authority to "repel, repatriate, or remove" migrants until he was satisfied that "the invasion at the southern border has ceased".

Although the details of the order are not yet known, officials have said that Trump plans to end birthright citizenship.

That refers to an approach

of the US government whereby anyone born on American soil is considered a citizen at birth, regardless of their parents' immigration status.

Trump appears to be seeking to change the rules so that that the children of undocumented migrants living in the US will no longer automatically be considered US citizens. It would not apply retrospectively.

Exactly how he intends to achieve this is unclear, however, because birthright citizenship is enshrined in the constitution and would require a two-thirds vote in both chambers of Congress to change. (BBC News)

WHO 'regrets' Trump's move to withdraw US membership

The World Health Organization (WHO) says it "regrets" the announcement that the United States of America intends to withdraw from the Organization.

US President Donald Trump used one of the flurry of executive actions that he issued on his first day back in the White House to begin the process of withdrawing the U.S. from the WHO for the second time in less than five years — a move many scientists fear could roll back decades long gains made in fighting infectious diseases like AIDS, malaria and tuber-

culosis, AP reported.

In response the WHO issued the following release:

"The World Health Organization regrets the announcement that the United States of America intends to withdraw from the Organization.

WHO plays a crucial role in protecting the health and security of the world's people, including Americans, by addressing the root causes of disease, building stronger health systems, and detecting, preventing and responding to health emergencies, including disease outbreaks, often in dangerous places where others cannot go.

The United States was a founding member of WHO in 1948 and has participated in shaping and governing WHO's work ever since, alongside 193 other Member States, including through its active participation in the World Health Assembly and Executive Board. For over seven decades, WHO and the USA have saved countless lives and protected Americans and all people from health threats. Together, we ended smallpox, and together we have brought polio to the brink of eradication. American institutions have contributed to and benefited from membership of WHO.

With the participation of the United States and other Member States, WHO has over the past 7 years implemented the largest set of reforms in its history, to transform our accountability, cost-effectiveness, and impact in countries. This work continues.

We hope the United States will reconsider and we look forward to engaging in constructive dialogue to maintain the partnership between the USA and WHO, for the benefit of the health and well-being of millions of people around the globe." (Trinidad Express)

India police volunteer gets life sentence for rape, murder of junior doctor

An Indian court has awarded the life sentence to a police volunteer convicted of the rape and murder of a junior doctor at the hospital she worked at in the eastern city of Kolkata.

Judge Anirban Das on Monday rejected demands for the death penalty for Sanjay Roy, saying it was not "the rarest of the rare cases", and ordered that the 33-year-old convict must spend his life behind bars.

Roy has consistently maintained his innocence, alleging he had been framed. He can appeal the judgement in a higher court.

The 31-year-old trainee doctor's bloodied body was found in a classroom at the state-run R G Kar Medical College and Hospital in Kolkata on August 9. An autopsy found she had been strangled and sexually assaulted.

Her parents broke into tears inside the court on Monday, saying they were "shocked" at the sentence and had hoped her murderer would be hanged, for a case that highlighted the chronic issue of violence against women in the world's most populous country.

"We are shocked by the verdict," the victim's father



told the AFP news agency, tears running down his face. "We will continue our fight, and won't let investigations stop... Come what may, we will fight for justice."

Family members cannot be identified in keeping with Indian law on the reporting of sexual violence cases.

The federal police who investigated the case had argued the crime belonged to the "rarest-of-rare" category and demanded the death penalty for Roy. The state's ruling Trinamool Congress (TMC) party had also demanded death for him.

Roy was arrested a day after the crime, and arguments in the case began in November. The assault prompted India's Supreme Court to set up a national task force to suggest ways to enhance safety in government hospitals.

and medical students across

India held protests and rallies demanding better security. Thousands of women also protested in the streets, demanding speedy trial in the country's slow-moving justice system.

India imposes the death penalty, although it is rarely carried out in practice. The last executions carried out were in March 2020 - of four men convicted of the 2012 gang rape and murder of a 23-year-old woman on a bus in capital New Delhi.

The doctor's killing drew comparisons with the 2012 incident and led to demands by doctors at government hospitals for better security.

Activists say new sentencing requirements have not deterred rape and the number of recorded rape cases has increased. In 2022, police recorded 31,516 reports of rape – a 20 percent jump from 2021, according to the National Crime Records Bureau. (Al Jazeera English)



Shallow urges BCA, GCB to voice concerns on governance reform at CWI meeting

Cricket West Indies (CWI) president
Dr. Kishore Shallow has emphasized that a special meeting scheduled for next month represents a critical opportunity for the Barbados Cricket Association (BCA) and the Guyana Cricket Board (GCB) to present their views on governance reform.

However, Shallow has made it clear that the regional body intends to move forward with or without their input.

"This time, I can state with a measure of certitude that we are going to proceed and progress with governance reform at that special meeting," Shallow said during an appearance on WESN TV in Trinidad.

The BCA and GCB's absence from a December 6, 2024, meet-

ing to vote on the Wehby Report—recommendations made by Jamaican business mogul Don Wehby—resulted in the meeting being adjourned due to a lack of quorum.

Despite this, Shallow remains committed to advancing the reform process.

"Governance reform has been on the table for well over two years, and we have had meetings with shareholders and other stakeholders. So, there have been opportunities to discuss this matter," Shallow shared.

"However, this special meeting gives them another platform where they can come and present their case and convince the other shareholders to understand and appreciate their positions. I urge them—and

I have done so directly, and now I want to urge them publicly—to come and attend the meeting and discuss the matters," he added.

The BCA and GCB have called for discussions to review how the CWI president and vice-president are selected, including proposing a rotational policy for the presidency. But Shallow dismissed the idea as "nonsensical" and unlikely to reduce the "politics in cricket."

"It (the rotation proposal) hasn't been in any way processed properly and ventilated. In fact, when the suggestion was discussed at the Governance Committee level, it was rejected. And we discussed it also at the CWI level, and there too it was rejected, because there is no meaningful way of how this thing will work," Shallow argued.

That said, he questioned the practicality of implementing such a system, particularly how a rotational presidency would function without introducing additional layers of political maneuvering.

"One of the excuses given for proposing this approach is to reduce the politics in cricket. How are you going to reduce it when, nationally, you are going to be electing a candidate to be president?" Shallow asked.

Using the BCA as an example, Shallow pointed out the politics inherent in recent elections where three members of the board, including the incumbent president, contested for the top position along with his vice-president and secretary.

"What politics are you trying to get around? And that is why I said it is an excuse," he noted.

Still, Shallow reiterated his commitment to inclusivity and urged the BCA and GCB to seize the opportunity provided by next month's meeting.

"The special meeting will provide the perfect platform for you to come and lay out your case... come to the meeting and discuss. One thing that is certain under my leadership is an inclusive approach. Everyone gets a voice and an opportunity to voice their opinion," Shallow declared.

Windies Under-19 women suffer second loss at ICC T20 World Cup

The West Indies Under-19 women endured another tough outing at the International Cricket Council (ICC) Under-19 Women's T20 World Cup, as they fell to Sri Lanka by 81 runs at the Bayuemas Oval in Kuala Lumpur on Tuesday.

A dismal performance with both bat and ball left the Caribbean side unable to contain a rampant Sri Lanka, who amassed 166 for five off 20 overs in their innings. The West Indies were then bowled out for 85 in 19.4 overs, their second defeat in the tournament.

Despite the setback, the young West Indies women still have a shot at progressing to the Super-Six League stage if they can secure a win in their final group match against hosts Malaysia on Thursday. Defending champions India and Sri Lanka currently lead Group A with four points each.

After electing to bat, Sri Lanka took full advantage of a lackluster West Indies bowling attack, as openers Sanjana Kavindi and Sumudu Nisansala laid the foundation with a tidy 54-run partnership. Kavindi top-scored with 38 off 36 balls, striking six boundaries, while Nisansala chipped in with 19, including two fours and a six, before falling to Kenika Cassar.

At 93 for one at the halfway stage, Sri
