Press statement From the Hon Gaston Browne Prime Minister of Antigua and Barbuda

Re: Alfa Nero Sale

I refer to the controversy that has arisen over the sale of the Alfa Nero by the Government of Antigua and Barbuda, and the disposition of the sales proceeds.

I will be perfectly clear about this.

The Alfa Nero was sold by the Government through an entirely lawful and transparent process for a total sales price of US\$ 40 million. This was publicly reported, and it was documented before the High Court in Antigua.

Every dollar received, and every dollar expended, has been publicly accounted for. I am today releasing an accounting in a form that can be clearly and easily understood by all interested parties. The same information was previously provided to the High Court.

The Government has nothing to hide. In fact, it invites and welcomes public scrutiny of this transaction in all its aspects. I trust this public disclosure will put an end to the false accusations that have been made by unscrupulous persons attempting to further their own selfish interests.

I refer, in particular, to statements that were made by on behalf of Yulia Guryeva-Motlokhov, the daughter of a Russian oligarch who is sanctioned by the US, UK and EU, among others. She has falsely claimed in our courts that she had an entitlement to the Alfa Nero in order to claim for herself the sales proceeds and damages and rob the people of Antigua and Barbuda of these public benefits. This alleged entitlement to the vessel was vigorously opposed by the legal team which represented the State.

She and her attorneys have made scandalous, malicious and entirely false accusations in order to further her illicit ends. The principal targets of her defamatory comments have been myself, and members of my family. There is not a grain of truth to any of these attacks on me, or my family's integrity.

It is apparent that Ms Guryeva-Motlokhov has not acted alone, but in cahoots with desperate political opponents here in Antigua, who have previously raised some of these stale fabrications, which have already proven to be false.

I will not be deterred by this smear campaign against me. I have always been an advocate and practitioner of good governance, and I will continue to govern our country with the highest standard of integrity.

I am currently discussing with my attorneys, in Antigua and Barbuda and in the United States, the legal remedies available to me as a result of the libelous statements and other wrongs that have been committed against me and my family.

Prime Minister Gaston Brown Prime Minister Gaston Browne is confident that the truth regarding the expenditures arising from the sale of the Alfa Nero, will clear his name and that of his family.

The Associated Press has reported that a federal judge in New York granted the attorneys of a Russian woman permission Monday to issue subpoenas to access the financial records of Antigua and Barbuda's prime minister and other officials involved in the sale of a megayacht that her father had abandoned.

The attorneys must first notify Prime Minister Gaston Browne and others before serving subpoenas on the Federal Reserve Bank of New York and the U.S.-based Clearing House Payments Co.

However, speaking in the Cabinet Room on Tuesday during the signing of the agreement between the government and FEMA Marine SA, PM Browne referred to the allegations made against him as 'spurious'.

FEMA Marine SA's CEO, Nazmi Topcuoglu, informed the prime minister that he was the one who had recommended the eventual buyer of the Alfa Nero to the government and that his company now manages the yacht. He revealed that FEMA Marine SA was called in to do a valuation of the Alfa Nero and that several million Euros were spent bringing back the vessel to a saleable condition as over time, it had significantly deteriorated.

In fact, he informed the prime minister that when his team had concluded their surveys of the vessel, the gave it a value of no more than US\$30 million, less than the US\$40 million that the government concluded with the buyer.

According to PM Browne the sale of the vessel was done 'in a most transparent way' and in collaboration with both the US Treasury Department and the State Department.

"The irony is that after having such a

transparent process, they (Yulia Guryeva-Motlokhov, the daughter of a Russian oligarch who is sanctioned by the US, UK and EU) are now making the claim, fallacious as it is, that US\$10 million are missing. It's totally untrue, but they have now joined our political opponents who, over the past decade, have been throwing a lot of mud at me because they are mad because our country has been doing well economically, and their political fortunes have been fading as a result," he stated.

He accused the opposition elements of seeking the use the issue to tarnish the country's reputation as well as his reputation and that of his family.

However, PM Browne remains confident that their names will be cleared with the truth is revealed.

Government signs an agreement to boost the country's registry of superyachts


The government through the Antigua and Barbuda Department of Marine Services (ADOMS) has signed an agreement with a company out of Switzerland that will undertake the promotion and marketing of the country's registry of superyachts.

The agreement was inked on Tuesday by Prime Minister and Minister Responsible for Merchant Shipping and Ship Registration, for and on behalf of the Government of Antigua and Barbuda, Gaston Browne and Chief Executive Officer of FEMA Marine S.A. Nazmi Topçuoğlu with Director of ADOMS, Ambassador Dwight Gardiner serving as the witness.

Under the agreement, the government agrees that the Company will exercise the rights conferred upon it by the agreement to promote and expand the international yacht registry in the Mediterranean, for a period of two (2) years commencing on the date of execution of this Agreement (March 18, 2025). This Agreement may be renewed on such terms and conditions as the parties may agree.

Both parties agreed that during the term of the agreement, the Government will not appoint or







engage any other person (natural or juridical) in the Mediterranean, for the purpose of providing yacht registration services on its behalf.

Additionally, in order to strengthen and expand the ADOMS network, the

Company will have the right to open and operate sub-branches in the Mediterranean, as deems appropriate to promote the activities contained in the agreement.

Nazmi Topcuoglu, as the Chairman of FEMA Marine SA, is a qualified and experienced Marine Engineer, who is an accredited Marine Surveyor appointed by the Government of Malta and also a Helicopter Pilot.

ADOMS said he is the proposed Deputy Registrar, and the partner identified for development of Yacht registration business in Mediterranean and Turkey.

FEMA Marine SA is a Superyacht Management Company based in Neuchatel, Switzerland. It has a large team of skilled and experienced yacht surveyors, offering worldwide services and expert advice.

Further a business plan was requested from FEMA. According to ADOMS the plan was positive and showed that the company had developed a plan for marketing yacht registration and providing operational support to ADOMS and by extension the government of Antigua and Barbuda.

IHO continues the Call for A Safe Shelter with Barbuda GBV Prevention Walk

The atmosphere at the IHO-GBV Walk in Barbuda last Saturday was one of deep reflection and resolve as participants grappled with the tragic loss that had shaken the nation that very morning. The event, held under the theme "Men and Women United 2025: Stop Gender-Based Violence," was not only a commemoration of International Women's Day (IWD) 2025 but also a poignant call to action for greater protections for women, girls, and vulnerable communities.

Project Manager, Britney McDonald addressed the gathering, emphasizing the heightened risks faced by women and girls. "Women and girls are at an increased risk of violence from all angles. As a community, we must come together and be vigilant. We cannot ignore the urgent need for a safe shelter for women, girls, and persons from vulnerable communities."

The IHO-GBV Walk in Barbuda was more than just a march; it was a declaration of resilience and an urgent plea for tangible change. 

Organizers from the Integrated Health Outreach Gender-Based Violence Coalition (IHO-GBV), in partnership with the Directorate of Gender Affairs (DoGA), share immense gratitude to the participants and volunteers in championing this year's walk. McDonald noted that, "We understand that climate change is increasingly impacting our day to day lives, and we're witnessing it unfold across several areas. Our communities are rallying together because of the ripple effects which have led to instances of gender based violence, which includes mental. emotional and financial violence. The overwhelming show of support demonstrates the need to continue the conversation in order to shift the culture forward."

Over 2,000 people participated across Antigua and Barbuda, making this year's event the largest turnout in the event's twoyear history. Many participants carried signs bearing the image of the nation's most recent victim of violence, further reinforcing the gravity of the issue. Several reflected on their own childhoods, emphasizing the importance of safeguarding future generations and fostering safer communities.

Jamaica recorded 158 murders between January 1 and March 15 this year, a 30 per cent decline in homicides compared with the similar period last year, according to latest police data.

The serious crime statistics published Sunday by the Jamaica Constabulary Force (JCF) show that 13 murders were recorded over the last week March 8-15, bringing the total so far this month to 41.

A total of 28 murders were committed in the first eight days of March.

For the entire month of February 47 murders were committed, the lowest monthly total in 25 years.


The 30 per cent decline in murders as of March 15, is about 70 fewer than the 228 recorded for period under review last year.

Seven of the 19 police divisions are in double-digit figures.

These include St Andrew South 24. St Catherine South 18, Westmoreland 13, St James 12, St Andrew Central 12, St Catherine North 11 and Kingston Western 10.

St Elizabeth has the least with only one homicide.

There is also a decline in shooting,



injured persons, rape and robbery.

Break-ins and motor vehicle larceny have seen an increase.

Deputy Prime Minister and Minister of National Security Dr Horace Chang is optimistic that the country's murder toll for 2025 could fall below 800.

"If we can maintain the trend, look at the projection and ensure that we pursue programmes and policies that [can aid] the Jamaica Constabulary Force (JCF), then we could

see under 800 murders," he said at Friday's official opening of the Frome Police Station in Frome, Westmoreland.

Dr Chang stressed that sustainable crime reduction requires continued government investment in police resources, technology, and infrastructure.

Jamaica ended 2024 with 1.141 murders, a decrease of 252 compared to 2023, when the country recorded 1,393 homicides. (Jamaica *Gleaner*)

Regional News Dominican historian in competition for Caribbean's biggest book prize

A book by renowned local historian and anthropologist, Dr Lennox Honychurch, has been shortlisted for the 2025 OCM Bocas Prize for Caribbean Literature, the most coveted award for Caribbean authors.


His work, "Resistance Refuge Revival: The Indigenous Kalinagos of Dominica" was recently published and it has already gained critical acclaim. It is one of 15 books by authors with roots in eight Caribbean countries shortlisted by judges of the competition.

Judges said the book, which falls under the category of best nonfiction, is an "epic account that restores to the Caribbean a story that should be our lingua franca."

"This elegant and accessible story is a gift to the region, its artists, its students, its Kalinago population, and Indigenous activists throughout the Americas," they said.

"We are left with the ethical imperative of centering this encounter as we go forward into the future."

The competition now moves on to the second stage and the judges will announce the winners in three categories - poetry, fiction, and nonfiction, on Sunday, April 6. The winners will then move on to compete for the grand



prize of US\$10,000 to be announced on Saturday 3 May, during the 15th annual Bocas Lit Fest in Port of Spain.

"Happy my latest book shortlisted," Dr Honychurch wrote in a brief note on his Facebook page.

The book has already been praised by his peers. "In this impressive book, Honychurch presents a history that emphasizes a Kalinago perspective and shows the important role they have played in the complex social and cultural evolution of Dominica," Mark Hauser, Professor of Anthropology, Northwestern University wrote.

"The product of a lifetime of engagement and decades of study, Lennox Honychurch's 'Resistance, Refuge, Revival' tells the story of the Kalinago peo-

ple of Dominica with consummate skill and compassion," Peter Hulme. emeritus Professor of Literature, University of Essex, wrote.

"It instantly becomes the most authoritative book on the subject, to which both scholars and the general reader will turn."

Dr Honychurch dedicated the book to the Kalinago people. "To the Kalinago people of Wai'tukubuli who, by the courageous resistance of their ancestors. defended, protected, and bequeathed this island to generations yet unborn," he wrote at the beginning of the book.

His most recent book "In the Forest of Freedom: the Fighting Maroons of Dominica" was published in 2017. He is well-known to generations of students as the author of the secondary school textbook series, "The Caribbean People."

His books include: Dominica: Isle of Adventure (1995); Caribbean Camera: A Journey Through the Islands (1998); The Cabrits and Prince Rupert Bay (1983); The Caribbean People (1979); Caribbean Landmarks: Historic Events and Sites (1983); Our Island Culture (1982) and The Dominica Story (1974).

He has also written countless articles and papers on a variety of subjects concerning history and literature.

Senior Counsel Stuart Young was officially sworn in as this country's eighth Prime Minister today, along with Camille Robinson-Regis as his Attorney General.

The duo received their letters of appointment from President Christine Kangaloo at a ceremony held at President's House, St Ann's, which started at 10 am.

In a second ceremony held at 3 pm, at the same venue, the rest of the country's Cabinet was unveiled.

Among the notable changes, former High Commissioner to the UK and former Permanent Secretary Vishnu Dhanpaul was named Minister of Finance, while Marvin Gonzales was appointed Minister of National Security.

These appointments were followed by Fitzgerald Hinds being named Minister in the Office of the Prime Minister and Colm Imbert being assigned the portfolio of Minister of Public Utilities.

Imbert had previously served as Minister of Finance, Hinds had held the position of Minister of National Security, and Gonzales was formerly the Minister of Public Utilities.

At least 42 deaths linked to severe US storms



A series of storms in the United States that sparked tornadoes, wildfires, high winds, and dust storms while barreling across eight states over the weekend have left at least 42 people dead and dozens injured.

Scattered tornadoes in Missouri killed over a dozen people, and a string of twisters in Mississippi — including two that hit near the same town within about an hour — left six people dead. Hundreds of homes and businesses were destroyed throughout the South and the Midwest.

The violent weather began Friday and earned an unusual "high risk" designation from meteorologists.

There were 46 tornadoes on Friday and 41 on Saturday, according to a preliminary count. The storm also spurred more than 130 wind-driven wildfires that damaged more than 400 homes in Oklahoma. Dozens of fires were still burning across the state on Monday, said Keith Merckx at Oklahoma Forestry Services.

High winds spurred several dust storms that led to almost a dozen deaths in car crashes on Friday.

Eight people died in a Kansas highway pileup involving at least 50 vehicles, according to the state highway patrol. Authorities said three people also were killed in car crashes during a dust storm in Amarillo in the Texas Panhandle.

President Donald Trump said the White House was monitoring the storms and would assist state and local officials to help in the recovery. He said National Guard troops were deployed to Arkansas. (*Jamaica Gleaner*)

Peru declares emergency and deploys army as violence surges in capital

International

Peru's president declared a state of emergency in the capital Monday and ordered the deployment of soldiers to help police address a surge of violence, amid widespread outcry a day after the killing of a popular singer.

President Dina Boluarte's government published a decree saying that the state of emergency will last 30 days, and authorities will restrict some rights, including the freedom of assembly and movement. That means the police and the army would be able to detain people without a judicial order.

Peru has seen an increase of killings, violent extortion



and attacks on public places in recent months. Police reported 459 killings from Jan. 1 to March 16, and 1,909 extortion reports in January alone. But outrage crested after the killing Sunday of Paul Flores, the 39-year-old lead singer of the cumbia band Armonia 10. In Congress, opposition lawmakers requested a vote of no confidence against Interior Minister Juan José Santiváñez for what they say is a lack of a plan to fight rising violence. The vote is expected to be discussed in the Congress' plenary later this week. Flores was shot to death early Sunday when assailants attacked the bus he and bandmates were travelling after a concert in Lima. Cumbia is a Latin music style that people dance to the rhythm of drums, maracas and other instruments.

The attack against the popular singer was not the only violent event over the weekend. On Saturday, an object exploded at a restaurant in the capital, injuring at least 11 people.

Boluarte's government previously decreed a state of emergency in an attempt to stem the violence between September and December. (*Jamaica Gleaner*)

Ukraine presses for unconditional ceasefire ahead of Trump-Putin talks

Ukraine has pressed Russia to accept an unconditional ceasefire ahead of a highly anticipated phone call in which United States President Donald Trump is set to discuss the war with Russia's President Vladimir Putin.

Kyiv and its European allies are demanding that Putin agree to an unconditional US-proposed 30-day ceasefire during the call, which is scheduled to take place later on Tuesday, according to the Kremlin.

"We expect the Russian side to unconditionally agree to this proposal," said Ukraine's Foreign Minister Andrii Sybiha ahead of the meeting. "It is time for Russia to show whether it really wants peace." Trump said on Monday that Washington and Moscow had already discussed "dividing up certain assets" – including territory and power plants – between Ukraine and Russia as part of the ceasefire deal.


In the run-up to talks, the Semafor news website published a report that cited two sources saying the Trump administration was considering recognising Crimea, which Russia annexed from Ukraine in 2014, as Russian territory.

The Kremlin has repeatedly said that Crimea, where Russia's Black Sea Fleet is based and where the pre-annexation population was mostly Russian speakers, is already formally part of Russia.

Kyiv has said it wants the Black Sea peninsula – internationally recognised as Ukrainian territory by most countries – back.

Ukraine's President Volodymyr Zelenskyy said on Monday that Putin does not want peace, accusing him of continuing "to drag out this war" in a bid to better the country's military position ahead of any halt in fighting.

Putin's spokesperson Dmitry Peskov told reporters on Tuesday that Trump and Putin will discuss the war in Ukraine but added that there are also a "large number of questions" regarding the normalisation of US-Russia relations. (*Al Jazeera English*)


