### PM repeats call to local contractors

The prime minister is again calling for local contractors to consider pooling their resources together and to submit bids for some of the major contracts into which the government will enter in the coming weeks and months.

Speaking on the Browne and Browne show on Saturday, Prime Minister Gaston Browne, was referencing the recent signing of a US\$47 million contract with a Canadian firm to undertake major upgrades of the runway at the VC Bird International Airport.

"As I speak about that contract, I am hoping that local Antigua and Barbuda contractors can come together in the future and partner with other firms external to Antigua and Barbuda to pursue these contracts. We are spending US\$47 million on this project and if you assume that there is a 20 percent profit margin, then I would love to see a local firm retain about half of that in the country," he noted.

The prime minister said he has observed that some local contractors




are 'not scaling up', or are trying to submit bids on their own, or, in other cases perhaps they don't have the capacity and have decided not to bid.

"All the firms that submitted bids (for the airport contract) were primarily foreign firms, including CCECC, the Chinese company, had submitted a bid. My view is that if our local contractors were able to come together and pool their resources they could be for these large contracts rather than allowing them to go to a begging," he remarked. According to the prime minister there are a number of future contracts in the works and he sees these as opportunities for the local contractors to come together, noting that it is not too late.

"We have another three years to go in this term and I am sure that there will be lots more capital projects. In fact, I can think of one, an \$11 million contract for the construction of a headquarters building for the Antigua and Barbuda Department of Marine Services (ADOMS)," he announced.

PM Browne is encouraging local contractors to bid for this contract even suggesting that if a single contractor does not have all the capacity then it could combine with another firm to make a submission for the contract.

The prime minister noted that in some contracts because of the financing, the contracts are open to international firms, so local contractors have to come together to assemble the required resources and skills to compete with the external firms.

## House of Representatives resumes sitting today with packed agenda

The House of Representatives will resume its sitting in the parliament chamber this morning to continue its discussions on a wide range of legislative measures being introduced by the government.

Among them is the Vehicles and Road Traffic (Amendment) Bill, 2025, through which the government is seeking to raise the licence fees that motor vehicle owners pay annually.

Transportation Minister, Charles Fernandez will introduce the amendment in the House during the sitting.

There has been much public discussion on the issue of the pending increase in licence fees and the government has responded to the concerns expressed by members of the public by adjusting the fee structure from what was initially announced.

According to Prime Minister Gaston Browne the measure going to parliament will propose an increase of \$100.00 across the board for motor cars (sedans/compacts), but Sports Utility Vehicles (SUV's), commercial vehicles and heavy-duty equipment will pay a 40 percent increase. PM Browne said there will be some carve-outs; for taxis and buses, hearses, ambulances and tractors.

When parliament met last Thursday, several individuals associated with the opposition United Progressive Party (UPP) staged a picket in the area outside of the parliament building. The picket was to protest the planned increases in licence fees.

Despite this however, the prime minister observed that there has generally been an acceptance by members of the public of the need to increase the fees, particularly as the monies raised will be dedicated to a dire need in the country; the universal agreement that the country's road network is in need

of urgent upgrades.

"The people have been embracing the increase, recognizing that barring an

adjustment that was made for SUV's in 2005, there has no increase in licence fees in the country and that an increase has been long overdue even if we did not have a 'noble purpose'. In this instance, we do have a noble purpose; to service the loan that we will secure to refurbish the nation's roads," he stated.

PM Browne also reiterated that measures will be put in place both by the lending institutions (ACB Caribbean and the Eastern Caribbean Amalgamated Bank) and the Ministry of Works to ensure that the funds go towards the purpose for which they were intended.

"No one should worry about the issue of accountability as systems will be put in place to ensure that this happens," he assured.

## In-Country Consultations on (CBI/CIP) Set to Commence

A series of in-country consultations is set to commence this week among all five Eastern Caribbean States which operate Citizenship By Investment (CBI/CIP) programmes.

The consultations are being organized by the Interim Regulatory Commission (IRC) to engage stakeholders on the establishment of a Regional Regulator for Citizenship by Investment Programmes (CBI/CIP). The consultations will commence on 4 March 2025 with Saint Christopher (St Kitts) and Nevis. The in-country consultations for Antigua and Barbuda are set for April 15-17.

The consultations will seek to engage a broad and inclusive set of stakeholders. Representatives from the Government, the CIP/CBI industry, the media and social partners will be invited to participate in a series

of discussions around the regional efforts to strengthen the transparency, accountability and integrity of the CIP/CBI Programmes.

At the engagements, Legal Drafting Consultant, Lydia Elliott, will present her work towards the development of the enabling legislative framework for the establishment of the Regional Regulator. Participants would then have an opportunity to engage Elliott on this work. They would also be able to engage members of the IRC present, who will support Elliott on the consultations.

The IRC was appointed by the five CBI/CIP countries to oversee the establishment of the Regional Regulator. The eight-member IRC comprises the following appointees;

## Details of Commonwealth Day 2025 Celebrations announced


Antigua and Barbuda will join the global family of nations in celebrating Commonwealth Day 2025 on Monday, March 10, 2025, under the theme "Together We Thrive". This year's observance will feature a Church Service, Commonwealth Day Youth FLOE (Future Leaders Opportunities Experience) engaging students across the nation, a grand street parade, a Commonwealth Flag Raising Ceremony, and the reading of a message from the Sovereign, all designed to highlight the Commonwealth's enduring values of unity, collaboration, and shared prosperity.

This year's theme, "Together We Thrive," celebrates the spirit of the Commonwealth's 56 independent member states, which are united by shared values enshrined in the Commonwealth Charter. Rooted in the principles of family, unity, and peace, the theme underscores the significance of building strong and interconnected communities that empower their members and foster meaningful progress.

The celebrations will commence with a Commonwealth Day Church Service on Sunday, March 9, 2025, at 8:00 a.m. at Spring Gardens Moravian Church, St. John's Street. The service will bring together government officials, representatives from Commonwealth organizations, students, and members of civil society in an act of thanksgiving. Special invitations have been extended to National Honourees to attend the Church Service.

The morning's activities will begin with Commonwealth Day Youth FLOE on the Go, taking place at intervals between 8:00 a.m. and 9:15

a.m. Representatives from youth-based and Commonwealth organizations will visit a total of twelve primary and secondary schools across Antigua and Barbuda to engage students in discussions on the Commonwealth's mission, essential

In addition to distinguished local speakers from the British High Commission and civil society, the event will once again feature special guests, Mr. and Mrs. Stuart Shilson from the United Kingdom. Shilson, a business consultant and senior member of the St John Ambulance, a humanitarian organization, previously served as an Assistant Private Secretary to Her Late Majesty The Oueen.

Following the school engagements, the Commonwealth Day Parade, organized by the Antigua and Barbuda Defence Force, will take place at 10:00 a.m. The parade will commence at the Telephone Exchange on Long Street and proceed to the Antigua Recreation Grounds (ARG).

Barbuda sporting complex

The basketball complex is in need of significant renovation to make it safe and usable for the community, while Coronation Park, a key venue for cricket and football, lacks essential amenities like proper lighting, seating areas, and restroom facilities. These gaps in infrastructure hinder the development of sports in Barbuda, affecting not only local athletes but also the ability to host larger events that could boost community engagement and tourism.

The absence of lighting at both the basketball complex and Coronation Park restricts the use of these facilities to daylight hours, limiting the opportunities for evening practices or matches. This issue particularly impacts students and working adults who can only participate after school or work. Additionally,

the lack of bathrooms and seating at the cricket and football fields makes the venues uncomfortable for both players and spectators, discouraging community support and participation. These essential improvements would not only increase the usage of these facilities but also contribute to fostering a sense of pride and belonging within the community.

Addressing these challenges presents an excellent opportunity to invest in Barbuda's future, particularly in youth development. As part of a broader strategy, you could explore partnerships with local businesses, government agencies, and international organizations to raise funds for the renovation and development of these sports facilities. Offering sponsorships or organizing fundraising events could provide the necessary resources to make Barbuda's sports venues more accessible and functional. This investment would provide Barbuda's youth with the facilities they need to develop their skills and engage in healthy activities, ultimately benefiting the community as a whole.

#### A CARIBBEAN PEOPLE'S MESSAGE TO THE USA



#### "LET OUR CUBAN BROTHERS AND SISTERS GO!"

The officers and members of the Caribbean Pan-African Network (CPAN) - a pan-Caribbean organization with membership in seventeen Caribbean countries - were pleased with and gratified by the 14th of January 2025 decision of the Joseph Biden administration of the United States of America (USA) to issue a certification of rescission of the Republic of Cuba's unjust and illegitimate designation by the US State Department as a State Sponsor of Terrorism.

The decision to remove Cuba from the US State Department's unilaterally composed list was considered by CPAN, and no doubt, by the overwhelming majority of Caribbean people, to be a victory for International Law and a demonstration of respect for the rights, interests and wellbeing of the nation and people of Cuba.

Indeed, the Caribbean's major indigenous multilateral organization – CARICOM - hailed the decision as "a step in the right direction" and urged the government of the USA to go further and remove the equally illegal and destructive financial, economic and trade em-

bargo that the USA has imposed on Cuba over the past 63 years.

However, to the dismay of the entire Caribbean region, less than one week later, the newly installed administration of President Donald Trump not only reinstated Cuba on the US State Department's list of State Sponsors of Terrorism, but also revoked the suspension of the filing of law suits in US Courts under Title III of the Helms-Burton Act, and reinstated the USA's List of Restricted Cuban Entities with which entities or persons in the USA are prohibited from carrying out transactions.

And this was subsequently followed by Trump's Secretary of State, Marco Rubio, purporting to impose illegal punitive sanctions on any person involved in facilitating the work of Cuba's world famous and highly regarded Medical Brigades.

The sole purpose of the retrogressive reinstatement of these destructive measures within the context of the continuance of other components of the embargo is to intimidate foreign investors, close off possible sources of external income for Cuba, subvert the capacity of Cuban entities to produce goods and services, and to ravage the living standards and quality of life of the Cuban people.

CPAN believes that we legitimately speak for our entire Caribbea region when we say that the people of the Caribbean consider that these actions and the ignoble purpose that they are designed to achieve do a disservice not only to the quality of inter-state relations within the hemisphere of the Americas, but also to the interests, image and reputation of the USA.

We, the people of the Caribbean, would like to remind the USA that on an annual basis over the past thirty years the leaders of an overwhelmingly large number of the nations of the world have voted at the United Nations General Assembly to condemn the US embargo against Cuba as a violation of International Law and to demand its immediate termination.

We therfore demand that the government of the USA respect the near unanimous will of the international community and adhere to its obligations under the United Nations charter.

We assert, without fear of any contradiction, that the government of the USA is under a clear legal obligation to terminate its financial, economic and trade embargo against Cuba and to also remove Cuba from the US State Department's List of State Sponsors of Terrorism.

## FAREWELL TO PRESIDENT SAMUEL SHAFISHUNA DANIEL NUJOMA



#### A LIFE OF HONOUR, PUR-POSE AND SERVICE by High Commissioner Karen-Mae Hill

On Friday 28th February 2025, it was my immense honour to meet, albeit posthumously, another of Africa's leaders whose influence, legacy and sacrifice distinguished him as iconic. Last week, I met Samuel Shafishuna Daniel Nujoma, the Founding Father of Namibia. Coincidentally it was also in February 2003, that I first met Nelson Mandela and Bishop Desmond Tutu at the Centenary Cele-

brations of the Rhodes Scholarships in Cape Town, South Africa, which incidentally also signaled the launch of the Mandela-Rhodes Foundation linking the name of the imperialist to the great liberator.

President Nujoma was a man born to peasant parents with only a primary school level education yet whose life meant and means so much to Namibia, to Africa and to the African Diaspora. His death, on 8th February at age 95, signaled the end of an era as he was the last remaining giant of that legendary generation of African lead-

ers who fought against and dismantled colonial minority rule and with great determination and singleness of purpose, led their people to independence. He was the last of Africa's freedom fighters who included Julius Nyerere of Tanzania, Samora Machel of Mozambique, Robert Mugabe of Zimbabwe, Kenneth Kaunda of Zambia, Kwame Nkrumah of Ghana, Amilcar Cabral of Guinea Bissau, Oliver Tambo and Nelson Mandela of South Africa. He was our Sir Vere Cornwall Bird.

There were several moments that stood out in the various tributes that populated this moving service of remembrance and celebration. I summarised these as his work in Namibia, his work in Southern Africa and across Africa and his global impact.

For Namibians, President Nujoma was their Father. Nambia was ruled by Germany for 31 years until 1915 after which the apartheid Government of South Africa extended its rule to the country, brutally denying Namibians any dignity, voice or place in their own land. Under this system of segregated rule, education, healthcare and governance were determined by race with the majority black population being denied basic access to these rights.

It was this second-class treatment of his brothers and sisters which ignited a flame in Nujoma to resist the oppression of his people and to dedicate his life to Namibia's independence. In exile for nearly 30 years, away from his family and the comforts of home, he valiantly embraced guerilla tactics in a country whose vast and sparse terrain made this type of offensive challenging. In addition, with the help

of supporters around the world, he journeyed to the United Nations to petition for the independence of his country.

In 1973, the United Nations General Assembly recognized SWAPO, the South West Africa People's Organization, founded by Nujoma in 1966 and of which he was President, as the 'sole and authentic' representative of the people of Namibia. In 1978, through his advocacy, UN Security Council Resolution 435 was adopted, spelling out the terms for Namibia's independence. In 1990, he was elected the first President of an independent Namibia.

To the people in Namibia during those dark years, President Nujoma was their hope as they witnessed the large tanks of the colonial masters driving through their streets daily. He was their hope as they struggled under a regime that treated them as inferior. During the service on Friday, Namibians spontaneously burst into song, echoing the words often sung by their people throughout the struggle: "Sam Ouli Peni?" meaning "Sam, Where are you?".

President Nujoma's sacrifice laid the foundation for the Namibia of today where all people, male, female, black and white, live as equals. As a fierce champion of women's rights, it is fitting that Namibia's first female President, Netumbo Nandi-Ndaitwah, will take office on 21st March 2025 the same day the country will celebrate its 35th anniversary of Independence.

In his words, "Namibia is our God-given country; we have no other one but Namibia, and we have to be there. Those who are trying to stand in our way to freedom; it's obvious we will smash them to pieces. Whether Botha/Reagan want it or not, Namibia shall be free. We will seize it from the hands of the Boers."

The second aspect of the service of thanksgiving and celebration that captured my mind was the impact President Nujoma had on southern Africa and indeed, the continent of Africa. He lived in Zambia and Tanzania and from there planned and executed much of the resistance. The post-Apartheid South African Government awarded him South Africa's Order of the Companions of O.R. Tambo in Gold, for his unwavering fight against the apartheid regime which included leading Namibian forces to fight alongside South African liberation fighters.

The understanding of the need for support from his brothers and sisters across Africa and also for him to lend support to these brothers and sisters in their struggle epitomised the depth of his maturity and understanding as a leader. In his words: "When the Founding Fathers were calling for African unity, they were calling for economic emancipation, cooperation and integration of the entire African continent because they fully understood that political freedom would remain insufficient and meaningless unless it was accompanied by genuine economic independence."

The impact of President Nujoma's life and work extended to the Caribbean. The Cuban Ambassador to the United Kingdom, Her Excellency Ismaa Vargas Walter, spoke of the support President Nujoma showed for the Cuban Revolution, an interest and support that remained throughout his life, receiving the José Marp Order, the highest recognition granted by the Cuban State.

It is important that all persons of the African Diaspora mark the life of President Nujoma with reflection and with purpose. Our reflections may centre on his commitment to advancing the freedom and prosperity of his people and country at great personal sacrifice. Our understanding of purpose may centre on his actions after achieving that independence and right to self-determination he so valiantly wanted for his people. His approach was to champion the rights of women and children, to build bridges across Africa and the world and to embrace a principle of reconciliation within his own country bringing together all Namibians including white businessmen and politicians in a non-racial, non-sexist democracy.

I end these observations with the words of the anthem of the African Union which were sung at the beginning and end of the service. These words are also a call to action we here in Antigua and Barbuda and I daresay across the Caribbean can embrace. I think that the question we must ask ourselves as we reflect on a life well lived and indelibly etched in history as among the great leaders of all times is: are we honouring the legacy of our forefathers and mothers in our stewardship of their legacy to us achieved with blood, sweat and sacrifice? This ability to honour must begin with knowing our history, teaching it to our children and ensuring that its lessons are never forgotten and understood by our actions. In the words of the anthem:

Let us all unite and celebrate together The victories won for our liberation.

Let us dedicate ourselves to rise together To defend our liberty and unity.

O Sons and Daughters of Africa Flesh of the Sun and Flesh of the Sky Let us make Africa the Tree of life.

Let us all unite and sing together
To uphold the bonds that frame our
destiny. Let us dedicate ourselves to
fight together For lasting peace and
justice on the earth.

### USVI: Pastor arrested for inappropriate contact with minor

A 63-year-old pastor has been arrested and charged with multiple offences related to inappropriate contact with a minor.

Lawrence Turnbull was taken into custody on Friday, February 28, by the department's Criminal Investigation Bureau. He faces charges of child abuse, unlawful sexual contact in the second degree, obscene internet contact with a minor, harassment, and disturbance of the peace.

According to the police,



"A minor reported to law enforcement that over the past six years, her pastor Mr. Turnbull, fostered a relationship with her, presenting himself as a mentor and father figure; however Mr. Turnbull's intentions were not genuine. He exploited her trust by engaging in inappropriate physical contact with her, despite her attempts to avoid him."

Investigators report that the minor provided evidence in which Turnbull allegedly acknowledged his involvement in unwelcome sexual contact and continued to pursue her even after she expressed disinterest.

Bail has been set at \$60,000. (Loop Caribbean)

### Manchester mother charged with child trafficking

A 45-year-old Manchester mother who allegedly exploited her teen daughter to be sexually assaulted at a bar in exchange for payment for alcohol has been charged with child trafficking.

The woman was charged by investigators assigned to the Trafficking in Persons Unit of the Counter Terrorism and Organised Crime Investigations Branch (C-TOC).

The police say the charge stems from an incident involving the exploitation and sexual assault of her 13-year-old child.

Reports are that in September 2020, the woman went to a bar with her child to get alcoholic beverages, however, she was unable to pay.

According to the police, in exchange for payment for the liquor, she orchestrated the sexual assault of her child by multiple men at the bar.

Following the incident, the child fled her home.

A report was made to the Child Protection and Family Services Agency (CPFSA), which brought the matter to the attention of the unit in 2024, which launched an investigation.

On Friday, February 21, 2025, the mother of the child was arrested and charged with the offence following an interview.

The men who allegedly assaulted the teen girl are still being sought by the police.

The head of the unit, Detective Inspector Kemisha Gordon, has reiterated the Jamaica Constabulary Force's pursuit of individuals who prey on the vulnerable.

"This is a serious matter, and we were unrelenting in our efforts to bring the accused into custody. Human trafficking is a violation of human rights that destroys lives and communities. No child should be subjected to exploitation, and no perpetrator should go unpunished," said Gordon.

"This arrest underscores our commitment to the safety of children and all citizens against human trafficking," he added.

According to the Trafficking in Persons (Prevention, Suppression, and Punishment) Act, a child is defined as a person under the age of 18.

The possible maximum sentence for trafficking a child is 30 years' imprisonment.

The police say the incident remains under active investigation as detectives work to identify and apprehend the other individuals involved in the crime.

They are urging anyone with information to contact the Trafficking in Persons Unit at C-TOC at 876-967-1389, Crime Stop at 311, the National Intelligence Bureau at 811, or the police 119 emergency number. (*Jamaica Gleaner*)



It was the first time Montano had entered the competition, singing his song Pepper Vine, alongside Drupatie Ramgoonai and Lady Lava.


Neval Chatelal, a former winner, place second, while nine-time champion Rikki Jai took third place.

### At least 37 people killed and 39 wounded as two buses collide in Bolivia

At least 37 people have been killed and dozens more injured in a crash involving two buses in the western Potosi region of Bolivia, police and local authorities have said.

The accident happened on Saturday at 7am local time (11:00 GMT) on the route between the cities of Uyuni and Colchani, when one of the vehicles swerved into the oncoming lane.

Uyuni is the gateway to the Salar de Uyuni, a major tourist attraction and the world's largest salt flat at more than 10,000sq km (3,900sq miles).

"As a result of this fatal accident we have 39 people injured in four hospitals in the town of Uyuni, and 37 people have lost their lives," a spokesperson for the Departmental Police Command of Potosi told reporters.

Police personnel are working to identify people who were killed and those who were injured and hospitalised, the spokesperson added.

One of the buses was heading to Oruro, where one of the most important carnival celebrations in Latin America



is currently taking place.

Police officers removed survivors from the steel wreckage, according to images shot by Radio Uyuni, which showed several bodies covered in blankets strewn across the high Andean flatlands.

A police spokesperson said one of

the two drivers, who both survived the crash, was spotted by passengers consuming alcohol.

Bolivia's mountainous, under-maintained and little-supervised roadways are some of the deadliest in the world, killing an average of 1,400 people every year. (Al Jazeera English)

# Pope Francis, stable in hospital, thanks well-wishers for support

Pope Francis, in a stable condition as he battles pneumonia in hospital for the 17th day, met two Vatican officials on Sunday and offered thanks to well-wishers for their prayers and support in a written message.

Francis, 88, was admitted to Rome's Gemelli hospital on February 14 with respiratory problems that degenerated into double pneumonia — a serious infection in both lungs that can inflame and scar them, making it difficult to breathe.

The Vatican said on Saturday evening that the pontiff's condition had stabilised, following an "isolated" breathing crisis a day earlier.

"I would like to thank you for the prayers," Francis said in a note released by the Vatican in place of his usual Sunday prayer with pilgrims, which the pope was not able to lead for the third week running.

"I feel all your affection and closeness and ... I feel as if I am 'carried' and supported by all God's people," the message said.

Francis also met at the hospital on Sunday with Cardinal Pietro Parolin, the Vatican's number-two official, and Parolin's deputy, said Vatican spokesperson Matteo Bruni, without giving further details about the meeting.

The pope, who is known to work himself to exhaustion, has continued leading the Vatican during his hospital stay and last met Parolin and the deputy at the Gemelli on February 24.

Earlier on Sunday, the Vatican said in a one-line update that the pope had rested well overnight. A full medical update on his condition is expected on Sunday evening.

A Vatican official, who did not wish to be named because he was not authorised to discuss the pope's health, said on Sunday that Francis was eating normally, moving about his hospital room, and continuing his treatment. (NBC News)

### Lawyers sue to block Trump administration from sending 10 migrants to Guantanamo Bay



Civil rights attorneys sued the Trump administration Saturday to prevent it from transferring 10 migrants detained in the US to Guantanamo Bay, Cuba, their second legal challenge in less than a month over plans for holding up to 30,000 immigrants there for deportation.

The latest federal lawsuit so far applies only to 10 men facing transfer to the naval base in Cuba. Like a lawsuit the same attorneys filed earlier this month for access to migrants already detained there, the latest case was filed in Washington and is backed by the American Civil Liberties Union.

At least 50 migrants have been transferred already to Guantanamo Bay, and the civil rights attorneys believe the number now may be about 200. They have said it is the first time in US history that the government has detained non-citizens on civil immigration charges there. For decades, the naval base was primarily used to detain foreigners associated with the September 11, 2001, attacks.

Trump has said Guantanamo Bay, also known as "Gitmo," has space for up to 30,000 immigrants living in the US and that he plans to send "the worst" or high-risk "criminal aliens" there. The administration

has not released specific information on who is being transferred, so it is not clear what crimes they are accused of committing in the US and whether they have been convicted in court, or merely charged or arrested.

The 10 men involved in the lawsuit came to the US in 2023 or 2024. Seven are from Venezuela, and the lawsuit said two had been tortured by the Venezuelan government for their political views. A man from Afghanistan and one from Pakistan came to the US, the lawsuit said, because of threats from the Taliban. One man fled Bangladesh because he was threatened over his political party

membership, the lawsuit said.

"The purpose of this second Guantanamo lawsuit is to prevent more people from being illegally sent to this notorious prison, where the conditions have now been revealed to be inhumane," said Lee Gelernt, an ACLU attorney and lead counsel on the case. "The lawsuit is not claiming they cannot be detained in US facilities, but only that they cannot be sent to Guantanamo."

The White House and the Defense and Homeland Security departments did not immediately respond to emails Saturday seeking comment about the lawsuit. (Jamaica Gleaner)

# Chakravarthy spins India to win against NZ

DUBAI (Reuters) - Spinner Varun Chakravarthy justified his selection with a five-wicket haul on Sunday and bowled India to a 44-run victory against New Zealand in a Group A clash between two sides, who had already made the last four of the Champions Trophy.

Electing to field, New Zealand restricted India to 249 for nine with Matt Henry (five for 42) leading their superb bowling display backed up by their characteristic sharp catching.

Shreyas Iyer (79), Axar Patel (42) and Hardik Pandya (45) scored valuable runs but India still settled for a below-par total. Chakravarthy (five for 42) helped India bundle out New Zealand for 205 despite Kane Williamson's classy 81 to maintain their unbeaten run in the tournament.

India, who topped Group A, will face Australia in the first semi-final in Dubai on Tuesday. New Zealand will take on Group B leaders South Africa in the second semi-final in Lahore on Wednesday.

"New Zealand are a good team, who are playing some good cricket," India captain Rohit Sharma said. "Very important to get a

India did not start well though and slumped to 30-3 in the seventh over following Henry's two-wicket burst in the powerplay.

The seamer removed Shubman Gill lbw and dismissed Virat Kohli when Glenn Phillips took a breathtaking catch at backward point leaving the batsman crestfallen.

In between those dismissals, Rohit, who often leads India's powerplay assault, mistimed his pull shot against Kyle Jamieson and returned to pavilion.

Iyer and Axar forged a 98-run stand to steady India before both fell in quick succession. Pandya produced a run-a-ball cameo down the order but India still fell short of the 250-mark.

All-rounder Pandya returned to remove Rachin Ravindra for six in the fourth over of the New Zealand innings but Williamson kept them in the hunt.

India substituted pacer Harshit Rana with Chakravarthy and the spinner made an immediate impact in his first match of the tournament that earned him player-of-the-match award.

India's spin quarter, who went on to claim nine of the 10 New Zealand wickets, put the squeeze on in the middle overs with Chakravarthy running through the middle and lower order.

"India controlled the middle phase better," New Zealand captain Mitchell Santner said.

"It spun a bit more than we thought, and they squeezed us well with four quality spinners."
