Prime Minister the Hon. Gaston Browne has written to Bishop of St. John's-Basseterre, The Most Rev. Robert Llanos expressing condolences on the passing of the head of the Catholic Church, Pope Francis who died on Monday.

In his letter to Bishop Llanos, Prime Minister Browne noted that the death of Pope Francis is an immense loss not only to the Roman Catholic Church but to the global community. "His life was a testament to the power of humility, mercy, and unwavering commitment to the Gospel of Christ. From the moment of his election, Pope Francis captured the hearts of millions with his simplicity, his openness, and his courageous voice in defense of the marginalized, the poor, and the voiceless. His papacy was marked by a renewed call to love, justice, and dialogue across all boundaries," the country's leader wrote.

Prime Minister Browne also outlined that Pope Francis inspired a spirit of renewal and compassion within the Church, while exemplifying the virtues of listening, discernment, and servant leadership. He said that the Pope's commitment to interfaith dia-

"For us in Small Island Developing States (SIDS), Pope Francis' stance on environmental issues has been a beacon of hope as we continue our pursuit of Climate Justice. Rooted in Scripture, theology, science, and the wisdom of his predecessors, the encyclical introduces the concept of integral ecology, highlighting the deep interconnection between environmental, economic, and social systems," he said.

OECS CIP countries engage in important meetings in St John's

Antigua and Barbuda is this week hosting important meetings of the OECS countries which operate Citizenship by Investment Programmes.

Dubbed the *Caribbean Investment Summit 2025*, the meetings will bring together prime ministers from the five CIP countries – Antigua and Barbuda, St. Lucia, Dominica, Grenada and St. Kitts and Nevis – who along with their top technicians will discuss the way forward for these programmes.

Earnings from CIP programmes have helped buttress revenues from other sources and serve as their main non-tax source for revenues for all five countries. However, there are attempts by powerful entities such as the European Union and the United States to curtail or even eliminate these programmes altogether.

The Eastern Caribbean Central Bank has been spear-heading efforts to improve regulations among these countries and to strengthen cooperation and coordination among them as part of efforts to insulate them from the external threats.

As the business session of CIS25 gets underway on Wednesday, ECCB Governor Timothy Antoine will provide a regional regulatory update. This will be followed by a second update on the consultative process draft legislation to be presented by Lydia Elliot.



Prime Minister Gaston Browne will begin the afternoon session with the welcome address during which he is expected to underscore the value of the CIP programme to the government's finances and he will also speak of the efforts that Antigua and Barbuda has made to ensure that its CIP programme operates at a high level of professionalism and transparency.

During the afternoon session, the will also be a prime ministers' forum where the leaders of the five countries will speak of their countries experiences with their respective programmes.

CIS25 will continue over the next few days.

ABRSC poised to usher in the Second International Decade for People of African Descent




The Antigua and Barbuda Reparations Support Commission (ABRSC) has strategically positioned itself to lead national efforts in support of the Second International Decade for People of African Descent.

This new decade provides a critical opportunity to take meaningful and sustained action in confronting the enduring legacies of slavery and colonialism, advancing reparatory justice, and securing the full realization of human rights and freedoms for people of African descent worldwide.

For Antigua and Barbuda, Commission's work during this period will center on recognition, with an emphasis on research and documentation of resistance efforts, including the pivotal roles of women freedom fighters. Key focus areas include renaming and reimagining spaces of historical significance, as well as collaboration with the CARICOM Reparations Commission to advance implementation of the CAR-ICOM Ten-Point Plan for Reparatory Justice.

This renewed thrust follows the ABRSC's participation in the Fourth Session of the United Nations Permanent Forum on People of African Descent (PF-PAD), which took place at the UN headquarters in New York last week. The two-member delegation of Commission Chair Ambassador Dorbrene O'Marde and Commissioner Angelica O'Donoghue engaged in high-level sessions and working groups, building critical alliances to support capacity-building and the Commission's future work. At the heart of the Forum was "The Garvey Talks: Reparations Rap Session," which brought together reparation advocates from across the African Diaspora under the theme "Reparatory Justice for Africa and People of African Descent." The event featured speakers from the CARICOM Reparations Commission and the National African-American Reparations Commission, sharing insights, achievements, and strategies for collective advancement.

Another featured session, "The Role of Arts and Culture in Acknowledging the Legacy of the Transatlantic Slave Trade and Supporting Afro-Descendant Communities," explored how



A powerful highlight of the Forum was its closing session, which focused on Haiti's Independence Debt — 200 Years Later. The session marked two centuries since France imposed an "independence debt" on Haiti, the world's first Black republic, underscoring Haiti's central role in the global history of anti-colonialism, abolition, and African self-determination.

Antigua and Barbuda's Permanent Representative to the United Nations Ambassador Walton Webson delivered a compelling address on behalf of CARICOM

stating

"The world owes a moral and historical debt to Haiti. The success of its revolution further emboldened the ancestors in the Caribbean. Haiti stood first, and for that it stood alone. Now, centuries later, we must not leave Haiti to stand alone again. This is a time for reparations. A time for justice. A time to restore Haiti — not just in words, but through concrete international action. France must account. The world must acknowledge. And we - people of African descent across the Caribbean and beyond must unite in defense of Haiti's future."

Moderated by H.E. Martin Kimani, Chair of the Permanent Forum, the discussion illuminated Haiti's historical significance and the urgency of supporting its restoration as a vital component of the Second International Decade for People of African Descent.

The Antigua and Barbuda Reparations Support Commission reaffirms its unwavering commitment to public education, community engagement, and projects that advance the global movement for reparatory justice.

CARICOM Private Sector Organization (CPSO), Chairman, Gervase Warner, Pleased with Exemption for Caribbean from USTR Proposed Fees regarding 'China's Targeting of the Maritime, Logistics and Shipbuilding Sectors'

Port of Spain, Trinidad and Tobago - April 19, 2025, On behalf of the regional private sector, the CPSO is grateful for the 'USTR Determination', on 'China-built vessels', published on April 17th, 2025. This Determination, in effect, exempts Caribbean Shipping from the high port fees on China-built vessels, originally proposed by the United States Trade Representative (USTR). As originally proposed by the USTR, these high port fees, in excess of US \$1,000,00000 for each US Port call, would have increased the cost of shipping between the Caribbean and the United States, with crippling consequences for inflation, shortages, delays and other 'supply-chain' disruptions for the people and the economies of CARICOM and the Caribbean.

The CPSO appreciates the 'USTR Determination' and recognizes that this tremendously beneficial outcome is the product of leadership and collaboration among several key private sector stakeholders and the governments of the CARICOM states. We make particular mention, in this regard, of our CARICOM Heads of Government, chaired by Prime Minister Mia Amor Mottley. The priority attention given to this issue by the Heads of Government, evidenced by their fervent advocacy at the meeting with U.S. Secretary of State Marco Rubio and their communication to President Donald Trump under the pen of Prime Minister Mottley, has been a significant driver of this positive outcome.

The technical leadership and commitment of our CPSO Secretariat, led by one of CARICOM's most competent Economist, Dr Patrick Antoine and his team, and their submissions and oral testimony was a major determinant of the positive USTR outcome. The coordination and advocacy of the CPSO was demonstrated by the record setting 700 plus attendees from multiple industries and countries in the Caribbean on the first coordination call to deal with the issue on March 18th, 2025. Indeed, the two community-wide regional consultations subsequently held to define and refine the regional private sector position for submission to the USTR, were proud moments for the private sector, symbolizing the enormous possibilities for successful outcomes inherent in collective action in pursuit of common goals.

The CPSO credits the openness and transparency of the USTR and the USTR Panel, comprising various representative from other US Government Departments. The USTR and its Panel were receptive to the issues peculiar to the Caribbean, introduced via the submissions made by and testimony of the CPSO and other Caribbean partners.

The partnership and collaboration with Tropical Shipping's CEO Tim Martin and Jennifer Nugent-Hill, a Director on the CPSO-United States Business Council Executive (CPSO-USBC), has been invaluable. We publicly acknowledge the collaboration with Caribbean Hotel and Tourism Association (CHTA), Caribbean

Tourism Organisation (CTO), Seaboard Marine, Atlantic Council, Caribbean Shipping Association (CSA), Mr. Darwin Telemaque, CEO of the Antigua Port Authority, Mr. Gerard Bergasse, Regional Manager Tropical Shipping, and the Port Management Association of the Caribbean (PMAC), all of which/whom contributed to the USTR positive determination for the Caribbean.

The positive outcome was facilitated by the seamless coordination efforts of Ambassador Wayne Mc Cook, Assistant Secretary General - CARICOM Single Market and Trade and Dr. Wendell Samuel, CARICOM Assistant Secretary-General (Ag), Economic Integration, Innovation and Development.

We were humbled by the contribution of Congresswoman Stacey Plaskett, Representative of United States Virgin Islands, who participated, at short notice, for the entire duration of the briefing meeting with the CPSO, Tropical Shipping and CARICOM Ambassadors. The strategic timing of the questions posed to the Hearings of the U.S. Ways and Means Committee, by Congresswoman Plaskett, was a significant contributor to the USTR outcome.

Profound appreciation is also extended to the Caucus of CARICOM Ambassadors accredited to the United States for their support.

The CPSO on behalf of the regional private sector advocated for:

- (i) an exemption for 'short Sea' Shipping, defined as vessels plying the route between **2,750** *Nautical Miles* of the CARICOM/Caribbean and the Continental United States the USTR Determination recommended the exemption for **2,000** *Nautical Miles* (acceptable to CPSO);
- (ii) an exemption for vessels carrying less than 55,000 deadweight tons and less than 4,999 TEU's USTR Determination recommended the exemption for 55,000 deadweight tons and less than 4,000 TEUs (acceptable to CPSO);
- (iii) an exemption for specialized cargo, such as energy and chemical products which may exceed 55,000 deadweight tons USTR Determination proposed exemptions for individual bulk capacity of 80,000 deadweight tons; and exemptions for specialized or special purpose-built vessels for the transport of chemicals substances in bulk or liquid forms (acceptable to CPSO).

The campaign by the regional private sector and the Community, would have been far more challenging without the overwhelming support of the regional print and electronic media. As Chairman of the CPSO, I convey heartfelt thanks on behalf of the Executive Committee and the 5,500 plus members of the Organization. We at the CPSO anticipate your continued support, even as we direct our focus to other matters critical to the Community, such as the impact of US tariffs on CARICOM trade. Dr. Antoine and his team at the CPSO are also playing an important strategic role with the CARICOM Secretariat on this issue..

To anyone I may have neglected to name and to the People of CARICOM and the Caribbean, the CPSO extends an enormous thank you.

The CPSO is honoured to have been pressed into the service of the people of the Community on such a significant issue, at such a critical time.

John Hughes duo committed to the September Assizes for trial

Two men who face several charges related to the illegal possession of firearm and ammunition as well as the illegal of possession of cannabis have been committed to stand trial at the September sitting of the Assize Court.

The men – Zamir Amir O'Garro and Hewette Sean Weathered of John Hughes – jointly appeared before Senior Magistrate Ngaio Emanuel in the Magistrate's Court on Tuesday.

Weathered faces a separate charge of armed robbery allegedly committed on August 19, 2024, where he is accused of robbing the Guang Yuan Supermarket of \$700.00 in cash along with a cash pan valued at \$700.00 for a total of \$1,400.00.

Additionally, Weathered and O'Garro are jointly charged with the illegal possession of a .380 pistol and 4 rounds of ammunition without either being the holder of a firearms licence. The also face the charge of possessing 113 grams of cannabis as well as possession with intent to sell contrary to

the Misuse of Drugs Act.

They men are also charged with the robbery of Andy Benjamin of one silver bracelet valued at \$660.00, \$400.00 in cash as well as US\$5.00. These alleged acts violate the Larceny Act. These acts allegedly happened in March of last year.

After listening to testimony from multiple witnesses and a perusal of several exhibits, Senior Magistrate Emanuel committed the pair to stand trial at the Criminal Assize Court in September.

Police have arrested and jointly charged two men in connection with a recent break-in at the TINY Supermarket

The accused, 24-year-old Jahbal Grant of Parham and 29-year-old Kamory Miller of Hatton, are facing charges of Breaking and Larceny after allegedly unlawfully entering the business premises and stealing several cartons of cigarettes, a pack of Blunt, and two boxes of Raw rolling papers. They were further charged with Resisting Arrest and Battery on Police.

The incident took place in the early hours of Sunday, April 20. Police responded promptly to a report of suspicious activity at the location and found both suspects hiding inside the supermarket. They were arrested and taken into custody.

Both men were expected to make their first appearance before the St. John's Magistrate's Court on Tuesday.

The Royal Police Force of Antigua and Barbuda continues to urge business owners to strengthen security measures and encourages the public to report any suspicious activity to the nearest police station or by calling 911.


Potters man hospitalized with life-threatening injuries

Antigua Sailing Week 2025: A Reflection of Global Maritime Trends

As another successful Antigua Classics Regatta draws to a close, attention shifts to the more contemporary Antigua Sailing Week (ASW) 2025, a cornerstone of the Caribbean's sailing calendar. Mirroring global trends, the event is experiencing notable shifts that reflect broader transformations within the maritime industry, encompassing participation dynamics, economic factors, technological advancements, and evolving consumer preferences.

Evolving Participation Patterns

Traditionally, ASW attracts over 100 yachts annually, ranging from high-tech racing vessels to performance cruisers. However, as of early April 2025, only 54 entries have been confirmed, with expectations of increased registrations as the event approaches.

Major events "Reggae in the Park," a signature event during ASW, will not be taking place in 2025. This marks a significant departure from previous years, where the event featured performances by renowned artists such as Sanchez and Damian Marley.

The decline in early participation is not an isolated phenomenon. It may be attributed to factors such as economic uncertainties and shifting sailing schedules. Yachts are departing the Caribbean earlier to participate in the Mediterranean sailing season, which begins in late spring, affecting the availability of vessels for Caribbean events like ASW. Fewer vessels are sailing in an increasing number of regattas in the region in recent years. In 2005, 750 boats were racing across the region. In 2024 across the Caribbean that number decreased to 500 boats, attending double the number of events.

Over the past two decades, Caribbean sailing events have witnessed a significant decline in participation, with entries reducing by approximately 40%. This downturn has been influenced particularly in the Caribbean by multiple factors, including the devastating impacts of Hurricanes Irma and Maria, the global COVID-19 pandemic, and escalating costs associated with shipping and logistics. These challenges have made it increasingly difficult for international participants to transport their vessels to the region, thereby affecting event turnout. Concurrently, there has been a notable rise in the number of cruising boats and novice sailors, a trend accelerated by the pandemic as individuals sought alternative lifestyles and embraced multihull cruising as a means to escape conventional routines. This shift reflects

a broader transformation within the sailing community, emphasizing leisure and exploration over competitive racing

Those boats that grace the waters are changing their routines. Many left English Harbour Marinas as early as the end of March, leaving the area uncharacteristically quiet. A restaurateur in Falmouth expressed anxiety: "we usually rely on the last few weeks of the season to see us through the summer, but this year, for us, the season has already ended."

This trend aligns with a broader global pattern. According to SuperYacht Times, the total sales of sailing yachts over 24 meters declined by 51% in 2023 compared to the previous year, indicating a significant downturn in the market.

Economic Influences on the Sailing Sector

The sailing industry is sensitive to global economic fluctuations and trends in the wider maritime industry. Interest rate variations and changes in consumer confidence can significantly impact purchasing decisions for sailboats and yachts.

The implementation of protectionist trade policies under President Donald Trump's administration has introduced further significant challenges for the global maritime industry, affecting all elements, including the sailing and yachting industry. Announced on April 2, 2025, these measures include a universal 10% tariff on all imports, with additional targeted tariffs: 20% on European Union goods, 32% on Taiwanese products, and a substantial 54% on Chinese imports.

These tariffs have disrupted the global supply chain, resulting in higher prices for imported materials and components essential to boat manufacturing and maintenance. This has led to delays in production, increased costs for

consumers, and a potential decline in participation in sailing events. The uncertainty surrounding these trade policies has also caused hesitation among investors and stakeholders within the sailing community.

In a climate of economic uncertainty, discretionary spending on luxury items such as yachts and sailing holidays is often the first to be curtailed during economic downturns. The Royal Yachting Association (RYA) has noted that grassroots sailing clubs are facing difficult decisions due to rising operational costs, including energy and labour, which have outpaced general inflation. A recent RYA survey revealed that 75% of clubs anticipate financial impacts from rising energy costs, with 64% reporting increased energy expenses over the past year.

Impact of Geopolitical Tensions

The seizure of Russian-owned superyachts has had a profound impact on the global maritime industry, reflecting the broader geopolitical tensions stemming from the Russia-Ukraine conflict. These high-profile actions have not only disrupted the luxury yacht market but have also led to complex legal disputes and significant financial implications.

While the Alfa Nero remains mired in controversy, it is not an isolated case. Among the most notable is the Amadea, a 348-foot superyacht valued at approximately \$300 million. Seized by U.S. authorities in Fiji in 2022, the vessel has been at the center of ongoing legal proceedings, with a U.S. judge recently ruling against a claim of ownership by a former Rosneft executive, thereby advancing the U.S. government's efforts to forfeit and potentially auction the yacht.

Similarly, the Tango in Spain, Phi in the UK, and Dilbar in Germany are among the seized and sanctioned yachts. These seizures have not only removed significant assets from the global yacht market but have also led to substantial maintenance costs for the detaining authorities and have sparked



intricate legal battles over ownership and the enforcement of international sanctions. Markets like Antigua that thrived on visiting Russian yachts are facing significant reductions in income. The sanctions have also created legal and logistical challenges, with many seized yachts now in a state of limbo, unclear ownership, and mounting maintenance costs, leading to complex legal disputes over their future.

Technological Advancements and Sustainability

Innovations in sailing technology are reshaping the industry. Advancements include the integration of artificial intelligence for navigation, development of solar and wind-powered boats, and the use of sustainable materials in boat manufacturing. These developments align with a growing emphasis on environmental sustainability within the sector.

The revival of sail-powered cargo ships, such as the Grain de Sail II, underscores a shift towards environmentally friendly transportation methods. Yann Jourdan, captain of the Grain de Sail II, emphasizes the environmental benefits of this shift:

"It's our job to prove that it's possible. For me, it's just logical, you know? Like the petrol is limited quantity and the wind is not."

These efforts reflect a broader industry trend towards sustainable practic-

es, despite the challenges and reduced earnings associated with such transitions.

Future Outlook

Despite current challenges, the sailing industry exhibits resilience and adaptability. The Global Maritime Trends 2050 report by Economist Impact discusses the transformative forces shaping the maritime industry:

"The maritime industry will transform over the coming decades, driven by technology adoption, the climate agenda, and intensifying geopolitical and macroeconomic shifts."

Organizers of events like ASW are exploring strategies to attract a broader audience, including diversifying event offerings and enhancing marketing efforts. The industry's focus on technological innovation and sustainability positions it well for continued growth and evolution in the coming years.

Antigua Sailing Week 2025 serves as a reflection of the broader transformations within the global maritime industry. The convergence of economic factors, technological advancements, and sustainability initiatives is reshaping the landscape.

Whatever the future brings, as Alison Sly-Adams, organiser of ASW says quite categorically, "Antigua has always been the 'Heart of Caribbean yachting'."

ILO's Director-General wraps first official visit to Guyana



Director-General of the International Labour Organization (ILO), Gilbert F. Houngbo, has wrapped up a significant official visit to Guyana, during which he took part in the 13th ILO Meeting of Caribbean Labour Ministers. This visit marks Mr. Houngbo's inaugural trip to Guyana in his current capacity, shared the ILO via press statement.

The two-day event, themed "Decent Work for Resilience: Securing the Future of Caribbean Labour," gathered Labour Ministers, senior officials, and various stakeholders from across the Caribbean, including Dominica's Minister of State, Daren Pinard, to engage in discussions about regional matters, enhance collaboration, and outline a strategy for building a more equitable and sustainable labour environment.

During his keynote speech at the opening ceremony on April 7, 2025, Houngbo emphasized the ILO's robust partnership with the Caribbean region. "The discussions here at this 13th

Caribbean Labour Ministers' Meeting will help us identify the priorities we must set and the strategies we can adopt to effectively renew a new Social Contract as we prepare for the Second World Social Summit," he stated. "I will stand with the Caribbean in ensuring that the realities of the subregion are prioritized within the ILO global agenda and beyond."

A significant moment of the visit was the signing of Guyana's third Decent Work Country Programme (DWCP). This tripartite agreement, witnessed by Mr. Houngbo, is part of Guyana's aim to "promote decent work through employment creation, social protection, rights at work, and social dialogue", according to the ILO statement. It was signed by representatives from the government, employers, and labour organizations, with ILO support.

On April 8, Mr. Houngbo engaged in high-level courtesy meetings with His Excellency Dr. Mohamed Irfaan Ali, President of the Co-operative Republic of Guyana, and Dr. Carla Barnett, Secretary-General of the Caribbean Community (CARICOM). These discussions reportedly emphasized mutual priorities and reaffirmed the ILO's commitment to addressing urgent regional and global issues, including climate change, labour migration, digital transformation, and the necessity for a just transition.

Throughout his visit, reports are that the Director-General's interactions underscored the ILO's commitment to fostering regional cooperation, enhancing social dialogue, and ensuring that Caribbean viewpoints are adequately represented in global policy discussions.

"As the region prepares for the 113th International Labour Conference and the Second World Social Summit, this meeting serves as a crucial step in aligning strategies and amplifying the Caribbean's voice on the world stage", said the ILO. (DNO)

Dawn Francis, sustainable agriculture and organic farming advocate and a model for small farmers in her native Dominica, is named an IICA Leader of Rurality of the Americas



Dawn Francis left a job in the corporate world to pursue her true passion, agriculture. She rolled up her sleeves and got to work, even as she remained mindful of her neighbors operating other family farms. Eventually, she was able to arrange for technical cooperation in the district and even established her own organization.

The Inter-American Institute for Cooperation on Agriculture (IICA) has named this Caribbean rural farmer as one of its "Leaders of Rurality of the Americas", and as such she will receive the "Soul of Rurality" award. This organization that specializes in agricultural and rural development created the award to turn the spotlight on men and women who are leaving their mark and making a difference in rural areas of the Americas.

With a warm smile that never fades throughout the interview, Dawn tells us that "[she] worked in a bank for twenty years". After a decade and a half as a supervisor in a branch of a well-known international bank in Rouseau, the country's capital, she confessed that, "I realized that although I loved to help people, I no longer enjoyed the

corporate world".

"I had a dream..."—she continues—
"a dream that I was in a forest, and I looked so content and happy". In the dream, Dawn had a "secret garden" in the forest.

That moment prompted a change in the direction of Francis' life, which began with her learning about sustainability and organic agriculture, in particular through programs organized by international agencies.

One of these projects took her to Wa Samaki Ecosystems in Freeport, Trinidad and Tobago, where she was introduced to a practice that enticed her: permaculture. Permaculture is an agricultural design system in which production areas work in close harmony with the surrounding natural environment.

"When I learned about permaculture, I realized that I was in the right sector. I felt that I could fulfill my passion, and I discovered my reason for being on Earth", Francis recalls.

Subsequently, thanks to an IICA program, she traveled to Mexico to pursue an earth sciences course, which she describes as "a marvelous experience". During that visit, the Dominican farmer recalls that, "the thing that struck me the most was when I spent time with a farming family that consumed only food grown in their own fields".

These practices became a goal for Francis, a type of sustainable criterion that stipulates that at least eighty percent of what is consumed in rural areas, should come from the land itself.

Mexico left her with unforgettable memories, such as sitting at nights with the rural women and watching them knit together. "For me, these moments represented peace and tranquility", she reflects.

On returning to Dominica after her educational tour, Dawn found a two-and-a-half-acre farm waiting for her – a gift from her mother. She was able to establish "an adorable family farm, D-Smart Farm" on a piece of land "where [she has] been practicing organic agriculture for more than twenty years".

She also established a biodiversity center to teach primary and secondary students about agriculture and the environment. The children enjoyed the field activities, and for Dawn, these were moments of fun on the farm.

The situation changed in September 2017, when a devastating force visited the Caribbean. Hurricane Maria, a tropical cyclone, ravaged Dominica, the U.S. Virgin Islands and Puerto Rico, leaving hundreds of deaths and immense material damage in its wake. Experts consider it to be the deadliest Atlantic hurricane since Jeanne in 2004

"Everything was damaged", says Francis. Maria "broke our hearts and I am still emotional when I remember it".

However, not even this terrible tropical cycle could extinguish Dawn's dream. "I am resilient; I am a resilient black woman", says the farmer. In fact, she insists that, "Being close to the land makes you strong and resistant". Furthermore, watching the forest renew itself after the hurricane, "made me stronger and my family and myself began to rebuild" the farm, which is located in the village of Pont Cassé.

Francis has a solid relationship with multilateral institutions and in 2011 even formed her own organization, EcoBalance Inc. Its Board of Directors

is one hundred percent female, and it is positioning itself a conduit to nurture the future of Dominica "through environmentally conscious and purposeful initiatives that aim to achieve green transformation". Through this effort, they are "Uniting for a Greener Tomorrow: Inspiring Hope, Catalyzing Progress".

Thanks to funds mobilized through EcoBalance, Dawn and her partners have organized training programs for farmers and implemented plans to acquire equipment for the region. One of these programs, funded by the Government of New Zealand, enabled them to introduce poultry rearing to a dozen farms in the area, supplying the farmers with feed for the chickens, offering management classes and sharing agribusiness secrets.

By the end of the project, Francis reports that the participating farmers "were already selling eggs". More importantly, they were using the manure from the birds to cultivate their vegetables, thereby applying less inorganic fertilizer.

Dawn shares her view that the results demonstrate that, "Every venture led by women succeeds, which is something that would also apply to the field of politics". If there were more women leaders, she believes that "the world would be a different place, a better place".

According to Francis, the participants in the agricultural training sessions in Dominica "are more likely than not women". She believes that this is because "we are the ones that absorb knowledge; we are strong".

She is quick to point out that, "This does not mean that men have no strength, but women make things materialize: "we come together, collaborate and work to ensure that our plans become reality".

When asked about the involvement of upcoming generations in agricultural production, Francis is realistic. First, she admits that young people "do not want to cultivate crops in the way that we have been doing it, with such intense and hard work. They don't want to do this".

Yet, all hope is not lost. Through a program sponsored by the Caribbean Policy Development Centre, a course on agricultural hydroponics was launched in Dominica. As organizers, "we were expecting about twenty participants, but eighty people expressed an in-


terest, with half of them being under thirty-five years of age". In the end, fifty-five students registered in the course – individuals with an interest in growing plants without the use of soil, using instead a solution of water enriched with nutrients.

Dawn realized that "young people may have an interest in agriculture", but using alternatives such as hydroponics, rather than traditional, intensely physical methods.

Potential producers in rural areas in the future "are looking for something easier and faster, which is not physically intensive" and which can quickly generate income".

In ending the conversation, Dawn Francis launched an appeal to multilateral institutions and development agencies. "Farmers in countries like Dominica need access to financing. They must have resources to tackle problems, such as roads in poor condition, the lack of manual labor and limited access to equipment.

Without these incentives, producers will only advance "slowly" without daring to take risks. "If big steps do not yield economic benefits relatively quickly, they won't take them". (DNO)

Vatican schedules funeral of Pope Francis for Saturday

The funeral of Pope Francis will be held on Saturday, the Vatican has announced.

The funeral ceremony will take place on Saturday at 10:00am (08:00 GMT) it was announced on Tuesday, shortly after cardinals began a meeting to prepare the next steps. World leaders are expected to attend the ceremony in advance of a conclave to elect the next head of the Catholic Church.

All cardinals currently in Rome were summoned to the meeting to outline the funeral arrangements and start preparations for the succession.

The funeral ceremony will take place in front of St Peter's Basilica, with the dean of the College of Cardinals, Giovanni Battista Re, leading the service. The pope's body will then be taken to the Basilica of St Mary Major in Rome and laid to rest.

As well as agreeing the timing of the funeral, the cardinals decreed that the body of the pontiff will be taken to St Peter's Basilica on Wednesday morning at 07:00 GMT for public viewing. Francis is currently laid out



in a coffin in the chapel of the Santa Marta residence where he lived during his 12-year papacy.

The Vatican said in a statement that Cardinal Kevin Joseph Farrell, the camerlengo of the Holy Roman Church, will preside over a prayer, after which the coffin will undertake a short itinerary that will culminate with entering the Basilica through its central door.

The camerlengo will then preside over a liturgy at the altar, at the end of which it will be possible for the public to begin paying their respects to Pope Francis's body.

Francis died aged 88 on Monday following a stroke and cardiac arrest, the Vatican said, bringing an end to a 12-year papacy defined by advocacy for the marginalised and at times clashes with traditionalist forces in the Church.

Having spent five weeks in hospital earlier this year with double pneumonia, the pope had returned to his modest Casa Santa Marta residence nearly a month ago and appeared to be on the mend. He had even addressed worshippers in St Peter's Square on Easter Sunday.

His passing has triggered time-honoured Vatican protocols, including the ceremonial destruction of the Fisherman's Ring and papal seal, which symbolises the end of his papal authority.

World leaders and royals,

including United States President Donald Trump and President Javier Milei of Argentina, the pontiff's native country, are preparing to attend the funeral ceremony.

Breaking with tradition, Francis wished to be buried at the Basilica of Saint Mary Major, which is outside the Vatican and home to his favourite icon of the Virgin Mary, rather than at St Peter's Basilica.

As the announcements regarding the funeral and public viewing of the body were made, the Vatican also published photos and a video of Pope Francis in his open coffin, dressed in a red robe with the papal mitre on his head and a rosary in his hand.

The Church is now preparing for a conclave, expected to begin after May 6, where 135 cardinal electors, nearly 80 percent of whom were appointed by Francis, will vote in secret to choose his successor.

With no clear favourite emerging, cardinals will use General Congregations in the coming days to reflect on the Church's future direction. (Al Jazeera English)

US and global economic outlook deteriorates in Trump trade war, IMF says



The United States and global economies will likely slow significantly in the wake of President Donald Trump's tariffs and the uncertainty they have created, the International Monetary Fund said Tuesday.

The IMF said that the global economy will grow just 2.8% this year, down from its forecast in January of 3.3%, according to its latest World Economic Outlook.

And in 2026, global growth will be 3%, the fund predicts, also below its previous 3.3% estimate.

And the Fund sees the world's two largest economies, China and the United States, weakening: US economic growth will come in at just 1.8% this year, down sharply from its previous forecast of 2.7% and a full percentage point below its 2024 expansion.

The IMF doesn't expect a US recession, though it has raised its odds of one this year from 25% to about 40%. China is now projected to expand 4% this year and next, down roughly half a point from its previous forecasts.

"We are entering a new era," Pierre-Olivier Gourinchas, chief economist at the IMF, said.

"This global economic system that has operated for the last eighty years is being reset."

The forecasts underscore the widespread impact of both the tariffs and the uncertainty they have created. Every country in the world is affected, the IMF said, by hikes in US import taxes that have now lifted average US duties to about 25%, the highest in a century.

The forecasts are largely in line with many private-sector economists' expectations, though some do fear a recession is increasingly likely.

Economists at JPMorgan say the

chances of a US recession are now 60%.

The Federal Reserve has also forecast that growth will weaken this year, to 1.7%

The IMF is a 191-nation lending organization that works to promote economic growth and financial stability and to reduce global poverty.

Gourinchas said that the heightened uncertainty around the import taxes led the IMF to take the unusual step of preparing several different scenarios for future growth. Its forecasts were finalized April 4, after the Trump administration announced sweeping tariffs on nearly 60 countries along with nearly-universal 10% duties.

Those duties were paused April 9 for 90 days.

Gourinchas said the pause didn't substantially change the IMF's forecasts because the US and China have imposed such steep tariffs on each other since then. (Jamaica Gleaner)

Israeli spy chief accuses Netanyahu of demanding illegal operations



Israel's spy chief has accused Prime Minister Benjamin Netanyahu of trying to fire him for his refusal to commit illegal acts aimed at protecting the leader's personal and political interests.

Ronen Bar, chief of Shin Bet, Israel's domestic intelligence service, made the assertion in an affidavit to the Supreme Court on Monday. Netanyahu's move last month to dismiss Bar was suspended by the court pending an investigation, and the ensuing tussle has provoked large protests, with crowds accusing the prime minister of endangering democracy.

Netanyahu said he would sack the spy chief due to a breakdown in trust, supposedly linked to Hamas's attack in October 2023 that led to the Gaza war.

However, Bar said Netanyahu's decision was motivated by a series of events between November 2024 and February 2025.

In the unclassified part of the court submission, Bar said Netanyahu had told him "on more than one occasion" that he expected Shin Bet to take action against Israelis involved in antigovernment demonstrations, "with a particular focus on monitoring the protests' financial backers".

The Shin Bet head also said he had refused to sign off on a security request aimed at relieving Netanyahu from testifying at an ongoing corruption trial in which he faces charges of bribery, fraud and breach of public trust.

Netanyahu's bid to oust Bar came as Shin Bet was investigating financial ties between the prime minister's office and Qatar, a key mediator in the Gaza war. Critics say the firing is tainted by a conflict of interest and was meant to derail that inquiry.

Shin Bet also happened to be carrying out an inquiry based on suspicion that the government had ignored warnings in advance of Hamas's attack on southern Israel on October 7, 2023, when the armed Palestinian group killed more than 1,100 people and took about 250 captive.

More than 50 of them remain in Gaza. Netanyahu and the hardline Zionist parties that support his gov-

ernment have faced harsh criticism for their failure to agree to a ceasefire and the return of the remaining prisoners.

Israel's onslaught on Gaza has killed more than 51,000 people, according to the enclave's Ministry of Health.

Netanyahu's office has said Bar's affidavit was "full of lies", and later responded to several of his claims, stating that he had "failed miserably" when Hamas attacked Israel.

It also denied that the move to sack Bar was aimed at thwarting the so-called "Qatargate" investigation.

"The dismissal was not intended to prevent the investigation. Rather, the investigation was intended to prevent the dismissal," it said.

Netanyahu's move to sack Bar was suspended by the Supreme Court after political watchdogs and opposition lawmakers argued the dismissal was unlawful.

The bid to unseat the spy chief and the continuing fight have further fuelled the protests over the government's failure to secure the captives from Gaza.

Bar has accepted Shin Bet's failure to stop Hamas's attack, saying on Monday that he would "soon announce the date of my resignation". (Al Jazeera English)

Bravos Wholesale and Distributors Rockets beat Police by 19 runs at the Dredgers playing field.


Rockets made 100 for seven off their 15 overs. Denise Parker and Kushana David each made 20, and Chemique Jarvis Benjamin scored 17.

Barbados continue to dominate CWI Under-15 Championship

Defending champions Barbados have all but secured a spot in the final of the West Indies Rising Stars Under-15 Championship, thanks to a 140-run win over the Windward Islands in round four at the Antigua Recreation Ground (ARG) on Monday.

Kelani Clarke got the first century of the tournament with 100 off 121 balls, including 11 fours and two sixes, as Barbados posted 248 all out from 48.1 overs after winning the toss.

Rajeev Parsooram (34) and Asher Branford (33 not out) also made meaningful contributions as Jershaun Joseph led the way with the ball with four for 53 from nine overs for the Windwards.

Captain Justin Parris then picked up three for 29 in 9.3

overs, while Zarell Harding took two for six in five overs to help bowl out the Windwards for 108 in 35.3 overs.

Joseph completed a solid all-round performance with a top score of 26 off 42 balls.

Elsewhere, Guyana got their third win in four matches with a dominant six-wicket victory over the Leeward Islands at the Sir Vivian Richards Stadium.

Guyana first dismissed the Leewards for 77 in 24.4 overs after the latter won the toss and chose to take first strike.

Reyaz Latif took a brilliant four for seven in six overs of leg spin, and was well supported by pacers Patrice Fraser (three for 21) and Rafell McKenzie (two for 21).


Phillip then hit a crucial 61 not out off 109 balls to steer the young Trinidadians to victory at 134 for six halfway through the 41st

Success for Antiguan swimmers at CARIFTA Aquatics Championships





Antigua and Barbuda won seven medals on the final night to finish with an overall total of 13 medals at the 38th CARIFTA Aquatics Championships, which concluded at the National Aquatic Centre in Couva, Trinidad and Tobago, on Monday evening.

The standout performer for the Antigua and Barbuda swimmers was Alessandro Bazzoni, who dominated the boys 11-12 age group, winning five medals.

Bazzoni clocked a personal best to win two of his medals on the final night. He won the gold in the 200-meter butterfly and claimed silver in the 200-meter individual medley final.

Earlier in the three-day regional meet, Bazzoni also won gold in the 400-meter individual medley, silver in the 200-meter freestyle, and a bronze in the 100-meter butterfly final.

Ellie Shaw won her second of two medals when she captured gold in the 50-meter breaststroke in the girls 15-17 age-group category. Shaw also captured a silver medal in the

Madison MacMillan won her only medal of the games when she captured silver with a second-place finish in the 1500-meter freestyle in the girls 15-17 division.

Ethan Stubbs-Green picked up a silver medal with a second-place finish in the final of the 200-meter butterfly in the boys 15-17 age group. Stubbs-Green had earlier won a bronze in the 100-meter butterfly final.

Anya DeGannes secured her second medal on the

last day as well, winning a silver in the 200-meter butterfly final in the girls 13-14 category.

DeGannes produced a personal best and set a national age-group record in capturing a bronze medal in the final of the 400-meter individual medley.

Aunjelique Liddie won the other medal for Antigua and Barbuda on the final night, producing a personal best and setting a new national record in winning bronze in the final of the 100-meter freestyle final in the girls 15-17 category.
