#### Antigua and Barbuda included in Trump's tariffs net



Antigua and Barbuda has been included in the latest tariffs announced by US President Donald Trump on Wednesday.

Point Express newspaper sought clarification on the matter from the country's Ambassador to the United States, Sir Ronald Sanders. He said Antigua and Barbuda and all of the Eastern Caribbean countries are to pay 10 percent tariff on goods that are exported to the United States.

"I suspect it relates to the Common External Tariff (CET) that we all apply. However, Antigua and Barbuda exports very little into the US market. Therefore, the 10% tariffs on our exports to the US will have a negligible effect on our economy and none on our revenues. It simply means that such goods as we export will be more-costly to the US consumer who will pay the tariff charge.

"We have always had a trade deficit with the US because we import almost 80 percent of all our imports from the US, and we export very little," Sir Ron explained.





#### **Ministry of Finance provides monthly update to the Cabinet**



The monthly update that the Ministry of Finance provides to the Cabinet detailing the state of the nation's finances took place on Wednesday.

This as a 10-member team from the ministry - to include the Financial Secretary, the Accountant General, the Minister of State in the Ministry, the Deputy Head of the Inland Revenue Department, the Budget Director and others— went to the Cabinet to provide a picture of the country's finances during the month just ended and for the first quarter of 2025.

"The state of Government's finances is improving and clearly shows that the economy continues to expand, despite the threats emanating from many quarters including the United States. The uncertain policy decisions, regarding tariffs, have proven to be harmful to the stock markets within the Western Hemisphere. Other pronouncements have caused uncertainty," according to a source familiar with the discussion.

During the discussion, the Budget Director pointed out that overtime payments owed to Government workers is now classified as 'salaries', as ordered by the Cabinet, causing overtime to be paid simultaneously with salaries. In the month just ended, overtime payments exceeded \$500,000 dollars. Payments of gratuities is also high on the agenda of the Treasury, almost \$10 million dollars of gratuities have been paid, in the month of January; \$20 million dollars are still outstanding.

Cabinet learnt that Corporation Tax, ABST, Education Levy, Customs Duty, and other revenue sources have been expanding. The Tourism Guest Levy is still being under-reported by hotels with 100% occupancy. The Inland Revenue Department is set to prepare a guestimate of amounts that have not been collected, and to pursue those taxpayers who have failed to reach the estimated amounts.

#### Alfa Nero sale documents to be laid before parliament



#### The government is taking a decisive step to provide transparency in the handling of the sale of the Alfa Nero superyacht and how the proceeds from the sale were disposed.

At Wednesday's meeting of the Cabinet, members took a decision to have the Prime Minister, at the next sitting of Parliament, place all documents relating to the sale of the Alfa Nero Yacht in that public domain.

A government spokesman said although the documents have been published in the newspaper as of Wednesday 2<sup>nd</sup> April 2025, and on the Government website, there are still political operatives who continue to pedal the fictitious and false claim of a Russian citizen, seeking to harm Government officials in Antigua, has cruelly propagated, by filings in a US Federal Court.

The government has provided the documents detailing what the money from the sale was used for, yet there has been a constant, unsubstantiated drumbeat of accusations from the Russian citizen and elements within the opposition party claiming misappropriation of funds from the sale.





#### **Blue Ocean makes its case**

The principals of Blue Ocean dredging company were in attendance at Wednesday's Cabinet meeting where they were requesting additional funds to enable them to complete the task of dredging both the Crabbes Harbour and the S. John's Harbour.

Cabinet sources say the principals were invited to address the scale of the dredging that is taking place at Crabbes and in the St. John's Harbour. Blue Ocean's principals reported that the firm hired to supplement their dredging efforts at Crabbes, has not been able to remove the rocky material that has proven to be a challenge to deepening the channel.

Larger cement-carrying vessels and liquid natural gas (LNG) vessels, require a deeper draught than exists. The ability to remove the rock requires some bigger equipment, Blue Ocean reported, to crack and rip the rock from its foundation.

Blue Ocean also reported that its equipment can remove three times as much material as the other company's ocean excavator. It requires payments that will allow it to purchase spare parts, repair damaged equipment, purchase fuel, and to pay its employees.

In an effort to remove illegal firearms from the streets of Antigua and Barbuda and to address the rise in gun-related crimes in recent weeks, the government will institute a gun amnesty beginning on Monday April 7.

The matter of the rise in these gun-related offices including the recent homicide of a 23-year old man, has caught the attention of the Cabinet and members considered a number of options to arrest the problem.

The government will place the Police in charge of managing the amnesty, as in times past. The police will receive the weapons from those who wish to surrender their unlawful weapons without any prosecution.

#### APUA Announces Water Levels at Potworks Reservoir and Increased Supply Measures to Ensure Continued Service

St. John's, Antigua – April 2, 2025: The Antigua Public Utilities Authority (APUA) continues to monitor and manage the island's water resources to ensure a stable supply for residents. Potworks Reservoir, the largest natural water catchment in Antigua, has a capacity of one billion gallons. Rainfall in February and October 2024 significantly replenished the reservoir, raising water levels by approximately 12 feet and allowing the Authority to extract an average of 900,000 gallons daily.

As of April 2, 2025, measurements indicate that the reservoir holds 6 feet 11 inches of water. Based on current extraction rates, APUA technicians estimate that this supply will last approximately three weeks before reaching the extraction threshold.

Potworks Reservoir primarily services the following communities: American Road from NODS, Belmont, Bethesda, Briggins, Buckleys, Follys area, Horsford Hill, John Hughes, Law Pasture, Liberta, Ottos New Town, Pattersons, Radio Range, St. Clair Heights, Swetes, Wallings Tank, and All Saints Road from Zephy's Tire Shop to John I. Martin Racetrack, extending up to Farrell Road in Falmouth.

To compensate for the reduced supply from Potworks Reservoir, APUA has increased an existing water purchase agreement with North Sound Management at Crabbs. This facility currently contributes an average of 300,000 imperial gallons per day to the APUA distribution network. North Sound Management has also invested in additional Reverse Osmosis (RO) units, which will increase capacity by a further 1,000,000 imperial gallons per day. Testing of these new units will commence on April 7, 2025, with commissioning expected by mid-April.

APUA remains dedicated to meeting the water needs of its customers and encourages the residents of Antigua and Barbuda to continue practising water conservation daily. In the event of planned or unplanned disruptions due to emergencies or routine maintenance, residents are advised to store enough water for their basic needs. Together, we can ensure a consistent water supply for everyone.

### A man who entered the country illegally is to be deported

A St. Vincent and the Grenadines national who entered into the country illegally and was deported is being held by the Immigration Department awaiting deportation after entering the country illegally for a second time.

38-year old Kemanie Curtis Spencer appeared before Senior magistrate Ngaio Emanuel on Wednesday on charges brought by the Chief Immigration Officer.

These include; departing from a vessel without the consent of the Chief Immigration Officer; and 2, having been legally deported from the state, did enter the state of Antigua and Barbuda without permission in writing, from the Chief Immigration Officer.

Meanwhile, Akeem Brookes of Grays Farm who was charged with the possession of an unlicenced firearm and ammunition pleaded guilty in the magistrate's court on Wednesday. The court heard that on Sunday March 30 at 1:30 am, a police tactical team was patrolling in the Grays Farm area when they came upon a group of men near the Hoppers Playing Field who were acting suspiciously.

A search of the men was carried out and Brookes was found to have in his possession a .32 Walter pistol and seven rounds of ammunition.

Following his guilty plea, Brookes is due back in court on Thursday for sentencing.

#### Belize: Funeral parlour owner guilty of having sex with a minor

A 40 year-old owner of a funeral parlour will return to court on April 25 for sentencing after he was found guilty of having sexual intercourse with an 11 year-old child. Patrick Robinson, appeared before Justice Derick Sylvester where he was convicted on three of five counts of having sex with the 11-year-old girl and continued until she was 14 years

old.

Robinson has been remanded to the Belize Central Prison, until April 25, when his mitigation plea will be heard before sentencing. (Loop Caribbean)

#### Soldier drowns at Maracas; body not found

A man is believed to have drowned while bathing at Maracas Bay yesterday morning but up to last night his body had not yet been found.

Police say Keith Pearson, a Defence Force soldier, was swimming in Maracas around 8.30 a.m. when he began experiencing difficulties and disappeared below the waves.

It is not known if any life-

guards were on duty at the time.

Police said minutes after he disappeared they were informed of what happened.

With the help of fishermen from the nearby village efforts were made to search for the man but he was not found.

## NPTAJ calls for greater parental oversight after alleged school sexual assault

President of the National Parent-Teacher Association of Jamaica (NPTAJ), Stewart Jacobs, is urging parents to pay closer attention to the content their children are exposed to at home and on the Internet.


His appeal follows an alleged incident at a Kingston-based primary school, where an 11-year-old male student is accused of sexually assaulting a sixyear-old female student.

Jacobs expressed his sadness over the alleged assault, highlighting it as a sign of moral decline in society.

"Children are impressionable. They are going to live out what they learn, they're going to live out what they hear, they're going to live out what they are seeing. What are they seeing? A high distribution of pornography on their tablets and phones and on their devices; it's popping up," he told The Gleaner.

He criticised parents for not inspecting their children's online activity and for allowing adult conversations to take place around them, which he believes can contribute to such behaviours.

n Tuesday, the Child Protection and Family Ser-



vices Agency (CPFSA) issued a statement expressing concern over the March 11 incident. The CPFSA's investigation revealed that the schoolboy allegedly led the girl into an empty classroom after school, where the assault took place. Following the report, the CPFSA initiated an investigation and spoke with both children and their parents. The girl was referred to the Ministry of Justice's Victim Services Division for counselling, while the boy was referred to the Child

Guidance Clinic for psychological intervention.

"We are deeply troubled by this incident, as school should be looked at as a safe haven for students, and not one where they should be vulnerable to being sexually abused, especially not by their fellow students," said CPF-SA CEO Laurette Adams-Thomas.

The CPFSA is continuing its investigation, which includes home visits and community assessments for both children, as well as a visit to the school for further details.

Under Section 63 of the Child Care and Protection Act, no child under the age of 12 can be held criminally responsible. Jacobs, acknowledging this legal framework, stressed that parents play a critical role in preventing such behaviour.

"Parents can put the security devices on their children's devices that they are able to see what they intend for them to see, and to encourage not to have adult conversations around their children and to also not expose their children to the type of music that implies those sort of behaviour," he said.

While noting that emotions surrounding this incident are "going to be high", he called for the adults to also exercise patience, keeping the well-being of both children at the forefront.

"Give her all the love and the guidance and support that she now needs and deserves, be gentle with her," he said of the schoolgirl, while adding that the 11-year-old boy is also deserving of love "while he goes through the process of "purging himself". (*Jamaica Gleaner*)

#### 3-year-old discovers 3,800-year-old treasure during a family outing in Israel

She could have picked up any old stone from the thousands in the ruins of Tel Azeka, an ancient town in Israel. Instead, 3-year-old Ziv Nitzan pulled out a 3,800-year-old treasure from the Middle Bronze age.

"When she rubbed it and removed the sand from it, we saw something was different about it," Ziv's sister Omer Nitzan said in a Facebook post released Tuesday by Israel's Antiquities Authority. "I called my parents to come see the beautiful stone, and we realized we had discovered an archaeological find."

Experts later identified it as a Canaanite seal or scarab.

"Scarabs were used in this period as seals and as amulets. They were found in graves, in public buildings and in private homes. Sometimes they bear symbols and messages, that reflect religious beliefs or status," Daphna Ben-Tor, an Egyptologist, said in the Facebook post.

Originating in ancient Egypt, scarabs were commonly used as seals and as amulets and were designed in the shape of a dung beetles. "This beetle,



considered sacred in the eyes of the ancient Egyptians, was a symbol of new life, because of the dung ball it created and then laid its eggs into it, from which new life would hatch," the Facebook post said.

Often they carried messages, reflecting religious beliefs.

Ziv's find is one of a number of arti-


facts found across Israel indicating ancient Egyptian presence in the country.

She picked it up at the base of a key archaeological site in central Israel. Situated 25 miles west of Jerusalem, the village of Tel Azekah is referenced in the Bible as the site of the infamous battle between David and Goliath. (*NBC News*)

#### An 'administrative error' sent Maryland man to an El Salvador prison, ICE says



President Donald Trump' s administration has acknowledged mistakenly deporting a Maryland man with protected legal status to a notorious El Salvador prison last month, but is arguing against returning him to the United States because of his alleged gang ties and the US government's lack of power over the Central American nation.

Lawyers for Kilmar Armando Abrego Garcia, 29, maintain he is not affiliated with MS-13 or any other street gang and argue the US government "has never produced an iota of evidence" that he does.

Abrego Garcia was arrested in Baltimore on March 12 after working a shift as a sheet metal apprentice in Baltimore and picking up his 5-year-old son, who has autism and other disabilities, from his grandmother's house, his lawyers' complaint stated.

Abrego Garcia was then sent to the Terrorism Con-

finement Center, or CECOT, which activists say is rife with abuses and where inmates are packed into cells and never allowed outside.

Abrego Garcia's wife later saw him in photos and video from the prison, identifying her husband through his distinctive tattoos and two scars on his head.

US Immigration and Customs Enforcement officials admitted in a court filing on Monday to an "administrative error" in deporting him. The government's acknowledgement sparked immediate uproar from immigration advocates while prompting Vice President JD Vance and other administration officials to repeat the allegation that he's a gang member.

Abrego Garcia came to the US illegally from El Salvador around 2011, "fleeing gang violence," according to his lawyers, and made his way to Maryland to join his older brother, a US citizen.

"Beginning around 2006,

gang members had stalked, hit, and threatened to kidnap and kill him in order to coerce his parents to succumb to their increasing demands for extortion," the complaint states of his life in his native country.

Abrego Garcia later married a US citizen and worked in construction to support her, their son and her two children from a previous relationship.

The allegations about his affiliation with MS-13 stem from a 2019 arrest outside a Maryland Home Depot store, where he and other young men were looking for work, according to the complaint.

County police asked if he was a gang member and demanded information about other gang members. After explaining that he wasn't a gang member and had no information, he was turned over to ICE.

ICE argued against Abrego Garcia's release at a subsequent immigration court hearing because local police had "verified" his gang membership, the complaint said. The evidence they cited included his wearing of a Chicago Bulls hat and hoodie and a confidential informant's claim that Abrego Garcia belonged to MS-13's "Westerns clique" in Long Island, New York, despite having never lived there.

Abrego Garcia filed for asy-

lum, while his lawyer submitted a "voluminous evidentiary filing establishing his eligibility for protection and contesting the unfounded allegation of gang membership," the complaint stated. In response, ICE cited the information previously provided by local police.

An immigration judge denied Abrego Garcia's asylum request in October 2019 but granted him protection from being deported back to El Salvador. He was released after ICE did not appeal.

Abrego Garcia's lawyers say "he has neither been convicted nor charged with any crime" and has fully complied with the conditions of his protected status, checking in with ICE yearly.

Abrego Garcia's lawyer, Simon Sandoval-Moshenberg, said U.S. government lawyers had multiple opportunities to try legally to deport him, including appealing the judge's 2019 decision or deporting him elsewhere.

"There are lots of things they could have done," Sandoval-Moshenberg told The Associated Press. "But each one of those is in a court and gives him the opportunity to defend himself. And they didn't do any of them. They just put him on an airplane." (*Jamaica Gleaner*)

## Millions brace for tornado outbreak and flash flooding in powerful spring storm

A powerful spring storm is forecast to unleash a tornado outbreak in the central part of the country on Wednesday, with multiple, long-track EF3 tornadoes possible, along with a potentially historic flash flood event.

Today 72 million from northern Texas to central Michigan are under severe storm risk in the system that will see heavy rain, flash flooding and strong tornadoes hit the Lower Ohio Valley and Mid-South region of the U.S., the National Weather Service said.

The flash flooding is "only the beginning of a multi-day catastrophic and potentially historic event," the weather service warned in its morning advisory.

Severe storms will be possible for the next five days in a row — with the greatest risk Wednesday.

Today the storms pose a risk of multiple long track EF-3 tornadoes, wind gusts up to 75 mph or higher, damaging hail two inches or larger in diameter with a high risk area from Paducah, Kentucky, down to Memphis, Tennessee.

Cities that will be impacted in the storms include Dallas, Little Rock, Memphis, Nashville, Paducah, St. Louis, Louisville, Indianapolis, Chicago and Cincinnati. Cities at the greatest risk for strong tornadoes include Memphis and Clarksville, Tennessee; Paducah and Louisville, Kentucky; Little Rock and Jonesboro, Arkansas; Evansville and Bloomington, Indiana; and Southhaven, Mississippi.

This morning, tornado watches are in effect in parts of Missouri, Oklahoma and Arkansas, set to expire between 10 to 12 p.m. CT. (11 to 1 p.m. ET). These storms will re-invigorate with daytime heating, and head east into the night. The storms have already started to roar.

The National Weather Service office of Kansas City/Pleasant Hill Missouri said at 7:12 a.m. CT, a confirmed tornado was located eight miles northwest of Montrose, Missouri, moving at 50 mph.



The Storm Prediction Center set a High Risk Level (5/5) of severe weather across portions of the Mid-South today, as well as a Moderate Risk of excessive rainfall from the Lower Ohio Valley to the Mid-South, where several inches of rainfall and flash flooding is forecast into the evening and overnight.

The tornado outbreak and severe thunderstorms are expected to rumble over parts of the Lower Mississippi Valley into the mid-South and Lower Ohio Valley later on Wednesday into the evening impacting western amid middle Tennessee, Arkansas, western and central Kentucky, eastern Missouri Illinois, Northern Mississippi, Indiana, northern Louisiana, western Ohio, northeast Texas and southern Lower Michigan.

This storm system will become stationary across the region on Thursday, leading to more than 6 inches of rain possible from Wednesday to Thursday.

The severe threat continues for 42

million people tomorrow, 22 million on Friday, 27 million people on Saturday and 12 million on Sunday.

All hazards from damaging winds to hail and tornadoes will be possible each day for many of the same areas from Texas to Ohio as well as into the Mid-Atlantic tomorrow.

There storm system will also bring a high risk for flash flooding Thursday through the weekend.

The front will remain stalled into the weekend and the event is forecast "to bring potentially historic amounts of rainfall, with some locations possibly seeing as much as 10 to 15 inches or rain through the weekend," the National Weather Service said.

This will be a long-duration, multiday event where rounds of heavy rain with intense rainfall rates of two to three inches an hour will back-build over many of the same areas over the course of four days. Once the heavy rain begins tonight, it will continue on and off until Sunday.

Thirty-three million people are under flood watches stretching from Texarkana to Detroit today. One of the Flood Watches is a "Particularly Dangerous Situation (PDS)" Flood Watch.

The National Weather Service warned: "The forecast heavy rainfall in this event has a return interval of anywhere from 25 to 100 years. In other words a heavy rainfall event of this magnitude falling within 4 days is an event that happens once in a generation to once in a lifetime. Historic rainfall totals and impacts are possible."

Communities are urged to prepare for the storm and "severe disruptions to daily life given the expected extreme rainfall and flood risk." (*NBC News*) 10STED BY




