# Government takes majority stake in Blue Ocean company

The government has made a significant cash injection into Blue Ocean company making it the new majority owner of the dredging company.

Prime Minister Gaston Browne made the major announcement about Antigua and Barbuda's latest infrastructure and maritime expansion on Saturday's *Browne and Browne*Show. The government, he revealed, has taken a majority stake—approximately

75%—in Blue Ocean, the nation's dredging and marine engineering enterprise.

"We just bought this massive dredging machine," Browne explained enthusiastically, sharing photos live during the broadcast. "The operator standing beside it is six feet tall, and the tracks alone tower above him. It's huge."

The equipment, valued at US\$1.2 million, will arrive in about four weeks,

accompanied by a barge worth another US\$1.3 million, bringing the total investment to US\$2.5 million. Together, these assets will position Blue Ocean as the largest dredging company in the Caribbean.

The new dredge, Browne said, will be capable of undertaking heavy-duty marine work, from deepening harbours to reclaiming land and expanding coastlines. "This machine can rip up the jaws of death in the harbour and finish the dredging at North Sound," he said.

The Prime Minister went further, outlining a bold vision for land creation and coastal development:

"There's no reason we can't use this equipment near Sandy Island to expand it tenfold and create a beautiful new bay. We can make more land — a new leisure space for locals and visitors alike."

He emphasized that such innovations were not dreams but tangible, ongoing projects: "We're showing people the evidence. We're not just talking — we're building. You're going to see new offshore islands created from that machine. Mark my word."

### Investing in Vision, Not Rhetoric

Addressing critics, PM Browne underscored his administration's momentum and accountability. "All they do is talk lies," he said. "But we're showing the people the results — concrete investments, real progress. We have the energy, the vision, and the plan. Work with us."

When asked about how such massive machinery would be transported, he explained that the dredge would be disassembled, shipped on specialized flat racks, and reassembled by international experts once it arrives.

"We did the same for our industrial printery," he reminded the hosts. "It's nothing new — just big, exciting progress."

# Young Entrepreneur receives commendation from the prime minister for innovation



A young entrepreneur – Joshua Ackah, 23, - has caught the attention of Prime Minister Gaston Browne who is praising him for his creativity and innovation.

Ackar, a resident of Royal Gardens, was a special guest of the prime minister on the popular Saturday afternoon radio programme, *the Browne and Browne Show*.

Ackah is the founder of '*Individuals*', a new business specializing in customized license plates for motor vehicles.

He explained that the idea began just three months ago and the business was officially launched only a month prior. However, after their debut, the Transport Board released a statement saying that custom plates were illegal — temporarily halting their operations. Acting on the advice of his father, Ackah sought the intervention of the prime

minister, given that he has made it clear that he favours opportunities for young people to get involved in business regardless of their age.

The Prime Minister, always an advocate for youth entrepreneurship, clarified the issue: "I haven't given the go-ahead, but I've arranged a meeting with Mr. Hubert Jarvis, General Manager at the Transport Board. I believe at the front of the vehicle, it is permissible. You just have to pay for it and have it assigned officially." That meeting takes place on Monday October 6.

He further emphasized the importance of regularizing such initiatives: "We're trying to create a space for him to apply his trade — to be a supplier."

When asked about pricing, Joshua mentioned that the plates were being sold for \$300.00, and the Prime Minister humourously requested a custom one reading 'Buffalo' — although, as he noted, "that might be a bit too long."

Prime Minister Browne was clearly enthusiastic for the young entrepreneur's craftsmanship and enterprise. When Ackah proudly mentioned that the license plates were made of *aluminum*, the Prime Minister was quick to recognize the value: "You can't lose with this. It's durable." The moment captured the supportive tone of the dialogue — a national leader recognizing innovation at the grassroots level.

Ackah's dedication impressed the

hosts, particularly his creative flexibility. When asked about customizing the plates further, the Prime Minister playfully brainstormed abbreviations for his own plate: "You could put WRD for World Boss." Amidst the laughter, he even offered immediate support: "I'll take \$6,000 in plates from you — we'll give them to our listeners and viewers."

Ackah was deeply appreciative, and it was clear that this small gesture would significantly boost the visibility of his young business. "Much appreciated, sir," he said with gratitude, as the studio echoed with applause and encouragement.

When asked about his team, Ackah proudly shared that the project was a family venture between him and his younger brother. Both were involved in graphic design, and Ackah had also built a strong background in music production and video creation.

"Originally, I'm a music producer," he explained. "But since I do most of the work myself, I learned graphic design because I had to create my own cover art."

This self-taught skillset — born from necessity and creative curiosity — now forms the backbone of his design enterprise.

Ackah is a graduate of the Antigua and Barbuda International Institute for Technology (ABIIT).

# One million cruise tourism passangers expected for the 2025-25 cruise season

Antigua and Barbuda is expected to welcome in access of One-million visitors during the 2025-26 cruise tourism season which officially kicked off on October 1, 2025.


He noted that the successful hosting of the UN SIDS Conference in 2024, Caribbean Hotel and Tourism Associa-

# ABEC wins prestigious award at International conference

# The Ministry of Health to launch social media campaign to address sugary drinks consumption

The Ministry of Health is to launch a social media campaign starting today to address a troubling statistic; nearly 59% of Antiguan and Barbudan children consume at least one sugary drink daily, a habit linked to rising rates of obesity, diabetes, heart disease, and shortened lives.

This troubling reality has prompted civil society and government partners to launch Sweet Talk on October 6th 2025, a national social media campaign designed to raise awareness of the dangers of sugary drink consumption and build public support for the proposed Sugar-Sweetened Beverage (SSB) Levy.

The initiative brings together the Antigua and Barbuda Diabetes Association (ABDA), the Heart & Stroke Foundation, Antigua and Barbuda (HSFAB), the Healthy Caribbean Coalition (HCC), and the Ministry of Health. Each partner brings a unique perspective and a shared commitment to protecting the nation's health.

Regional leaders have emphasized the importance of bold policies.

Dr. Kenneth Connell, President of the HCC, explains, "the HCC congratulates the Government of Antigua and Barbuda for its commitment to implementing the health levy and strongly endorses the Sweet Talk campaign.



The tax is a proven cost-effective strategy; a key measure of the broader healthy food policy package, which increases water intake while creating healthier food environments."

The campaign resonates deeply with the Antigua and Barbuda Diabetes Association (ABDA). Charity Dublin, ABDA President, shared, "Every week, I meet families grappling with the devastating effects of diabetes: amputations, dialysis, and lives cut short. We cannot stand by while preventable illnesses continue to rob our people of their health. An SSB levy is a bold, proven step to reduce consumption and support healthier choices."

Government leadership has also voiced strong support. Sir Molwyn Joseph, Minister of Health, stated, "By introducing a tax on sugar-sweetened beverages, we are taking a crucial step toward reducing obesity and promoting healthier lifestyles. Revenue will directly benefit schools, families, and communities — making the healthy choice the easy choice."

The Heart & Stroke Foundation has underscored the urgency of acting now. Ms. Sumita Balooja, HSFAB Vice President, noted, "Too

often, the victims are far too young. Sugary drink consumption fuels silent killers. Through Sweet Talk, we want to inspire Antiguans and Barbudans to make healthier choices and support a policy that puts lives first."

Grassroots initiatives, including the Foundation's school mascot Arter, continue to promote healthier habits among children, and the campaign will now carry that message nationwide.

Cabinet approved the SSB policy in 2023, and work is underway with the Ministry of Legal Affairs to finalize the legislation. Advocates insist that raising awareness and securing public support are essential to ensure swift implementation.

As Dublin reminds us: "This is about protecting our nation's future. And that future cannot wait."

"This award will celebrate graduating Grade 6 stu-



The criteria for selection include commitment to service, impact on others, leadership in action and character and values.



# Antigua and Barbuda and Sri Lanka establish Diplomatic Relations

Upon the signing of Agreement by H.E. Sir Ronald Sanders, Ambassador of Antigua and Barbuda to United States of America and H.E. Mahinda Samarasinghe, Ambassador of Sri Lanka to the United States of America on October 3rd, 2025, in Washington D.C, the Government of Antigua and Barbuda and the Government of Sri Lanka have established Diplomatic Relations between the two countries with immediate effect.

The establishment of diplomatic ties between Antigua and Barbuda and Sri Lanka will enhance the existing friendly relations and cooperation in the political, socio-economic and cultural spheres for the mutual benefit of the two countries.

Sri Lanka and Antigua and Barbuda are both Commonwealth Countries. Sri Lanka hosted the Commonwealth Heads of





Government Meeting in 2013 and Antigua and Barbuda will host the gathering of 56 nations in 2026.

Ambassador Sanders said that "Antigua and Barbuda and Sri Lanka can work together to ensure the Commonwealth Heads of Government meeting is a success for the Organization and all member states". He added that "prior to the Meeting in Antigua and

Barbuda, Prime Minister Gaston Browne is working toward establishing diplomatic relations and visa waiver agreements with as many Commonwealth countries with which such arrangements do not already exist". This will not only make travel between Commonwealth countries easier, it will also strengthen the value of the Antigua and Barbuda passport.

# Sgt Warner is serving his sentence at the prison facility at the former Pan Am Base

The police officer who was found guilty of illegally discharging his service weapon in a public place, and who was sentenced to a one year in prison, is serving his sentence at the prison facility at the former US Pan Am Base at Coolidge.

37-year old Sgt. Karim Warner was sentenced on Friday when he appeared in the magistrate's court to learn of his fate. He was found guilty just days earlier by the court.

Prison sources say Warner is being housed at the facility at the Pan Am Base 'for his own safety and well-being'. He is one of two persons serving prison sentences at the facility. The other is a UK national who was convicted on rape charges and who is being housed at the facility under an agreement with the UK government.


The rooms at the Pan Am Base that serve as part of the prison have been converted to cells. However, they offer accommodation that is better than what is available at the main prison at 1735.

On Friday, the magistrate found that Warner has abused his authority when he discharged twelve rounds of bullet at a motor vehicle with two occupants inside. In the victim statement, one person spoke of sheer 'terror' caused by the discharge of bullets. The magistrate also noted the damage to property, the motor vehicle.

In terms of mitigating circumstances, the magistrate made note of the character witnesses testimonies and Warner's past history of positive action. Additionally, he cooperated with the police on the scene and upon his arrest.

The magistrate also made note of the potential for his rehabilitation. The penalty for this crime is a maximum of two years, but given all the circumstances of the case, the magistrate sentenced the officer to one year in prison.

# DR Consulate General offers condolences to family of farm worker who died tragically on Saturday

A Dominican Republic national employed as a farm worker here in Antigua and Barbuda lost his life tragically last Saturday when he fell from a roof of a farm building and died shortly after due to severe head injuries.

The victim has been identified as 23year old Michael Alexander Garcia. The accident happened on a farm in the Blackout Area near Potswork Dam.

In an official statement, the Consulate General of the Dominican Republic in Antigua and Barbuda, under the direction of the Honorable Consul Joaquín Díaz López, says it deeply regrets the tragic passing of a young Dominican national that occurred this Saturday in the Blackout area.

"By instruction of the Honorable Consul, the Director of the Consular Cabinet, Mr. Huascar Félix, will provide direct follow-up on the case in coordination with local authorities, ensuring support and assistance to the victim's family.

"We extend our heartfelt condolences to his loved ones and to the Dominican community in Antigua and Barbuda during this difficult time."

The statement from the Consulate General of the Dominican Republic in Antigua and Barbuda was issued on Sunday.

Meanwhile, Antigua and Barbuda police are investigating the circumstances surrounding the death of Garcia, a father of a three-year-old.

The incident occurred around 4:30 p.m. in along Dam Road. Garcia was said to be on the roof of a building

when he fell, suffering severe head injuries.

Emergency Medical Services personnel arrived to find him lying in a pool of blood. Advanced Emergency Medical Technicians Marina Walker and Mekile Tonkinson are being commended for their efforts to resuscitate him.

Despite their attempts and continued efforts by doctors at Sir Lester Bird Medical Centre, Garcia was later pronounced dead. The tragedy has deeply affected Antigua's Hispanic community, with many gathering at the hospital Saturday evening to mourn his death.

May you continue to teach with courage.


May you continue to collaborate with confidence.

# Beyond the Ramp: Redefining Accessibility in Antigua & Barbuda



What comes to your mind when you hear the word accessibility? For many, it's ramps, rails, or a special bathroom. But let's pause—can we really call a space accessible if a person who is blind can't read the signs? Or if a deaf person can't follow what's being said? Accessibility isn't just physical; it's psychological, technological, and cultural.Inclusive development demands that everyone, regardless of ability, can participate and benefit. That's why our recent visit to the Government House Museum felt like a celebration of inclusion in motion.

The team there isn't just checking boxes; they're re-imagining access. Two bathrooms were condemned to make space for a lift—yes, a lift, in one of the island's oldest heritage sites! Two others are being redesigned to ensure wheelchair users have adequate space. Even the ramp, which was once considered sufficient, is being redone to meet international standards. The UN CRPD declares, "States Parties shall take appropriate measures

to ensure access, on an equal basis with others, to the physical environment, transportation, information and communications." As the Disabilities and Equal Opportunities Act 2017 reminds us, accessibility is a right, not a favor. So, when a museum lifts its walls—literally—to make room for inclusion, it's not just construction; it's transformation. It's proof that we're moving from awareness to action. And here's the question for all of us: if a building as old and complex as the Government House Museum can adapt, what's stopping our modern offices, schools, and public institutions from doing the same? Accessibility benefits everyone—parents with strollers, the elderly, those recovering from injury. Inclusion isn't charity; it's common sense.

So yes, beyond the ramps and bathrooms lies the real heart of acces-





sibility: equal participation. And if Antigua and Barbuda continues in this direction, we'll soon be a nation that doesn't just speak inclusion but lives it every day.

# Police in Trinidad foil drone-assisted plot to smuggle contraband into prison

A major intelligence-led operation in Trinidad involving several arms of national security disrupted an attempted drone-based contraband smuggling operation near the Arouca Maximum Security Prison between Friday evening and Saturday morning.

Acting on credible intelligence, law enforcement officers conducted surveillance in the Forde Street Extension, Bon Air area, after receiving reports of individuals attempting to use a drone to smuggle contraband into the prison.

A search of a nearby bushy area resulted in the apprehension of two suspects — a 13-year-old boy from Oropune Gardens and a 26-year-old man from Tunapuna — who at-



tempted to flee by running through dense vegetation and leaping from a 25-foot embankment.

They were held following a targeted search of a river in the area.

Police said one of them sustained injuries during his escape attempt and was treated at a medical facility.

A simultaneous search inside the Maximum Security

Prison turned up additional contraband.

A nearby premises was also searched under Section 12 of the Emergency Powers Regulations, 2025, but no illegal items were found.

Investigations are continuing under the supervision of Acting Corporal Hyde.

In a statement, the Trinidad and Tobago Police Service (TTPS) said investigations are continuing.

It said it remains committed, along with the Prison Service, to disrupting criminal networks and preventing illegal items from entering correctional facilities.

The exercise was coordinated by Commissioner of Police Allister Guevarro, Deputy Commissioner Suzette Martin, and Senior Superintendent of Prisons Lee Davis.

The joint operation involved personnel from the TTPS, the Trinidad and Tobago Defence Force Specialist Units, the Port of Spain Task Force, the Multi Operational Police Section, the Crime Scene Unit, the Prison Service, and the Special Investigative Unit. (CMC)

### Missing 29-yearold woman found dead in suitcase in Savanna-la-Mar

The body of a woman was found in a suitcase Saturday in Savanna-la-Mar.

It was reportedly found in a gully within the community of Gully Banks.

The deceased has been identified as 29-year-old Kerrian

Malcolm of Barracks Road in Savanna-la-Mar.

Malcolm was reported missing on Thursday.

She was last seen at home about 11:00 pm the previous day, according to police reports. At the time, she was reportedly wearing a brown sleeveless blouse and blue and white shorts. (Jamaica Observer)

# Sean 'Diddy' Combs' lawyers plan to appeal as convicted hip-hop star faces more years behind bars

Attorneys for Sean 'Diddy' Combs are planning to appeal after the Grammy-winning artist and music executive was sentenced Friday to more than four years in prison for transporting people across state lines for sexual encounters.

The case shattered his carefully cultivated reputation as an affable celebrity entrepreneur, A-list party host and reality TV star.

It culminated a public reckoning for the 55-year-old hip-hop star, who made a plea for leniency and wept as his lawyers played a video portraying his family life, career and philanthropy.

US District Judge Arun Subramanian also fined Combs \$500,000, the maximum allowed.

Combs was convicted in July of flying his girlfriends and male sex work-



ers around the country to engage in drug-fuelled sexual encounters over many years and in multiple places.

The sordid, nearly two-month trial in a federal court in Manhattan featured harrowing testimony from women who said Combs beat, threatened, sexually assaulted and blackmailed them.

He was acquitted of sex trafficking and racketeering charges that could have put him behind bars for life. (Jamaica Gleaner)

# Federal appeals court rules Trump administration can't end birthright citizenship

A federal appeals court in Boston ruled on Friday that the Trump administration cannot withhold citizenship from children born to people in the country illegally or temporarily, adding to the mounting legal setbacks for the president's birthright order.

A three-judge panel of the 1st US Circuit Court of Appeals became the fifth federal court since June to either issue or uphold orders blocking the president's birthright order.

The court concluded that the plaintiffs are likely to succeed on their claims that the children described in the order are entitled to birthright citizenship under the Citizenship Clause of the 14th Amendment.

The panel upheld lower courts' preliminary injunctions, which blocked the birthright order while lawsuits challenging it moved ahead.

The order, signed the day the president took office in January, would halt automatic citizenship for babies born to people in the US illegally or temporarily.

"The 'lessons of history' thus give us every reason to be wary of now blessing this most recent effort to break with our established tradition of recognising birthright citizenship and to make citizenship depend on the actions of one's parents rather than — in all but the rarest of circumstances — the simple fact of being



born in the United States," the court wrote.

California Attorney General Rob Bonta, whose state was one of nearly 20 that were part of the lawsuit challenging the order, welcomed the ruling.

"The First Circuit reaffirmed what we already knew to be true: The President's attack on birthright citizenship flagrantly defies the Fourteenth Amendment of the U.S. Constitution and a nationwide injunction is the only reasonable way to protect against its catastrophic implications," Bonta said in a statement. "We are glad that the courts have continued to protect Americans' fundamental rights."

A second appeals court ruling on Friday also found in favour of several organisations that challenged the birthright citizenship order.

The plaintiffs, including New Hampshire Indonesian Community Support and League of United Latin American Citizens, were represented by the American Civil Liberties Union.

"The federal appeals court today reinforced that this executive order is a flagrant violation of the U.S. Constitution — and we agree," said SangYeob Kim, senior staff attorney at the ACLU of New Hampshire.

"Our Constitution is clear: no politician can decide who among those born in this country is worthy of citizenship."

In September, the Trump administration asked the Supreme Court to uphold its birthright citizenship order.

The appeal sets in motion a process at the high court that could lead to a definitive ruling from the justices by early summer on whether the citizenship restrictions are constitutional.

"The court is misinterpreting the 14th Amendment. We look forward to being vindicated by the Supreme Court," White House spokesperson Abigail Jackson said in a statement.

In July, US District Judge Leo Sorokin in Boston issued the third court ruling blocking the birthright order nationwide after a key Supreme Court decision in June.

Less than two weeks later, a federal judge in Maryland also issued a nationwide preliminary injunction against the order. The issue is expected to move quickly back to the nation's highest court.

The justices ruled in June that lower courts generally can't issue nationwide injunctions, but they didn't rule out other court orders that could have nationwide effects, including in class-action lawsuits and those brought by states.

A federal judge in New Hampshire later issued a ruling prohibiting Trump's executive order from taking effect nationwide in a new class-action suit, and a San Francisco-based appeals court affirmed a different lower court's nationwide injunction in a lawsuit that included state plaintiffs.

At the heart of the lawsuits challenging the birthright order is the 14th Amendment to the Constitution, which includes a citizenship clause that says all people born or naturalised in the United States, and subject to US jurisdiction, are citizens. (AP)

# Judge blocks Trump policy to detain migrant children turning 18 in adult facilities

A federal judge has temporarily blocked a new Trump administration policy to keep migrant children in detention after they turn 18, moving quickly to stop transfers to adult facilities that advocates said were scheduled for this weekend.

US District Judge Rudolph Contreras on Saturday issued a temporary restraining order to US Immigration and Customs Enforcement to not detain any child who came to the country alone and without permission in ICE adult detention facilities after they become an adult.

The Washington, D.C., judge found that such automatic detention violates a court order he issued in 2021 barring such practices.

ICE and the US Department of Homeland Security didn't immediately respond Saturday to emails seeking comment.

The push to detain new adults is yet another battle over one of the most sensitive issues in President Donald Trump's hard-line immigration agenda — how to treat children who cross the border unaccompanied by adults.

The Associated Press reported Friday that officials are offering migrant children age 14 and older \$2,500 to voluntarily return to their home countries.

Last month a separate federal judge blocked attempts to immediately deport Guatemalan migrant children who came to the US alone back to their home country.

Some children had been put on board planes in that late-night operation before a judge blocked it.

"All of these are pieces of the same general policy to coerce immigrant youth into giving up their right to seek protection in the United States," said Michelle Lapointe, a lawyer for the American Immigration Council, one of the groups that asked Contreras to



intervene in a filing made just after midnight Saturday.

Unaccompanied children are held in shelters run by the Office of Refugee Resettlement, under not ICE but the U.S. Health and Human Services Department. Contreras' 2021 order instructed federal officials to release minors who turn 18 from those shelters to "the least restrictive setting available." He ruled that is what is required by federal law as long as the minor isn't a danger to themselves or others and isn't a flight risk. Minors are often released to the custody of a relative, or maybe into foster care.

But lawyers who represent unaccompanied minors said they began getting word in the last few days that ICE was telling shelters that children who were about to turn 18 — even those who had already-approved release plans — could no longer be released and would instead be taken to detention facilities, possibly as early as Saturday.

One email from ICE asserted that the new adults could only be released by ICE under its case-by-case parole authority for "urgent humanitarian reasons" or "significant public benefit." From March through September, ICE has paroled fewer than 500 people overall.

The plaintiffs argued that "release on parole is all but a dead letter" and

that children ageing out of shelters would experience lasting harm from "unnecessary and inappropriate adult detention" in jails that might be overcrowded or in remote locations. The plaintiffs said that was especially true because some of the clients they cited had been victims of trafficking or had been abused, neglected or abandoned by their parents.

US border authorities have arrested children crossing the border without parents more than 400,000 times since October 2021. A 2008 law requires them to appear before an immigration judge before being returned to their countries.

Children have been spending more time in government-run shelters since the Trump administration put them under closer scrutiny before releasing them to family in the United States to pursue their immigration cases.

The additional scrutiny includes fingerprinting, DNA testing and home visits by immigration officers. Over the summer, immigration officers started showing up and arresting parents.

The average length of stay at government-run shelters for those released in the US was 171 days in July, down from a peak of 217 days in April but well above 37 days in January, when Trump took office. (Jamaica Gleaner)

# India crush West Indies by innings and 140 runs

GUJARAT (Reuters) - India cruised to victory over West Indies by an innings and 140 runs within three days of the opening Test in Ahmedabad on Saturday to take a 1-0 lead in the twomatch series.

The hosts were always in the ascendancy after bundling out the West Indies for 162 in their first innings at the Narendra Modi Stadium.

India racked up 448 for five before declaring their first innings, riding hundreds by opener KL Rahul and middle order batters Dhruv Jurel and Ravindra Jadeja.

Jadeja (four for 54) then led India's superb bowling, aided by a catching masterclass, as they skittled out West Indies for 146 to secure a comfortable win ahead of the second Test in New Delhi from October 10.

Jadeja was adjudged player-of-the-match while seamer Mohammed Siraj finished with seven wickets in the match.

Captain Shubman Gill said with Jadeja, Kuldeep Yadav and Washington Sundar at his disposal, he was spoilt for choice.

"When you've got quality spinners like them, it's difficult to rotate them," he said.

many options rather than not having options...That's the fun of playing in India.

"You know there will always be someone who will be out there, ready to get the job done for the team. The entire team and the young team came out with flying colours."

Earlier, India decided a lead of 286 was good enough and declared on their overnight score.

For the second time in the match, the West Indies top order wilted almost against India's incisive bowling backed by their sharp catching.

Nitish Kumar Reddy, "It's good to have too manning square leg, flew to his left to take a stunning catch after Tagnarine Chanderpaul had pulled Siraj. Jadeja then dealt back-toback blows to rattle the touring side.

John Campbell lunged forward and guided a delivery into Sai Sudharsan's hands at short leg, while Brandon King perished when KL Rahul took a smart, low catch at slip.

wrist-spinner Left-arm Kuldeep uprooted rival captain Roston Chase's offstump to reduce West Indies to 35 for four.

Jadeja picked up his third wicket when Yashasvi Jaiswal dived forward at backward point to take a good catch to send back Shai Hope.

Jayden Seales (22) produced an entertaining cameo but it was not enough for West Indies to avoid an innings defeat.

"When you win the toss and get bowled out for 160odd it is tough to come back from that," Chase said.

"Not the performance we were looking for. We have to bat better especially in India.

"You have to put a big first-innings total on the board especially with the ball spinning, and pitch deteriorating...I think that's something we need to look at."

### Postecoglou under fire as Forest lose again

NEWCASTLE (Reuters) - Newcastle United beat Nottingham Forest 2-0 to heap more pressure on Ange Postecoglou while Crystal Palace's club-record unbeaten run came to an end with defeat at Everton in the Premier League on Sunday.

Bottom side Wolverhampton Wanderers were denied their first win of the season when Brighton & Hove Albion scored a late equaliser in a 1-1 draw at Molineux.

Erling Haaland scored his ninth Premier League goal of the season to earn Manchester City a laboured 1-0 victory at Brentford, which lifted them to fifth in the table.

In the other match on Sunday, Aston Villa beat Burnley 2-1, thanks to two goals by Donyell Malen.

But it was Postecoglou who found himself under fire after Newcastle midfielder Bruno Guimaraes curled a long-range strike into the top corner before earning the penalty put away by German striker Nick Woltemade.

Postecoglou has yet to win a game since taking over at Forest last month, a run of seven games in all competitions that includes five defeats -- the worst start by a Forest manager in a century.

"I knew it was a big challenge walking in, there is nothing wrong with that. I don't get why people think it is a burden but I love a challenge. The alternative is sitting at home watching the game and I don't want to do

that," Postecoglou told the BBC.

Palace saw their club-record 19-game unbeaten run come to an end when Jack Grealish scored his first goal for Everton with a 93rd-minute winner in a 2-1 victory for the Merseyside club.

Daniel Munoz had given Palace the lead in the first half with a goal at the near post and Oliver Glasner's side had dared to dream when it moved them provisionally up to second in the league behind Arsenal.

But Iliman Ndiaye levelled from the spot before Grealish stole into the box to knock in a rebound in a melee after goalkeeper Dean Henderson had made a save. Wolves profited from an unlikely own goal when Bart Verbruggen made a fine attempt to save Marshall Munetsi's shot, only to tip it on to the crossbar before it bounced back off the keeper and into the net.

The goal came a minute after Wolves boss Vitor Pereira was sent off for kicking the ball into the dugout to protest a decision, but his team held on to their lead until the 86th minute when Brighton scored from a quickly taken corner.


Jan Paul van Hecke rose above the defence to direct a bullet header into the net as the two teams shared the spoils.

The Norwegian Haaland muscled through to finish in style in the ninth minute to continue his impressive start to the season as City extended their unbeaten run in all competitions to seven.

It should have been far more comfortable for Pep Guardiola's side though and they were dealt a potentially significant blow when midfielder Rodri went off injured in the first half.

Brentford failed to have a touch in the City penalty area in the first half but did liven up after the break and Igor Thiago wasted a glorious chance to equalise.

City came under pressure late on under Brentford's aerial assault but held on to move to 13 points from seven games, three behind leaders Arsenal heading into the international break.

# India beat Pakistan in women's World Cup

COLOMBO, Sri Lanka (AP) — Seam bowler Kranti Goud and spinner Deepti Sharma took three wickets each as India routed archrival Pakistan by 88 runs in their women's World Cup match on Sunday, which had a controversial dismissal.

Pakistan captain Fatima Sana won the toss and chose to bowl first in the 50-over match at R. Premadasa Stadium, Colombo.

India were all out for 247 in 50 overs. In reply, Pakistan were dismissed for 159 in 43 overs. The only half-century of the game came from Pakistan's Sidra Amin, who made 81 runs in her 13th score over 50 in one-day internationals.

Amin shared 69 runs for the fourth wicket with Natalia Pervaiz (33) to lift Pakistan's hopes briefly after being reduced to 26 for three.

Pakistan's first wicket was lost in a confusing manner when opening batter Muneeba Ali was adjudged run out. Ali had grounded her bat after returning to her

crease, having moved forward to play a shot.

Her bat was seen lifted when an Indian fielder hit the stumps. Sana argued with the fourth umpire that the batter was not attempting a run but the decision stood.

The frosty relations were evident in Colombo too where Kaur and Sana did not shake hands at the toss, nearly ignoring each other's presence.

India captain Harmanpreet Kaur and Pakistan counterpart Fatima Sana skipped the customary handshake before a women's cricket World Cup match on Sunday amid ongoing tensions between the rivals that plagued the men's Asia Cup last month.

India-Pakistan relations have significantly deteriorated following military conflicts in May that nearly escalated into a full-fledged war between the nuclear-armed neighbours.

India beat Pakistan three times in the men's Asia Cup, including in the September 28 final in Dubai, but refused to shake hands with their counterparts before or after the matches.

They also declined to receive the winners' trophy from Asian Cricket Council (ACC) president Mohsin Naqvi, who is Pakistan's interior minister.

Bilateral cricket remains suspended between India and Pakistan, who play each other only in multi-team events at neutral venues.

India are the hosts of the ongoing women's World Cup but Pakistan will be playing all their matches in Colombo under an agreement approved by the International Cricket Council.
