Sir Robin Resigns After 50 Years As An MP...

Just hours after being honoured in a special sitting of the House of Representatives for five decades of service, veteran parliamentarian Sir Robin Yearwood formally resigned his seat Wednesday with immediate effect, bringing an extraordinary political era to a close and triggering a by-election in the constituency of St. Phillip's North.

In his letter, Sir Robin reflected on what he described as "exactly 50 years" in the Lower House and eleven successful electoral victories at the polls.

"As you are aware, I have served in the Lower House of Parliament since 18 February 1976," he wrote. "I have been successfully returned to Parliament by the people of St. Phillip's North on eleven separate occasions."

Sir Robin signalled that stepping down now represented a natural and dignified transition.


"I believe that the time has come for me to pass the baton to a younger and

more vigorous representative," he wrote. "No time could be better than the moment when a 50-year milestone is achieved."

Over half a century, Sir Robin Yearwood became one of the most recognisable and enduring figures in Antigua and Barbudan politics, serving across multiple administrations and holding several senior Cabinet portfolios.

Throughout those years, he remained a stalwart of the Antigua and Barbuda Labour Party, which he described as a movement he joined more than 50 years ago and served "faithfully at all times."

"The Antigua and Barbuda Labour Party is a movement which I joined more than fifty years ago," he wrote, "Its creed, its vision and mission em-

bodied and characterized the new personality which the Antigua and Barbuda person would become”.

Even during periods when the party lost its parliamentary majority and moved into opposition, Sir Robin maintained his seat.

In his letter, he struck a reflective tone, thanking the electors of St. Phillip’s North, his family, friends and colleagues for sustaining him through the demands of public life.

“It is impossible for any successful seeker of public office to operate with equanimity without the backing of a coterie of confidants,” he wrote,

expressing appreciation to relatives, church members and supporters who stood by him over the decades.

He also expressed pride in what he believes the country has achieved during his years in office.

“It pleases me to think that my own contribution has resulted in an Antigua and Barbuda that is sovereign, wealthier, prideful, accomplished and leading in human development in the entire Caribbean,” he stated.

Sir Robin’s connection to St. Phillip’s North has long been described as personal rather than political. Known for operating without a formal constitu-

ency office, he instead made himself available from his home in Willikies, where residents regularly sought assistance and advice.

With his resignation taking immediate effect, the Antigua and Barbuda Electoral Commission is moving towards organising a by-election to fill the vacancy that was created in parliament. The Constitutional process to fill the seat has started with the issuance of the Writ of Election today (Thursday 19) and the by-election set for Monday March 16.

The by-election will be between two candidates — Randy Baltimore, who received the nod as Sir Robin Yearwood’s successor from ABLP supporters in a primary held in July, 2024, and Alex Browne, who was appointed a United Progressive Party Senator in 2023.

Both men are entering the race with clear missions. Baltimore, to retain the seat held by his successor for half a century, while Browne will be seeking to break the trend and secure victory for the UPP.

Already, leader of the Antigua and Barbuda Labour Party, Prime Minister Gaston Browne, is reiterating his support for Randy Baltimore, writing on his social media page, “We look forward to formally receiving Mr. Randy Baltimore - ABLP’s candidate in the upcoming St Phillip’s North by election, as the newest member of Parliament shortly”.

Both political parties are expected to roll out their campaigns in the upcoming weeks as they seek to convince eligible voters within Saint Phillip’s North why theirs is the ideal candidate.

PM Browne Leads Tributes as Parliament Honours Sir Robin Yearwood's 50 Years of Service

The chamber of the House of Representatives was steeped in gratitude and reflection Wednesday morning when Prime Minister Gaston Browne opened a special sitting to honour the remarkable 50-year parliamentary career of Sir Robin Yearwood.

With his record of half a century, Sir Robin Yearwood is listed as the longest-serving MP in Antigua and Barbuda's history, a record that also includes the wider Caribbean and the Commonwealth of Nations.

Wednesday's special parliamentary sitting was not crafted for debate or division. Instead, it was one for tributes, commemorating a career Prime Minister Browne described as "rooted not in spectacle, but in substance; not in rhetoric, but in results."

For five decades, Sir Robin has represented the people of St. Philip's North, earning an extraordinary 11 consecutive electoral victories since first entering Parliament in 1976. His longevity, Prime Minister Browne said, reflects more than political skill — it speaks to "character, discipline, resilience, humility and an unshakable sense of responsibility."

According to the Prime Minister Gaston Browne, unlike many modern politicians, Sir Robin Yearwood never maintained a formal constituency branch office. Instead, his modest home in Willikies served as the centre of his public life.

Constituents knew they could find him there — not behind layers of protocol, but accessible and pres-



ent.

"He was tactile, always in close touch with his people," Browne said. "His door has never been closed to those in need, and his voice has never been absent when justice or fairness required it."

Residents often regarded him not simply as their MP, but as a neighbour, counsellor and advocate — a familiar figure who lived among them and understood their everyday struggles.

Sir Robin's parliamentary service spanned multiple administrations and critical national portfolios, including agriculture, aviation, public utilities and finance. He also held senior leadership roles as Deputy Prime Minister, Leader of the Opposition and chairman of several statutory corporations and private companies.

Throughout his career, he worked

alongside and under three generations of national leadership, including the late Vere Cornwall Bird, Lester Bird and now Prime Minister Gaston Browne.

"You have stood at the centre of defining chapters in our political history," Browne told him directly during the sitting. "You fought unrelentingly to protect and advance the living standards of our people."

While parliamentary records document the length of his service, the Antiguan and Barbudan leader stressed that Sir Robin's true legacy is etched into communities and institutions across Antigua and Barbuda.

"Our nation is stronger because of Sir Robin's service," he said. "Generations have benefited from his contribution. Our democracy has been enriched by his steadfast presence."

I present my compliments and wish to inform that the Honourable Sir Robin Yearwood has submitted his resignation from the Parliament of Antigua and Barbuda, effective this date. Hence, under Section 41(3) of the Antigua and Barbuda Constitution Order 1981, "where the seat of an elected member of the House is vacant ... there shall be a by-election to fill the seat in the House."

The Constitution of Antigua and Barbuda further requires the by-election to be held anytime within 120 days of the date on which the vacancy arose. I therefore inform, based on the power vested in the Prime Minister under the Representation of the People (Amendment) Act, that the vacancy of the Constituency of St. Phillip's North be filled. I direct that the following take place on the dates indicated:

Thursday 19 February 2026 – Issuance of the Writ of Election
Wednesday 25 February 2026 – Day of Nomination of Candidates
Monday 16 March 2026 – Day of by-Election in the St. Phillip Constituency

I thank you, Excellency, for acting with the usual alacrity, and I avail myself of this opportunity to renew to you the assurances of my highest regard and esteem.

GG, Cabinet Colleagues and others pay tribute to Sir Robin

Wednesday February 18, 2026, will go down in the history books as a momentous day for the people of Antigua and Barbuda, but especially for Sir Robin Yearwood and his family for this was the day that he created history by being the longest serving member of parliament with 50 years of unbroken serving to the people of St. Philip's North constituency.

It was a historic day in several respects; firstly, it was a rare occasion when the Governor General, Sir Rodney Williams, is invited to address the House of Representatives. This was not an occasion when the Governor General is decked out in his ceremonial wear; this was an occasion for regular business suit. Nonetheless, the presence of the Governor General at a sitting of the House of Representatives, though rare, still comes with its own set of protocol requirements. These relate to where he sits and who sits on either side of him.

When he did speak, the Governor General's remarks took a deeply personal tone. He recalled that for twenty of Sir Robin's 50 years in the House of Representatives, that he also sat in the House as the representative for St. Paul.

"That shared parliamentary experience affords me a unique appreciation of the demands and responsibilities that accompany this office. We have debated across this floor, collaborated on national matters, and witnessed together the maturing of our democracy. "Indeed, our association within this Chamber predates my own tenure. Sir Robin served alongside my late father, Sir Ernest Emmanuel Williams, for several years. Their generation bore significant responsibility during critical years of national development. The professional respect between them grew into a friendship between families, a bond that has endured for decades and remains strong to this day," Sir Rodney recalled.

Sir Rodney took time to mention the



many occasions that his family had been gifted with one of Sir Robin's cherished goats and the significance of this generosity. "I would be remiss if I did not recall, with warmth and gratitude, the many occasions on which you gifted our family one of your well-known goats, gestures of generosity that invariably transformed into sumptuous fare and cherished family gatherings. Those moments remind us that leadership is expressed not only in debate, but also in generosity and goodwill."

The nation's Attorney General Sir Steadroy Benjamin also added his voice to expressions of admiration and gratitude to Sir Robin. He told the gathering that the special session of the House of Representatives was more than an acknowledgement of the passage of time; but the celebration of a legacy.

"Fifty years, Mr. Speaker, is more than a milestone. It is a lifetime of dedication. It is half a century of answering the call to serve. It is countless debates, decisions, consultations, and commitments — all undertaken in the interest of strengthening our democracy and advancing our nation.

"From his early days in public life to his seasoned leadership in Parliament, Sir Robin has exemplified the core values upon which parliamentary democracy stands: respect for the rule of law, belief in the power of representation, and an unshakeable commitment

to the voice of the people."

Sir Steadroy added that everyone is aware that parliamentary democracy is not sustained by institutions alone. "It is sustained by individuals - by men and women who understand that leadership is a responsibility, not a privilege. Sir Robin Yearwood has embodied that principle," he declared.

For Foreign Minister E. P Chet Greene, Sir Robin has left an imprint on virtually every facet of national life, having served with distinction as Minister of Agriculture, Land and Fisheries, nurturing the very soil of the nation; as Minister of Aviation, Public Information and Public Utilities, where he modernized the connectivity and infrastructure; and ultimately as Deputy Prime Minister and Minister of Finance, helping to steward the economy through turbulent waters.

Minister Greene also described Sir Robin as the link between the past generations, such as the Thirty-Niners and the Seventy-Sixers to the generations of today.

"His career reflects the ABLP's resilience, withstanding the defeat of 1971, the internal shifts of the 1980s and 1990s, the devastating loss of 2004 and the triumphant return to government in 2014. To survive and thrive in the rough and tumble of Antiguan politics for five decades requires not just political skill but a genuine connection to the people that transcends political cycles," Greene observed.

Opposition Leader Pringle says 'Thank You' to Sir Robin



Opposition Leader, Jamale Pringle, expressed heartfelt gratitude to Sir Robin Yearwood, in whose honour a special session of the House of Representatives was held on Wednesday to commemorate his 50 years of unbroken service as the representative for St Phillip's North.

Health Minister Sir Molwyn Joseph, who spoke after the opposition leader, noted that it would be a service to Sir Robin's memory if the expressions of goodwill at the special session on Wednesday could carry over into how the affairs of the House of Representatives are conducted in the months and years ahead.

"I am happy to hear the comments from the other side and I am now asking, is this a new beginning for Antigua and Barbuda? All the commendations, all the pleasing expressions, can we use this moment in honouring Sir Robin to have a new outlook on the way that we prosecute our politics in Antigua and Barbuda. We have got to make a way to get the benefits of this moment. Notwithstanding what has transpired

in the past, you have to agree that Sir Robin made his contribution, and an enormous contribution," he remarked.

Tourism Minister Charles Max Fernandez revealed that he first cast a vote in an election the same year that Sir Robin was first elected to the House of Representative, adding that there was a time when he lived in St. Philip's North and cast a vote in favour of Sir Robin.

But it was Sir Robin's unique ability to communicate with ordinary men and women that has stood out as a key reason for the retiring politician's success for five decades, Fernandez suggested.

"I remember sharing many political platforms with Sir Robin over these many years and I was always impressed by how he has been able to communicate with people. Sir Robin has a way for making even the most complex issue understandable to the common people. No matter the subject, he was able to break it down in the simplest of ways for everyone to understand, and that was his special gift," Minister Fernandez observed.

Minister Maria Browne Praises Veteran MP's Legacy of Dedication and Sacrifice



Saint John's Rural East MP, Maria Browne has expressed gratitude to retired politician Sir Robin Yearwood, summing up his political life as a model of sacrifice, loyalty and nation-building — one which younger parliamentarians like herself strive to emulate.

The youngest among her parliamentary colleagues, MP Browne recalled first learning about Sir Robin as a child, long before she entered politics herself.

She painted a nostalgic picture of primary school classrooms where students were required to memorise the names, faces and portfolios of government ministers.

Their photographs, she said, hung prominently on the walls.

"I recall three very prominent faces that are still in here today," she said,

referring to what she affectionately called "the Three Knights" — senior statesmen who shaped the country's political landscape for decades.

Years later, she found herself not just recognising those faces, but serving alongside them.

"I could not believe in 2018 that I would be on a slate next to these three knights," Browne said. "What an honour it was — and still is — to be serving alongside such great men. True patriots of Antigua and Barbuda."

In her glowing tribute to Sir Robin Yearwood on the attainment of 50 years as a member of parliament, Minister Maria Browne addressed the issue of ageism in public life, noting that younger leaders are often told they lack experience while older leaders are sometimes dismissed as past their prime.

She credited the Antigua and Barbuda Labour Party for fostering an environment where every generation is valued.

"We know to get to where we want to go, we have to know where we are coming from," she said. "And we must respect all and their contributions."

She added that serving alongside seasoned figures like Sir Robin has given younger MPs invaluable guidance and institutional memory.

"In a position that many individuals can find themselves gravitating away from their true selves and become very aloof, Sir Robin always stayed grounded," she said. "And I think that is something we can all emulate."

Antigua and Barbuda, Spain Hold Bilateral Discussions

Antigua and Barbuda and the Kingdom of Spain used the opportunity of this week's EU-Caribbean Parliamentary Assembly meeting in St. John's to hold important bilateral discussions.

Foreign Affairs Minister, E.P Chet Greene, met briefly on Wednesday with the Spanish Ambassador At-Large For The Caribbean, Carlos de la Morena Casado and an assistant in discussions at the Ministry of Foreign Affairs. Joining Minister Greene were Permanent Secretary, Ambassador Dr. Clarence Pilgrim and Director General for Foreign Affairs, Ann Marie Layne.

It was noted that Antigua and Barbuda and the Kingdom of Spain formally established diplomatic relations in 1988, seven years after Antigua and Barbuda gained independence. Since then, both countries have engaged in various forms of cooperation, including:

- **Bilateral Summits:** notably, summits were held in Madrid in 2006 and 2008, which helped to strengthen diplomatic and economic ties
- **Development and technical assistance:** Spain has supported development initiatives in the Caribbean, including Antigua and Barbuda, often through regional programs and partnerships with the European Union
- **Cultural and Educational Exchange:** There have been efforts to promote Spanish language and culture in the Caribbean, as well as opportunities for educational exchange and scholarships. A shining example of this is the "Ibero-American Cultural Week," launched in April 2011, which has provided Antigua and Barbuda citizens with the opportunity to experience and appreciate

the rich cultural heritage of the Hispanic and Spanish-speaking communities.

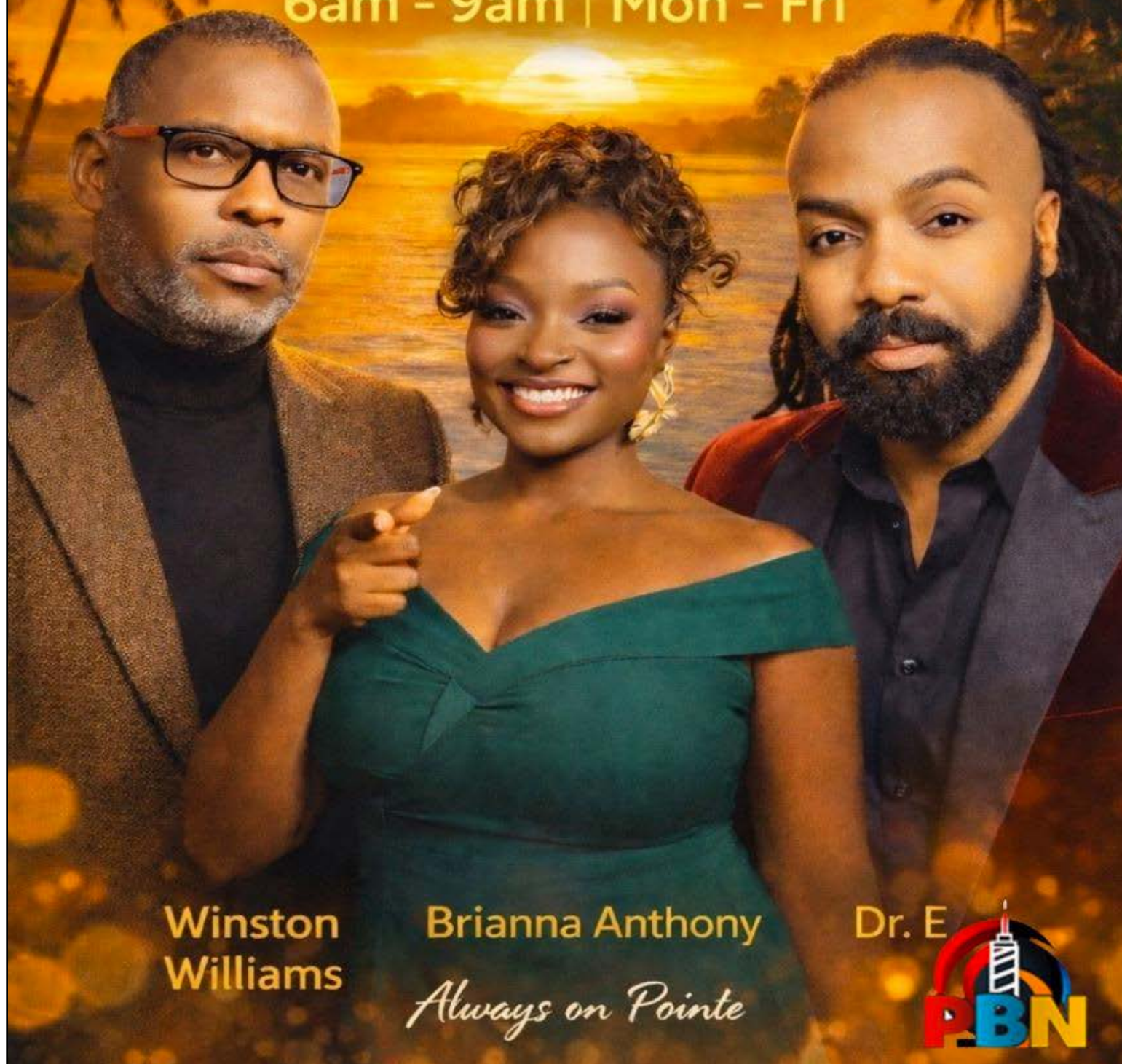
At the meeting, Minister Greene called for a reset of the Economic Partnership Agreement (EPA) between the EU and the African Caribbean and Pacific (ACP) states, noting that small countries in the OECS face structural challenges that limit their ability to fully capitalize on the EPA's provisions. Unlike larger Caribbean economies, OECS states have limited export capacity, which restricts their participation in and benefits from expanded trade opportunities under the agreement.

One suggestion to address these disparities, is a proposal that grant funding under the EPA's development cooperation pillar could be more strategically aligned with the unique needs of small island states.

Work under way to upgrade arrivals, retail spaces at NMIA



PAC Kingston Airport Limited (PACKAL) has begun two major renovation projects at the Norman Manley International Airport (NMIA) as part of the next phase of the operator's \$25.8-billion (US\$161-million) transformation programme first unveiled in 2024.

A \$1.2-billion overhaul of the customs and arrivals hall – expected to take roughly 24 months – will introduce improved lighting, upgraded flooring, expanded seating, enhanced aesthetics, a covered kerbside pickup zone, and a revamped bar and restaurant.

Meanwhile, \$320-million upgrade to the link corridor aims to modernise both arrivals and departures, while improving overall passenger flow. The

16-month project is described by the operator as one that will “transform the shopping experience with four new retail locations, including two food and beverage outlets, one duty-free shop, and one retail store, alongside improvements to lighting, flooring, and seating areas”.

PACKAL's transformation programme spans five years. With operational infrastructure upgrades progressing, the operator is now accelerating its passenger-facing projects, including works in the departures area, scheduled to begin later this month.

“These projects will transform the first and last impression passengers have at our gateway. As we modernise the passenger experience throughout

the airport, we are curating a passenger experience that starts as soon as you land and continues through to your departure,” said Sitara English-Byfield, chief executive officer of PACKAL.

The works follow several passenger-centred upgrades, including restroom modernisation, retiling of the check-in hall, and improvements to the baggage-handling system. These enhancements complement ongoing safety-related projects, such as the \$11.5-billion Runway End Safety Area implementation, apron-slab rehabilitation, and taxiway improvements, PACKAL said.

Man arrested for sexual assault during Jouvert in Port of Spain

Police have arrested a man for the sexual assault of a woman participating in a Jouvert band on Monday morning, warning the public that “any form of sexual assault is a serious criminal offence.”

Authorities reported that around 9:08 a.m., the 34-year-old victim was playing mas along Tragarete Road, Port of Spain, near

a Ministry of Agriculture building, when the suspect approached her from behind.

Police said the man began dancing behind the woman before attempting what was described as “a non-consensual sexual act.” Realising what was happening, the woman quickly pushed the man away. He then attempted to flee from the band.

Private security personnel working with the band intervened immediately upon witnessing the incident, apprehending the suspect and handing him over to patrolling police officers who were nearby.

The suspect was taken to the St. Clair Police Station, where he is expected to be questioned and may face charges later this week.

In a statement issued yesterday afternoon, police reminded the public that “any form of sexual assault is a serious criminal offence and will be treated with the utmost urgency.” They also urged individuals attending Carnival events to remain vigilant, respect personal boundaries, and report any incidents immediately to the nearest police officer. Govt remains silent days after US military boat strike in SVG waters



Kingstown remains silent some six days following a lethal U.S. military strike which, according to all reports, occurred inside St Vincent's territorial waters.

Remnants of the alleged drug boat hit by the strike were found off Canouan on Saturday.

St Vincent Times efforts to obtain official confirmation have been futile, even as St Lucia's Prime Minister, Philip J Peirre, on Monday confirmed that lives were lost.

Peirre was referring to reports of a second strike which, according to reports, occurred off Owia in which it is understood that three St Lucian nationals were killed.

"I can confirm that people lost their lives. As to the circumstances, I have no official notification on the circumstances surrounding their deaths".

St Vincent's Opposition Leader, Ralph Gonsalves, on Monday described U.S. actions in the Caribbean as "wholly unjustified in law" and warned that they threaten regional stability and sovereignty.

The Opposition Leader criticized the current administration in St. Vincent for failing to speak out, suggesting they are afraid of US retaliation, particularly regarding their Citizenship

by Investment (CBI) programs or diplomatic ties. He advocates a "mature engagement" with the US that avoids both "subservience" and "infantile opposition" to ensure the survival of free and independent Caribbean peoples.

Gonsalves stated that the unilateral action of the US in destroying vessels within or near Caribbean waters challenges the independence of regional nations. He suggests that if Caribbean governments remain silent out of fear, they risk being seen as "slaves of the United States" or mere "local government bodies" rather than sovereign states with national rights.

He emphasized that even if individuals are involved in drug trafficking,

they are entitled to a trial and are "innocent until proven guilty." By destroying boats at sea, the US acts as "judge, jury, and executioner," which Gonsalves terms a "species of barbarism."

Meanwhile, this publication understands that police in St Vincent conducted a major drug haul on Monday. It remains unconfirmed if it was related to the U.S. strike on Friday.

Reports to the St Vincent Times indicate that some 9kilos of cocaine were seized. The exact location of the haul has not been made public yet by local authorities.

The St Vincent Times understands that there have been several reports of cocaine washing ashore in other Southern Caribbean islands since Saturday evening.

The Trump administration has adamantly defended the strikes as necessary to stop illegal drugs from entering the U.S. Since the strikes began in September, at least 37 strikes have killed 120 people, excluding Friday's strike, according to the Department of Defense.

The U.S. resumed boat strikes in late January after largely backing off from attacking boats in the region following the U.S. military's Jan. 3 kidnapping of Venezuelan President Nicolás Maduro. (St Vincent Times)

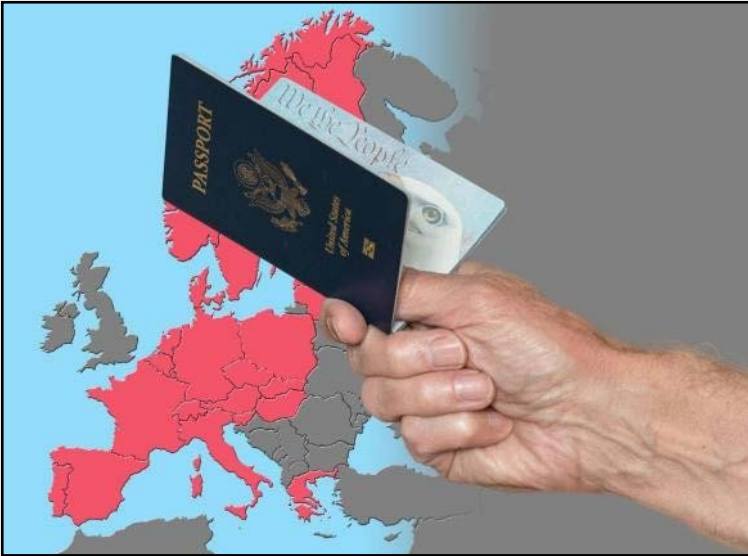

US to expand passport revocations for parents who owe child support, AP sources say



Parents who owe a significant amount of child support soon could lose their ability to travel internationally as the Trump administration expands and steps up enforcement of a 30-year-old law that allows the federal government to revoke American passports until payments are made, three US officials told The Associated Press.

While passport revocations for unpaid child support of more than \$2,500 have been permitted under 1996 federal legislation, the State Department had in the past acted only when someone applied to renew their travel document or sought other consular services.

In other words, enforcement depended on the person approaching the department for assistance.

Starting soon, however, the department will begin to revoke passports on its own initiative based on

data shared with it by the Health and Human Services Department, according to the US officials familiar with the plan.

They spoke on condition of anonymity because the change has not yet been publicly announced.

The number of people who could be affected was not immediately clear, but it is believed to be in the thousands. Because of the potentially large universe of those owing child support who currently hold passports, the State Department will make the change in tiers, the officials said.

The first group to be affected will be passport holders who owe more than \$100,000 in past-due child support, the officials said.

One of the officials said fewer than 500 people meet that threshold and could avoid having their passport revoked if they enter into a payment plan with HHS

after being notified of the pending revocation.

The official acknowledged, though, that if and when the threshold is lowered to a smaller past-due amount, the number of those affected will rise significantly.

The official could not say when any further changes would take effect or estimate how many people might then lose their passports.

In an emailed response to the AP's queries about the change, the State Department said it "is reviewing options to enforce long-standing law to prevent those owing substantial amounts of child support from neglecting their legal and moral obligations to their children."

It added: "It is simple: deadbeat parents need to pay their child support arrears." (AP)

Climber on trial for leaving girlfriend to die on Austria's highest mountain



More than a year after a 33-year-old woman froze to death on Austria's highest mountain, her boyfriend goes on trial on Thursday accused of gross negligent manslaughter.

Kerstin G died of hypothermia on a mountain climbing trip to the Grossglockner that went horribly wrong. Her boyfriend is accused of leaving her unprotected and exhausted close to the summit in stormy conditions in the early hours of 19 January 2025, while he went to get help.

The trial has sparked interest and debate, not just in Austria but in mountain climbing communities far beyond its borders.

Prosecutors say that, as the more experienced climber, the man on trial was "the responsible guide for the tour" and failed to turn back or call for support in time to help his girlfriend.

Identified by Austrian media as Thomas P, he denies the charges and his lawyer, Kurt Jelinek, has described the woman's death as "a tragic accident."

The tragedy unfolded after the couple began their climb of the 3,798m (12,460ft) Grossglockner.

Prosecutors accuse Thomas P of making mistakes from the outset and have published a list of nine errors.

At stake is the question of when per-

sonal judgement and risk-taking become a matter of criminal liability. If the climber is found guilty it could mean "a paradigm shift for mountain sports", says Austria's Der Standard newspaper.

Key to the case is the charge by state prosecutors in Innsbruck that he was to be considered the "responsible guide for the tour", as "unlike his girlfriend [he was] already very experienced in high-altitude Alpine tours and had planned the tour".

They said he attempted the trip even though his girlfriend had "never undertaken an Alpine tour of this length, difficulty, and altitude, and despite the challenging winter conditions".

They also allege he started out two hours too late and had failed to take "enough emergency bivouac equipment".

He also "allowed his girlfriend to use... snowboard soft boots, equipment that is not suitable for a high-altitude tour in mixed terrain", say prosecutors.

The defendant disputes this. In a statement, his lawyer Kurt Jelinek, said the couple had planned the tour together.

"Both considered themselves... to be sufficiently experienced, adequately prepared, and well equipped," he said. Both had "relevant Alpine experience"

and were “in very good physical condition”.

Once on the mountain, prosecutors say the man should have turned back, when it was still possible, because of strong winds of up to 74km/h (45mph), and the winter cold. It was -8C, with a windchill temperature of -20, they said.

The couple did not turn back.

Accounts of what happened next differ.

According to the defendant’s lawyer, they reached a place called Frühstück-splatz at 13:30 on 18 January, the point of the tour after which there was no turning back before the summit.

As neither of them was “exhausted or overwhelmed, they continued on”, Kurt Jelinek said.

Prosecutors say the couple got stuck at about 20:50 and that the man failed to call the police and did not send any distress signals when a police helicopter flew overhead at around 22:50.

The boyfriend’s lawyer said at that point his client and girlfriend still felt fine and did not call for help as they were close to the summit.

But shortly afterwards, Mr Jelinek said the situation changed dramatically. To the man’s “complete surprise”, the woman “suddenly showed increased signs of exhaustion”, although by then turning back was too late.

At 00:35 on 19 January, he called mountain police. The content of the conversation is unclear but the lawyer says he asked for help and denies telling police that everything was fine. Police allege he then put his phone on silent and did not take any more calls.

Kurt Jelinek says the couple managed to reach an area about 40m (130ft) below the cross marking the summit of the Grossglockner.

As the defendant’s girlfriend was too exhausted to move, he left her to find help, scaling the summit and descending on the other side, he says. Prosecutors say he left her at 02:00am.

His torchlit figure is captured on webcam images as he descended from the summit.

Prosecutors say he did not use aluminium rescue blankets or other gear to protect her from the cold and waited until 03:30 before notifying emergency services.

By that point it was most probably too late. The strong winds meant that no helicopter rescue could take place during the night.

Kerstin G died alone in the snow on the frozen mountainside.

Her social media feed suggests she

was a keen mountaineer and her mother has told German media that she loved mountain hiking at night.

Thomas P’s lawyer says he is “deeply sorry” for her death. “Above all, he would like to express his sincere condolences to the family of the deceased,” Mr Jelinek said.

If found guilty, Thomas P faces up to three years in prison.

And a guilty verdict could also have implications for other mountain climbers, and how much they could be liable for their companions in the future. (BBC)

Rescuers search for nine missing skiers after California avalanche

Nine backcountry skiers are missing following an avalanche in California's Lake Tahoe region on Tuesday, authorities say.

Six others have been rescued after they became stranded, the Nevada County Sheriff's Office said.

The avalanche was reported about 11:30 PST (19:30 GMT) in the Castle Peak area near the town of Truckee, according to officials. Weather conditions remain dangerous, with a high chance of further avalanches.

"Highly skilled rescue ski teams" have deployed from two nearby ski resorts, the sheriff said. The six known survivors have been "directed to shelter in place as best they can in the conditions," the sheriff added.

Officials initially reported that a group of 16 people in total - four guides and 12 clients - were involved, though that number was later lowered to 15.

"The six initially reported skiers who survived the avalanche have been successfully rescued this evening," the sheriff's office wrote on Facebook late on Tuesday night. Two of the six rescued skiers were taken to hospital, it said.

Experts from the nearby Boreal Mountain Ski Resort and the Alder Creek Adventure Center are also attempting to reach the site.

An earlier statement posted by the sheriff's office said 46 emergency responders had joined the rescue efforts.

The Sierra Avalanche Center wrote in a forecast: "Large avalanches are expected to occur [on] Tuesday, Tuesday night, and into at least early Wednesday morning across backcountry terrain."



The avalanche centre listed the danger rating as "high" - a four out of five on the rating scale.

"Travel in, near, or below avalanche terrain is not recommended today. A widespread natural avalanche cycle is expected over the next 24 hours," the centre said. "Large avalanches may run through treed areas."

The avalanche that trapped the skiers was rated as a D2.5 on a scale of D1 to D5, Sierra Avalanche Center Forecaster Steve Reynaud told local outlet ABC News 10. D2 avalanches can injure, bury or kill people, according to avalanche.org.

Reynaud told ABC that the skiers were on the last day of a three-day backcountry skiing trip.

He said the skiers spent two nights at huts on a trip that involved navigating "rugged mountainous terrain" for 4 miles (6.4km) while carrying food and supplies.

A spokesman for the sheriff's office, Capt Russell Greene, told local news station KCRA-TV that it would be a "slow, tedious process" to find the missing skiers because of the high avalanche danger posing a risk to

rescuers.

As of around 17:15 PST (01:15 GMT), he said first responders, including some on skis, were still trying to reach the avalanche zone and that those alive were sheltering under tarpaulin sheets "doing the best they can to survive".

He said it was not uncommon for ski tour companies to take paying customers out in such conditions, adding: "I don't think it was a wise choice but we don't know all the details yet."

California Governor Gavin Newsom's office said in a post on X that state authorities were "co-ordinating an all-hands search-and-rescue effort" with local emergency teams.

The Boreal Mountain Ski Resort, which is near where the accident occurred, has reported 30 inches (76cm) of snowfall in the past 24 hours.

The resort decided to close on Tuesday because of high winds and low visibility.

The storm has also closed several highways, including Interstate 80 and Highway 50. (BBC)

Vatican says it will not participate in Trump's 'Board of Peace'

The Vatican will not participate in President Donald Trump's "Board of Peace" initiative, Cardinal Pietro Parolin, the Vatican's top diplomatic official, said on Tuesday while adding that efforts to handle crisis situations should be managed by the United Nations.

Pope Leo, the first U.S. pope and a critic of some of Trump's policies, was invited to join the board in January.

Under Trump's Gaza plan that led to a fragile ceasefire in October, the board was meant to supervise Gaza's temporary governance. Trump thereafter said the board, with him as chair, would be expanded to tackle global conflicts. The board will hold its first meeting in Washington on Thursday to discuss Gaza's reconstruction.

Italy and the European Union have said their representatives plan to at-

tend as observers as they have not joined the board.

The Holy See "will not participate in the Board of Peace because of its particular nature, which is evidently not that of other States," Parolin said.

"One concern," he said, "is that at the international level it should above all be the UN that manages these crisis situations. This is one of the points on which we have insisted."

Many rights experts say that Trump overseeing a board to supervise a foreign territory's affairs resembled a colonial structure. The board launched last month has also faced criticism for not including a Palestinian.

Countries have reacted cautiously to Trump's invitation, with experts concerned that the board could undermine the U.N. Some of Washington's Middle Eastern allies have joined but its

Western allies have stayed away so far.

The Gaza truce has been repeatedly violated with hundreds of Palestinians and four Israeli soldiers reported killed since it began in October.

Israel's assault on Gaza has killed over 72,000, caused a hunger crisis and internally displaced Gaza's entire population.

Multiple rights experts, scholars and a U.N. inquiry say it amounts to genocide. Israel calls its actions self-defense after Hamas-led militants killed 1,200 people and took over 250 hostages in a late 2023 attack.

Leo has repeatedly decried conditions in Gaza. The pope, leader of the world's 1.4 billion Catholics, rarely joins international boards. The Vatican has an extensive diplomatic service and is a permanent observer at the United Nations. (NBC)

RORC Caribbean 600 2026: Antigua's Offshore Season Ignites

Antigua's offshore racing season shifts into top gear this week as the island hosts the twin pillars of its February sailing calendar — the RORC Nelson's Cup Series from February 17, followed by the 17th edition of the RORC Caribbean 600 starting February 23.

Nelson's Cup: The Proving Ground

Before the 600-mile offshore marathon begins, the Nelson's Cup has become a crucial proving ground in English Harbour. The series features two days of intense coastal racing, culminating in the Antigua 360 — a full circumnavigation of the island that demands precise navigation and disciplined boat handling. For crews preparing for the Caribbean 600, it offers competitive racing in the very waters they will soon face offshore.

Importantly, the Nelson's Cup is also open to boats not contesting the 600, allowing maxis, IRC contenders and strong regional programmes to compete. The result is a deeper, more inclusive fleet and a full week of racing that keeps Antigua's waterfront firmly in the spotlight.

The 600: Strategy Meets Stamina

When the RORC Caribbean 600 proper begins on February 23, the focus shifts offshore. The 600-nautical-mile course threads past 11 Caribbean islands, combining powerful trade winds with tactical wind shadows and demanding night watches. Strategy and stamina carry equal weight.

The 2026 fleet once again reflects the race's global draw. The MOD70



trimaran ARGO (USA) is expected to challenge for multihull line honours, while the Maxi 72 BALTHASAR brings serious offshore pedigree to the monohull battle. In the fiercely contested IRC divisions, boats such as the J/121 WHISTLER and Swan 58 WAVEWALKER are among those targeting corrected-time honours.

Among returning competitors is Galateia, a familiar campaigner in Antigua waters. This year marks a first Caribbean 600 for one of her helmsmen, racing alongside her father. "The start will be fascinating," she said. "You line up beneath the cliffs, and the breeze can either roll down beautifully or vanish completely. It's a bit of a gamble." Af-

ter scouting the course from Shirley Heights as well as at sea, she added: “It’s stunning here. I’m excited to experience it properly.

She did! Day One of the Nelson’s Cup delivered a proper slice of Antigua sailing — morning squalls that kept crews guessing, followed by gentler trade winds that rewarded patience and clean boat handling. Across both races, starts and smart decisions in shifty pressure made the difference. Leopard 3 found her rhythm in Race Two, surging back to take the win from Galateia, setting up a compelling contest as the series unfolds. With conditions refusing to settle, consistency — not just speed — is already proving decisive.

Inspiring the Next Generation

The week is not only about established campaigns but about inspiring the next generation. On Sunday evening, crew from V, Deep Blue and Leopard joined Antigua Yacht Club’s youth sailors to share what it truly takes to reach the top: hard work, pacing docks, relentless networking — and above all, sailing, sailing, sailing.

Among them was Giles de Jager,



who learned his craft at AYC and is now mate aboard the high-performance racing yacht Leopard.

“For me it was simple,” Giles told the youngsters. “I was in Spain, saw Leopard going in the water, walked down the dock and asked if they needed someone to clean. I got the job — and worked my way up.” His message was direct: make yourself valuable. “You don’t just get on these boats for being a good sailor. Learn a trade — engineering, sail-making, splicing, organising. Find

what you’re good at and own it.”

Coach Karl James reminded the sailors that Giles’s journey began years earlier while watching the Volvo Ocean Race in Martinique and declaring, “I want to do that.” From Optimist racing at AYC to cleaning decks and now serving as second-in-command — with captaincy in sight — his path stands as tangible proof that even from a small island, ambition paired with persistence can carry you onto the world stage.

An Island Effort

Beyond the racecourse, the economic and community impact is

tangible. English Harbour fills with international crews, marine services operate at capacity, hospitality businesses see a seasonal lift, and safety teams including ABSAR remain on alert throughout the week.

The Nelson’s Cup sharpens the fleet.

The Caribbean 600 tests it.

And once again, Antigua and Barbuda stands at the centre of the off-shore sailing world.

Five Islands open up eight-point lead atop First Division League

The Five Islands FC won their latest match to open up an eight-point lead at the top of the Antigua and Barbuda Football Association's (ABFA) First Division League.

Five Islands FC notched up their ninth win in 15 matches by coasting to a 4-1 victory against the Cedar Grove Blue Jays at Five Islands on Tuesday.

Jamal Joseph scored twice in the second half with goals in the 51st and 62nd minutes to seal the win. Demario Roberts scored in the second minute, and Shane Cochrane had a 23rd-minute conversion to give Five Islands a two-nil lead.

Khalid Adams scored a consolation goal for his team in the 35th minute as Cedar Grove trailed Five Islands 1-2

at halftime.

The Cedar Grove Blue Jays remain at the bottom of the standings with eight points after crashing to their 10th defeat in 14 matches.

Kamali Looby scored in the 53rd minute, and Nickado Lindsay had a 90th-minute conversion for Empire FC.

The result allows SAP FC to move into fourth place on goal difference with 23 points, while Empire FC slipped from fifth to sixth place with 21 points after suffering their fifth defeat in 14 matches.
